




Thanks for the notice of the 1982 World Congress for the Prevention of Alcoholism and Drug Dependency in Kenya, August 29-September 2, 1982.

Dear Dr. Stelzer:

Enclosed you will find a xerox copy of a letter I received from Mr. A. Calderbank of ICI in England. Apparently, Mr. Calderbank misinterpreted our original request. Let me bring you up-to-date.

Dr. Michael Rose, who happens to be a friend of mine, was contacted regarding information on paraquat. Michael has apparently been lost by ICI or reassigned and subsequently, I was referred to Dr. Smith and now subsequently to you. The issue of paraquat and its use in eradicating narcotic plants is of interest to me in my present position as well as in my last position. There seems to be misconceptions about paraquat all over the place in Washington. My concern is to get the LD-50 of paraquat orally, IV and, if you have it, through the smoking process. Other toxocological information would be of great use on paraquat.

I have read considerable papers on paraquat but sometimes the people writing those papers don't really understand the nature of what they are doing.

If you have a review article that will give us this information in a graphic presentation, I would be delighted to receive it. Certainly this office does not want to receive a box full of information which would be impossible for me to digest.

Your help would be greatly appreciated.
