COMPREHENSIVE SUMMARY

BLOW THE WHISTLE ON DRUGS

INTRODUCTION

Historically, the task of ridding communities of drug traffic has been left to law enforcement officials. Consequently, Police Departments have been playing a game of "catch-up," when it comes to the tracking and arrests of those who are involved in bringing drugs into our city. Efforts have centered around the arrests of "top" people, those who bring large quantities of drugs into our ports, and across state and city boundaries. Recently however, this has begun to change.

During the past two (2) years, more national attention has been given to drug smuggling and drug trafficking than ever before. As a result, other dimensions of the drug problem have been highlighted as well, e.g., chemical dependence as a treatable disease, the need for substance abuse treatment taking the form of various modalities, and substance abuse prevention strategies.

Baltimore City has been victimized by the drug problem in a way similar to other urban centers. It has been said that 80% of all crimes committed are drug related. This staggering statistic translates into fear, anger and frustration on the grassroots level. Citizens feel that they cannot safely send their children outdoors to play, or walk down the block to visit a neighbor, without fear. Drug activity has virtually taken over neighborhoods. Much of the concern voiced by citizens at community meetings centers around drug trafficking and drug dealers, and what can be done to stop it.

In response to the City's concern about the drug problem, Mayor William Donald Schaefer made the issue a priority. He called for a plan to be designed and implemented that would involve all of the citizens of Baltimore. The following is a description of the "Blow the Whistle on Drugs" campaign, one which attacks the problem on the community level.

PURPOSE

To reduce/eliminate drug trafficking in Baltimore's neighborhoods, and on street corners.

OBJECTIVE

To enlist the community's support in utilizing the Police Department's 24 hour drug hotline, 685-DRUG, to report suspected drug activity, and 911, to report observed drug activity. (911 call results in immediate police response.)

THEME

Drug laws are designed to help control the problem, but they do not eliminate or prevent it. The key to success in the battle against drug trafficking is a deep, personal involvement of countless individuals. Government programs can provide a means for encouraging such involvement, and for providing other necessary resources, but without the concern and commitment of people in their communities, the battle against drug trafficking cannot be won.

PROGRAM DESIGN

I. Facilitation of Community Involvement

As Baltimore is a city comprised of neighborhoods, it was felt that the most effective way to maximize the number of citizens reached is through community associations.

120 non-police city employees were recruited and trained to do 2-3 brief presentations to community associations and neighborhood groups.

The presentations include the following:

- a. What drug activity looks like.
- b. What information to report to police, and which telephone numbers to use.
- c. What police do after receiving citizen information.
- d. Telephone numbers and names of city employees who work specifically on drug abuse issues, so that communities can further their involvement.

Materials were also developed to augment and reinforce speakers' presentations for citizens. These include brochures and posters with the slogan "Your Eyes Can Help Stop Drugs in Our Neighborhoods, Blow the Whistle on Drugs, Call 685-DRUG," and whistles, with 685-DRUG printed on them. Materials are being distributed at each community meeting, and presentations are taking place throughout September and October and will continue as needed. MTA buses are also sporting billboards with the logo, slogan, and telephone number.

II. Media

Part of the success of the "Blow the Whistle on Drugs" campaign depended on the involvement of the various media. To achieve media support, several avenues were taken. First, approximately one and one-half (1½) weeks before the campaign kickoff Mary Ann Willin, Director of the Mayor's Coordinating Council on Criminal Justice, and Bishop L. Robinson, Police Commissioner, briefed the editorial staffs of the city's three major newspapers on the components of the program. As a result, all three newspapers printed positive editorials and news articles.

Second, press releases were sent to the three major networks, which gave minimal detail regarding the campaign but did notify them of the place, date, and time of the kickoff event. The morning of the event, the stations were again contacted. Radio and television stations gave the kickoff comprehensive coverage.

III. Event

To bring the message to the citizens, Mayor William Donald Schaefer and other city officials travelled by trolley to the three street corners identified as known drug "hot spots." Stopping at each corner for approximately fifteen minutes, the Mayor, Police Commissioner Robinson, City State's Attorney Schmoke, and Circuit Court Judge Joseph H.H. Kaplan, and community leaders made remarks to those assembled, telling them that they are a part of the solution to the drug trafficking issue, and asking for their assistance by calling 685-DRUG. Whistles and brochures were distributed at each stop.

RESULTS AND CONCLUSIONS

"Blow the Whistle on Drugs" has received widespread community support, through citizens' feedback, and more importantly, the increased utilization of 685-DRUG, and 911. From the kickoff event to date, a period of twenty-two days, 685-DRUG has received over 850 calls, and from those have come 1,012 investigative leads, and numerous arrests. Because of the tremendous support this program has received, three (3) more street corners have been targeted for solicitation of community involvement.

The success of this program has depended on many factors, the most important being the citizens' willingness to come forward and be part of a solution. Community empowerment is an essential ingredient in dealing with any large scale urban problem. Citizens need to learn, and have an opportunity to help themselves. "Blow the Whistle on Drugs" is an example of what can happen when individual citizens identify with an issue, own it, and act in concert. Continued success is predicted for this campaign.

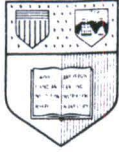

I would like to alert you to an upcoming request for your help. During an electronic dialogue last Thursday with a conference of USIS Public Affairs Officers (PAO's) from thirteen East Asian/Pacific countries, I was asked about your availability to participate in their activities via videotape.

There was heartfelt concensus during the conference that your participation and leadership in the area of drug education is having a recognizable and positive effect on East Asian/Pacific communities. Dear Dr. Turner:

I am writing to ask your help in an urgent matter concerning the future of the Chemistry Department. The State is supposed to review Ph.D. programs (again) sometime in the Fall and the Ph.D. granting universities (USM, State, Jackson State, Ole Miss) have decided to develop a unified defense of these programs. As part of this defense I am asking you to please provide me with the following information.

- a. Your initial job after graduation.
- b. Your current position/title.
- c. Your accomplishments, limited to important positions held, scholarly activities (books, papers, patents, etc.), awards and honors.

Most of this information would, of course, be in a copy of your current resumé. It would also be very helpful to us if you could ask your present and/or former employer(s) to write to us commenting on the quality of the Ph.D. education you received. If you would also comment in your own letter on how you felt the quality of your education at USM compared with that of your contemporaries in similar positions, this too would be extremely useful. Many of you sent this latter type of letter of support in 1982. I will use these older letters unless you feel you would prefer to send a new, updated version.

My deadline for completion of my report to the University for incorporation into the joint universities presentation to the College Board is July 26. I am sorry for the impersonal nature of this letter, there have now been 54 graduates in the 18 years since our first Ph.D. was granted. I am also sorry to have to impose upon you again as part of our efforts to defend a high quality, educationally viable, cost effective program.

SUBJECT: Drug Abuse Policy

The successes we have had in combatting drug abuse has raised the level of awareness of the problem, but also generated "horror" stories picturing the situation as "out of control" and therefore, fueling pro-drug arguments. There is a fine line between favorable publicity and destructive sensationalism when reporting on drug issues and the way in which Administration officials describe the drug situation often makes the difference.

Mrs. Reagan's international drug abuse initiatives, the kidnapping of the DEA agent, seizures of large amounts of drugs, seized airplanes and increased focus on the effects of cocaine have resulted in a dramatic increase in media attention given to all aspects of the drug issue. There is every indication that this attention will continue if efforts are taken to assure a flow of information.

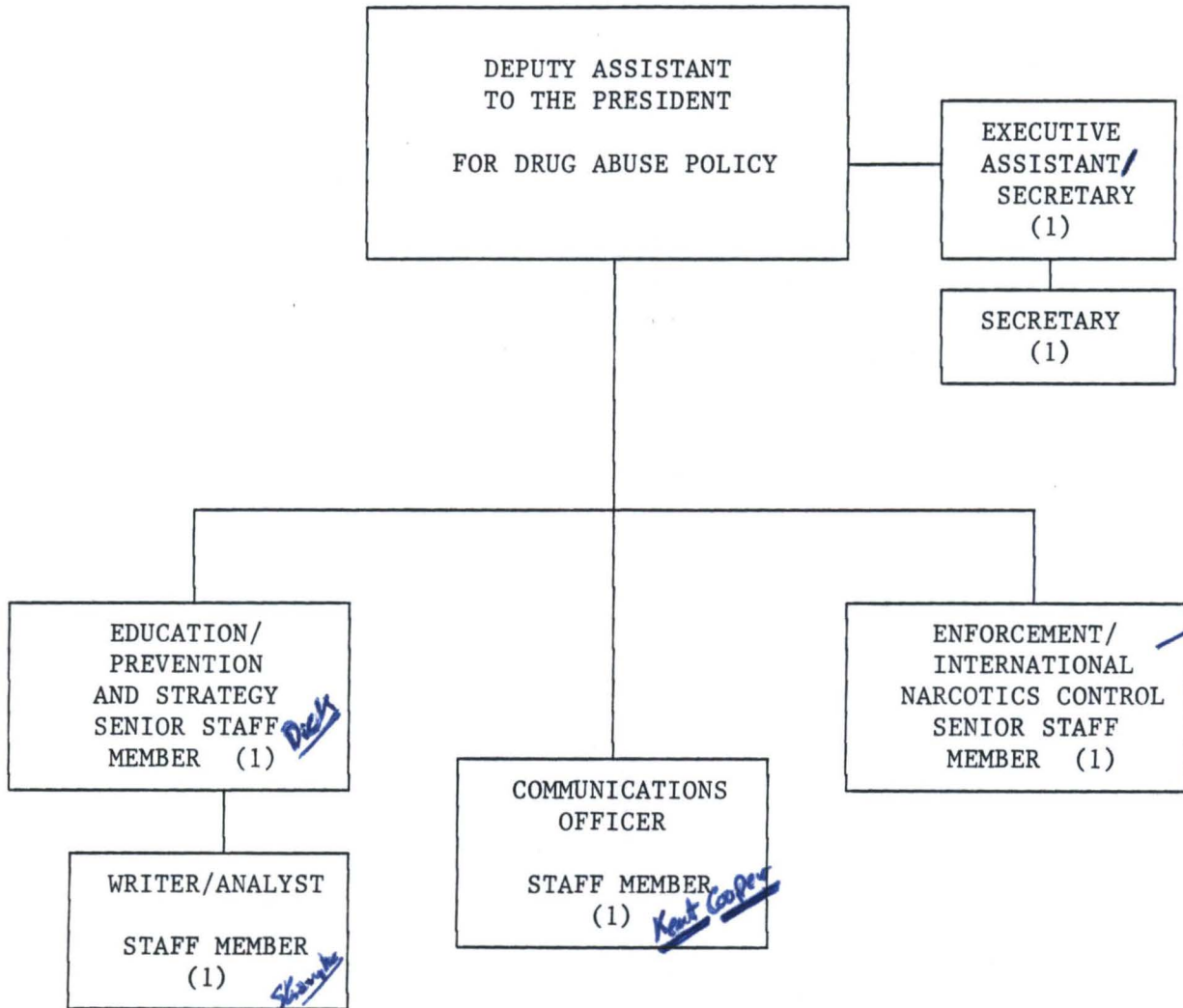
As you know, I will be the moderator for the First Lady's White House meeting in April and will accompany the group to Atlanta. While I do not have a clear crystal ball regarding the future of my office, I know a staff of three, including myself, cannot provide the previous level of support to the National program, provide oversight of the 34 Federal agencies, manage the media, and assist the First Lady.

If the drug abuse policy office is to remain a separate entity there are several options. One would be to deliberately reduce the role of my office to eliminate private sector efforts and alcohol issues. This option would focus on providing staff support to the system and is not consistent with the program established by the President which requires us to provide leadership and serve as a catalyst for national action. A second option would be to assign the entire drug abuse policy function to the Attorney General and make him the overall drug czar. Thus, my office could be eliminated or I could continue to be the White House drug adviser, with my current staff. This option would be consistent with the "drug czar" legislation passed by Congress, but would slight the health-related aspects of the drug issue because of the obvious limitations on education and prevention activities.

If my office is to be continued and we are to continue to provide oversight and policy direction as in the past, I need a comprehensive communication strategy and someone to implement it, a writer/analyst and a professional staff member to coordinate and liaison with the health-related activities, the law enforcement agencies and the international control activities. The staff for these drug abuse policy functions has varied from 7 in 1973 to over 15 during the early Carter years.

Which way do I go? I recommend that we increase the staff -- specifically add a communications coordinator, a writer/analyst, a secretary and an enforcement/international staff member. (Increase of 4 payroll positions, for a total of 7 -- see attached chart).
