
We really Solicit your Co-operation, Physical and Moral Support. We shall keep you well posted with our activities.

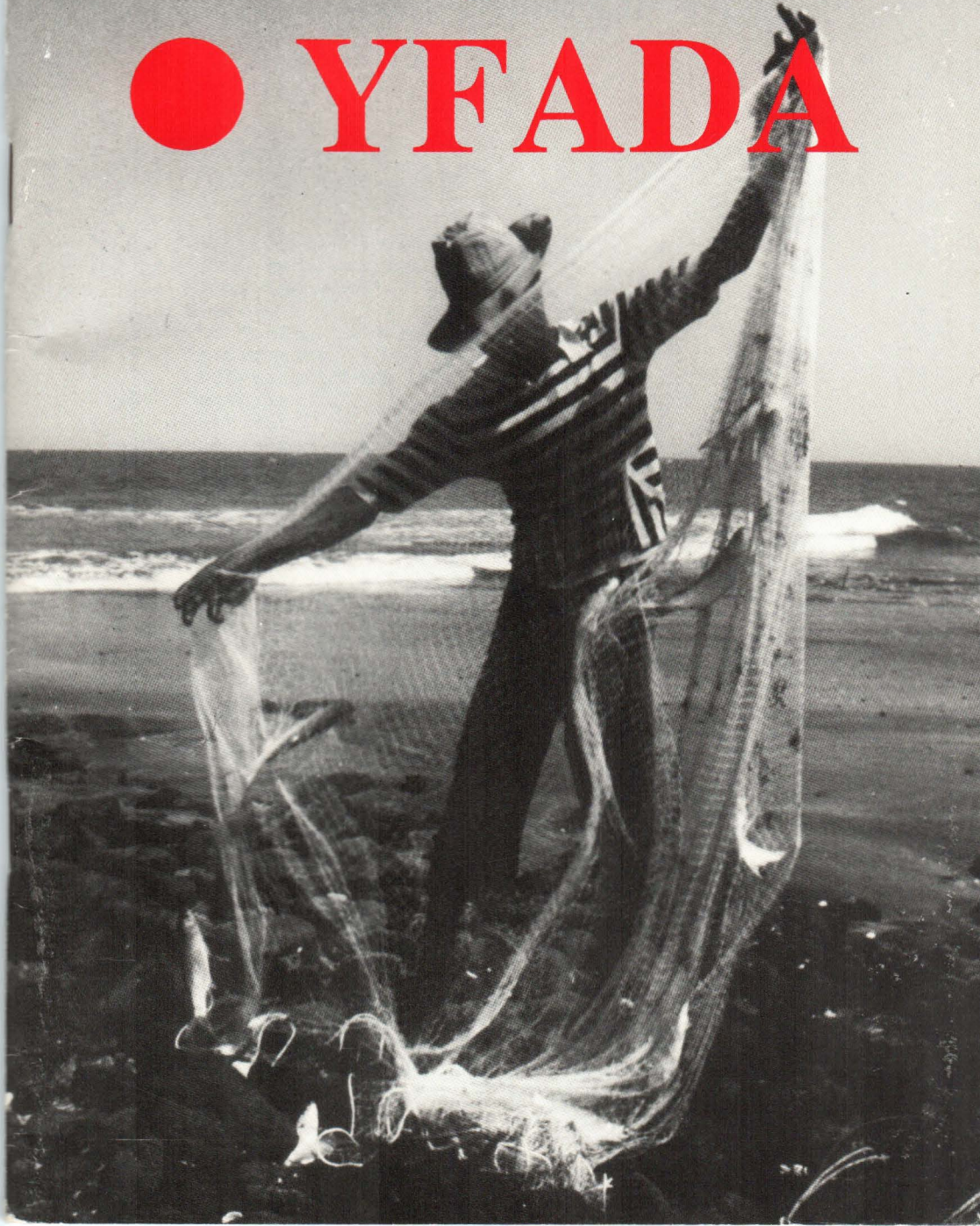
