The President today appointed Carlton E. Turner, Ph.D. as Deputy Assistant to the President. Dr. Turner has been Special Assistant to the President for Drug Abuse Policy and Director of the Drug Abuse Policy Office in the Office of Policy Development. He will retain his title of Director of the Drug Abuse Policy Office.

Dr. Turner serves on the Cabinet-level Executive Board of the National Narcotics Border Interdiction System. He also assists the First Lady in her drug abuse education projects. He came to the White House on July 9, 1981 as the Senior Policy Adviser for Drug Policy. Prior to joining the Administration, he was the Director of the Research Institute of Pharmaceutical Sciences, School of Pharmacy, University of Mississippi. He has served as a consultant for various government agencies and private firms in the United States, Mexico, etc., as well as for the United Nations.

Dr. Turner is the past president of the American Council on Marijuana's Scientific Advisory Board and was the 1982 Harry G. Armstrong Lecturer at the Aerospace Medical Association's scientific meeting. # rime, drugs top economy

Americans want the USA's crime and drug problems to be government's top priority, according to a new poll by Roper Reports.

This is the first time since 1977 that a non-economic issue was selected as the top need for government action.

"It surprises me that the pub-lic has focused on the issue," Francis M. Mullen, head of the Drug Enforcement Administration, said Tuesday. "That's the type of focus we need in the Congress and administration.

Seven years ago, "slowing down inflation" was identified as in need of government's top efforts, and in 1982 and 1983 reducing unemployment was the top choice in the poll.

The number of people this year choosing unemployment as a top priority was down 9 percentage points from 1983; those choosing inflation dropped by 4 percentage points.

Containing health care costs, asked for the first time, tied for third.

The poll also showed a high

percentage of Americans favor government action to solve non-economic problems such as limiting nuclear arms and developing energy sources.

The 2,000 adults surveyed were shown a list of 21 topics and asked to rate whether the government should make a major effort, some effort or no particular effort to solve the problems.

#### CONTRIBUTION:

Governor Clements (TX) designated Mr. Perot as Chairman of the Texans War on Drugs Committee with the goal of making Texas the worst possible place in the world to be a drug user, pusher, dealer, or trafficker. Mr. Perot used his personal resources and organizational ability to set the organization in motion and successfully sought dramatic legislative reforms which enabled the goal to be achieved.

The Keebler Company was the first to respond to the need for providing drug abuse educational materials to young people in a manner in which they understand and accept. Keebler underwrote the cost of the production and research in DC Comics preparation of the first drug awareness adventure comic book in the President's Drug Awareness Campaign. They initially sponsored the production of one million copies which were distributed by the Federal government to fourth grade classes in 35,000 elementary schools across the country. Another one million copies were printed for use in drug awareness programs held in shopping centers in the Western United States and made unlimited copies available to all of the Federal government for additional distribution.


