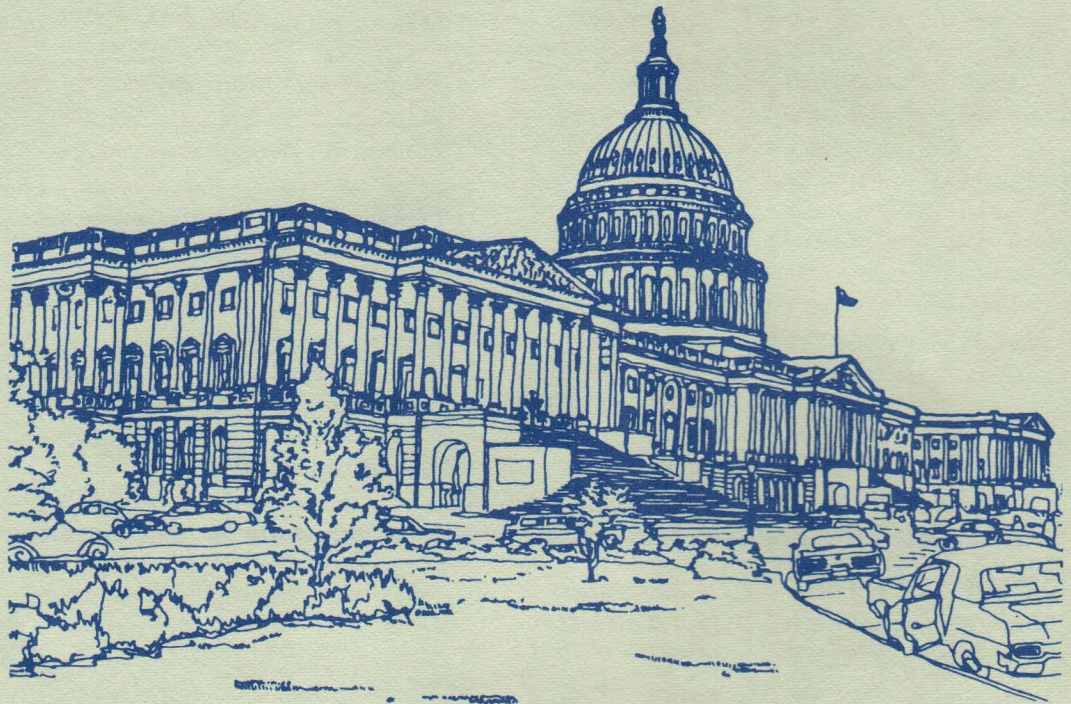

Theme

"New Initiatives for Changing Times" is the theme of the 34th Annual Conference. The program has been designed to give participants information on the changing social and political environment and how new initiatives will help alcohol and drug abuse professionals do a better job.

Program Objectives

By participating in the conference, attendees will increase their skills to:

- Provide leadership in their programs and communities in determining future program developments that meet the challenge of the economic, social and health care environments;
- Evaluate current and proposed patterns of delivering alcohol and drug abuse education, occupational, prevention, research and treatment services; and understand the implications of specific patterns on individual programs as well as on the community as a whole;
- Compare local and state alcohol and drug abuse services to other services in similar settings and identify means of improving and/or expanding local and state programs to provide quality, comprehensive services;

- Determine necessary program adjustments needed to meet changing reimbursement regulations and to be aware of shifts in third party policies and requirements;
- Identify national and state resources to assist in local planning and implementing of services; and
- Initiate local action to affect legislation and regulations at the state and national level.

CEU/CME Credits

Continuing Education Units and Continuing Medical Education Credits have been applied for and are expected to be available. An additional fee of approximately \$7.00 will be charged. Additional information will be available at the conference.

Who Should Attend

Participants at the conference will represent the professional sector of the alcohol and drug problems field. Typical attendees at ADPA Annual Conferences include: educators, prevention specialists, treatment clinicians, administrators, state and national governmental employees, researchers, librarians, medical personnel, trainers and numerous others.

Scholarships

A limited number of conference scholarships are available. Write or call the ADPA Conference Office for additional information.

Concurrent Workshops and Presentations

Over 120 workshops and presentations featuring over 170 speakers will be scheduled to cover a broad array of topics. Sessions are organized within 11 tracks including Addictions and Family Issues, Armed Services Programming, College and University Programming, Criminal Justice Issues, Drinking and Drugged Driving, Financing of Services, Occupational Programming, Prescription Drug Abuse, Public Policy/Advocacy, Prevention and Treatment Techniques. Education, research, womens', multicultural, nurses and training issues are covered within many tracks. NIAAA and NIDA are providing expert speakers to supplement the program, and poster sessions are being planned to give participants access to many new ideas.

Women's Breakfast

Women working professionally in the alcohol and drug problems field are invited to attend the Women's Support Network Breakfast. This is an opportunity for women in the field to share the special concerns unique to them. A separate charge of \$7.00 is made to cover the cost of the breakfast.

Women in Management - Chance to Advance

This one day pre-conference seminar for women professionals and managers will focus on increasing knowledge of management concepts, self-assessment, and development of individual action plans for meeting career goals. Training methods include brief lectures, group discussion and role play. Marcia Manter, Vice President of Flint Associates, Inc., Newport, Rhode Island, who has conducted more than 100 workshops for women in the health care profession, will be the moderator. For additional information contact the ADPA office. There is a \$55.00 fee for this seminar.




ADPA is now in the process of planning its Annual Conference for 1983. The theme of the national meeting will be "New Initiatives for Changing Times" and is being designed to look at the rapidly changing complexities of the alcohol and drug abuse field.
