Dear Members of the ABA House of Delegates; ABA Section and Division Chairs; Council Members of Interested ABA Entities; and State and Local Bar Presidents, Presidents-Elect and Executive Directors:

As President of the American Bar Association and on behalf of the ABA Section of Individual Rights and Responsibilities and its ABA Advisory Commission on Youth Alcohol and Drug Problems, I am personally sending you the enclosed recommendation and report addressing one of the most serious national crises of our time. In response to the enormity of America's youth alcohol and drug problems, this excellent recommendation calls for the implementation of a comprehensive national strategy, including prevention, education, law reforms, and new methods for raising the necessary fiscal resources attendant to such policies. Due to the urgency of these problems and my personal commitment that the ABA House of Delegates would consider a responsive recommendation during my term as ABA President, I am asking each of you to carefully review the enclosed resolution and to support its adoption by the House this July.

The Advisory Commission's work has been the hallmark and a top priority of my term as ABA President. On the national scene, it is difficult to imagine anything more tragic than the spectre of hundreds of thousands of American children destroying their young minds and bodies through alcohol and drug abuse. Last year, in response to the growing national crisis of substance abuse by children and at my suggestion, the Section of Individual Rights and Responsibilities created its Advisory Commission on Youth Alcohol and Drug Problems, under the auspices of its Committee on Alcoholism and Drug Law Reform. In my inaugural address, I articulated the Advisory Commission's mandate, noting that an escalating number of America's children had become the customers of merchants of drugs and alcohol. I encouraged the Advisory Commission to help define an agenda for law reform and action by the organized bar and urged lawyers to lend their support and expertise to help combat this growing problem.

The I.R. & R. Section quickly accepted this challenge, as its Chairperson, J. David Ellwanger, joined with me in appointing an outstanding multidisciplinary, non-partisan Advisory Commission of 27 experts, consisting of 13 lawyers, 3 judges and 11 non-lawyers, including representatives of the U.S. Department of Justice and the ABA Sections of Individual Rights and Responsibilities, Criminal Justice and Family Law; the Young Lawyers Division and the Special Committee on Youth Education for Citizenship. Most of the commissioners have extensive prior experience in some aspect of federal or local government, substance abuse, treatment, education, private industry, pharmacology, medicine or juvenile justice. During the past eight months, the Advisory Commission undertook an intensive series of meetings and two-day field hearings in Atlanta, Princeton and Los Angeles. It received the personal testimony of over 160 witnesses, who submitted over 250 recommendations and hundreds of pages of written testimony and exhibits. Witness after witness appearing before the Advisory Commission testified about the enormity of youth alcohol and other drug problems. Witnesses repeatedly noted the demonstrated links between youth alcohol and other drug abuse and juvenile crime, serious health problems, poor school performance, automobile accidents, fatalities and other life-threatening injuries, as well as teenage suicide.

Throughout the coming year, the Section of Individual Rights and Responsibilities and its Advisory Commission will work to implement the recommendation adopted by the House. The Advisory Commission has planned six regional meetings in Washington, Boston, Chicago, New Orleans, Austin and San Francisco to stimulate ABA, state, and local bar initiatives with community-based groups of parents, teachers, children, professional associations, treatment specialists, and others. Special training and educational programs for lawyers and judges will be designed and implemented. Working closely with the state and local bar associations, a national speakers' bureau of lawyers and judges will be established to stimulate their public appearances before community groups, parent and youth groups, schools and others. Informational speakers packets for this bureau will be made available through the Advisory Commission. This "implementation" phase of our work will reaffirm my commitment on behalf of the ABA to work toward the amelioration of the serious and growing national crisis of youth alcohol and drug abuse.

Panel Discussion

The panel discussion will focus on the legal community's responsibility and involvement to help alleviate the devastation to our society that is caused by the use of alcohol and drugs by today's youth and will feature highlights of the past year's work of the Section of Individual Rights and Responsibilities' new Advisory Commission on Youth Alcohol and Drug Problems. The ABA Advisory Commission on Youth Alcohol and Drug Problems was created by the Section of Individual Rights and Responsibilities during the 1984-85 Association year under the auspices of its Committee on Alcoholism and Drug Law Reform at the suggestion of ABA President John Shepherd. The Advisory Commission held three

regional field hearings in Atlanta, Princeton and Los Angeles. After listening to the oral testimony of over 160 witnesses who submitted over 250 recommendations, and after examining the vast amount of written data, a 20-part report and recommendation was drafted by the twenty-seven member Commission and its three subcommittees on prevention, treatment and improvements in the law and procedure.

After final adoption of the recommendation by the ABA House of Delegates, the Commission will begin its implementation stage. This stage of the Commission's work will focus upon combined efforts of the Commission and the state and local bar associations in attempting to institute the recommended legislative and legal reforms at the local level. Additionally, the Commission will continue to develop its relations with state and local groups and organizations with whom it has worked during its initial stage of operation. Together with the bar associations and the local groups, the Commission will develop and implement a speakers' bureau and training programs for judges and attorneys that will specifically focus on the local level the alcohol and drug problems that confront today's youth.

Simultaneously, the Commission subcommittees will be given assignments to develop model laws which can be used to implement the Commission's recommendations at the state and local level. In addition, the Commissioners will continue to publish articles, write monographs and contribute new ideas for the consideration of the Commission. Throughout the life of the Commission, the Speakers Bureau will continue to spread the word about the Commission's work. Participants in the speakers bureau will speak before state and local bar associations, parent groups, children's clubs and others groups with a common interest in the concerns of substance use and abuse among children.

Re: Need for your immediate assistance regarding strategy for the adoption of Individual Rights and Responsibilities Section resolutions at the ABA Annual Meeting

Dear Colleague Assisting In the Presentation of I.R. & R. Section Resolutions:

The ABA Annual Meeting is just two weeks away. This is an urgent plea for your immediate assistance to help us ensure successful adoption of the four I.R. & R. Section-sponsored resolutions.\* / We have taken the liberty of assigning you to one of four "Task Forces" established to take charge of lobbying the House of Delegates on one of our recommendations (see attached list). Enclosed is the recommendation to which you have been assigned. The following is our five-part strategy and the specific help we need from you in executing each part.

Preliminarily, you should know that the following steps are already underway:

## "Honcho Letter"

A separate letter to the entire House of Delegates supporting each recommendation is being sent in the next week, signed by section leaders and/or famous influential lawyers specializing in the subject addressed.

## Letter to I.R. & R. Section Members in the House of Delegates

The enclosed letter and a packet of all four recommendations and reports is being sent to all I.R. & R. Section members in the House of Delegates urging their support and that they organize their state delegations, and speak in favor of our four resolutions on the floor of the House of Delegates.

9:30 - 11:30 a.m. Youth Alcohol and Drug Problems

12:00 - 2:00 p.m. Human Rights/Torture

2:00 - 4:00 p.m. Gay Rights

4:00 - 6:00 p.m. Free Flow of Information

Follow-up strategy meetings will be scheduled as needed.

Attendance at this meeting is critical. Assignments will be made so that we have task force coverage at all key ABA entity council meetings, state caucus meetings, social functions, etc. Detailed strategy for the entire annual meeting will be discussed at this meeting in addition to delegating specific assignments.

4. Attendance at State Delegation Meetings, Council and Section Meetings, Receptions, Etc.

Each Task Force member will be assigned to cover certain events at the Annual Meeting, including attendance at such events as the following:

1. State delegation meetings
2. Section and Division Council meetings
3. General meetings
4. Luncheons, dinners, receptions, cocktail parties and other social events
5. Presidential showcases and general programs on subjects relevant to the resolutions

Individual assignments for the section and division meetings will be discussed during the conference call on June 21st and in other communications prior to the July 4th meeting. All other assignments will be given out at the July 4th meeting.

5. Lobbying on the House Floor July 9th and 10th

During the House of Delegates meeting on July 9th and 10th, we need you to be present to "buttonhole" individual House members, answer their questions, persuade them to support the resolutions, etc. You'll also be asked to help prepare and distribute "talking points" and other supplemental material. This information will benefit those Delegates who have questions regarding a particular point raised by the resolution. We need your help to assist members of the House who will be speaking on behalf of a particular resolution and may need last minute consultations regarding a particular issue.

It is only through such a well-organized and comprehensive strategy over the next two weeks and throughout the week of the Annual Meeting that these recommendations, that have been the product of months of careful drafting and negotiating, will gain passage. We need your support and cooperation. We or I.R. & R. Staff Director Steven G. Raikin will be in touch with you shortly regarding these assignments.

## Section of Individual Rights and Responsibilities

### Summary of Four Recommendations

1. Youth Alcohol and Drug Problems (#112A). This recommendation has already been personally transmitted to you under separate cover by ABA President John C. Shepherd. Reflecting the work of our Section's Advisory Commission on Youth Alcohol and Drug Problems, this resolution calls for the implementation of a comprehensive national strategy, including prevention, treatment, education, law reforms and new methods for raising the necessary fiscal resources attendant to such policies.

2. Human Rights/Torture Legislation (#111D). (Co-sponsored with the Standing Committee on World Order Under Law). This recommendation calls for support for federal legislation which would establish a federal right of action by both aliens and U.S. citizens against persons who, under color of foreign law, engage in acts of torture, extrajudicial killing or prolonged arbitrary detention as well as an amendment to the immigration laws to allow the deportation from the U.S. of any alien who, in his or her official capacity, took part in the torture of another person under color of foreign law.

3. Free Flow of Information and Ideas Across the American Border (#112B). This recommendation states that U.S. policy concerning the free flow of information and ideas across the American border should be guided by two principles: 1) An alien should not be denied a visa or excluded from admission into the U.S. because of any past, current, or expected speech, activity, belief, affiliation or membership which, if held or conducted within the U.S., would be protected by the First Amendment to the Constitution; and 2) The right of Americans to travel abroad should not be restricted because of any past, current, or expected speech, activity, belief, affiliation, or membership which, if held or conducted within the U.S., would be protected by the First Amendment.

4. Non-Discrimination on the Basis of Sexual Orientation. (#10A) (Co-Sponsored with the Association of the Bar of the City of New York and the ABA Young Lawyers Division). This recommendation urges the federal, state and local governments to adopt legislation prohibiting discrimination in employment, housing and public accommodations on the basis of sexual orientation.
