SUBJ: PUBLIC REACTION TO PARIS CLUB MEETING

1. ON MARCH 24, ZYCIE WARSZAWY CARRIED A POLISH PRESS AGENCY (PAP) RELEASE AUTHORED BY PAP'S PARIS CORRESPONDENT HEADLINED: "INCONSISTENCY IN POSITION OF PARIS CLUB TOWARDS POLAND; RISKY DECISION OF CREDITOR COUNTRIES." AN INFORMAL TRANSLATION FOLLOWS.
2. A MEETING OF THE PARIS CLUB SENT A LETTER TO POLISH FINANCIAL OFFICIALS STATING ITS OFFICIAL POSITION THAT THE CREDITOR COUNTRIES CONFIRMS THEIR JANUARY 14 DECISION TO SUSPEND NEGOTIATIONS WITH POLAND ON THE RESCHEDULING OF DEBT PAYMENTS DUE DURING 1982. AT THE SAME TIME, THE LETTER EXPRESSED THE HOPE THAT POLAND WILL BE ABLE TO MEET ITS PAYMENT OBLIGATIONS. POLISH FINANCIAL AND ECONOMIC CIRCLES MUST EVALUATE THIS DECISION AS A VERY IMPORTANT ONE. WESTERN COUNTRIES HAVE TAKEN A GREAT RISK, ACCEPTING THAT THERE IS NO SOCIAL-POLITICAL AND ECONOMIC PROGRESS IN POLAND AND EXTENDING THEIR DECISION WHICH AUTOMATICALLY MEANS THE DENIAL OF NEW CREDITS FOR SUPPLIES OF MATERIALS AND COMPONENTS FOR PRODUCTION.
3. IT IS POSSIBLE TO DEMONSTRATE THE INCONSISTENCY IN THE PARIS CLUBS POSITION. THE CREDITORS REALIZE THAT POLAND CANNOT MEET IS PAYMENT OBLIGATIONS IF IT CANNOT EXPORT. IN TURN, THESE EXPORTS DEPEND, TO A GREAT EXTENT ON IMPORTED COMPONENTS FOR WHICH CREDITS

[Redacted] 25x1 The use of Western components is quite likely the result of a scarcity of these items in Socialist inventories. These policies provide indications of the effectiveness of Western embargoes against the Warsaw Pact and their reliance upon non-Socialist sources of technology. This is probably especially true in the R & D phase where a variety of components may not be available through the rigidly controlled Socialist economies.

(S) The lack of sufficient hard currency in East Germany is partially an outgrowth of the Polish economic crisis. This situation last year forced the East Germans to buy additional goods from the West in order to make up for interruptions in Polish deliveries. These purchases have added to East Germany's hard currency debt, now estimated at \$21 billion, the second largest in Eastern Europe. (Revw 23 Mar 12)
