1 FEB 85. THE QUARTER HOUSES GERMAN PERSONNEL WHO WORK
AT THE AIR BASE, APPROX 6 KM FROM THE TOWN ITSELF.
THE BOMBS, PLANTED UNDER OR NEAR PARKED CARS, DID
SUBSTANTIAL DAMAGE TO MANY OF THE HOUSES, AND CAUSED
AT LEAST ONE INJURY. ALTHOUGH NO GROUP HAS YET CLAIMED
RESPONSIBILITY, [REDACTED] 25x1 THE
WORK OF THE PORTUGUESE TERRORIST GROUP FP-25.

TEXT: (U) AT APPROXIMATELY 0150Z HRS ON 1 FEB 85,
THE GERMAN QUARTER ("BARRIO ALEMAO") IN THE TOWN OF
BEJA (38 01 N, 7 52 W:NIS GAZETTEER) WAS ROCKED BY
BOMB BLASTS. EIGHTEEN CARS, ALL BELONGING TO GERMAN
AIR FORCE PERSONNEL WHO WORK AT THE AIR BASE, WERE
SEVERELY DAMAGED. EIGHT SEPARATE BOMBS WERE APPARENTLY
PLANTED UNDER OR NEAR THE AUTOMOBILES WHICH WERE PARKED
IN FRONT OF THE HOUSES. THE GERMAN AIR FORCE COMMANDER
HEARD THE FIRST BOMB AT 0150Z AND SAID THE BOMBS CON-

2. ON JANUARY 30 THE RSO WAS CONTACTED BY BKA (BUNDES-KRIMINALAMT). THEY INFORMED US OF A REPORT THAT A GROUP OF 10 TO 12 SHIITES HAD STAYED OR IS STILL STAYING ON THE ISLAND OF MALTA. IT IS REPORTED THAT THIS GROUP CAME FROM IRAN AND LEBANON WITH LEBANESE PASSPORTS AND THAT THEY PLANNED A SUICIDE ATTACK AGAINST A U.S. INSTALLATION IN EUROPE.

3. WE WERE INFORMED THAT THE INFORMATION ORIGINATED WITH THE AMEMBASSY IN VALLETTA AND WAS PASSED THROUGH THE GERMAN EMBASSY IN MALTA. THE RSO OFFICE THEN CONTACTED THE POST SECURITY OFFICER IN MALTA AND WAS TOLD THAT IT HAD BEEN INFORMED APPROXIMATELY 10 DAYS AGO

THAT A GROUP OF IRANIANS AND LEBANESE ARRIVING IN MALTA FROM LIBYA HAD BEEN ASSESSING THE AMERICAN EMBASSY IN VALLETTA FOR A POSSIBLE ATTACK. TWO MEMBERS OF THIS GROUP SUBSEQUENTLY WENT TO BRUSSELS FOR UNKNOWN REASONS.
