1. SUMMARY: ALTHOUGH MOST JUNE 20 GREEK CYPRIOT NEWSPAPERS GAVE MAJOR COVERAGE TO THE GREEK GOVERNMENT'S RESPONSE TO THE U.S. TRAVEL ADVISORY ON TRAVEL VIA ATHENS AIRPORT, THE AKEL-GOC CONTROVERSY OVER THE USE OF LARNACA AIRPORT BY AMERICAN FORCES CONTINUED TO RECEIVE ATTENTION. END SUMMARY.
2. THE GOC SPOKESMAN REITERATED JUNE 19 THAT THE U.S. IS NOT ALLOWED TO USE LARNACA AIRPORT FOR MILITARY PURPOSES, BUT FOR HUMANITARIAN REASONS AND TRANSPORT OF MAIL. HE ALSO SAID THAT THE HOUSE OF REPRESENTATIVES HAD BEEN NOTIFIED ABOUT THE U.S. USE OF LARNACA AIRPORT IN THE PAST AND WILL BE CONSULTED AGAIN ON THE CURRENT SITUATION.
3. ON JUNE 20, COMMUNIST "HARAVGHI" STATED "THAT THE CYPRUS GOVERNMENT STILL REMAINS SILENT ON WHETHER THE

SITUATION: HIJACK

MESSAGE / ANNOTATION:

AMERICANS ARE USING THE FACILITIES AT LARNACA AIRPORT." ACCORDING TO AKEL'S CENTRAL COMMITTEE, CYPRUS, A NONALIGNED COUNTRY, IS NOW BEING USED BY THE U.S. ARMED FORCES AS A BASE AND TRANSIT STATION FOR NEW INTERVENTIONS IN NEIGHBORING LEBANON. AKEL DEMANDED THAT ALL "FACILITIES" GIVEN TO NATO COUNTRIES TWO YEARS AGO (DURING THE MULTINATIONAL FORCE OPERATIONS IN LEBANON) SHOULD BE ABOLISHED, ALL FOREIGN TROOPS SHOULD LEAVE AND THEIR BASES BE EXPROPRIATED. ACCORDING TO MOSCOW-LINE COMMUNIST AKEL, "CYPRUS IS FOR THE CYPRIOTS!"

4. ON JUNE 20 CENTRIST "AGON" EXPRESSED ITS FEAR THAT PRESIDENT REAGAN, AFTER VERBALLY ATTACKING AND THREATENING GREECE, MIGHT RESORT TO VIOLENCE IF CYPRUS DID NOT LET THE U.S. USE THE AIRPORT FACILITIES IN LARNACA. THEREFORE, "AGON" SAID, "THE ATTITUDE OF THE CYPRUS GOVERNMENT HAS BEEN WISE IN ITS DECISION TO PROVIDE THE U.S. WITH FACILITIES AT LARNACA AIRPORT."

5. LOCAL REACTION TO PRESIDENT REAGAN'S STATEMENT ON ATHENS AIRPORT: CENTRIST "AGON" CALLED PRESIDENT REAGAN'S COMMENTS "UNACCEPTABLE, INCONCEIVABLE, AND PROVOCATIVE. . . . THE UNITED STATES IS SEEKING TO PUT RESPONSIBILITIES WHERE THEY DO NOT EXIST. IT SEARCHES FOR EXCUSES TO HARM GREECE, BECAUSE IT WANTS TO PUNISH PAPANDREOU." RIGHTIST "SIMERINI" AGREED THAT PRESIDENT REAGAN'S STATEMENTS ABOUT GREECE WERE "WRONG, UNFAIR, AND VINDICTIVE."
