AND THE "REJECTION OF THIS ACT CONTRARY TO THE MOST ELEMENTARY NORMS OF CIVILIZED COEXISTENCE." FOREIGN MINISTER TERAN SENT SEPARATE MESSAGES TO UNITED NATIONS SECRETARY GENERAL XAVIER PEREZ DE CUELLAR AND LEBANESE FOREIGN MINISTER ELIE SALEM. IN HIS MESSAGE TO THE UNITED NATIONS SECRETARY GENERAL, TERAN EXPRESSED THE ECUADOREAN GOVERNMENT'S "REPUDIATION OF THESE ACTS WHICH THREATEN THE LIVES OF INNOCENT PERSONS, PLACE IN SERIOUS DANGER PEACEFUL COEXISTENCE AND SECURITY BETWEEN NATIONS AND CONSTITUTE A FLAGRANT VIOLATION OF INTERNATIONAL CONVENTIONS ADOPTED BY THE UNITED NATIONS." AFTER EXPRESSING THE GOE'S "PROFOUND PREOCCUPATION AND ENERGETIC CONDEMNATION" OF THE HIJACKING, TERAN EXPRESSED HIS CONFIDENCE THAT THE SECGEN WOULD UNDERTAKE THE "STRONGEST EFFORTS" TO PROTECT THE HUMAN RIGHTS WHICH HAD BEEN VIOLATED IN THIS CASE. IN HIS MESSAGE TO THE LEBANESE FOREIGN MINISTER, TERAN EXPRESSED HIS CONCERN FOR THE FATE OF THE HOSTAGES AND REITERATED ECUADOR'S TRADITIONAL RESPECT FOR HUMAN RIGHTS. HE THEN TOLD OF ECUADOR'S "CONVICTION OF THE NECESSITY OF TAKING MEASURES IN THIS CASE FOR THE SAFEGUARDING OF THE HUMAN RIGHTS OF THE PERSONS HELD AS HOSTAGES AND FOR FACILITATING THEIR RAPID RELEASE."
