DUTIES AND RESPONSIBILITIES OF INDIVIDUALS INVOLVED IN THE CONFIRMATION OF JUDGE SANDRA O'CONNOR TO BE ASSOCIATE JUSTICE OF THE UNITED STATES SUPREME COURT

- I. Max Friedersdorf, Assistant to the President for Legislative Affairs, has supervisory responsibility within the Executive Branch for planning and executing a strategy in the Senate leading to the prompt confirmation of Judge O'Connor.
- II. Powell Moore, Deputy Assistant to the President for Legislative Affairs (Senate), will coordinate confirmation strategy on a day-to-day basis.
- III. Bob McConnell, Assistant Attorney General for Legislative Affairs, will coordinate the research in preparation for the confirmation hearings, provide primary assistance in connection with the preparation of an opening statement for the hearing and prepare the nominee for questioning by members of the Senate Judiciary Committee. He will carry out this function under the supervision and guidance of the Attorney General and Fred Fielding, Counsel to the President. McConnell will also be the nominee's primary source of staff support in connection with complying with financial and conflict of interest requirements of the committee.
- IV. Pete Roussel, Deputy Press Secretary, will be the point of contact for the media in connection with this confirmation effort. He will coordinate public comment by the White House Press Office at the daily briefing and by the Justice Department's Public Information Office. No public comment will be made without coordinating with him and prior clearance on public comments should be obtained from Friedersdorf and/or Moore. This aspect of the confirmation process is particularly crucial, realizing that that historically, the media has had a major role in untracking previous nominees. Far more investigative resources will be applied to the nominee's background by the media than by the Justice Department, the White House, and the Senate Judiciary Committee combined.

The current situation in the Senate does not make it necessary to wage a major campaign to generate public support for the nomination. However, the White House political staff, communications staff, public liaison staff, and intergovernmental relations staff should remain abreast of developments relating to the confirmation procedures in the event the situation changes. These offices should also be sensitive to information received from their contacts, realizing such information could provide early warning of changing attitutes in the Senate.

STROM THURMOND, Republican, of Aiken, S.C.; President pro tempore; chairman, Judiciary Committee; senior Republican: Armed Services and Veterans' Affairs Committees; attorney and farmer; born December 5, 1902, in Edgefield, S.C., son of John William and Eleanor Gertrude (Strom) Thurmond; married Jean Crouch of Elko, S.C., November 7, 1947 (dec. Jan. 6, 1960); married Nancy Moore of Aiken, S.C., December 22, 1968; four children: Nancy Moore, J. 
#### COMMENT:

Senator Strom Thurmond is Chairman of the Senate
Judiciary Committee and within two years of becoming
80 years old. The most important aspect of his life
is his relationship with his wife, who is some forty
years his junior, and his four pre-teenage children.
He is a former Circuit Court Judge in South Carolina,
a former Governor, and has been in the Senate since
1954. He ran as a Dixiecrat for President in 1948
and has been elected in South Carolina as an Independent
on a write-in, as a Democrat, and as a Republican. He
became a Republican in 1964 during the presidential
campaign of Senator Barry Goldwater.

He has been active on the Senate Judiciary Committee for a number of years and is a strong advocate on the conservative side of such issues before his committee



as the death penalty, abortion, busing and gun control. He is a reliable supporter of the Administration and will be cooperative in expediting consideration of your nomination, but believes that he should be open and objective until the record has been presented in hearings before his committee.



COMMENT:

Senator Charles McC. Mathias of Maryland has been in the Senate since 1968. He is considered to be one of the more liberal Republicans in the Senate. One reason Senator Strom Thurmond is Chairman of the Senate Judiciary Committee, when he could be Chairman of the Senate Armed Services Committee, is that Republican Conservatives are interested in precluding Mathias from running this important committee. He has been on the liberal side of such issues before the Judiciary Committee as busing and the Equal Rights Amendment. He has a strong interest in drug abuse and is Chairman of the Criminal Law Subcommittee. He is highly regarded for his integrity and affability and generally supports your nomination.



#### COMMENT:

Senator Paul Laxalt from Nevada is the President's closest personal friend in the Senate. As you undoubtedly know, he was the President's campaign chairman in 1976 and 1980, having developed a close personal friendship with him when both of them were Governors of western states. early career, he was a District Attorney in Ormsby County, Nevada. He has strong alliances with the conservative groups that have an interest in social issues before the Senate Judiciary Committee such as busing, abortion and the Equal Rights Amendment. His primary current interests are regulatory reform and pro-family legislation. He is Chairman of the Regulatory Reform Subcommittee of the Senate Judiciary Committee. Because of his unusually close relationship with the President, he is a de-facto member of the Senate Leadership. He is generally supportive of your nomination.


#### COMMENT:

Senator Orrin Hatch of Utah confides to close friends that his primary ambition is to someday serve as a member of the United States Supreme Court. His current interests include being reelected to his second term in Utah and providing effective leadership to the truculent Senate Committee on Labor and Human Resources. He finds himself in the unusual position of being Chairman of this committee during his first six-year term in the Senate. He is encountering substantial difficulties in leading the committee in the direction of his general political philosophy as this committee has tended to attract liberals and repell conservatives making it balanced against him.

He has been very active on social issues and has intorduced a pro-family bill, which, he says, you oppose. A primary interest of his, among the issues before the Labor and Human Resources Committee, is the funding of abortions, to which he is opposed.

As a member of the Separation of Powers Subcommittee of the Judiciary Committee, he voted to report Senator East's bill, which states that life begins at conception and precludes the lower Federal courts from considering challenges to anti-abortion legislation. However he has serious reservations about the constitutionality of such legislation and will hold hearings this fall in his Subcommittee on the Constitution on a constitutional amendment to ban abortions.

Senator Hatch has indicated that he intends to question you sternly and carefully when your confirmation hearings occur, but has indicated his intention to vote for you.



Dole; married Mary Elizabeth Hanford, member, Federal Trade Commission, December 6, 1975; one daughter, Robin; graduate of Russell public schools; attended University of Kansas, Lawrence; A.B., Washburn Municipal University, Topeka, 1952; LL.B., Washburn, 1952; enlisted U.S. Army, 1943; served 5½ years in World War II as 10th Mountain Division platoon leader in Italy; twice wounded and twice decorated for "heroic achievement"; discharged with rank of captain, 1948; at age 26, elected to Kansas Legislature, 1951–53; elected four terms as Russell County attorney, 1953–61; elected to U.S. House of Representatives, 1960; reelected 1962, 1964, and 1966; elected to U.S. Senate 1968; reelected 1974 and 1980; Republican candidate for Vice President of the United States, 1976; Republican National Committee chairman, 1971–73; adviser, U.S. delegation to United Nations Food and Agriculture Organization Conference, Rome, Italy, 1975; member, Congressional delegation to survey food crisis in India at request of President Johnson, 1966; Congressional delegation to study Arab refugee problem, Middle East, 1967; past president, Washburn Alumni Association and Kansas County Attorneys Association; past lieutenant governor, Kiwanis; chairman of Russell County Red Cross; member, county, State, and American Bar Associations, 4–H Fair Association, B.P.O.E., Massons, Isis Shrine, Chamber of Commerce, American Legion, Veterans of Foreign Wars, and Disabled American Veterans; National Board of Sponsors of the American Medical Center, Denver, Colo.; member of the board for National Society of Autistic Children; member, Advisory Committee of the National Association for Retarded Children; Advisory Council on Scouting for the Handicapped; Board of Directors, Rehabilitation International, U.S.A.; Advisory Committee, Kansas Kiwanis Foundation; Kansas Easter Seal Society.

COMMENT:

The primary interest in the Senate of Senator Robert Dole of Kansas is his service as Chairman of the Senate Finance Committee and as a senior member of the Senate Agriculture Committee, leaving him little time for attention to the Senate Judiciary Committee. He is known for his acid humor and his acerbic wit, and you should be prepared for it during your courtesy calls. He has a strong interest in issues relating to the handicapped stemming from his permanently disabling wounds during W.W. II. His wife, Elizabeth Hanford Dole, is Assistant to the President for Public Liaison and in this role will undoubtedly be providing us with some assistance during the confirmation process. There was speculation in the media that she would be appointed as the first woman to the Supreme Court.



#### COMMENT:

Senator Alan Simpson of Wyoming is an affable, well liked member of the Senate. He is a former state legislator and attorney, and has expressed public support for your nomination. His primary interest on the Senate Judiciary Committee is refugee and immigration policy and he is Chairman of a subcommittee dealing with this subject.

He is Chairman of the Senate Committee on Veterans Affairs, although it is highly unusual for someone to be chairman of a committee after only two years in the Senate. Senator Simpson also has an interest in nuclear power, stemming from his chairmanship of the Nuclear Regulation Subcommittee of the Senate Committee on Environment and Public Works.



#### COMMENT:

Senator John East of North Carolina is Senator Jesse Helms' closest ally in the Senate. His upset victory over incumbent Senator Robert Morgan of North Carolina last year is considered to be largely attributable to the support of Senator Helms, as well as the coattail strings of the President. He is also the closest ally on the Committee of the so-called "pro-life" groups. He is Chairman of the Separation of Powers Subcommittee of the Senate Judiciary Committee. After several days of highly publicized hearings, this subcommittee recently reported legislation that states that human life begins at conception and prohibits the lower Federal courts from considering challenges to anti-abortion legislation.

Senator East contracted polio in the early 1950's while serving as a Marine officer at Cherry Point, North Carolina, and is now confined to a wheelchair. When he was elected to the Senate, he was a professor of constitutional law at East Carolina University in Greenville; and he is regarded by some as a constitutional scholar.





COMMENT:

Senator Jeremiah Denton of Alabama was elected in an upset victory last fall. He was the ranking officer among our prisoners of war in North Vietnam and first received national attention when he spoke for the returning POWs after their aircraft flight from North Vietnam in 1973. He was the subject of a movie about his experience in North Vietnam, "When Hell Was In Session." When he returned from seven-and-a-half years in an enemy prison camp, he was appalled by the deterioration of America's moral values. This concern is reflected in his intense interest in such issues as youth morality, alcoholism, and the preservation of traditional family values.

He is Chairman of the Subcommittee on Security and Terrorism of the Senate Judiciary Committee and also serves with Senator Hatch on the Senate Labor and Human Resources Committee.
