STATEMENT

The President was pleased to receive the reports on yesterday's elections in the Republic of Korea. U.S. observers have been impressed by the enthusiasm of the Korean campaign and the remarkable voter turnout of 90%. This speaks clearly of the commitment of Koreans to the democratic process. The candidate of the Democratic Justice Party, Mr. Roh Tae Woo, appears to be the winner by a substantial margin, and the President will be sending his congratulations to Mr. Roh.

STATEMENT

The President, in correspondence on December 17, to Mr. Roh Tae Woo, President-elect of the Republic of Korea, congratulated Mr. Roh on the occasion of his election. The President noted that he had followed with great interest the election campaign in Korea, and that Americans, as friends and allies of Korea, are looking forward to the opportunity of working closely with the new government.

The President told Mr. Roh that he and his administration face formidable tasks: achieving national reconciliation, sustaining Korea's remarkable economic growth, maintaining, with the United States, an effective military deterrent against aggression, and hosting the Seoul Olympics. The President assured Mr. Roh of the United States' fullest support in each of these endeavors.

Commenting on the road to democracy, the President remarked on the impressive openness with which Mr. Roh and his opponents had presented ideas for the future to the Korean people during the election campaign. Mr. Roh's pledge to continue the democratization process was, the President said, a key element in his victory. The President continued that Mr. Roh's willingness to work positively with the political opposition, which he had emphasized in his first statement after the election, could also make a major contribution to his administration's success.

The President also extended the good wishes and holiday greetings of Mrs. Reagan and himself to President-elect Roh and his family.
