JIM

General Kuo, this is Jim Kelly.

I wanted just to give a call to you because from AIT a copy of a letter was sent over that you had referred to them, dated 24 August, to yourself from Retired Lt.Gen. Richard Schweitzer. I was concerned when I saw this letter and I wanted to call you to say I had not foreseen that letter previously and I hope there is no misrepresentation of that letter. I wanted to inform you and I do so seriously that Lt.Gen. Schweitzer does not represent this government and any propositions that come to you are solely his own and his firm's. I am not sure in that letter what he represented to you but I think you did the appropriate and correct thing to refer the letter to AIT.

I also wanted to say, as a separate matter, I had discussed this with Sigur and Armitage and we mentioned the pending decision on the Frigate, which is in my opinion that the atmosphere is improved although the decision has not been made.

GENERAL KUO --

JIM. Well, I think your referral to AIT was exactly correct. I was surprised and did not like the tone of that letter, not so much of what it said but what it seemed to suggest. It seemed to suggest a quasi-official status and that is not so.
