BACKGROUND: LUNCHEON WITH CULTURAL FIGURES AT HOUSE OF WRITERS
DAY 7, TUESDAY, MAY 31

- Your luncheon and visit to the House of Writers (the headquarters of the USSR Writers Union) will enable you to meet many of the leading Soviet figures in literature and the arts.
- In your prepared remarks and informal comments, you will emphasize the importance of creative freedom. You will relate the guests to a long tradition of artistic excellence, but you will also mention some of the great talents whom Soviet censorship forced to leave the country. You should also express satisfaction that today's climate of "new thinking" has permitted much greater creative latitude to Soviet writers and artists.
- You will be greeted first by Vladimir Karpov, Head of the USSR Writers Union and the official host at the House of Writers.
- A number of the writers and artists at this luncheon will also attend the reciprocal dinner at Spaso House later in the day.
- Among the most interesting guests at today's luncheon are the following personalities:
 - Bulat Okudzhava: The USSR's most famous balladeer and poet. Okudzhava's critical songs and recordings used to circulate underground, but he has become more accepted in recent years.
 - Vladimir Lakshin: Literary critic who defended Solzhenitsyn and fought for official publication of Bulgakov's works.
 - Sergei Zalygin: Chief Editor of monthly literary journal Novy Mir (New World). A leader in the Soviet environmental protection movement.
 - Anatoliy Anan'yev: Editor of journal Oktyabr; published Grossman's epic novel "Life and Fate," which had been suppressed for more than two decades, and works by Anna Akhmatova and Anatoliy Rybakov.
 - Sergei Solov'yev: Young filmmaker; promoter of avant-garde film "Assa" which deals in part with previously-taboo subjects of rock music and drugs in Soviet society.
 - Gennady Rozhdestvenskiy: Conductor of Ministry of Culture Orchestra; frequent visitor to U.S.; will also attend evening reciprocal dinner.

- Al'fred Schnitke: Composer known for his unconventional works; will also attend reciprocal dinner at Spaso House.
- Valentin Rasputin: Siberian writer and Russophile. Also concerned about the environment, especially the pollution of Lake Baikal.
- Chinghiz Aitmatov: Kirghiz writer, author of "Plakha," a novel about religion and environmental issues.
- Yevgeniy Pasternak: Writer and son of Boris Paternak; his biography of his father will soon appear in journal Novy Mir.
- Viktor Yerofeyev: Writer and member of the Metropole group of underground writers. Recently re-elected to Writers Union.
- Roy Medvedev: Nonconformist historian; author of various analytical pieces about the Stalin era, including "Let History Judge" (published in English translation in the United States).
- N.P. Shmelev: Economist: advocate of capitalist-style reforms.
- Mark Rozovskiy: Playwright. His "Father and Son" was performed at La Mama Theater in New York.

BACKGROUND: RECIPROCAL DINNER, SPASO HOUSE
DAY 7, TUESDAY, MAY 31

- You and Mrs. Reagan will host a reciprocal dinner for the Soviet leadership in the ballroom of Spaso House.
- Unlike the affair at the Kremlin the previous evening, your reciprocal dinner will include not only the top Party and government officials. The guest list for Spaso House includes writers, artists, musicians, and even sports figures.
- Several of the guests have been critical of the USSR's official policies over the years, and one, Nobel Peace Prize winner Andrei Sakharov, is still the most famous and respected Soviet political dissident. A year and a half ago, Dr. Sakharov was finally permitted to return to Moscow from exile in Gorky, and has become a sort of semi-accepted dissenting voice. He recently issued a sharp protest, however, about the authorities' treatment of Armenians and Crimean Tatars who had participated in peaceful demonstrations.
- Other Soviet guests of special interest are the following:
 - Abel Aganbegyan: architect of economic reform; advocate of selected market economy measures.
 - Fyodor Burlatsky: prominent liberal who has advocated pluralistic reforms; heads the "public" Soviet human rights commission.
 - Yury Grigorovich: Director, Bolshoi Ballet
 - Yelim Klimov: First Secretary of the USSR Cinematographers' Union; has arranged the distribution of U.S. films in the Soviet Union, including a number of your films.
 - Vitaly Korotich: Editor of liberal journal "Ogonyok"; did a written interview with you several weeks ago.
 - Dmitriy Likhachev: an Academician and Chairman of the Cultural Fund; a survivor of Stalin's camps, he is, at 82, his country's most distinguished scholar in the Humanities and one of its most respected citizens.
 - Anatoly Rybakov: a former persecuted writer, author of "Children of the Arbat," a devastating novel about anti-Semitism in the Stalin era.
 - Vladislav Tret'yak: Now a coach, he was the goalie on several Soviet Olympic gold-medal teams; considered one of the greatest players of the century.

-- Yegor Yakovlev: Editor of liberal newspaper "Moscow News"; on the cutting edge of glasnost, "Moscow News" has published critical articles on previously-taboo subjects.
