SUBJECT: Call on the President by Canadian Conservative
Leader Mulroney

We strongly recommend that the President receive, for no more than 15 minutes, Canada's new Conservative Leader and probable next Prime Minister, Brian Mulroney. Since being elected Opposition Leader earlier this year, Mulroney has consolidated his political position and now leads Prime Minister Trudeau's Liberals by more than 2 to 1 (56% to 27%) according to recent polls. Mulroney has been outspoken in his support of the US and of the President, whom he has publicly called Canada's "greatest friend." Concerning the Grenada rescue operation, he chided the Trudeau Government for not giving the US "the benefit of the doubt."

Since the President met with Trudeau on December 15, we recommend a brief White House meeting and photo opportunity for Mulroney as early as possible to avoid any appearance of US favoritism in the general election campaign that will take place sometime in 1984.

Subject: Presidential Meetings with Foreign Leaders,
January-June, 1984

In a memorandum dated December 10, 1983, the NSC requested the Department of State's recommendations for additional Presidential meetings with foreign leaders during the first half of 1984. We have divided visits into three categories: State/Official visits; working visits; and office calls. Our recommendations for State/Official visits, in priority order, are as follows:

President Shagari of Nigeria
President Jorge Blanco of the Dominican Republic
President Jayewardene of Sri Lanka

We note that, in a memo dated August 11, the NSC had already approved a State visit for President Shagari during the first half of 1984.

Our recommendations for additional working visits, in priority order, are as follows:

Chancellor Kohl of West Germany
President Suazo of Honduras
Prime Minister Prem of Thailand
Crown Prince and Prime Minister Sa'ad al-Sabah
of Kuwait
President Masire of Botswana

Our recommendations for office calls are as follows:

Dutch Prime Minister Lubbers, January 19-20
Canadian Leader of the Opposition Mulroney
Italian Foreign Minister Andreotti, January 10-13
British Leader of the Opposition Kinnock
former French Prime Minister Barre

Unlike State/Official visits and working visits, the "office calls" category is not limited to heads of State and heads of Government. It also includes visits by foreigners who are in this country on private business, or are en route to another desination. It is, thus, difficult for us to predict much in advance when these "targets of opportunity" will occur. We realize that the White House is under very heavy scheduling pressure; and we will, therefore, try to provide as much advanced warning of requests in this category as is possible.

SUBJECT: Visits -- Official and Other

We have received two formal and one verbal request from State for appointments/meeting with the President in January. The three, all of which have merit, are: Dutch Prime Minister Lubbers, French opposition leader Barre, and (by telephone) Italian Foreign Minister Andreotti. We expect State to formalize the Andreotti request this week.

As Ty noted last week, we have suggested that State consolidate these new requests into its overall list for the first half of 1984 that you previously requested. However, State seems to feel that these "office calls" or short meetings fall outside of the purview of that directive.

Since we don't want these visitors to fall prey to bureaucratic bungling (they, particularly Andreotti and Lubbers, deserve appointments) we need to establish guidelines quickly for the submission of requests that do not fall under the rubric of "State" or "Official Working" visits.

RECOMMENDATION:

That you sign the memorandum at Tab I to Hill, making it clear that State should incorporate these sorts of visits into its list for the first half of 1984.

Subject: Appointment Request for the President:
Raymond Barre, Former Prime Minister of France

The Department recommends that the President meet with Raymond Barre, former Prime Minister of France and current prominent opposition figure, during Barre's visit to the United States, January 9-13, 1984. Such a meeting would be consistent with the Administration's policy of meeting with major opposition figures of allied countries. The President has already seen the other two prominent members of the French opposition, Paris Mayor Jacques Chirac and former President Valery Giscard d'Estaing.

Ambassador Galbraith has strongly recommended the President receive Barre, considering him to be a lively and important interlocutor. Barre is currently France's most rapidly rising opposition figure and in the last month has become a serious contender for the Presidency. The Department feels that the President would find a meeting with Barre to be both interesting and informative.

Barre will travel first to New York to speak before the Council on Foreign Relations. He plans to spend the latter part of the week in Washington meeting with Secretaries Shultz, Weinberger and Regan. He would prefer to schedule his Washington appointments for January 11, 12, and 13, but would adjust his schedule so as to be available for a meeting with the President any time the week of January 9-13.

SUBJECT: Extraterritoriality in U.S.-Canadian Relations

The attached memorandum to Bud summarizes a State memo to the President on emerging problems relating to extraterritoriality (ET), particularly with respect to agency jurisdiction over questions on ET and poor interagency coordination.

Along the same line, the NSC, too, should eliminate the practice of handling ET matters in a loosely-coordinated fashion. Currently, although these issues are primarily legal and economic, they are generally referred to the regional office of the country affected, rather than to a particular individual responsible for ET. You might wish to give some consideration to designating an NSC staffer as the responsible individual for ET issues at the NSC.

RECOMMENDATION:

That you designate an NSC staffer to be the primary point of contact on questions of extraterritoriality and forward the memo to Bud.

The Canadian and U.S. economies are linked more closely than are most pairs of states within the U.S. Americans own about 45 percent of Canadian industry, and dominate such Canadian industries as automobiles, chemicals, rubber, oil and gas, electric appliances, and electronics. Canadian trade with the U.S. last year was almost a quarter of Canada's GNP.

Canadians, therefore, are sensitive to American influence over the Canadian economy. They are especially disturbed when they think the U.S. Government controls American properties in Canada in accordance with American interests, policies, and laws, whether these are consistent with or contrary to the interests, policies, and laws of Canada.

Similar concerns have been expressed in the United States about foreign governments controlling American economic activities, and thereby gaining an ability to contravene our policies. The U.S. Government has, for example, recently prevented an American company owned by the Kuwait Government from expanding its control of U.S. natural resources. For us the problem so far has been mostly hypothetical: "What if" France were to direct AMC (51 percent owned by Renault, which is owned by the French Government) not to ship jeeps to El Salvador? It should be noted, however, that Canadian direct investment here is about \$10 billion, and total foreign direct investment is \$102 billion. Thus, we have a substantial stake in not having done unto us what the Canadians would not have done unto them -- that is, an interest in not having domestic economic activities controlled by the interests, policies, or laws of a foreign country -- extraterritoriality or ET, for short.

My recent consultations with Canadian Foreign Minister MacEachen, your recent letter from Prime Minister Trudeau, and continuing representations by the Canadian Ambassador to

several officials of the Department of State and other departments all emphasize the danger of seriously adverse effects of ET, or what is perceived in Canada as ET, on our economic relations with Canada (which are by far our most extensive economic relations with any country) and -- perhaps even more ominous -- on our political relations with Canada (which are at least as important as our political relations with any country).

Friction from ET is serious with other countries too, notably the United Kingdom, other members of the European Economic Community, Japan, Switzerland, and Australia -- most of our major trading partners and political allies. Furthermore, the complaints are by no means one-way; we have serious complaints ourselves, in particular against Canada and the EC. ET issues could become a bigger threat to our economic and political interests than are the issues of international trade, investment, and exchange rates.

Current ET disputes relate to the enforcement of export controls, restrictions on foreign subsidiaries and licensees, taxes based partly on foreign earnings, applications of antitrust laws, and subpoenas for documents located abroad. These issues will become more serious, and others will appear, as the world economy becomes more interdependent. The prospect that a foreign government will interfere with some activity that the host government approves is beginning to result in barriers against investment, including acquisitions and mergers, and is stimulating searches for alternative sources of the products and technologies of countries judged likely to invoke ET, especially the U.S. Just as with trade, interference in the market by one government leads to a spiral of uneconomic interference in markets by other governments.

In a world where transactions often involve parties in several nations, where corporations and individuals can frustrate important national regulations and laws by transferring assets, data and documents across oceans with a telephone call or the push of a computer button, rigid territorial limits to jurisdiction are unworkable. The increasing complexity of international life is leading countries into actions with extraterritorial effects, although as yet others are far short of U.S. practice. The variety of issues under the rubric of "extraterritoriality" or "ET", their complexity and their importance to the national interest preclude any simple across-the-board solution. Nevertheless, we cannot, without paying a heavy and growing price, ignore or defy the increasingly-united opinion of important friendly nations.

This view is shared by a number of senior officials of your Administration. Some agencies have established policies of restraint and consultation, and use cooperative channels. However, assertions of jurisdiction over persons, activities, or documents in other countries can be initiated by so many different government officers at various levels, some of whom are independent of the Executive Branch, that it is difficult to manage and coordinate United States policy and practice. Nevertheless, I believe the effort must be made.

Interagency coordination and international consultations have begun on some of these problems. We would like to encourage other agencies to consult with the State Department when contemplating actions which may touch "extraterritoriality" sensitivities. We need to consider what other measures can be taken to avoid or minimize these problems. I believe that it would be useful to give these efforts impetus and direction through a Cabinet-level discussion with you in the near future.

It was with pleasure that I learned from your note of January 25 and the State of the Union address that the United States will welcome international cooperation in the development of its manned space station programme. I can assure you that Canada will give most serious consideration to this opportunity.

Indeed, I have been advised that space officials from our two countries have already had preliminary discussions concerning potential Canadian interest in the manned space station programme. My Cabinet colleague, the Honourable Donald Johnston, who is the responsible Minister, recently had an opportunity to discuss these questions informally with Mr. James Beggs. I understand that further discussions are scheduled to take place in the near future.

Canada is pleased with the results of its ongoing cooperation with NASA, and thus we look forward to exploring other avenues of cooperation for the future.

GANDER MOU

The GOC announced on February 28 plans to sign a long-term agreement with the Soviet Union which would expand the use of Gander for refueling Aeroflot flights en route to and from the Western Hemisphere. This agreement was negotiated some months ago but was set aside by the Canadians following the KAL shootdown. It will permit Aeroflot to increase its landings from 45 to approximately 350 a year.

Assistant Secretaries Burt and Motley have raised this issue with Ambassador Gotlieb. They indicated any action which facilitates Soviet mischief-making in Central America must be viewed as inconsistent with US foreign policy interests. This is true even if no specific evidence exists that the Soviets have used these flights in the past for carrying military supplies. Motley also noted the increased opportunities Gander stopovers give for surveillance of the US coastline.

In response, Ambassador Gotlieb made four points:

- past monitoring of Aeroflot cargo in Gander had revealed no weapons or munitions on the planes;
- the number of jobs created by this agreement would appreciably alleviate the high unemployment in Newfoundland;
- the GOC would gladly discuss with US details of the MOU and how we might avoid security risks;
- the GOC hoped we would not put this item on the agenda for your next meeting with MacEachen.

We are planning to take the GOC up on Gotlieb's offer of consultations on avoiding security risks. Meanwhile, our Embassy in Ottawa has also expressed our concerns to the Ministry of External Affairs.

Dear Mr. President:

It is my pleasure to report to you on the 167th meeting of the Permanent Joint Board on Defense Canada - U.S. held in Colorado Springs, Colorado, March 6-9. The meeting was particularly notable because it marked the first participation in the Board's activities of the new Canadian Co-chairman, the Honorable Bud Cullen, MP, and because members received exceptionally useful briefings at the Cheyenne Mountain Complex from Commander in Chief, North American Aerospace Defense Command, and members of his staff. NORAD stands as a dramatically successful example of peaceful cooperation and common resolve between Canada and the United States, objectives which the PJBD has been working to advance since 1940. Board Members also benefitted from briefings and the use of facilities at the U.S. Air Force Academy, one of the most inspiring institutions on American soil.

Our deliberations were wide ranging and generally successful in promoting cooperative approaches to common problems. For example, we again addressed the continuing need to secure more equitable treatment by Canadian federal and provincial authorities for U.S. non-diplomatic military personnel and their dependents stationed in Canada. While the Board's Canadian members have made significant progress in this area in recent months, we reminded our colleagues that problems remain and that we still require their active assistance. I was particularly gratified by the forthright statements of support by the new Canadian Chairman, who fully appreciates the urgency of resolving these issues.

Board members also reviewed the state of play of other current issues, including defense economic cooperation, [REDACTED]

[REDACTED] and Canada's request to renegotiate the long-term lease held by the U.S. Navy at Argentia, Newfoundland. I was encouraged to learn that both Canada's Secretary of State for External Affairs and its Minister of National Defence have recommended [REDACTED]

Unfortunately, there was one serious problem on our agenda on which I must report less positive results, namely the sharing of responsibilities for modernizing North American air defense. Although Canadian and U.S. officials reached an ad referendum agreement last September on how to proceed on this complex and costly program, subsequent escalation of projected costs for the proposed North Warning System to replace the obsolete Distant Early Warning System have altered the basis for that understanding. Both delegations agreed that our respective planners must continue their efforts to develop a new common approach in this important area. The obstacles to success, however, are formidable. ✓

A full report of our Colorado Springs deliberations is contained in the Journal of the 167th meeting of the Board, a copy of which is being sent to the National Security Council for Mr. McFarlane.

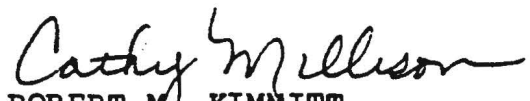
