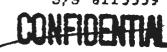

The Vice President's Meeting with Avital Shcharanskiy 6:30 p.m., May 19, Room 274 Old Executive Office Building

You are meeting with Mrs. Avital Shcharanskiy, wife of imprisoned Soviet dissident Anatoliy Shcharanskiy, at a time when her husband reportedly has been placed in isolation in his prison camp and has had visitor and letter-writing privileges removed. His health is also reported to be declining, although sources disagree as to the extent. Mrs. Shcharanskiy is convinced that Soviet authorities have decided to let her husband die in prison.

Secretary Haig met with Mrs. Shcharanskiy at the request of Senator Alfonse D' Amato (R - N.Y.), on Wednesday, May 13. In response to her request for a maximum USG effort to save her husband's life, Secretary Haig reassured Mrs. Shcharanskiy of continued USG concern and support for her husband. He indicated that the USG will pursue every appropriate opportunity to gain her husband's release, and agreed to issue a public statement on Shcharanskiy's behalf (Tab A). The statement, which was released on May 14, quoted the Senate resolution sponsored by Senator D'Amato and passed by the Senate May 12. It also stated that Secretary Haig agreed to give a copy of the Senate Resolution to Soviet Ambassador Dobrynin which he did May 15.

The Department of State has followed developments in Shcharanskiy's situation closely since his arrest in 1977. We repeatedly have made the Soviets aware of USG concern over Shcharanskiy's situation. Most recently, Ambassador Kampelman discussed the Shcharanskiy case at length in his April 10 speech to the Madrid CSCE Conference, and raised it again in a speech at the Conference on Tuesday, May 12. The case was also raised at a high level in diplomatic channels last fall. Background information on the Shcharanskiy case is attached (Tab B).

#### DEPARTMENT PRESS STATEMENT

Secretary Haig met with Mrs. Avital Shcharansky, wife of imprisoned Soviet dissident Anatoly Shcharansky, on May 13. Mrs. Shcharansky described to the Secretary the suffering of her husband under his harsh conditions of incarceration in the Soviet Union and expressed fears for his welfare.

Accompanying Mrs. Shcharansky were Senator Alfonse M. D'Amato of New York, Senator Arlen Spector of Pennsylvania, Mr. Jerry Goodman, Director of the National Conference on Soviet Jewry, and Mr. Gordon Zacks, President of the R.G. Barry Corporation of Pickerington, Ohio. The two Senators presented to Secretary Haig the resolution concerning Mr. Shcharansky which was adopted on the evening of May 12 by the United States Senate. That Resolution (S. RES. 131) reads as follows:

"WHEREAS, the final act of the Conference on Security and Cooperation in Europe commits its 35 signatories to respect human rights and fundamental freedoms;

"WHEREAS, the Soviet Union is signatory to this Act;

"WHEREAS, Mr. Shcharansky's health has now deteriorated to the point where his life is threatened, as a result of the actions of Soviet officials, and

"WHEREAS, humanitarian interests and the provisions of the final act require that Soviet authorities cease their continued incarceration and inhumane treatment of Mr. Shcharansky;

"NOW, THEREFORE, BE IT RESOLVED that it is the sense of the Senate that:

"Section I - Anatoly Shcharansky be released from prison and be given proper medical treatment and be permitted to emigrate to Israel,

"Section II - the Senate urges the President, the Secretary of State and the United States Delegation to the Current Madrid Conference on Security and Cooperation in Europe meeting to continue to express at every suitable opportunity and in the strongest terms the opposition of the United States to the imprisonment of Anatoly Shcharansky,

"Section III - The Secretary of the Senate shall transmit copies of this resolution to the Soviet Ambassador to the United States and to the Chairman of the Presidium of the Supreme Soviet of the Union of Soviet Socialist Republics."

The Secretary emphasized that he fully supported the views expressed in the Senate resolution. He undertook to present a copy of the resolution to Soviet Ambassador Dobrynin at the first opportunity and to request that it be transmitted to the Soviet leadership.

## CONF NOENTIAL

#### BACKGROUND ON SHCHARANSKIY CASE

Anatoliy Shcharanskiy was a prominent Jewish activist and one of the leading members of the Moscow group established 1976 to monitor Soviet compliance with the Helsinki Final Act. He was arrested in March 1977, when the Soviets began a major crackdown on dissidents. He was accused of treason, falsely charged with working for U.S. intelligence agencies. Tried in July 1978, he was sentenced to 13 years' imprisonment followed by five years' internal exile.

President Carter publicly denied the Soviet allegation that Shcharanskiy had any connection with the CIA, and the U.S. has several times spoken out on the Shcharanskiy case, both publicly and through diplomatic channels. Although Aleksandr Ginzburg, another prominent dissident who had been sentenced at the same time, was included in the April 1979 exchange of Soviet dissidents for two Soviet spies held in the U.S., the Soviets refused to exchange Shcharanskiy. Meanwhile, he remains a symbol of Soviet repression against both Soviet Jews and human rights activists.

Shcharanskiy's wife Avital, who lives in Israel, conducts an active public relations campaign on her husband's behalf. She has been received in the U.S. by high officials of the previous Administration, and also by Rosalynn Carter.

1. Meeting with Wife of Anatoliy Shcharanskiy. Mrs. Avital Shcharanskiy, wife of imprisoned Soviet dissident Anatoliy Shcharanskiy, called on me today to appeal for Administration efforts to obtain the release of her husband. She pointed out that he was convicted on false charges of spying for the U.S. European leaders with whom she had spoken, including Mrs. Thatcher, told her that only U.S. influence would be great enough to effect his release.

Senators D'Amato and Spector accompanied Mrs. Shcharanskiy and gave me a copy of last night's Senate resolution concerning her husband. The Department is announcing to the press that I have agreed to give Dobrynin a copy of the resolution for transmittal to the Soviet leadership. (C)

Senate Action on the Clark Amendment. The Senate Foreign Relations Committee today approved the repeal of the Clark Amendment which restricts our activities in Angola. But other restrictive language has been added. Any military or paramilitary operations in Angola will require a Presidential determination that it is in our national security interest. This determination must be accompanied by a statement giving the reasons for the determination and a description of the assistance and its recipients. Further, the President will have to take into account the effect of such assistance on other African nations and the prospects for an internationally acceptable Namibia settlement.

This is better than the Clark Amendment but still unduly restrictive. We will work to cut back these strictures on the floor. (U)

BUT THEY DID NOT KNOW OF THE DEPARTMENT'S MAY 14 ANNOUNCEMENT THAT THE SECRETARY WOULD DELIVER THE SENATE'S RESOLUTION ON SHCHARANSKIY TO SOVIET AMBASSADOR DOBRIVIN AT THEIR NEXT MEETING. EMBOFFS BRIEFED THEM ON THE CONTENTS OF THE SENATE RESOLUTION AND THE DEPARTMENT'S STATEMENT. AND THEY ASKED THAT THEIR APPRECIATION FOR THE SECRETARY'S PERSONAL INVOLVEMENT BE PASSED TO THE SECRETARY.

THEY INDICATED THEY HAD HEARD ABOUT A (NOTE: POSSIBLE MEETING BETWEEN VICE PRESIDENT BUSH AND AVITAL SHCHARANSKIY, BUT EMBOFFS WERE UNABLE TO PROVIDE CONFIRMATION THAT A MEETING HAD TAKEN PLACE.)

EMBOFFS ALSO ALERTED THE SHCHARANSKIY FAMILY TO A TASS ENGLISH PIECE BY YURI KORNILOV (ASSUME DEPARTMENT HAS TEXT) WHICH ATTACKED AVITAL SHCHARANSKIY AS WELL AS THE SECRETARY, FOR "HOB-NOBBING WITH A PATENT SWINDLER" AND ACTING IN A WAY THAT DOES "ADD TO THE PRESTIGE OF A U.S. SECRETARY OF MUCH OF THE ARTICLE, WHICH WE HAVE NOT YET SEEN IN THE SOVIET PRESS, IS DEVOTED TO STANDARD SOVIET ALLEGATIONS THAT MRS. SHCHARANSKIY IS NOT "OFFICIALLY" MARRIED TO SHCHARANSKIY, THAT SHE IS BEING "ACTIVELY USED BY ZIONIST CENTERS. AND ENGAGING IN A CAMPAIGN OF ANTI-SOVIET SLANDER.

58: THE FAMILY EXPRESSED GREAT FRUSTRATION ANXIETY ABOUT SHCHARANSKIY'S CONDITION. HAD JUST RETURNED FROM A MAY 4-5 TRIP TO PERM LABOR CAMP NUMBER 36 WHERE SHCHARANSKIY IS BEING ALTHOUGH THEY DID NOT GET TO SEE SHCHARANSKIY, THEY SPOKE WITH THE CAMP ADMINISTRATOR AND "FELD'SHER" (MEDICAL ORDERLY). THEY LEARNED THAT SHCHARANSKIY HAS BEEN IN THE INTERNAL PRISON IN THE CAMP SINCE JANUARY 13. WITH LONG PERIODS IN THE EVEN MORE HARSH PUNISHMENT CELLS. HE WAS ALLEGEDLY SENT TO THE PRISON "FOR REFUSING TO WORK. BUT THE CAMP OFFICIALS WOULD NOT EXPLAIN THE CIRCUM-STANCES. SHCHARANSKIY WAS DUE TO COME OUT OF THE INTERNAL PRISON ON JULY 13, BUT HIS SENTENCE HAS BEEN EXTENDED TO SEPTEMBER. ACCORDING TO HIS SISTER-IN-LAW, THIS MEANS HE WILL HAVE SPENT APPROXIMATELY THREE MONTHS IN A SOLITARY CONFINEMENT PUNISHMENT CELL.

Thus, this obviates the necessity of scheduling a meeting with Mendelevich so as to further manifest the Administration's strong position on Soviet Jewry.

## 'Next Year in Jerusalem'

In March and April, during interrogation, the chief investigators warned methat in the position i have taken during investigation, and held to here in court, I would be threatened with execution by firing squad, or at least 15 years. If I would agree to cooperate with the investigation for the purpose of destroying the Jewish emigration movement, they promised me early freedom and a quick reunion with my wife.

Five years ago, I submitted my application for exit to Israel. Now I'm further than ever from my dream. It would seem to be cause for regret. But it is absolutely otherwise. I am happy, I am happy that I lived honestly. In peace with my conscience, I never compromised my soul, even under the threat of death.

I am happy that I helped people. I am proud that I knew and worked with such honest, prave and courageous people as Sakharov. Criov. Ginzburg, who are carrying on the traditions of the Russian intelligentsia. I am fortunate to have been witness to the process of the liberation of Jews of the U.S.S.R.

I hope that the absurd accusation against me and the entire Jewish emigration movement will not hinder the liberation of my people. My near ones and friends know how I wanted to exchange activity in the emigration movement for a life with my wife. Avital, in Israel.

For more than 2,000 years the Jewish people, my people, have been dispersed. But wherever they are, wherever Jews are found, every year they have repeated. "Next year in Jerusalem." Now, when I am further than ever from my people, from Avital, facing many arduous years of imprisonment, I say, turning to my people, my Avital; Next year in Jerusalem.

Now. I turn to you, the court, who were required to confirm a predetermined sentence: to you I have nothing to say.

On June 15, 1970, Mendelevich was arrested at Leningrad's Smolnii Airport for the attempt to steal a plane to fly to Israel. Simultaneously, Soviet Jewish activists were apprehended in citites throughout the Soviet Union.

Mendelevich, who had studied engineering at the Riga Polytechnical Institute, admitted to having long been involved in the Jewish movement in the USSR. As an editor of Jewish <u>Samizdat</u> ("underground" publications), he was accused of publishing anti-Soviet articles, using as "evidence" articles on the significance of the Jewish holidays and on the anniversary of the Warsaw Ghetto Uprising.

After world-wide expressions of outrage, Mendelevich's original sentence of 15 years was reduced to 12 years in a strict regime labor camp.

An observant Jew, Mendelevich refuses to eat certain foods in his already bare, subsistence diet because they are not kosher, although he is forced to work long hours at hard labor.

In the Spring of 1977, he was accused of "maliciously violating the regime of confinement" - the main evidence being his refusal to work on Sabbath (though he worked extra hours on other days to make up the lost time) and his "violation of the form of camp dress", i.e. his insistence on wearing his "yarmulke". He was punished by being transferred to the notorious Vladimir prison and thereafter to the equally notorious Chistopol prison in Central Russia.

losif's father died in 1978 on the eve of departing for Israel. All losif's relatives are now in Israel and the camp authorities are refusing to permit a visit from his friends. Thus he has seen neither relatives nor friends for six years. Most of the letters sent from family and friends are confiscated and do not reach him.

In April 1980, after serving 3 years in prison, losif was returned to camp No.36 in the Perm region. Since the sudden release in April 1979 of his co-defendants, Mendelevich remains the only Jewish prisoner from this trial still in Soviet prison.

#### TOSIF MENDELEVICH

Born into a family close to Jewish tradition, losif Mendelevich studied Hebrew on his own as an adolescent and read whatever he could find on Jewish history and culture. He and his family were refused permission to emigrate to Israel three times between 1967 and 1970.

On June 15, 1970, Mendelevich was arrested at Leningrad's Smolnii Airport for the alleged attempt to steal a plane to Israel. Simultaneously, Soviet Jewish activists were apprehended in cities throughout the Soviet Union.

After world-wide expressions of outrage, Mendelevich's original sentence of 15 years was reduced to 12 years in a strict regime labor camp.

The release in April 1979 of seven prisoners serving heavy sentences imposed at the infamous Leningrad Trials, would have marked a triumph for morality and justice; yet it was marred by the cruel and unexplained retention of the last founding members of the group, losif Mendelevich, as well as the two non-Jewish members, Yuri Federov and Aleksei Murzhenko.

Although losif carried a lighter sentence than some of his comrades, his release was refused. Throughout the nine long years of his internment, losif has courageously persisted in the strict observance of his religious beliefs, despite the additional hardships and suffering this has brought upon him.

In the spring of 1977, he was accused under the Corrective Labor Code of "maliciously violating the regime of confinement" - the main evidence being his refusal to work on Sabbath (though he worked extra hours on other days to make up the lost time) and his "violation of the form of camp dress", i.e. his insistence on wearing his "yarmulke". He was punished by being transferred to the notorious Vladimir prison and thereafter to the equally notorious Chistopol prison in Central Russia where he is today.

Mendelevich refuses to eat any unkosher foods in his grossly inadequate daily diet, and he has lost considerable weight. During the eight days of Passover, he existed on nothing more than a few ounces of Unleavened Bread - the only ration he was permitted. According to Soviet Law, every prisoner is entitled to receive only two food parcels of 1 kilogram each per year, and this has made it impossible to provide Mendelevich with sufficient provisions for his sustenance.

losif, 32, suffers from hypertension, and his health is rapidly and dangerously deteriorating under the subhuman conditions in which he fights to exist. Throughout his painful struggle, Mendelevich has never complained, but in a desperate letter to his family in Israel, he expressed his fear and anguish at his increasingly failing health and overwhelming fatigue.

Mrs. Shcharanskiy refused to speak with me at any great length for she said the matters which she wished to discuss were too sensitive to be conveyed to too many people, and that she specifically wanted only your reactions. She also wanted to respond to those questions which you raised in her meeting with Vice President Bush. (C)

However, she did, after considerable prodding, tell me she was asked to speak on "Good Morning America" and heard that you might be appearing at the same time. She hinted that on "Good Morning America" she had some announcements and information to present which she thought would be wise to clear with you first. She did not know when she is scheduled to appear on the show. Furthermore, Mrs. Shcharanskiy wanted to discuss her husband's current condition (she received a call from the USSR last night) and her ideas on how he can be released. Timing was critical.

She asked if you could telephone her or even meet with her next week. However, you should be aware that a religious holiday will prevent her from answering the telephone from 8 o'clock tonight until 9 p.m. tomorrow. Moreover, she will be in New York on Sunday but is willing to come back to Washington to meet with you. (C)

It was hopeless. We also sent three letters and a telegram to the 26th Congress of the Communist Party. We received no response. Beginning March 6, 1981 we sent more than 150 letters to different organizations and well known individuals in the Soviet Union asking for support.

Today, we and our children are appealing to all people in all countries. Please, help us to reunite our families.

Visit of Eduard Lozansky, Elena Balovlenkov, Lois Becker Frolov, and Aloyzas Jurgutis, Spouses of Soviet Hunger Strikers, 11:00 a.m., May 27

#### I. SETTING AND OBJECTIVES

Eduard Lozansky, Elena Balovlenkov, Lois Becker Frolov, and Aloyzas Jurgutis, whose spouses began a hunger strike in Moscow two weeks ago, met May 25 at the State Department with Assistant Secretary for Human Rights and Humanitarian Affairs Elliott Abrams. Three of the four are American citizens; the fourth is a permanent resident who has filed for citizenship. Their efforts on behalf of their spouses have the support of the Young Republicans, Senator Dole, and Congressman Kemp. Mrs. Frolov is also on a hunger strike.

Consistent with our long-term policy (as enunciated in the recent Sakharov and Embassy Pentecostal hunger strikes), Abrams told the group that, while we do not believe that hunger strikes are the proper tactic in these cases because of the real physical damage, even death, that could result, we have followed these cases closely from our Embassy in Moscow, and intend to raise them with the Soviet Embassy here.

The cases of the hunger strikers are diverse.

Until the hunger strike politicized the Frolov case, it had appeared to be one of the few problem cases which might have been resolved fairly easily. The other three are among the most difficult cases currently pending. Aloyzas Jurgutis is a defector, the Balovlenkov case has had an extraordinary amount of publicity, and Eduard Lozansky has been active in the US on behalf of a variety of human rights groups. The Soviet Union is more than usually resistant to granting exit visas in such cases. Except under extraordinary circumstances (which are not present in this situation) we have not observed the Soviet authorities to be responsive to the concerns of hunger strikers.

All cases except the relatively new Frolov case have been raised repeatedly in Moscow by our Embassy. The general problem of divided families, including the hunger strikers, has been most recently raised in Moscow May 25 and May 26, with no apparent positive response.

Objectives of the Vice President's meeting are:

- 1. to demonstrate the Administration's concern in this humanitarian issue, while making clear that we do not support hunger strikes;
- 2. to show the Administration's continuing support for the reunification of divided families;
- 3. to reassure these persons that the U.S. Government is pursuing their spouses' cases, and those of other divided families, vigorously.

The Administration does not support hunger strikes but wishes to make clear its concern over divided families.

- -- We do not approve of hunger strikes and cannot support them. Hunger strikes unnecessarily create the risk of permanent physical damage, or even death.
- The Administration is, however, deeply concerned about all families divided by Soviet restrictions on emigration.
- We continue to support the reunification of such families.
- -- The US Government is following your spouses' cases vigorously, as well as those of other divided families.
- -- Your spouses' cases are being followed closely by our Embassy in Moscow, and they have been the subject of discussions with Soviet authorities there.
- -- We also intend to raise these cases with the Soviet Embassy here.

After overcoming a series of bureaucratic obstacles, they were married in December, 1979. She left the Soviet Union shortly afterward; he has been unable to Soviet authorities against the large amount of publicity received by the wedding The Policity received by the wedding. Lois Becker Frolov (Andrei Frolov).

They were married in May, 1981, a month before her visa expired and she returned to the U.S. Mr. Frolov's application for an exit visa has been turned down twice, on grounds of "bad relation" tions with the US" and because it was "not in the interest of the Soviet state", reasons normally indicating that the case would have possibilities of gaining approval within a reasonable time span. Mrs. Frolov has filed a multi-million dollar court case against the Soviet Union. TShe began a hunger strike after her husband began his.

Aloyzas Jurgutis (Marija Jurgutis). Jurgutis, a professional musician, conductor, and composer from Lithuania, defected while on tour in Yugoslavia in May, 1974, and escaped to Italy. He came to the US in September, 1974, and is now a US citizen. the years, Mr. Jurgutis and his wife have repeatedly filed the necessary documents for the emigration of Mrs. Jurgutis and their daughter (now 17 years old) and have appealed to numerous US and Soviet officials, including over 30 Senators and 100 Congressmen. We fear that Mr. Jurgutis' status as a defector and his association with Baltic ethnic organizations in this country make his case almost impossible to resolve.

Eduard D. Lozansky (Tatyana Lozansky).

Dr. Lozansky, a Soviet Jewish physicist, married Mrs. Lozansky, the daughter of a senior Soviet general, in 1971. Mrs. Lozansky is a chemist. Unable to get a permanent job because of persecution, Dr. Lozansky decided to emigrate in 1976, but was unable to do so unless he first obtained a divorce. Since coming to the US shortly afterward, he has been attempting to get per---- mission for his wife and their daughter (now 9 years old) to join him, but permission has been denied on the basis of the 1976 divorce. The Soviet authorities do -not recognize the Lozanskys' proxy remarriage by telephone. Dr. Lozansky has been active in the US with various human rights groups concerned about problems in the Soviet Union; these activities may be a further factor in the Soviet refusal to grant exit visas in this case.

Attached (Tab A) are brief biographical sketches of Avital Shcharanskii and Iosif Mendelevich whom you are scheduled to meet at 10:00 a.m. Thursday, May 28. (C)

These two visitors personify the tragedy of Soviet Jewry in a very special way:

- Avital Shcharanskii has been married to her husband, Anatolii, for one single day in 1973. She has not seen him since and has devoted herself totally to securing her husband's release. Anatolii is serving a 13-year sentence in special Soviet jails on trumped up charges of spying for the United States. Latest reports indicate that his weight is down to 101 pounds.
- Iosif Mendelevich has recently been released from Soviet camps and prisons where he had spent 11 of his 34 years. His crime was to seek to emigrate to Israel, and when that request was repeatedly denied, to help organize a clandestine flight to Sweden which the KGB thwarted. In prison he was singled out for especially harsh treatment for his refusal to work on the Sabbath, insistence on wearing a skull-cap, and observing Jewish dietary laws. He is a truly heroic figure, fully dedicated to improving the condition of his coreligionists under growing Soviet anti-Semitism.

Present at your meeting with Shcharanskii and Mendelevich will be Vice President Bush, Edwin Meese, James Baker, Michael Deaver, Gordon Zacks, as well as Richard Pipes of the NSC Staff and myself. (U)

Case

Avital Shcharanskii is the wife of imprisoned Soviet dissident, Anatolii Shcharanskii, who together with Iurii Orlov (also presently in a Soviet jail) founded in 1976 the Moscow Helsinki Watch Group. This organization is dedicated to monitoring Soviet compliance with the terms of the Helsinki Final Accords. Prior to that, Shcharanskii had been primarily interested in securing permission to emigrate to Israel. (U)

The Shcharanskiis were married in 1973, one day before she was allowed to leave the Soviet Union for Israel; at the time the couple was told that his exit visa would be issued soon. In fact, they have not seen each other since. Anatolii was arrested in March 1977, and given a show trial in July 1978. Accused of serving U.S. secret services, he drew an unusually severe sentence of 13 years imprisonment to be followed by five years of internal exile. At the time of the trial, President Carter emphathically denied that Shcharanskii had any connection with U.S. intelligence. (C)

Shcharanskii's case is unusual in that he is a martyr for the cause of Judaism as well as that of human rights in the USSR (the two movements usually march their separate ways). He is presently reported to be confined to the "strict regime" barracks of the Perm prison complex where he receives substandard rations of food and clothing, and is allowed virtually no contact with the outside world. His health is said to be deteriorating. (C), on sept. 27, he went on a house at a protest with the contact with the outside world.

Mrs. Shcharanskii, who resides in Israel, has worked indefatigably for the past eight years to secure the release of her husband of one day. -- (U)

Attached (Tab A) are brief biographical sketches of Avital Shcharanskii and Iosif Mendelevich whom you are scheduled to meet at 10:00 a.m. Thursday, May 28. (C)

These two visitors personify the tragedy of Soviet Jewry in a very special way:

- -- Avital Shcharanskii has been married to her husband, Anatolii, for one single day in 1973. She has not seen him since and has devoted herself totally to securing her husband's release. Anatolii is serving a 13-year sentence in special Soviet jails on trumped up charges of spying for the United States. Latest reports indicate that his weight is down to 101 pounds. (C)
- -- <u>Iosif Mendelevich</u> has recently been released from Soviet camps and prisons where he had spent 11 of his 34 years. His crime was to seek to emigrate to Israel, and when that request was repeatedly denied, to help organize a clandestine flight to Sweden which the KGB thwarted. In prison he was singled out for especially harsh treatment for his refusal to work on the Sabbath, insistence on wearing a skull-cap, and observing Jewish dietary laws. He is a truly heroic figure, fully dedicated to improving the condition of his coreligionists under growing Soviet anti-Semitism. (C)

Present at your meeting with Shcharanskii and Mendelevich will be Vice President Bush, Edwin Meese, James Baker, Michael Deaver, Gordon Zacks, as well as Richard Pipes of the NSC Staff and myself. (U)

Avital Shcharanskii is the wife of imprisoned Soviet dissident, Anatolii Shcharanskii, who together with Iurii Orlov (also presently in a Soviet jail) founded in 1976 the Moscow Helsinki Watch Group. This organization is dedicated to monitoring Soviet compliance with the terms of the Helsinki Final Accords. Prior to that, Shcharanskii had been primarily interested in securing permission to emigrate to Israel. (U)

The Shcharanskiis were married in 1973, one day before she was allowed to leave the Soviet Union for Israel; at the time the couple was told that his exit visa would be issued soon. In fact, they have not seen each other since. Anatolii was arrested in March 1977, and given a show trial in July 1978. Accused of serving U.S. secret services, he drew an unusually severe sentence of 13 years imprisonment to be followed by five years of internal exile. At the time of the trial, President Carter emphathically denied that Shcharanskii had any connection with U.S. intelligence. (C)

Shcharanskii's case is unusual in that he is a martyr for the cause of Judaism as well as that of human rights in the USSR (the two movements usually march their separate ways). He is presently reported to be confined to the "strict regime" barracks of the Perm prison complex where he receives substandard rations of food and clothing, and is allowed virtually no contact with the outside world. His health is said to be deteriorating. (C)

Mrs. Shcharanskii, who resides in Israel, has worked indefatigably for the past eight years to secure the release of her husband of one day. (U)

The President and the Vice President met this morning for half a hour with two leading representatives of Soviet Jewry, Avital Shcharanskii and Iosif Mendelevich. Mrs. Shcharanskii's husband, Anatolii, has been languishing in Soviet jails for the past five years, having been accused of engaging in espionage on behalf of the United States — a charge that the United States Government has unqualifiedly repudiated. Iosif Mendelevich was recently released from Soviet jail after 11 years of imprisonment for attempting with several friends to escape the Soviet Union by plane in order to settle in Israel. The President expressed deep sympathy for the persecuted Jewish and other religious communities in the Soviet Union, as well as for the plight of Mrs. Shcharanskii's husband, and promised to do all in his power to help alleviate the situation.

The following in the background material for the Allen memo to the President:

On June 27, 1978 seven members of the Pentacostalist faith sought refuge in the American Embassy in Moscow and have remained there since. They want to emigrate from the Soviet Union in order to practice their religion in freedom; however, Soviet authorities insist that they return to their hometown and go through the official emigration if they leave the Embassy premises. (C)

The Pentacostalists consist of five members of the Vashchenko family and two members of the Chmykhlov family. They are members of the Pentacostalist branch considered illegal in the Soviet Union and membering about 200,000. The State Department has repeatedly asked the Soviet Government to permit these familes to emigrate and each time was told they must first return to their homes. Secretary Haig raised this with Soviet Ambassador Dobyrin on April 1, 1981, and our Delegation to the current Madrid Conference on Secretary and Cooperation in Europe has raised this issue with the Soviets in the context of the Helsinki Accords provisions on emigration. (C)

These two families have relatives in their native town of Charnogorsk who would also like to emigrate. The "illegal" Pentacostalists have been subject to harassment and persecution for years.

The following is suggested language on the Pentacostalists for the letter to Brezhnev:

The Vashchinko and Chanykholov families have spent nearly three years in the American Embassy in Moscow awaiting permission to emigrate from the Soviet Union. They fear leaving the Embassy without such permission and the Embassy will continue to shelter these families as long as they choose to remain there. It would

Press Conference No. 9 of the President of the United States:

Q: Mr. President, to follow up on your remarks about human rights, Mrs. Anatoliy Shcharanskiy, the wife of the Soviet dissident who is under arrest, is visiting in the United States and yesterday she expressed interest in seeing you to ask you to intervene in this case.

I would like to ask, do you think that this sort of thing can be useful, and do you plan to see her?

#### The President:

I don't have any plans to meet Mrs. Shcharanskiy but
I have inquired deeply within the State Department and
within the CIA as to whether or not Mr. Shcharanskiy
has ever had any known relationship in a subversive
way or otherwise with the CIA. The answer is no.
We have double-checked this and I have been hesitant

The Case of Mrs. McClellan

You may be familiar with the tragic case of Mrs. McClellan, the Soviet wife of an American professor from the University of Virginia, who for seven years has been denied an exit visa to join her husband. It is an inexplicable incident, even in the murky world of Soviet police-state politics.

Through U.S. channels, Mrs. McClellan has sent the attached letter (Tab A) addressed to you, pleading for intercession. It is a case that indeed warrants an effort on our part.

Respected Mr. President,

My tragic fate is already well known to many simple Americans and social and political leaders of your country. Many people in the U.S.A. on many different levels have worked for my liberation. But so far their efforts have not led to any result.

Seven years ago I married a U.S. citizen, Woodford McClellan, a professor of Russian history at the University of Virginia. Our marriage was registered in Moscow by the Soviet authorities. But so far I have not been able to get an exit visa from the Soviet Union in order to live in America with my husband.

The tragedy and hopelessness of my situation consists of the fact that although all my attempts to leave the Soviet Union not only did not lead to any positive result but also in the course of seven years, I cannot obtain any kind of reasonable explanation for the refusal of a visa, or any answer as to when I can leave to join my husband. I am already 42. My husband is 47. This is already a respectable age and it is terrible for me to think about tomorrow. The years pass, my life is being ruined and when theend will come to this humiliation is impossible to say.

In these seven years I have lost everything. I lost my job at the Institute of World Economy and International Relations because of contact with foreigners although I had done good work and was preparing to defend a dissertation. I lost my mother, who has disowned me because of ties to a foreigner. My daughter in these years suffers from a serious stomach ulcer, which appeared as a result of our entirely inhuman situation and she is now threatened with an operation although she is only 22 years old. I am constantly subjected to persecution as if I were the greatest criminal of the twentieth century. But in what is my crime — the wish of a woman to live with her husband. During all this time, the Soviet authorities refuse to give my husband an entry visa to the Soviet Union and here already for seven years we don't have any opportunity to meet, not speaking about a normal family life.

Here in the U.S.S.R., I have tried all possible means on the path to the achievement of my goal. I have written thousands of letters to all the leading figures in the government, including Brezhnev, Gromyko, Sholokhov and Andropov, with one request - that they seriously investigate my present situation. But I have not received a single answer. No one will speak to me. No one will receive me.

In complete desperation, I carried out four demonstrations three years ago, including a demonstration at the American embassy at the time of the arrival of Secretary of State Vance in Moscow in the hope that I could attract the attention of world public opinion and of Soviet and American political figures to my situation. And then, three years ago, I was at last promised that I would be given permission to emigrate to the United States within one month. But this was only a deceitful game. I am as before separated from my husband and am left to struggle alone with the entire Soviet system.

This year I was received by deputy minister of internal affairs Yelisov, who promised to investigate my situation. After two months, this man, the only official who has responsibility for emigration matters at the highest level, told me that my case was "very, very complicated" and therefore he could not tell me anything.

I am desperate from all that has happened to me. In the course of seven years, I have been forced to fight, absolutely alone, with an entire power, which apparently can be destroyed if I leave to live with my husband. This is absurd.

Mr. President, a citizen of your country is caught up in this tragedy, my husband, Woodford McLellan. During all these years he has also struggled for our unification. But apparently our question has run into an absurd dead end. Therefore I am appealing to you personally for help. Please save our family. These long sufferings and separations are intolerable.

Mr. President, you are at the very beginning of your term and ahead of you lie many long negotiations in the framework of Soviet-American relations. Our small example on the background of all the great problems in Soviet-American relations nonetheless shows very clearly the essence of the Soviet system, which illegally represses people and which has no wish to observe its own laws, including the constitution and the laws on marriage and the family, without speaking about international agreements. Cur family is a living example of Soviet violations in the area of human rights and this aspect is not so insignificant against the background of all the other problems of Soviet-American relations.

I ask you, Mr. Reagan, to take part personally in the deciding of my fate.

He has taken some further steps to convey to the Soviet authorities his feelings on this matter.

Experience indicates that wide publicity of these and related cases in the media is the single best means of exerting pressure on the Soviet Government.

#### HISTORY OF HARASSMENT SINCE VISA APPLICATION / ADDITIONAL COMMENTS:

The Chernobilskys are among the most active Jewish refuseniks in Moscow. Both attend seminars on Jewish history and culture, celebrate Jewish holidays with others and study Hebrew. Elena teaches Hebrew and was among the organisers of the "gan yeladim" - the kindergarten in Moscow for Jewish children. The Chernobilskys are the only family among the founders of the "gan" who have not yet been granted visas to Israel. Boris has also taken a special interest in the Jews of Ilyinka - a collective settlement - who are not granted exit visas. He has also made the long journey to Tsokto Khangil in Siberia to visit Vladimir Slepak, Prisoner of Zion serving a five year sentence of exile since 1978.

The Chernobilskys have been harassed by the KGB over the years. On 19 October 1976, Boris went to the offices of the Praesidium of the Supreme Soviet with a number of other refuseniks where they hoped to find out why they were being refused visas and for how long they would refused. Instead of being received, the men were rounded up and taken to a site outside Moscow where they were beaten. Two men, Yosef Ahs and Boris Chernobilsky were detained as the others were set free. They were held in prison for 22 days for "malicious hooliganism". Ahs was allowed to leave for Israel in 1978 after many years of waiting. Boris has not been able

to work in his profession and thus has been working as a plumber in order to support the family. Elena has worked in the kindergarten. She has become religious and tries to keep a kosher home.

The Chernobilskys' flat has been searched and they were threatened with arrest more that once.

On 10 May 1981, a number of Jews set out to an area near Moscow called Opalikha in order to have a picnic to celebrate Israel's Independence Day. Towards the end of the picnic, militiamen who had been standing nearby told the Jews to move "schnell" ("quickly" in German). Boris told a friend standing near him not to speak to the "fascists". Apparently one of the militiamen then said: "You again, Chernobilsky". Everyone went home without incident, but several days later Boris received in the post a summons to report to the police station. As there was no mention of why he was being summoned, he did not report. In early June he disappeared for two days — he had been picked up by the police and held overnight. At the end of the first week in June he returned home after having signed that he would not leave Moscow.

A criminal file against Chernobilsky was being compiled in Moscow under which he is alleged to have violated Article 191 -1 - "resisting the police". The indictment claims that Boris was asked to give his name and produce his internal passport in Opalikha but refused to do so. The file is due to be completed by 26 June 1981 and then Boris may be brought to trial.

#### OPEN LETTER - 24 June 1981

The name of Boris Chernobilsky is well known amongst the Jews in the Soviet Union who are waiting to go to Israel. Boris has been an activist in the struggle against the authorities' unlawful relation to the question of Aliya. He has participated in seminars on Jewish history and culture, has come to the aid of helpless Jewish farmers in the village of Ilyinka and was one of the organisers of the Jewish children's kindergarten in Moscow.

He is 35 years old, lives in Moscow with his wife Elena and two daughters - Anna who 10 years old and Yevgenia who is 7.

Now he is in danger of being tried and sent to prison or labour camp.

The first time he faced grave danger was in October 1976. It was in the same year that he and his family applied for visas to Israel and were refused.

On 19 October 1976 Boris, together with a group of other refuseniks, came to the office of the Supreme Soviet requesting to meet with the relevant officials in order to receive answers to various questions, such as, why are they refused visas, for how long will they be refused visas, to whom may one appeal if one is refused, etc.

In answer to their request, Boris and the others were taken to the outskirts of town, beaten and left in the unknown forest. I was with Boris in this group.

This story was publicised in the west. The authorities tried to justify the arrests and beatings by accusing us of hooliganism. Boris and I were separated from the others and accused of "malicious hooliganism" which could have been punishable under Soviet law by five years in prison.

The public around the world reacted quickly to our arrest. Protests poured in from America, England and France. As we later found out, even the president-elect of the United States took part in the campaign on our behalf. Thanks to this worldwide reaction, after 22 days, on 15 October 1976, we were released without trial. As we were freed from prison, we were told that this incident might be used against us if we would ever be called in again.

I was lucky, I received a visa in 1978 and came to Israel.

Boris was not so fortunate. He, his wife and their two small children (then they were small) are still in the Soviet Union.

He was followed many times since then, thrown out of work (he is a radio-engineer but works as a plumber to support the family), arrested and held for 15 days, had his flat searched and was threatened with physical violence.

Boris wasn't intimidated. He continued to struggle, to study Hebrew, to celebrate Jewish festivals together with refuseniks. Moscow Jews have been celebrating such festivals for many years in a forest near Moscow. Year after year the authorities have tried to interfere. And so they tried again this year — on 10 May 1981 — in Opalikha near Moscow. The Jews were told to leave the forest and head for the train station "schnell" (in German). Boris was there. It is possible he tried to argue.

The result - a summons to the police, a criminal file, Article 191' of the RSFSR Criminal Code, a few days' arrest, a signed statement that he will not leave Moscow.

The file should be completed by 26 June 1981. Then - a trial. The verdict is always known before the trial. Before the trial starts.

This is the second time.

Four and a half years ago worldwide pressure succeeded in releasing us from prison.

Now it is necessary to release only one - Boris Chernobilsky.

Dear Sir,

I, Faina Tsukerman, appeal to you hoping to receive your assistance in my efforts to save my husband residing in the USSR from a cruel and unjustified sentence that is now endangering his life.

My husband, Vladimir (Leonidovich) Tsukerman, born in 1947, residing in Kishinev-27, Gagarina blvd. 9/3, was arrested in Kishinev at the end of May 1981 and is now awaiting trial. He was arrested for his attempts to realise his legal right to emigrate to Israel in order to join me, his wife, and our son. I have been living in Israel since 1978 together with our son. He was three years' old when we left the USSR and is now six; he spent half of his childhood without seeing his father.

My husband was not granted the permit to emigrate to Israel in order to join us and the refusal of the Soviet authorities to grant him the exit visa was based on the fact that he had in the past served in the Navy. He was discharged from the Navy in 1975 and after so many years the pretext used by the authorities can hardly seem justified.

In the years following our separation my husband found himself in a difficult moral and material position: he was, on one hand, deprived of all means of livelihood by being unable to find a job and, on the other hand, he was subjected to harrassment and was thrown into prison several times for his struggle to obtain an exit visa. Seeing his determination to join his family the authorities have finally removed the security consideration applied to his case and promised to let him leave the USSR at the 20th of April 1981. This promise, however, turned out to be a cruel joke. When he came to the OVIR office to receive the emigration permit he was told that his application for emigration was rejected: once again.

on the 30th of May 1981, he staged a peaceful demonstration of protest against the heartless refusal of the authorities to grant him the emigration permit. For that he was arrested and charged with "disturbing public order". He was informed that he will be put on trial and according to the Soviet law this charge automatically leads to a 3 year term in labour camps with the possibility of being sent into exile afterwards. Such a sentence would ruin our lives.

I therefore appeal to you now, while there is still time to prevent the tragedy. I realise that there is so much suffering in the world and that the fate of our family is one amongst many, many others. Yet, the circumstances are pressing, there is still some time left and our situation is really desperate. I cannot bear the thought that our child would be deprived of his father's love and care for so many years. There must be some way to put an end to this act of cruelty committed by the Soviet authorities, to this violation of the Helsinki Accords signed and ratified by the Soviet government.

I plead with you to use all your influence and authorities, to do everything possible to help my husband, to stop the trial, to avert the verdict and to secure his right to live with his wife and child in Israel.

Placing all my hopes in your kindness and help and thanking you in advance.

#### TRANSLATED from Russian

#### Evgeny Lein - History of Arrest

Evgeny Lein was born in 1939. He graduated from the Leningrad. State University in 1963. He is a mathematician, a Candidate of Technical Sciences.

His wife, Irina, born in 1939, is also a scientist. They have two children: the daughter Sasha, born in 1960, and the son Aleksey, born in 1971.

E. Lein worked as a senior scientific worker until 1978, when he applied for emigration to Israel. He received a refusal.

Unable to find work in his profession he worked as a watchman. He then gave private lessons in mathematics, having registered officially at the Regional Finance Department.

In 1978, he took part in the work of the Leningrad Seminar in Applied Mathematics organized by Jewish refusmik-scientists. Since autum 1977 he has become interested in Jewish history and has been attending meetings on the subject arranged by refuseniks. He has also been studying Hebrew.

On the 16th of May 1981, he was arrested during the meeting on Jewish History held at the apartment of another Leningrad jew, Vasserman, and charged, in accordance with Art. 191, part II of the Criminal Code of the RSFSR, with showing resistance accompanied by violence to authorities (the article in question foresees a punishment term of 1 to 5 years of deprivation of freedom).

#### History of Arrest

On the 16th of May 1981, he took part in a meeting on Jewish History together with some other 70 participants. At 19.00, a la rge group of militiamen and agents in civilian clothes burst into the Vasserman apartment. They refused to produce their identification papers and documents sanctioning their entrance into the apartment. The men started photographing those present, rummaging in thier bags, demanding that they should leave the premises, they roughly pushed those present trying to provoke them. Without presenting any reasons they started checking the documents and making lists of names of those present. In recly to E. Lein's rightful demand to produce their identification documents, two of the men in civilian clothes (who had not produced any documents and had no tags of "People's Guards" members) pulled Lein out of the apartment. He had been held under arrest since that day.

According to the unanimous claim of the people who had been present in the apartment, Lein had not committed any violations of the law. He does not have any previous convictions, has a permanent address and has always engaged in socially useful work. The arrest was, therefore, considered an unjust measure.

The events that preceeded the arrest had shown that the purpose pursues by the authorities was to unterfere with the apparently known and legal desire of the Jews to study their history and culture. For example, on the 10th of May 1981, the authorities interfered with the conduct of another meeting on Jewish history and culture that was due to be held at Lein's apartment. About an hour and a half before the meeting, two militia officials and two men in civilian clothes entered the Lein apartment and demanded to cancel the meeting. After that. pickets were placed at the door of the apartment and at different spots near the house. Without giving any explanation the militiamen and the men in civilian clothes prevented people from entering lein's apartment. His own protests against the illegal activities of the militia officials were ignored.

On the 24th of May 1981, the authorities again prevented such a meeting

from taking place at Lein's apartment.

# "DEPARTMENT OF STATE" "SUGGESTED LETTER"

Dear Mr. Glickman:

I have been asked to respond to your letter of June 26 co-signed by 77 other Congressmen to President Reagan concerning Viktor Braylovskiy.

The U.S. Government has been following developments in Viktor Eraylovskiy's situation very closely since the spring of 1980 when Dr. Praylovskiy was triefly arrested but then released by the Soviet police. Like you, we are very concerned over his recent conviction and sentence to 5 years' internal exile (minus 21 months for time already served) for allegedly "spreading fatrications defaming the Soviet state."

Immediately following the recent arrest of Dr. Braylovskiy in November of 1980, our concern for his situation was communicated to all the participants attending the CSCE Review Conference then under way in Madrid, by Max Kampelman, the co-chairman of the United States delegation to the conference. Mr. Kampelman stated that Dr. Braylovskiy's arrest made him the twelfth Jew imprisoned by the Soviet authorities for attempting to emigrate. He stated that Soviet actions in these twelve cases were "in direct violation" of the Helsinki Final Act.

In view of our continuing concern for Dr. Braylovskiy's welfare, representatives from the United States Embassy in Moscow attempted to attend his trial, but were denied access

to the courthouse by Soviet officials. Immediately following the announcement that Dr. Braylovskiy had been convicted, our delegation to the Madrid CSCE Review Conference again raised the case, stating that the Braylovskiy case was considered to be a matter of serious political concern. We have also made the Soviets aware of our concern over the circumstances surrounding Braylovskiy's trial.

Let me assure you that we will continue to follow Dr.

Braylovskiy's situation closely and that we will lend him

whatever support and assistance we can in every appropriate

way. In the meantime, the name of the Braylovskiy family

remains included in a list of names, maintained by the Depart
ment of State, of persons refused permission to emigrate from

the Soviet Union to Israel.

This list is presented to high Soviet officials whenever an appropriate occasion arises, to express our continuing concern on this issue for all those who suffer for their efforts to emigrate from the Soviet Union. The Braylovskiy family name will remain on this list until their request to emigrate is granted by the Soviet authorities.

Dear President Reagan:

For nearly a decade, Dr. Viktor Brailovsky, a Soviet dissident scientist, and his family have been seeking permission from Soviet authorities to emigrate to Israel where his brother lives. Those requests have been denied repeatedly, and Dr. Brailovsky has continued his efforts to secure emigration papers tirelessly. He has also spoken out against the apparent discrimination which he and his family have faced in seeking permission to join his brother in Israel.

Now, last Thursday, Dr. Brailovsky was sentenced to five years of internal exile. The location has not yet been determined, but it is very likely to be somewhere in Siberia. As was reflected in a resolution adopted by the full House of Representatives in April, Dr. Brailovsky is in very poor health and needs medical care. Certainly, that will be a virtual impossibility if he is sent to Siberia.

The fact that the Brailovsky family requests for exit permits have been denied for so long flies in the face of the Helsinki Accords. Now, the Soviets have taken that violation one step further by sentencing him to exile for speaking out in support of the rights protected by the Helsinki Accords which have been violated by Soviet authorities. The United States Government has a responsibility to make sure that our fellow signatories of the Helsinki Agreements fulfill the obligation to respect human rights embodied therein. In light of these flagrant violations of the principles embodied in those agreements, we urge you and appropriate members of your Administration to use every possible avenue and opportunity to seek reversal of the Brailovsky sentence and permission for the Brailovsky family to emigrate.

We, of course, stand ready to cooperate in this endeavor.

#### STATEMENT OF VALERY CHALIDZE

RE: Denial of visa to my family

July 1st, 1981, the Soviet authorities denied emigration visas to my mother, Francesca Yanson, and my sister, Francesca Chalidze and her family, on their request to leave the USSR and take up permanent residence in the United States on my official invitation, which was verified by the U.S. Secretary of State.

I understand that there are many cases when people are not allowed to leave the USSR, but I believe that in this case the Soviet authorities have a special obligation to issue these visas, because the separation of our family was brought about by the action of the Soviet government. In 1972 I was permitted by the Soviet authorities to come to the United States for one month on the invitation of Georgetown University. After I arrived, the Presidium of the Supreme Soviet of the USSR issued a decree depriving me of my Soviet citizenship, and a Soviet consulate officer took my passport and stated that I would be unable to return to the USSR. It must be noted that in similar cases where a person was involuntarily deprived of citizenship, family reunification was allowed, such as in the cases of Aleksandr Solzhenitsyn, Vladimir Bukovsky and Alexander Ginsberg.

Since then I have lived in the United States and am now an American citizen, and as I said in the invitation to my family, I am completely capable of providing a place for them to live, as well as helping to supply other necessities.

My family is now in a very difficult situation. My mother (who is 73 years old) suffers from cancer, and my sister has lost her job after applying for the visa. I understand that my activities in support of human rights in the Soviet Union can be unpleasant to the Soviet authorities, but it is an inhumane act to try to take revenge against me by persecuting my family, especially because my family never participated in my public activities.

Your letter of June 22 is an eloquent and poignant reminder of your many efforts in these past years to obtain permission from the Soviet authorities to emigrate to the United States to live with your husband.

Your situation is a particularly tragic one. Your numerous attempts to try to gain exit permission from the Soviet Union have touched the heart of all of us who believe in freedom and fundamental human rights. Your courage in the face of continued harassment from the Soviet authorities inspires our admiration and deepens our concern, which we share with your many supporters and well-wishers in the United States.

In past years high U.S. Government officials have raised your case with their Soviet counterparts on numerous occasions. We will continue to express our concern and indignation about your case to Soviet officials at every appropriate occasion. The lack of Soviet responsiveness to our representations on your behalf has not lessened our concern or our determination to try to help. Your name was placed on the United States Government Representation List of Divided Families once it

became apparent the Soviets would not readily grant you permission to emigrate. Your name will remain on the list until the Soviets do permit you to be reunited with your husand in the United States. In this way, as well as in others, we have continued and will continue to remind the Soviets of our long-standing concern that your tragic circumstances must be resolved to allow you to be reunited with your husband.

In addition to expressing your concern to the Soviets, we want to keep abreast of your situation in every possible way. Please contact the American Embassy in Moscow any time you feel we can be of assistance. We have asked your husband to do the same with the Department of State in Washington. It is our hope that through continued, determined efforts you may soon be reunited with your husband.

SUBJECT: Response to Letter to the President from Irina McClellan

Attached is a draft response to the letter to President Reagan from Irina McClellan, a Soviet woman who has repeatedly been denied permission by the Soviets to emigrate to the United States to live with her husband, Professor Woodford McClellan of the University of Virginia. The McClellan case is a particularly tragic one and one that has attracted a great deal of public and Congressional attention. In the past the USG has devoted considerable energy to attempts to help Mrs. McClellan join her husband. The Soviets have not proven responsive in any way and have indicated that this is a case that may never be resolved.

In view of the considerable problems involved for Mrs. McClellan should she be found by Soviet authorities to have in her possession a written statement from President Reagan (most recently, prominent refusenik Viktor Braylovskiy was convicted in part for carrying on a correspondence with U.S. Government officials and the Congress), it is our recommendation that this response to be transmitted to the American Embassy in Moscow to be delivered orally to Mrs. McClellan. This procedure would not only conform with this Administration's previous practice in communications with prominent Soviet dissidents (such as Dr. Sakharov), but also ensure that Mrs. McClellan would receive the response and not be endangered unnecessarily. Delivery of the response in this fashion would also preclude circulation of a signed original in an undesirable and possibly damaging fashion.

Upon receipt of White House clearance, the Department will transmit instructions to the Embassy in Moscow to deliver the reply to Irina McClellan in the name of the President.

Dear Mrs. McClellan:

Your letter of June 22 is an eloquent and poignant reminder of your many efforts in these past years to obtain permission from the Soviet authorities to emigrate to the United States to live with your husband.

Your situation is a particularly tragic one. Your numerous attempts to try to gain exit permission from the Soviet Union have touched the heart of all of us who believe in freedom and fundamental human rights. Your courage in the face of continued harassment from the Soviet authorities inspires our admiration and deepens our concern, which we share with your many supporters and well-wishers in the United States.

In past years high U.S. Government officials have raised your case with their Soviet counterparts on numerous occasions. We will continue to express our concern and indignation about your case to Soviet officials at every appropriate occasion. The lack of Soviet responsiveness to our representations on your behalf has not lessened our concern or our determination to try to help. Your name was placed on the United States Government Representation List of Divided Families once it became apparent

Mrs. Irina McClellan Chernyshevsky 7, Kv. 150, Moscow, U.S.S.R. the Soviets would not readily grant you permission to emigrate. Your name will remain on the list until the Soviets do permit you to be reunited with your husband in the United States. In this way, as well as others, we have continued and will continue to remind the Soviets of our long-standing concern that your tragic circumstances must be resolved to allow you to be reunited with your husband.

In addition to expressing our concern to the Soviets, we want to keep abreast of your situation in every possible way. Please contact the American Embassy in Moscow any time you feel we can be of assistance. We have asked your husband to do the same with the Department of State in Washington.

The present climate of increased bilateral tensions does not give us reason to be optimistic that the Soviet authorities will be more responsive now than they have been in the past in permitting a satisfactory resolution of your emigration request. Nonetheless, it is our hope that through continued, determined efforts you may soon be reunited with your husband.

Mrs. McClellan, a Soviet citizen, wrote you a letter (Tab B) explaining her problems in getting a Soviet exit visa since marrying a U.S. citizen seven years ago. She asks for your help. At Tab A is a suggested reply to be transmitted to our Embassy in Moscow for oral delivery to Mrs. McClellan.

Since her marriage to a University of Virginia professor seven years ago, Mrs McClellan has repeatedly been denied permission by the Soviets to emigrate to the United States. The U.S. Government has devoted considerable energy to attempts to help her join her husband in the U.S., but the Soviets have been totally unresponsive and have indicated they will remain so. This tragic case has attracted a great deal of public and Congressional attention.

State recommends that your reply to her be transmitted to our Embassy in Moscow for oral delivery to avoid Soviet interception and possible misuse of a signed letter from you. Possession of such a letter could also get her into trouble with Soviet authorities.

#### Recommendation

That you approve the letter at Tab A to be transmitted to the American Embassy in Moscow for oral delivery to Mrs. McClellan.

But so far I have not been able to get an exit visa from the Soviet Union in order to live in America with my husband.

The tragedy and hopelessness of my situation consists of the fact that although all my attempts to leave the Soviet Union not only did not lead to any positive result but also in the course of seven years, I cannot obtain any kind of reasonable explanation for the refusal of a visa, or any answer as to when I can leave to join my husband. I am already 42. My husband is 47. This is already a respectable age and it is terrible for me to think about tomorrow. The years pass, my life is being ruined and when theend will come to this humiliation is impossible to say.

In these seven years I have lost everything. I lost my job at the Institute of World Economy and International Relations because of contact with foreigners although I had done good work and was preparing to defend a dissertation. I lost my mother, who has discoved me because of ties to a foreigner. My daughter in these years suffers from a serious stomach ulcer, which appeared as a result of our entirely inhuman situation and she is now threatened with an operation although she is only 22 years old. I am constantly subjected to persecution as if I were the greatest criminal of the twentieth century. But in what is my crime - the wish of a woman to live with her husband. During all this time, the Soviet authorities refuse to give my husband an entry visa to the Soviet Union and here already for seven years we don't have any opportunity to meet, not speaking about a normal family life.

Here in the U.S.S.R., I have tried all possible means on the path to the achievement of my goal. I have written thousands of letters to all the leading figures in the government, including Brezhnev, Gromyko, Sholokhov and Andropov, with one request - that they seriously investigate my present situation. But I have not received a single answer. No one will speak to me. No one will receive me. In complete desperation, I carried out four demonstrations three years ago, including a demonstration at the American embassy at the time of the arrival of Secretary of State Vance in Moscow in the hope that I could attract the attention of world public opinion and of Soviet and American political figures to my situation. And then, three years ago, I was at last promised that I would be given permission to emigrate to the United States within one month. But this was only a deceitful game. I am as before separated from my husband and am left to struggle alone with the entire Soviet system.

This year I was received by deputy minister of internal affairs Yelisov, who promised to investigate my situation. After two months, this man, the only official who has responsibility for emigration matters at the highest level, told me that my case was "very, very complicated" and therefore he could not tell me anything.

I am desperate from all that has happened to me. In the course of seven years, I have been forced to fight, absolutely alone, with an entire power, which appearently can be destroyed if I leave to live with my husband. This is absurd.

Mr. President, a citizen of your country is caught up in this tragedy, my husband, Woodford McLellan. During all these years he has also struggled for our unification. But apparently our question has run into an absurd dead end. Therefore I am appealing to you personally for help. Please save our family. These long sufferings and separations are intolerable.

Mr. President, you are at the very beginning of your term and ahead of you lie many long negotiations in the framework of Soviet-American relations. Our small example on the background of all the great problems in Soviet-American relations nonetheless shows very clearly the essence of the Soviet system, which illegally represses people and which has no wish to observe its own laws, including the constitution and the laws on marriage and the family, without speaking about international agreements. Our family is a living example of Soviet violations in the area of human rights and this aspect is not so insignificant against the background of all the other problems of Soviet-American relations.

I ask you, Mr. Reagan, to take part personally in the deciding of my fate.

Mrs. McClellan, a Soviet citizen, wrote the President a letter (Tab B) requesting his help in getting a Soviet exit visa which has been denied her despite the fact that she has been married to a U.S. citizen for seven years. State has sent a draft reply which, with my changes, is at Tab A. memo at Tab I from you to the President recommends that he approve transmission of this reply to Embassy Moscow for oral delivery to Mrs. McClellan.

The Bremer memo (Tab II) forwarding the draft reply suggests oral delivery to ensure delivery of the message and both to avoid getting her into trouble and to avoid Soviet interception and possible misuse of a signed letter. I agree with this procedure. I deleted most of the last paragraph of State's draft (Tab II) because I saw no point in discouraging Mrs. McClellan with references to present US-Soviet tensions as a factor militating against her getting a visa.

FYI: The Soviet desk believes she is not getting her visa because of KGB ties she or someone in her family has had. The Soviets have apparently told us that we might as well forget her case. One of my professors married a Russian girl a year and a half ago, and he got her out in a few months. This led me to believe there was something special about the McClellan case and evidently there is.

Dick Pipes sent you a memo on July 23 recommending a Presidential reply. You returned it with a request for a draft reply.
