

CHEVRON JOINS OTHER COMPANIES IN CONSORTIUM TO EXPLORE BUSINESS OPPORTUNITIES IN THE SOVIET UNION

Chevron is one of seven American companies in the American Trade Consortium (ATC), which has been formed to explore the potential for developing business ventures with Soviet partners in the Soviet Union, it was announced April 13 at a news conference in Moscow.

The other companies are units of Archer Daniels Midland, Eastman Kodak Company, Ford Motor Company, Johnson & Johnson, The Mercator Company and RJR Nabisco.

At the news conference, officials of the member companies joined the ATC's president, James Giffen of Mercator Corp., in calling the event an important first step in the expansion of commerce between the United States and the U.S.S.R. Representing Chevron was John Silcox, president of Chevron Overseas and a member of the board of directors of the new consortium.

Giffen pointed out that the expansion of non-strategic commercial and trade relations between the two countries has the strong encouragement and support of both the U.S. and Soviet governments.

He said that all projects negotiated under the auspices of the ATC will comply with the laws and regulations of both countries. In fact, the projects will be subject to prior review and approval by the U.S. government, Giffen said.

Chevron, as previously reported, is engaged in discussions with the Soviets about possible joint-venture projects involving oil exploration and development. Each of the consortium's member companies is considering its own individual joint ventures in the Soviet Union, primarily in the areas of manufacturing and marketing products.

The ATC, which will have offices in New York and Moscow, will assist the companies in launching business ventures in the U.S.S.R. It will be available to assist the consortium members both in the negotiating process and in providing extensive administrative, communications and general office support services.

The ATC will now work with its Soviet counterpart, the Soviet Foreign Economic Consortium, to negotiate a "general trade agreement" that will establish the legal, business, financial and economic framework for joint ventures between American and Soviet partners.

Financial terms of the consortium's establishment were not disclosed.


