RESTRICTION CODES

Presidential Records Act - [44 U.S.C. 2204(a)]

- F-9 Release would disclose geological or geophysical information concerning wells [(b)(9) of the FOIA].

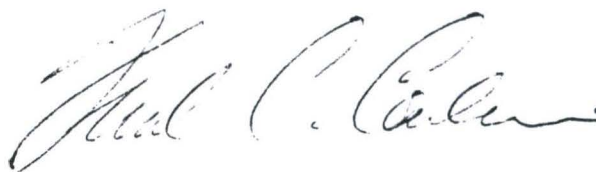

SUBJECT: Oil and Gas Equipment Trade Promotion in the USSR

You have my concurrence to proceed with trade expansion support for the U.S. oil and gas industry for equipment sales into the USSR. This concurrence, of course, is restricted only to items not restricted under COCOM national security controls.
