1. (U) SUMMARY: EC MINISTERS RESPONSIBLE FOR LAW ENFORCEMENT AND INTELLIGENCE ("TREVI" GROUP) MET IN LONDON ON SEPTEMBER 25 TO DISCUSS FURTHER STEPS TO COMBAT TERRORISM. FOLLOWING THE MEETING, UK HOME

CONFIDENTIAL

SECRETARY AND CURRENT TREVI CHAIRMAN DOUGLAS HURD ISSUED A STATEMENT ON BEHALF OF THE TWELVE NOTING:

- -- EC DETERMINATION NOT TO MAKE CONCESSIONS TO TERRORISTS;
- -- TREVI GROUP AGREEMENT TO INTENSIFY EFFORTS AGAINST TERRORISM;
- -- THE NEED FOR THE FULLEST POSSIBLE SHARING AND JOINT ANALYSIS OF NATIONAL INTELLIGENCE;
- -- NEW ARRANGEMENTS FOR REGULAR UP-TO-DATE ASSESSMENTS OF TERRORIST THREATS, TO TARGET THE MAJOR LEADERS AND ORGANIZERS; AND,
- -- SETTING UP A NEW SYSTEM OF SPEEDY AND SECURE COMMUNICATIONS BETWEEN EUROPEAN POLICE FORCES.
- 2. (W) IN ADDITION, MINISTERS SET IN HAND A PROGRAM TO HELP EXCLUDE TERRORISTS FROM THE COMMUNITY BY AGREEING TO EXAMINE VISA ARRANGEMENTS; MAKE EFFECTIVE USE OF EXCLUSION AND EXPULSION PROCEDURES; REVIEW ARRANGEMENTS FOR EFFECTIVE SECURITY CHECKS AT AIRPORTS, AND THE WORK DONE BY MEMBER GOVERNMENTS TO CURB ABUSES OF DIPLOMATIC IMMUNITY. END SUMMARY.

3. LUY BEGIN TEXT:

EMERGENCY MEETING OF COMMUNITY INTERIOR MINISTERS AND MINISTERS OF JUSTICE

PRESIDENCY STATEMENT BY THE RT HON DOUGLAS HURD CBE MP

THE COMMUNITY TODAY REAFFIRMED ITS DETERMINATION NOT TO MAKE CONCESSIONS TO TERRORISTS. MY FELLOW MINISTERS HAVE AGREED TO INTENSIFY THEIR EFFORTS AGAINST TERRORISM; AND WE HAVE TAKEN SOME DECISIVE STEPS TO ACT MORE CLOSELY TOGETHER TO THIS END.

TERRORISTS NOWADAYS ARE NOT ALWAYS INDIVIDUALS OR SMALL GROUPS OPERATING ONLY WITHIN ONE COUNTRY. THEY ARE INCREASINGLY MEMBERS OF ORGANIZATIONS WHICH OPERATE ACROSS NATIONAL FRONTIERS AND HAVE ACCESS TO

SUBSTANTIAL SUMS OF MONEY, ARMS, EQUIPMENT AND TECHNICAL KNOWLEDGE AND TRAINING. AS TERRORISTS HAVE BECOME BETTER ORGANIZED, SO GOVERNMENTS AND THEIR COUNTER-TERRORIST FORCES ARE HAVING CONTINUALLY TO IMPROVE THEIR KNOWLEDGE AND COOPERATION IF THEY ARE TO PREVENT TERRORIST ATTACKS AND TAKE EFFECTIVE COUNTER-ACTION IF THEY OCCUR.

FIRST, THE SETTING UP OF NEW ARRANGEMENTS WITHIN TREVIFOR REGULAR UP-TO-DATE ASSESSMENTS OF TERRORIST THREATS, TO TARGET THE MAJOR LEADERS AND ORGANIZERS. SECOND, THE START OF A NEW SYSTEM OF SPEEDY AND SECURE COMMUNICATIONS BETWEEN EUROPEAN POLICE FORCES.

THESE NEW MEASURES WILL HELP US TO TARGET TERRORISTS' MOVEMENTS, SUPPLIES OF MONEY, ARMS AND EQUIPMENT, SO THAT WE CAN HARRY AND DISRUPT THEM. WE HAVE HAD SOME NOTABLE SUCCESSES WITHIN EUROPE IN RECENT MONTHS. BUT WE NEED TO STEP UP THE PRESSURE FURTHER WITH SELECTIVE MEASURES AIMED AT TERRORISTS AND THEIR ASSOCIATES.

TO BACK THIS UP, MINISTERS HAVE ALSO SET IN HAND A PROGRAM OF WORK TO HELP EXCLUDE TERRORISTS FROM THE COMMUNITY. THEY AGREED TO EXAMINE VISA ARRANGEMENTS, AND TO MAKE EFFECTIVE USE OF EXCLUSION AND EXPULSION PROCEDURES. THEY ALSO AGREED TO EXAMINE THE NEED FOR MORE EFFECTIVE EXTRADITION PROCEDURES, SO THAT TERRORISTS CANNOT TAKE ADVANTAGE OF LEGAL LOOPHOLES TO AVOID JUSTICE. I INDICATED MY INTENTION TO BRING FORWARD PROPOSALS DESIGNED TO FACILITATE EXTRADITION PROCEDURES FROM THE UK. WE ALSO AGREED TO REVIEW ARRANGEMENTS FOR MAKING EFFECTIVE SECURITY CHECKS AT AIRPORTS, AND THE WORK DONE BY MEMBER GOVERNMENTS TO CURB ABUSES OF DIPLOMATIC IMMUNITY.

SOME OF THESE ISSUES WILL BE FURTHER PURSUED AFTER THE NECESSARY CONSULTATION WITH FOREIGN MINISTERS AT THE MEETING OF EC INTERIOR MINISTERS IN LONDON IN OCTOBER AND THE NEXT MEETING OF THIS TREVI GROUP OF MINISTERS ALREADY ARRANGED FOR EARLY DECEMBER. THE AIM MUST BE TO MAKE THESE MEASURES MUTUAL, SO THAT A TERRORIST EXCLUDED OR DRIVEN FROM ONE COUNTRY CANNOT FIND ENTRY OR REFUGE IN ANOTHER. TERRORISTS BY THEIR CHOICE OF METHOD ARE NOT WARRIORS BUT CRIMINALS, AND SHOULD BE TREATED AS SUCH. A PRINCIPAL AIM OF THE EC IN BUILDING EUROPE MUST BE TO SAFEGUARD OUR CITIZENS BY OUTWITTING TERRORISTS AND BRINGING THEM TO JUSTICE. END TEXT.

3. (*) IN HIS POST-MEETING PRESS CONFERENCE, HOME SECRETARY HURD NOTED THE MINISTERS' ADMIRATION FOR THE

CALM AND COURAGE WITH WHICH FRANCE HAS DEALT WITH RECENT TERRORIST ATTACKS THERE. HE ALSO REMINDED JOURNALISTS THAT THE MINISTERS DID NOT DISCUSS THE ROLE OF THIRD COUNTRIES IN TERRORISM NOR THE POSSIBLE USE OF

FORCE AGAINST OTHERS SINCE THAT WAS NOT PART OF THEIR RESPONSIBILITIES. HURD SAID THAT THE TREVI MEETING MARKED THE REINFORCEMENT AND ACCELERATION OF COOPERATION AMONG EC GOVERNMENTS AND WAS NOT INTENDED TO "MAKE STARTLING HEADLINES". HE ADDED THAT THE TWELVE ARE COMMITTED TO STEADY, PRACTICAL PROGRESS AGAINST TERRORISTS AND THAT THE EC'S RECORD TO DATE IS "MORE SUBSTANTIAL THAN MANY AMERICAN CRITICS GIVE IT CREDIT FOR".

4. (U) FRENCH MINISTER-DELEGATE FOR SECURITY PANDRAUD ALSO ADDRESSED THE PRESS AND UNDERLINED FRANCE'S DETERMINATION NOT TO NEGOTIATE WITH TERRORISTS. HE WAS EAGER TO DISPEL RUMORS OF A PENDING "DEAL" INVOLVING THE RELEASE OF CONVICTED TERRORIST ABDALLAH AND REITERATED FRENCH DETERMINATION NOT TO SUCCUMB TO BLACKMAIL. HE ALSO DENIED RUMORS OF ABDALLAH'S ILLTREATMENT AT THE HANDS OF FRENCH POLICE. ON THE QUESTION OF A COMMON EC VISA POLICY, PANDRAUD SAID THAT

FREEDOM OF MOVEMENT FOR EC NATIONALS BETWEEN COMMUNITY COUNTRIES MAKES LITTLE SENSE IF THE COMMUNITY'S "OUTER BORDERS" ARE NOT EFFECTIVELY CONTROLLED. PANDRAUD ADDED THAT THE MEASURES DIRECTED AGAINST TERRORISTS SHOULD ALSO APPLY TO DRUG TRAFFICKERS. AS FOR IMPROVED SHARING OF INFORMATION AND ANALYSIS AMONG NATIONAL POLICE FORCES, HE ACKNOWLEDGED THAT DIFFERENT HISTORIC AND CULTURAL BACKGROUNDS IN EACH EC COUNTRY WOULD MAKE COMPLETE COOPERATION DIFFICULT. HE THOUGHT, HOWEVER, THAT THERE WAS ROOM FOR IMPROVEMENT IN EACH NATION'S UNDERSTANDING OF COUNTER-TERRORIST PROCEDURES AND POLICIES IN OTHER COMMUNITY COUNTRIES.

5. (2) COMMENT: ALTHOUGH FEW PRACTICAL COMMON MEASURES EMERGED FROM THE SEPTEMBER 25 MEETING, INTERIOR AND JUSTICE MINISTERS APPEAR TO HAVE RECOGNIZED THE CONTINUING NEED TO FIRM UP POLICE PRACTICES AND BORDER CONTROLS TO COMBAT TERRORISM, EVEN IF ON A NATIONAL BASIS. DESPITE THE POLITICAL IMPETUS TO IMPROVED INTELLIGENCE AND ANALYSIS EXCHANGES AMONG MEMBER

STATES, WE AGREE WITH PANDRAUD'S OBSERVATION THAT THIS IS EASIER SAID THAN DONE. EC INTERIOR MINISTERS ARE EXPECTED TO DISCUSS FURTHER THE POSSIBILITY OF TIGHTENING COMMUNITY VISA POLICIES WHEN THEY MEET IN LONDON ON OCTOBER 17. DISCUSSION OF ANY ADDITIONAL MEASURES DIRECTED AGAINST THIRD COUNTRIES, BESIDES CLOSER SCRUTINY OF DIPLOMATIC IMMUNITY ABUSE, REMAINS THE DOMAIN OF EC FOREIGN MINISTRIES. WE HAVE SCHEDULED A SEPTEMBER 26 MEETING WITH A SENIOR UK HOME OFFICE OFFICIAL FOR A READ-OUT OF DISCUSSIONS AT THE TREVIMINISTERIAL.

French Terrorism

Prime Minister Chirac's address to the United Nations yesterday made clear the French Government's focus on solving their terrorist problem. For the first time, the French are actively seeking international cooperation in the fight against terrorism as seen in their performance at the Council of Europe (COE) Parliamentarians' meeting in Strasborg and their wholehearted support for the Convention on the Suppression of Terrorism. In addition, at the emergency session of the European Community Interior Ministers held in London, the European Ministers, at French urging, agreed to increase anti-terrorism measures. French overtures to us are yet another positive sign. Their course of action on UNIFIL is interesting in that it may indicate an intention to take military action against terrorist targets in the region once their forces are free of the peacekeeping constraint.

The AmEmb Paris cable at Tab II indicates that French Public Security Minister Pandraud will visit Washington in October and Ambassador Rodgers has suggested North and Clarridge participate in the meetings with him. The cable at Tab III proposes that meetings also be scheduled for Pandraud's aide in November or December. Ambassador Rodgers suggests this be organized by State (S/CT) and emphasizes the sensitivity of the discussions.

OSG principals, Ty Cobb, Howard Teicher, and Dennis Ross concur.

RECOMMENDATION

The OSG/TIWG recommends that they take the lead in both of these meetings, given the subject of terrorism as the sole focus of the discussions.

FRENCH SECURITY MINISTER PANDRAUD HAS REQUESTED THAT HIS CLOSE AIDE, WHO HAS PROVIDED SUCH INTERESTING REPORTING IN RECENT MONTHS, TRAVEL TO WASHINGTON IN ORDER TO PARTICIPATE IN A SPECIAL FOUR OR FIVE-DAY ATA PROGRAM (ORGANIZED BY S/CT) TO BECOME FAMILIAR WITH OUR ANTI-TERRORISM EFFORTS AND PROGRAM. TIMING WOULD BE NOVEMBER OR DECEMBER. AIDE IS WILLING TO HAVE A MEETING DURING HIS VISIT TO DISCUSS WHAT HE HAS LEARNED AND KNOWS ON TERRORISM, HOSTAGES, ETC. Visit by French Public Security Minister Pandraud

French Public Security Minister Pandraud has requested a brief meeting with you during his visit to Washington on October 16-17, 1986. As we have previously discussed with you (Tab I), Pandraud will be meeting with members of the OSG and other senior officials including the Vice President, the Attorney General, and Deputy Secretary Whitehead.

Pandraud is here specifically to consult with the United States on the Lebanon hostage situation and related terrorist problems. We recommend a brief (15 minute) meeting with you and North. This will provide another opportunity to reiterate our continued interest in working quietly with the French on activities of mutual interest to combat terrorism. Presently, his schedule is available to meet with you during the afternoon of October 17.

We will provide talking points prior to the meeting.

OSG Principals, Tyloob, Howard Teicher and Dennis Ross concur.

RECOMMENDATION

That you agree to schedule a meeting with Pandraud.

Prime Minister Chirac's address to the United Nations yesterday made clear the French Government's focus on solving their terrorist problem. For the first time, the French are actively seeking international cooperation in the fight against terrorism as seen in their performance at the Council of Europe (COE) Parliamentarians' meeting in Strasborg and their wholehearted support for the Convention on the Suppression of Terrorism. In addition, at the emergency session of the European Community Interior Ministers held in London, the European Ministers, at French urging, agreed to increase anti-terrorism measures. French overtures to us are yet another positive sign. Their course of action on UNIFIL is interesting in that it may indicate an intention to take military action against terrorist targets in the region once their forces are free of the peacekeeping constraint.

The Amemb Paris cable at Tab II indicates that French Public Security Minister Pandraud will visit Washington in October and Ambassador Rodgers has suggested North and Clarridge participate in the meetings with him. The cable at Tab III proposes that meetings also be scheduled for Pandraud's aide in November or December. Ambassador Rodgers suggests this be organized by State (S/CT) and emphasizes the sensitivity of the discussions.

OSG principals, Ty Cobb, Howard Teicher, and Dennis Ross concur.

RECOMMENDATION

The OSG/TIWG recommends that they take the lead in both of these meetings, given the subject of terrorism as the sole focus of the discussions.



Your Meeting with Bujon de l'Estang

Bujon will be coming to Washington at your invitation, following on your discussions in Tokyo where you agreed to try to get together for a tour d'horizon. Bujon will be anxious to get a readout from you on the Reykjavik meetings, but will also want to discuss a range of politico-military issues.

Regarded as one of the brightest lights of his generation in France, Bujon is now PM Chirac's Counselor for Defense and Diplomatic Affairs -- roughly your counterpart. Bujon began his government career as a Special Assistant for Foreign Affairs (1966-1969) for Charles de Gaulle. He later served in Washington with the Embassy, earned an MBA from Harvard and returned in 1982 to head the industrial firm, Cogema, Inc. Bujon is extraordinarily well-connected: he served as Chief of Staff when Defense Minister Giraud headed the French Atomic Energy Agency, is close to Mitterrand's summit sherpa Jacques Attali, and is married to the cousin of the French Ambassador to the U.S., Emmanuel de Margerie.

Bujon will be meeting with: <u>Jerry Bremer</u> to discuss counterterrorism cooperation; Mike Armacost on Franco-U.S. interests in the Third World and Fred Ikle on increasing French integration in European/NATO politico-military affairs. In addition to East-West relations, Bujon will likely raise Chad, SPNFZ, new measures France has imposed to combat terrorism and Chirac's visit to the U.S. We would suggest that you press Bujon particularly on the post-CDE conventional arms negotiations forum, prospects for cohabitation and increased Franco-U.S. military cooperation.

A summary of the key issues and suggested points, you may wish to raise are at Tab I. Ambassador de Margerie and Political Counselor Jean Desazars will accompany Bujon for the one-hour meeting

Tab I Summary of Key Issues

YOUR MEETING WITH BUJON

TOPICS BUJON MAY RAISE:

- -- COUNTERTERRORISM: Will emphasize Chirac's firmness in dealing with terrorists; stress French will make no concessions or negotiate with terrorists. Believe Abdullah clan behind many acts, but will emphasize Chirac does not appreciate U.S. pressure (will say what GOF needs is proof from U.S.; Abdullah dossier very thin). GOF uncertain over foreign support, Chirac/ DGSE think Syria, but Mitterrand/DST point to Iran. You might determine Bujon's views on this, stress USG willingness to increase counterterrorist cooperation. Specifically, if evidence of Syrian involvement in Karachi hijacking/Paris bombings develop, should coordinate responses. You may also ask Bujon's thinking on extent of Iranian influence in Damascus and anti-west activities in Lebanon. (Note: Pandraud will be in Washington this week for meetings with Meese, Casey, others.)
- -- CHAD: Chirac feels Walters' visit high on media content, low on substance. GOF concerned US pressing Habre to move north, feels Qadhafi position weakened and may fall on own accord. May inquire on report U.S. had "disinformation plan", including attempt to "shame France" into supporting Habre. You should stress we feel French judgment is key, plan no independent action, but note GOF and U.S. have responsibilities in region, and we want to work with them.
- -- SPNFZ: GOF has made series of high-level demarches emphasizing opposition to protocols. Will argue French nuclear policy requires testing. Chirac said GOF would regard US signing of Raratonga Treaty as "somewhat of an aggressive act", bad precedent. You should reiterate we sympathize with French position, as President wrote to Chirac, but also must consider broader interests in Pacific. Continuing to study.
- -- EAST-WEST: Bujon will be appreciative of your personal read-out from the Reykjavik meetings and will want to hear your view on prospects for Soviet-American relations following the impasse. He may focus on the INF proposal, particularly guidelines affecting third country nuclear systems.
- -- CHIRAC VISIT TO U.S.: On behalf of White House, Shultz extended invite to Chirac to come to Washington for OWV, probably early 1987. You might note we are looking forward to welcoming good friend of U.S. NOTE: Chirac is also planning to go to Moscow in 1987.

TOPICS YOU MAY WISH TO RAISE:

-- FRANCE AS ALLY: Note historic ties with France, reinforced at Liberty Weekend. Bujon will add that France only country which enjoys consensus on foreign and defense policy. You should praise France's global role and express appreciation for intimate dialogue demonstrated by meetings such as this one.

COHABITATION: Survives, but tensions rising over division of responsibilities, as recent flap over our communications to Elysee and Matignon demonstrated. You may want to seek his counsel on how best to handle communications. Given Bujon's position and ties to Attali, he may provide you with a candid assessment of internal French politics.

-- CONVENTIONAL ARMS CONTROL: French are committed to maintaining balance between human rights and security in CSCE. Regard CSCE as proper forum for Halifax - mandated arms negotiations. We feel potential reductions should be conducted on alliance-to-alliance basis; French strongly oppose alliance-to-alliance negotiations as evidenced by their absence from MBFR talks. We believe Western negotiators should act on instructions from NAC; negotiations should be conducted outside of and separate from the CSCE framework. Also, MBFR negotiations should continue until satisfactory mandate for new talks found. NOTE: Chancellor Kohl leans toward CSCE forum because of perceived importance of getting French involved and has pressed us on this. We asked Hal Sonnenfeldt to see Bianco and Bujon in France this week to press U.S. position.

1. ENTIRE TEXT.

2. REFTEL A INVITED USG TO PRESENT ITS VIEWS ON TRAVEL CONTROLS THAT COULD BE USED TO LIMIT THE MOVEMENT OF SUSPECTED TERRORISTS. THE VISIT OF DAS NEWLIN TO LONDON OCTOBER 10 IS AN EXCELLENT OPPORTUNITY TO PRESENT OUR VIEWS IN PREPARATION FOR THE SERIES OF TREVI AND EPC MEETINGS THAT WILL BEGIN OCTOBER 17 AT WHICH THE EC WILL CONSIDER THE RANGE OF ISSUES INVOLVED. THE DEPARTMENT REQUESTS THAT U.S. VIEWS IN FOLLOWING PARAGRAPHS BE LEFT WITH FCO AND HOME OFFICE AUTHORITIES TO BE PRESENTED APPROPRIATELY AT THE VARIOUS EUROPEAN POLITICAL COMMITTEE

AND TREVI MEETINGS.

3. THE UNITED STATES WELCOMES THE EUROPEAN EFFORT TO USE TRAVEL CONTROLS TO HELP COMPLICATE THE MOVEMENT OF

TERRORISTS. WE WOULD BE HAPPY TO WORK WITH THE EC ON THE IMPLEMENTATION OF SUCH MEASURES. AT THE SAME TIME, THE UNITED STATES PROVIDES THE LARGEST VOLUME OF VISITORS TO THE EC. TRAVEL CONTROLS IMPOSED BY THE EC COULD AFFECT U.S. TRAVEL AND TOURISM. BOTH THE U.S. AND THE EC HAVE EMPHASIZED FACILITATION OF TRAVEL AND WE WOULD LIKE TO CONTINUE TO HOLD TO THIS OBJECTIVE, WHICH HAS BEEN BENEFICIAL TO COMMERCE AND TO SUSTAINING AND STRENGTHENING THE MANY TIES BETWEEN THE UNITED STATES AND EC STATES. AS THE EC MOVES TO CONSIDER MULTILATERAL MEASURES TO CONTROL THE MOVEMENT OF SUSPECTED TERRORISTS IN THE EC AREA, THE U.S. GOVERNMENT STRONGLY URGES THE EC TO TAKE U.S. CONCERNS REGARDING TRAVEL INTO CONSIDERATION BY WORKING OUT MEASURES IN COLLABORATION WITH THE U.S., POSSIBLY INCLUDING THE U.S. (AND CANADA) IN THE AREA WHERE COMMON MEASURES WOULD APPLY.

- 4. THE USG APPROACHES THIS ISSUE ACCORDING TO THE FOLLOWING PRINCIPLES:
- -- MEASURES SHOULD ENTAIL MINIMUM INCONVENIENCE TO NON-TERRORIST TRAVELLERS.
- -- CONTROLS CAN BE EFFECTED THROUGH LOOKOUT SYSTEMS, VISAS AND PORT OF ENTRY CHECKS. WHILE THE U.S. EMPLOYS ALL THREE, WE ARE FLEXIBLE ABOUT THE MIX OF CONTROL MEASURES. HOWEVER, ANY SET OF CONTROLS WILL BE MORE EFFECTIVE IF IT IS APPLIED ON A MULTILATERAL BASIS.
- WE HAVE SUGGESTED THAT MULTILATERAL MEASURES BE DISCUSSED AT AN AD HOC MEETING, SINCE MOST OF THE MEASURES CONTEMPLATED ARE TECHNICAL IN NATURE AND WOULD BE AD REFERENDUM TO GOVERNMENTS.
- -- THE ISSUES WE HAVE PROPOSED FOR DISCUSSION AT AN AD HOC MEETING ARE (1) A MECHANISM FOR EXCHANGING INTELLIGENCE ON THE MOVEMENT OF SUSPECTED TERRORISTS, (2) COMPILING, EXCHANGING AND KEEPING UP TO DATE LISTS OF PERSONS DENIED ENTRY OR EXPELLED FOR REASONS OF TERRORISM, (3) EXCHANGES OF INFORMATION ON FALSE OR FORGED DOCUMENTATION USED BY TERRORISTS, (4) DISCUSSION OF VISA POLICIES, LOOKOUT LISTS AND OTHER SYSTEMS AND TECHNIQUES FOR CONTROLLING THE MOVEMENT OF SUSPECTED TERRORISTS.
- 5. THE U.S. WOULD BE PLEASED TO SEND OFFICIALS TO CONSULT FURTHER WITH THE UK IN ITS EC PRESIDENCY CAPACITY AND OTHER EC MEMBERS ON THE MARGINS OF THE TREVI MEETINGS OR
