EXCERPTS FROM REMARKS BY VICE PRESIDENT GEORGE BUSH TO THE MIDWESTERN REPUBLICAN LEADERSHIP CONFERENCE GRAND RAPIDS, MICHIGAN SATURDAY, JUNE 22, 1985

Good evening.

I know this is a political gathering, and I've got a political speech here that I had planned to deliver tonight.

I'd like to put off the discussion of politics, though, and talk to you for a few minutes about the global epidemic of terrorism. The events of the past week -- ___ people hijacked out of Athens on TWA Flight 847, one of them, a young U.S. Navy diver, brutally beaten and shot; four Marines, two American businessmen, and seven Salvadorans machine-gunned gangland-style as they sat in a cafe in San Salvador; two Australian children killed by a bomb at the airport in Frankfurt, Germany -- these events remind us that we live in a world in which the threats to peace do not come only from hostile governments or menacing armies.

Under the President's leadership, George Shultz, Cap
Weinberger, Bill Casey, General Jack Vessey, Bud McFarlane and I
have met daily to shape our nation's response to the TWA
hijacking and the San Salvador murders. Out of our discussions
at the National Security Council have grown a conviction that we
must redouble our efforts to shape an effective response to the
problem of global terrorism.

Terrorism has always been a difficult problem for free

societies. The terrorist, acting on the basis of some perceived, injustice, or to achieve a narrow political goal, hopes to provoke free societies into personal through uncharacteristic faced with this actions which can then fuel the terrorist cause. The responses available to free societies thus need to be carefully constructed.

Terrorism, as we now face it, has new dimensions. Media attention magnifies every incident. Beyond that, we face the fact that the terrorist is now aided and abetted by certain governments who, by sponsoring, paying, supplying, and training, give the terrorist a range of support which he has not enjoyed before. In the hijacking, which began in Athens, we have seen the capacity of the terrorist strengthened by their ability to receive aid and reinforcements from Beirut.

The free world must respond and respond effectively to the problem. The tradition of coming together goes back to our joint

actions against the Barbary pirate. We can draw encouragement in modern times from the success that countries like Italy and Germany have enjoyed in working meticulously against terrorist movements within their borders.

The President went to Camp David this weekend to get out in the clear air up in those mountains, but of course his responsibilities can never be left behind. I stopped up there this afternoon on my way out here to review with him the messages that he has asked me to deliver to the leaders of seven of our close allies in Europe.

We've all got to work together on this problem. Terrorists respect no boundaries. The innocent everywhere can fall victim without warning. It is the first duty of civilized governments to put in place measures that protect their citizens against attacks of the kind we have seen this past week.

The President has asked me to lead the efforts of the U.S. Government in developing responses to this scourge of terrorism. In all honesty, I cannot stand here this evening and tell you I know the answer, that no American will ever suffer the fact of Ricahrd Stedham in Beirut or those young marines in San Salvador. But I can tell you that the President and I are determined to work with every resource at our disposal to get this problem under control.

It will take cooperation from other governments. It will take firmness on our part in responding to the threat. Those governments that shelter terrorists must understand that the community of nations will respond in concert to reject their criminal behavior and bring it to a halt. Most important of all, we must ensure that terrorists never succeed in destroying our values by the use of fear and brutality.

The President is determined about another thing, too. Even as we pursue every avenue available for securing the return to freedom of the Americans held prisoner in Beirut, we've got to keep this country moving forward.

The Reagan revolution has accomplished a tremendous amount in setting a new course for America over the past four and half years. But we have much remaining to be done.

Right now, the two biggest items on our agenda are tax simplification and getting the deficit under control by cutting spending.

We Republicans have a vision of America and America's future.

And it's not just our vision... it's America's vision, too.

You could see it last year when the Olympic torch came through the country and entire towns turned out to see it pass and to sing "America the Beautiful" as it went by.

You can see it in Hispanic families and Vietnamese families that came to this country with nothing and have shown once more that with hard work and strong values, America is still what it's always been, the land of opportunity, opportunity for people from every corner of the earth.

You can see it in the pride very American feels -- I know I feel it -- I'm proud we have a President who doesn't go around apologizing for America. And who doesn't negotiate with terrorists.

And, yes, I saw it Tuesday night at Andrews Air Force Base.
Richard Stedham and his courageous wife stood at attention as
their 23 year old son came home for the last time, killed in cold
blood for resisting the murders who hijacked TWA Flight 847.

In their love of country, their pride in their son, their support for our President, Mr. and Mrs. Stedham demonstrated the finest in the American spirit.

So, that's our vision of America... an America that's good and free and proud and brave and filled with hope and opportunity for all.

That's our vision and that's what we're fighting to build and preserve.

That vision is why our top priority in Congress this year is tax reform.

The President and I want to bring down the marginal rates and eliminate deductions. It's time that the after-tax income of every man and woman in this country was based on true earnings and not on how clever the accountant was.

At the same time, we must keep shrinking the claim that government makes on our citizens' pocketbooks by cutting spending and the deficit. It was a proud moment for me to be there last month to break the tie when the Senate passed a three year, \$300 billion spending cut package.

America will grow stronger if all of us, all Americans, invest our hopes and dreams and time and money not because there's the shadow of a tax write-off at the end of the tunnel, but because there's something real that produces real goods, real services and real growth, a light of real reward for real effort and of more growth for our economy.

America's growth depends on people who take their hard earned savings and invest in the future. To invest,

particularily to become part of the entrepreneurial tide that has swept away all talk of America's decline and has swept in the admiration of the world... to become part of that tide requires an act of faith... faith in one's own judgment, faith in the product or service you're backing, and, most of all, perhaps, faith in America's future.

To Democrats who feel their party has left theem, President Reagan has said, "Join us." And across the country -- in California and Michigan, in Florida and New York -- men and women of conscience have remembered what John Kennedy once said when asked to support a member of his own party he thought unqualified for office. He said, "Sometimes party loyalty asks too much."

Many Democrats today agree, and so they've come over.

What we're doing is important for the country. It's also important for the world.

On the President's behalf, I've been to 64 countries since becoming Vice President. I've seen a growing respect for the United States over the past five years. Particularly in Europe, I've seen respect and wonder at how strong our economy is, at how many jobs we've created in the last few years, at or fantastic entrepreneurial energy. And I've seen that others want to follow us.

Everywhere -- Europe, Africa, China -- leaders are saying,
"Maybe the Americans are right. Maybe free enterprise really is
best. Maybe freedom really is best."

So you see, our faith and our vision has not just rekindled the light of hope, opportunity and liberty in America. It's rekindling it throughout the world.

This is the duty the President and I feel. This is the duty we Republicans all share. This is our Party's duty.... To keep the light of that faith and that vision shining bright so it can light our country and so that it grows truly to light all mankind.




