Practical Measures Against Terrorism

In preparation for the Summit Seven Experts meeting on terrorism in mid-March, we are attempting to identify practical measures which we are taking—and which we and other governments might take—against states which support terrorism. At this meeting we would like to discuss these sorts of measures and explore common ground for possible joint action. The general categories of action we have in mind are: restrictions upon entry and/or duration of stay and freedom of movement of private citizens and government officials from states which support terrorism; size of diplomatic missions and freedom of movement; restrictions upon experts and imports for commercial and/or military use, etc. We would also welcome any other ideas you might have as to additional actions we should/could take and other actions we should/could propose to others.

The US has designated Cuba, Libya, Syria, Iran and South Yemen as states which support terrorism. We would appreciate your assistance with information and ideas by February 25 in the following areas:

For PM:

Sales of military equipment. What has been the level of US sales to these five states over the past few years? What specific restrictions apply? In addition to forbidding or restricting sales of military equipment, what other sorts of realistic practices might be adopted (licensing, delays in granting licenses, delays in processing requests, etc.)?

Trade. What has been US trade with the five For EB: states over the past few years? What specific restrictions apply? Recognizing that trade boycotts do not work, that we would be unable to sell trade restrictions within our own government and that our allies are unlikely to be uncooperative in most trade matters, what sorts of measures have we attempted at other times in the past or might we propose to the Summit Seven?

For CA and L:

Movement of People. Although we do not have diplomatic relations with any of the five states, some operate interest sections at other Embassies, all have missions at the UN, some of their citizens come to the US for business and studies, etc. What restrictions do we apply to entry and movement? Are there measures which we might take to deny or delay entry to the US, to expel or deport those engaged or suspected of activities contrary to USG interests? We would like to look at possible measures which might be imposed not only against diplomats but also against ordinary citizens who are current residents of the country.

For OFM &

Protocol: Restrictions on diplomats. What sort of restrictions have we placed on diplomats from each of the five countries? What are the sorts of restrictions which might be considered? I am thinking about movement of diplomats, restrictions on where they might live, purchase of property, use of official banking and travel facilities, in short the whole range of actions employed by your office. Since the US does not have a diplomatic presence in most of these countries, might we be in a position to consider the sorts of restrictions which they might place on us if we did have a diplomatic presence?

99th Congress Anti-Terrorism Proposals

There follows a status report on all of the legislative proposals which have been discussed for submission to this session of the Congress.

Proposals on which the State Department has the lead:

ITAR Penalties. Stiffened penalties for violating ITAR regulations are included in the FY 1986 Foreign Assistance Bill (Section 110). The bill, now with OMB, increases the ceiling for criminal penalties from \$100,000 and up to two years' imprisonment to \$1 million and up to 10 years' imprisonment. The ceiling for civil penalties is increased from \$100,000 to \$500,000.

Anti-Terrorism Training. An additional \$5 million authorization, permission to transfer equipment and commodities on the US munitions control list, and repeal of the sunset provision are included in the FY 1986 Foreign Assistance Bill (Section 506), now with OMB.

Foreign Missions Protection. Authority for the Department to provide extraordinary protective services for foreign missions and foreign dignitaries, along with \$6.3 million in addition to the \$7 million for protective services for missions to the UN, is included in the FY 1986-87 State Department Authorization Bill (Sections 105, 106 and 107).

New SY Officer Authorities. SY officers are authorized to conduct investigations, carry firearms, and make arrests related to the security functions of the Department by the FY 1986-87 State Department Authorization Bill (Sections 108 and 109).

Embassy Security Improvement. A request for \$227 million will go to the Hill this week as a FY 1985 Supplemental Request.

Pilot Certification Revocation--Under Review. The proposal to provide the FAA with authority to revoke pilot certifications of those who fly for countries which violate terrorist-related international obligations is still under review. The FAA is apparently having second thoughts about the impact this authority might have on its thus far purely regulatory authority. Terry Arnold is following up with the agency head.

Extradition--Dropped. We will not present an extradition reform bill, as we have concluded that it would not pass the House in acceptable form. Certain bilateral extradition treaties may be amended, however.

Overseas Attacks on Americans--Dropped. We have decided not to seek expansion of criminal jurisdiction to cover overseas terrorist attacks on any American, although Senator Specter may well introduce a bill covering all USG employees, agents, etc.

Training and Support--Dropped. Because ITAR regulations have been expanded to cover certain terrorism-related services, which we estimate will cover 60-70% of our concerns, we have dropped the training and support proposal presented to the Congress last year, and the idea of post-retirement agreements for certain military, police and intelligence personnel. If after a year or so, we find that the new regulations do not meet our needs, we will reconsider the alternatives.

Proposals on which the Justice Department has the lead:

TAGGANTS--Under Review. Justice Department technicians are studying the matter and sounding out Hill staffers. A decision will be made on a proposal in about three weeks.

Controls on Biological/Toxic Substances--Under Review. Justice is interested in the issue and is staffing it. Nothing is imminent.

Mandatory Reporting--To Be Presented. Geoff Levitt has suggested the desirability of mandatory reporting to the FBI by state and local law enforcement agencies of all bomb threats, bombings, etc. We will request a Justice Department reaction to this suggestion.

Conspiracy Gaps--Dropped. The drastically revised criminal code passed last year covered much of our area of concern related to possible anti-terrorist conspiracies hatched in the US for overseas implementation. We have decided to wait a year or so to see how the courts handle certain leading cases.

1. (SECRET - ENTIRE TEXT.)

2. SUMMARY: BRITISH ATTITUDES TOWARD TERRORISM --DOMINATED FOR SO LONG BY NORTHERN IRELAND -- ARE EVOLVING TO MEET THE BROADER MENACE TO WESTERN INTERESTS. THE IMMEDIACY OF THE PROVISIONAL IRA THREAT WILL CONTINUE TO CAPTURE THE BULK OF BRITISH ATTENTION AND RESOURCES (AND TO RANK HIGH ON OUR BILATERAL AGENDA); BUT HMG SOLIDLY BACKS OUR CONCERN OVER THE GROWING THREAT AGAINST NATO TARGETS. THE BRITISH ARE EAGER TO COOPERATE WITH US AND THE EUROPEANS IN BROADER COUNTER-TERRORISM EFFORTS, ALTHOUGH THEY TEND TO PREFER BILATERAL MECHANISMS OVER STRUCTURED, MULTILATERAL RESPONSES. SINCE THE LIBYAN INCIDENT IN ST. JAMES' SQUARE LAST APRIL, THERE HAS BEEN HEIGHTENED INTEREST HERE IN MIDDLE EAST TERRORISM, WHICH THE BRITISH ARE SEEKING TO TRANSLATE INTO EFFECTIVE EC-10 MEASURES. THERE IS ALSO A NEW RECOGNITION THAT, DESPITE THE UNIQUENESS, OF IRISH TERRORISM, IT IS BUT ONE FACET OF A WIDER INTERNATIONAL PHENOMENON. THIS IS A POINT WE HAVE LONG TRIED TO GET ACROSS TO THE BRITISH AND WHICH ST. JAMES' SQUARE SEEMS FIMALLY TO HAVE ACCOMPLISHED. THE BRITISH HAVE WORKED TO IMPROVE HMG'S ABILITY TO COORDINATE AND RESPOND EFFECTIVELY. THERE WILL BE DIFFERENCES OF PERSPECTIVE BETWEEN US -- SUCH AS GEOFFREY HOWE'S STRONG PERSONAL CONCERNS OVER THE LEGALITY OF WESTERN RETALIATION -- BUT, ON THE WHOLE, WE CAN EXPECT COOPERATION FROM LONDON. END SUMMARY

3. NORTHERN IRELAND.

THE PAST SIX YEARS, FROM THE 1979 MURDERS OF AIREY NEAVE AND LORD MOUNTBATTEN TO THE 1984 BOMBING OF THE GRAND HOTEL IN BRIGHTON, HAVE FORCED A FUNDAMENTAL SHIFT IN BRITISH PERCEPTIONS OF THE PIRA/INLA THREAT. A WAR THAT HAD BEEN VIEWED AS A DISTANT TRIBAL CONFLICT WAS TRANSFORMED ULTIMATELY INTO A DIRECT ATTACK ON THE BRITISH CABINET ITSELF. FOR A SOCIETY THAT HAS ALWAYS BEEN CASUAL ABOUT SECURITY FOR ITS POLITICIANS, THE COMMITMENT OF BRITISH RESOURCES IN MEETING THE THREAT HAS BEEN SIGNIFICANT. GOVERNMENT INSTALLATIONS HAVE BEEN ON HEIGHTENED ALERT SINCE OCTOBER, WHILE SECURITY FORCES HAVE MARSHALLED THEIR SURVEILLANCE, FORENSIC, AND INVESTIGATIVE CAPABILITIES TO IDENTIFY THE "SLEEPER SQUAD" PRESUMED TO HAVE CARRIED OUT THE BRIGHTON OPERATION -- SO FAR WITHOUT SUCCESS. 4. THE THREAT TO NATO -- A GROWING BRITISH STAKE.

MEXT TO THE IRISH PROBLEM, OTHER ASPECTS OF TERRORISM HAVE UNTIL RECENTLY BEEN OF SECONDARY INTEREST TO HMG -- FOR SEVERAL REASONS. ISOLATION FROM EUROPE AND SOCIETAL DIFFERENCES MAKE THE UK A SOMEWHAT LESS HOSPITABLE ENVIRONMENT THAN THE MAINLAND FOR OUTSIDE TERRORISTS. ALSO, THE BRITISH HAVE NOT HAD TO COPE WITH THE IDEOLOGICAL SPUR TO TERRORISM THAT PLAGUES THE REST OF EUROPE. THE RED ARMY FACTION, THE RED BRIGADES, AND ACTION DIRECTE HAVE NO COUNTERPART IN BRITAIN. (EVEN THE PIRA, WITH ITS FUZZY MARXIST PRETENSIONS, HAS ITS ORIGINS IN SOCIO-ECONOMIC AND POLITICAL GRIEVANCES.)

5. ALL OF THIS IS BEGINNING TO CHANGE. ANTI-MATO SENTIMENT IN BRITAIN HAS NOT YET MOVED BEYOND THE CIVIL DISOBEDIENCE OF THE PEACE WOMEN AND THE CND, BUT HMG IS ACUTELY AWARE OF THE POTENTIAL FOR CONTINENTAL RHETORIC AND ACTIONS TO SPILL OVER VIOLENTLY INTO THE UK, WHERE HIGH-PROFILE NATO TARGETS ABOUND. 6. WE HAVE BEEN TOLD AT HIGH LEVEL THAT THE BRITISH WILL BE WORKING WITH THE FRENCH. IN PARTICULAR, TO OVERCOME RESERVATIONS ABOUT A "MATO" RESPONSE. THE CHARACTER-OF SUCH A RESPONSE DOES, HOWEVER, RAISE QUESTIONS FOR HMG WHICH IS ANXIOUS TO AVOID CASTING THE TERRORIST THREAT TO NATO IN EAST-WEST TERMS. HMG SEES THE VALUE OF A POLÍTICAL PUSH FROM THE NAC, BUT BELIEVES THAT BILATERAL CHANNELS OFFER THE BEST HOPE OF AGREEMENT ON PRACTICAL ANTI-TERRORIST MEASURES.

7. THE MIDDLE EAST.

HISTORICALLY, BRITISH ATTITUDES TOWARD MIDDLE EAST TERRORISM HAVE REFLECTED A BASIC FCO VIEW THAT THE WHOLE PHENOMENON IS, ULTIMATELY, MANAGEABLE. FCO MIDDLE EAST SPECIALISTS HAVE ALWAYS TAKEN PRIDE IN RESPONDING CALMLY TO THE MOST DANGEROUS SITUATIONS, AND THEY STILL TEND TO BE A BIT SCORNFUL OF SECURITY CONSCIOUSNESS IN MISSIONS ABROAD. THIS RELATIVELY COMPLACENT ATTITUDE STANDS IN SHARP CONTRAST TO THE LONG HISTORY OF MIDDLE EAST TERRORIST ACTIVITY IN THE UK. THAT HAS FINALLY GRABBED THE ATTENTION OF THE FCO'S POLITICAL MASTERS.

- 8. THERE HAVE BEEN TWO SORTS OF MIDDLE EAST TERRORISM IN BRITAIN -- ATTACKS AGAINST DISSIDENTS AND ATTACKS AGAINST DIPLOMATS OR REPRESENTATIVES OF THIRD COUNTRIES (E.G., ABU NIDAL'S ATTEMPT TO ASSASSINATE AMBASSADOR ARGOV). WHILE BRITISH INTERESTS HAVE NEVER BEEN DIRECTLY TARGETED. THE ST. JAMES' SQUARE INCIDENT -- THE FIRST TO RESULT IN THE DEATH OF A BRITISH CITIZEN -- MARKED A WATERSHED IN HMG'S DETERMINATION TO ENSURE LONDON WILL NOT CONTINUE TO ATTRACT MIDDLE EASTERN TERRORISTS.
- 9. IN RESPONSE, THE BRITISH HAVE PRESSED IN EC POLITICAL COOPERATION FOR EFFECTIVE MEASURES IN COMBATTING STATE-SUPPORTED TERRORISM ON THE LIBYAN MODEL. THE BRITISH WOULD LIKE TO SEE THE TEN TIGHTEN UP ON ABUSE OF DIPLOMATIC PRIVILEGES. INCLUDING DIPLOMATIC BAGS AND PREMISES AND OTHER VIENNA CONVENTION ISSUES.

THE DIRECTOR FOR SPECIAL POLICE MATTERS (RUPPRECHT) INTENDS TO VISIT WASHINGTON (FEBRUARY 24-26), OTTAWA, AND TOKYO TO DISCUSS PREPARATIONS FOR THIS MEETING. THE GERMANS ARE WELL AWARE OF THE NEED TO COORDINATE APPROACHES TO THE ISSUE OF TERRORISM IN VARIOUS FORUMS (EC, NATO, SUMMIT SEVEN AND BETWEEN EUROPEAN AND NON-EUROPEAN NATIONS. THE EFFORT AT CLOSER COOPERATION IN EUROPE IS GOING FORWARD AS UNDERSCORED IN RECENT VISITS TO BONN Ex THE INTERIOR MINISTERS OF FRANCE AND ITALY. END SUMMARY.
- 3. ON FEBRUARY 13 EMBOFF MET WITH INTERIOR MINISTRY COUNTER-TERRORISM OFFICE CHIEF SIEGELE TO DISCUSS PREPARATIONS FOR THE UPCOMING SUMMIT SEVEN EXPERTS MEETING. CABLES HAD BEEN SENT FEBRUARY 12 TO FRG EMBASSIES IN THOSE CAPITALS REQUESTING APPOINT-MENTS FOR HIM. RUPPRECHT INTENDED TO BE IN WASHINGTON FOR APPOINTMENTS ON FEBRUARY 25 AND 26. 
