## ACTION MEMORANDUM FOR MR. ARMITAGE

SUBJECT: U.S. reaction to Soviet strategy in Afghanistan

The attached paper makes clear the emergence into the open of Soviet designs and possible forthcoming actions toward the absorption within the Soviet Union of the northern half of Afghanistan. The paper also describes the likely progression of events leading to the "moving southward" of Afghanistan (analogy to post WWII Poland).

When the Soviets may intend formally to annex northern Afghanistan is secondary from the standpoint of a U.S. reaction. The facts on the ground are clear enough, and the most appropriate U.S. response would be to bring those facts and our analysis of them out into the open. Such a move on our part, together with enhanced effective support to the Afghan resistance, should forestall further Soviet progress and contribute to the failure of Soviet strategy in the area.

Actions recommendations:

- The contents of the attached paper should become part of the President's discussion of Afghanistan at the November summit.
- Any public statement on the issue should include a reaffirmation of our support for the territorial integrity and security of Pakistan.
- We should consider initiating discussions with allies likely to support us and denounce what we would describe as our analysis of Soviet actions and intentions in the region.
- I am writing a longer piece based on the attached paper for open publication. A piece going into greater detail should help buttress further what is a strong argument to begin with.
