Dear Ed:

On August 23, 1982, the President of the American Society for Public Administration, A. Lee Fritschler, sent a letter to President Reagan requesting him to establish a National Commission on Crime Control and Administration of Justice Policy. Although it is very likely that you have been informed of this request, I felt it best to follow up to make sure, given your long-standing interest and personal efforts to improve criminal justice. Enclosed with this letter is a copy of the letter Mr. Fritschler sent to the President along with the full text of the ASPA resolution, and copies of letters sent to Chief Justice Burger and Senate and House Judiciary Committee Chairmen Thurmond and Rodino, respectively.

The concept of a National Commission on Crime Control and Administration of Justice Policy originated with the ASPA Section of Criminal Justice Administration on which I serve as an executive board member and White House liaison.

The genesis of the proposed initiative is an outgrowth and reflection of concerns over how best to adjust to changing relations between Federal, State, and local governments and the well-recognized need to achieve effective planning and management of justice system policies, programs, and resources which impact executive, legislative, and judicial branches of Government on an intergovernmental basis. A National Commission on Crime Control and Administration of Justice Policy is another significant way in which the President can demonstrate the Administration's resolve to effectively deal with the Nation's crime problems and improve the administration of justice. It could provide a valuable forum for addressing those problems and conditions which limit or constrain effective intergovernmental relations in the implementation of criminal and civil justice policies and programs. Further, given the broad-based composition of such a commission, it could develop bi-partisan, a-political recommendations to overcome dysfunctions between executive, judicial, and legislative branches of Government which frustrate the achievement of National crime control and justice system improvement goals.

This proposed initiative does not call for a new Federal grant program. It would require relatively little investment of Federal resources, while serving as an important component of the Administration's program to make our Nation's streets safe and its justice systems more effective and efficient. It would complement and enhance the work of the Cabinet Council on Legal Affairs and assist the Department of Justice and Attorney General Smith to achieve the goal of improving coordination among law enforcement and criminal justice agencies at all levels of government. For example, a National Commission on Crime Control and Administration of Justice Policy could provide a National-level counterpart to the Law Enforcement Coordinating Committees which have been established in each Federal district; tackling broader policy and management questions and issues that transcend any one local Federal district.

In July, I provided Michael Uhlmann with a draft of the ASPA resolution and briefed Lowell Jensen on August 2, 1982. Lowell, who remembered me as a staff member who worked with you in California, expressed interest in the initiative and suggested I get in touch with Rudy Giuliani. This I am prepared to do but thought it best to inform you of the initiative first since (1) it would involve the President directly and (2) it is of sufficient importance to warrant White House staff attention given that the recommended membership on the proposed Commission would invite the participation of Chief Justice Burger, and Chairmen Thurmond and Rodino of the Senate and House Judiciary Committees, as well as top-level representation by officials of State and local governments.

If you believe the proposal has merit and would like to expedite its consideration for adoption prior to November 1, I and the members of the Section on Criminal Justice Administration of ASPA stand ready to assist you.

Please excuse the informality of slipping in this note with the preceeding letter on the National Commission on Crime Control and Administration of Justice Policy. I just wanted to tell you how much we all appreciate the outstanding job you have been doing and let you know that I will continue to do whatever I can to help, as I am sure Herb Ellingwood, Mike Uhlmann, Lou Giuffrida, Lois Herrington, and others may attest.

Unfortunately, I still have not heard from White House Personnel about an appointment since Pendleton James letter of December 3, 1980 in response to your forwarding of my vita in November 1980. (Attached are copies of your letter of November 20, 1980, the letter from Penn James and an updated resume).

Both Senator Spector and Congressman Bud Shuster have written in support of my qualifications and interest in serving in the Administration, and Frank Carrington told me that he has mentioned to Ken Crib that I am still able and willing to join the team. Dear Mr. Chief Justice:

The American Society for Public Administration (ASPA) has requested that President Reagan formulate a clear statement of national policy on the prevention, control and reduction of crime. We specifically have asked the president to establish a National Commission on Crime Control and Administration of Justice Policy. A copy of our letter is enclosed for your reference.

Dear Mr. President:

The American Society for Public Administration (ASPA) requests that you formulate a clear statement of national policy on the prevention, control and reduction of crime. We recognize that you and key members of your administration have spoken on this issue, such as your September 1981 speech to the International Association of Chiefs of Police. Specifically, we request that you establish a National Commission on Crime Control and Administration of Justice Policy. We ask that you call upon the Senate and House Judiciary Committees of the Congress and the Federal Judicial Conference under the chairmanship of the Chief Justice of the United States to join you in convening such a Commission. The National Council of ASPA has adopted a resolution on this matter. A copy is attached.

We feel that this Commission should be given authority to review the state of the nation's justice systems and recommend policies, legislation and actions designed to prevent, control, and reduce crime and delinquency and improve the management and operational effectiveness of criminal and civil justice in the United States. The Commission should give special attention to addressing those problems and conditions which limit or constrain effective intergovernmental relations in the implementation of criminal and civil justice policies and programs at federal, state, and/or local levels or which generate dysfunctions between executive, legislative and judicial branches of government in pursuit of common crime control and justice system improvement goals. The statement contains a recommended composition for the Commission.

Our Society recognizes the serious efforts and initiatives which your administration has already taken toward effective crime control, specifically including the Attorney General's Task Force on Violent Crime and the resulting Law Enforcement Coordinating Committees, the Vice President's South Florida Task Group, your recently appointed Task Force on Victims of Crime, and the numerous legislative proposals that have emanated from the Department of Justice. We are also aware that your focus on macro-economic issues has precluded any sizable federal expenditures in support of the traditional criminal justice functions of state and local jurisdictions.

My colleagues and I in the field of public administration believe, however, that a National Commission on Crime Control and Administration of Justice Policy established and convened under your leadership will aid in achieving "new federalism" goals and provide a needed institutional framework for policyplanning, coordination and cooperation among and between the various levels and branches of government responsible for combating crime and administering the nation's justice systems. We recognize the role that major criminal justice interest groups might wish to play in the formation of such a Commission.

At your convenience, I would be most happy to meet with your representative to discuss our proposal and offer the assistance of ASPA to bring about its implementation.

A RESOLUTION OF THE

NATIONAL COUNCIL OF THE AMERICAN SOCIETY FOR PUBLIC ADMINISTRATION ON CRIMINAL JUSTICE ADMINISTRATION

BE IT RESOLVED that the American Society for Public Administration calls on the President and Congress to formulate a clear statement of national policy on the prevention, control, and reduction of crime and delinquency.

BE IT FURTHER RESOLVED that such policy emphasize the high priority assigned by the Administration and the Congress to improve the effectiveness and efficiency of the nation's criminal and juvenile justice systems, to strengthen their role in crime control, and stress the importance of a new partnership between federal, state, and local governments to achieve improved policy-making, decision-making and management of the nation's justice systems. The ultimate success of this new partnership is dependent, in large measure, on the willingness of the federal government to (1) involve state and local governments in the process of formulating and changing criminal justice policies and (2) recognize and productively plan with state and local participation to cope with the intergovernmental consequences of shifts in national priorities and activities on the nation's ability to prevent and control crime and deliquency and improve the effectiveness of the nation's justice systems.

BE IT FURTHER RESOLVED, that the President call upon the Senate and House Judiciary Committees of the Congress and the Federal Judicial Conference under the chairmanship of the Chief Justice of the United States to join with the Administration in establishing and convening a National Commission on Crime Control and Administration of Justice Policy which shall be given authority to review the state of the nation's justice systems and recommend policies, legislation and actions designed to prevent, control, and reduce crime and delinquency and improve the management and operational effectiveness of criminal and civil justice in the The Commission would give special attention to addressing those United States. problems and conditions which limit or constrain effective intergovernmental relations in the implementation of criminal and civil justice policies and programs at federal, state, and/or local levels or which generate dysfunctions between executive, legislative and judicial branches of government in pursuit of common crime control and justice system improvement goals. ASPA recommends that the membership of the National Commission be broadly representative in its make up to include along with the President's Cabinet, Council on Legal Affairs, the Chief Justice of the United States or his designee, and the Chairmen of the Senate and House Judiciary Committees of the United States Congress, the elected officials or chairpersons from the National Governors' Association, the National Conference of State Legislatures, the National League of Cities. U.S. Conference of Mayors, the National Association of Counties, and representatives drawn from criminal justice professions and organizations such as those participating in the recent National Forum on Criminal Justice.
