I. PURPOSE

To continue your dialogue with women Members of Congress on major legislative issues.

II. BACKGROUND

On January 6, 1981, you hosted a similar luncheon at Blair House to establish communication with this group, and to hear their concerns. You suggested at that time that you intend to have an ongoing dialogue with the group, and that "we will do this (meet) again." Today's luncheon is a follow-up on that commitment.

There are currently twenty women serving in the 97th Congress: two Senators (both Republican), and eighteen Representatives (nine Republicans and nine Democrats). Since your first meeting with the group, the seat of former Representative Gladys Spellman (D-Maryland) has been declared vacant due to her prolonged illness.

At the January 6th meeting, remarks were generally of a congratulatory nature with some reference to specific programs such as day care for working mothers, transportation programs, environmental issues, and federal policies which affect the family. Several participants encouraged the appointment of women to positions of responsibility in your new administration.

Since that initial meeting, you have been inaugurated, established the framework of your administration and sent to the Congress an extensive economic recovery program. It is likely that your record thus far may prompt questions on the following topics:

- -- Appointments: You have appointed a number of women to high-level positions in your administration, several of whom are attending this luncheon (see attached list of participants). Nevertheless, there may be some Members who will not be satisfied with the number and the level of appointments thus far. You could pre-empt a challenge here by "challenging yourself" first and citing your efforts to bring more women into the administration, (see Talking Point #4).
- -- Proposed budget cuts: Particularly those affecting job training, medical care, welfare, transportation, and other social programs aimed primarily toward women.
- -- Regulatory Reform: Relaxation of standards for environmental pollution.

Other items of interest to individual Members are outlined in Attachment B.

NOTE: Mrs. Reagan is hosting a luncheon today for Mrs. Anwar Sadat in the Red Room. Republican Congresswoman Millicent Fenwick of New Jersey is also lunching with the First Lady and it is possible that they may drop in.

Also, each guest will receive an appropriate piece of Presidential signature jewelery as a favor from the luncheon.

SUGGESTED TALKING POINTS FOR MEETING WITH WOMEN SENATORS AND REPRESENTATIVES

- -- Welcome your guests. Mention how much you enjoyed meeting with them at Blair House on January 6th, and remind them that you are following through on your promise to get together again.
- -- You also promised to work with Congress and you have been doing just that. Since taking office on January 20th, you have personally conducted 52 meetings involving approximately 373 Members of Congress. This kind of communication is essential to a good working relationship with Congress and that kind of cooperation is what we must have to turn this country around.
- -- Cite some of your major actions since your last meeting: The Inauguration . . . submission of your economic recovery package . . . establishment of the Task Force on Regulatory Relief headed by Vice President Bush . . . Margaret Thatcher visit . . . your trip to Canada.
- -- Mention that you are also in the process of building your administration team. Stress your awareness of their interest in appointing women to high-level positions. Mention that you are pleased with the caliber of women already appointed some of whom are here today but that you are determined to bring on many more women appointees in the weeks ahead. To accomplish this, you have appointed Mrs. Wendy Borcherdt to your Presidential Personnel Offict to work with women candidates.

Page 2 TALKING POINTS

-- Bring up your economic program. Most of the legislators are involved in committee action on your budget proposals. Acknowledge the fact that this will involve some tough decisions and difficult votes, but point out the widespread public support for spending restraint. Encourage them to work with you in holding the line on this issue.

-- Reiterate your interest in working with this group and being sensitive to their concerns. Thank them for coming.
