BRIEF REMARKS: SALUTE TO A STRONGER AMERICA DINNER
NOVEMBER 13, 1981

Thank you, Governor. You know, I am very grateful and the country is very lucky to have so many of your sons of Texas at work in the Administration. They are doing a tremendous job, and all of you can be very proud of them. I just can't figure out why anyone would want to leave this great way of life to work in the Federal Government. Isn't there a song, "Mama don't let your babies grow up to be Presidential appointees"?

You know, I think the reason is they finally found something bigger than Texas -- the Federal bureaucracy. It seems in Texas you never run out of land. In Washington, we never run out of agencies. Or your money.

Seriously, I love Texas and I am glad to have the chance to come out here. Tomorrow, Jim is taking me turkey shooting, and it occurred to me that's a skill I could make use of back in Washington . . . Apparently he's got quite a ranch, and I'm envious of Texas ranches. My spread in California could fit into one of your backyards.

But I'm also glad to be here tonight because I know you believe in what we're trying to do. You worked hard to win the election last year, and I'm here to call on you again. We cannot rest. We must not take our victories for granted. You and I must rally the country, for only together -- united as a people the way we were a year ago -- can we face the challenges ahead of us and triumph.

We need courage. All around us we hear the howls of special interests, and they wail like the wind that whips across the Texas plains. But it is only noise. We need only to recall our vision to renew our courage.

Last fall, in the heat of the campaign, I said: For the rest of this century and into the next, America should be a Nation where freedom is secure -- a Nation of secure freedom. Today we must trust that freedom. We must let freedom work. And we must protect it.

Look around you. There is irrefutable evidence that when people work in freedom their energies and ideas and dedication create a world of prosperity for millions.

Look around you. Yes, we have economic problems. In fact, we are in the worst economic mess this country has seen in 40 years. But this mess wasn't created by trusting ourselves. We made this mess because we were afraid to trust ourselves. For the last 40 years we have been straying farther and farther from the principles of freedom and free enterprise that made this country the greatest, strongest, fairest land of opportunity the world has ever known.

We have problems, but look around. As a people we have much to be thankful for, and I thank God I am an American. What we have, the comparative plenty we enjoy, came from freedom and not from a bewildering maze of Government programs.

This vision of freedom was the central idea of my campaign and today guides all programs and all policies in this Administration.

Today, barely 6 weeks after our program for economic recovery began, the very people who created economic chaos in America are pretending that somehow our problems began in the month of October.

The Democrats who controlled the Congress -- all of its spending and all of its taxing -- for the last 26 years say it's too risky to give our proposals a chance. But what is their alternative? Shall we go back to their programs, the ones that gave us the trillion dollar debt? Shall we go back to their policies that gave us interest rates of 20 percent and higher? Shall we return to the mismanagement that produced back-to-back years of double-digit inflation?

We offer the American people hope. They offer only retreat and despair. We could return to their merry-go-round of spending and taxing and spending and taxing, but, if we do, one day in the not-too-distant future we will destroy all that is good in America.

Is that what the people want?

I think Americans made themselves clear last November at the ballot box. They don't want to hear any more doom and gloom this year from demagogues on a soapbox.

I have asked the Congress to make this Government live within its means. Is breaking the spending habit so impossible? I have insisted that this budget not be balanced on the backs of the taxpayers. Is that unreasonable? I have said before and pledge to you again tonight: I will not sign any bill that abuses the limited resources of the taxpayers. We

are not asking that the people do with any less, we are asking that the Government do with less.

We cannot back off now. A retreat to the status quo will only entangle us further in an economic web that threatens to strangle our people at the moment we most need their energies and their drive to make a better life.

We are not calling for a change of principles, but a return to them. We are not abandoning our poor and our elderly, but opening the trap others have closed them in. We did not lock our people in place on the economic ladder, but we will set them free to climb as high as their ambitions and talent will take them.

I promised when I was running for this office that I would do all within my power to see that freedom would be again the driving force of economic growth in the United States and I will not relent.

The recession that grips us now was created by the oppressive policies of the past. The economic hardships produced by our predecessors make me only firmer in my resolve to change their course. The cries of indignation from special interests make me only more sure we have touched a nerve. I have a message tonight for all who doubt our commitment: We will be firm and we will keep on pressing.

But at the same time we must take no risks with our security. We must end the bickering and indecision that have plagued our defense strategy for the last decade. We can no longer sit on our hands as the United States becomes more and more vulnerable to aggression.

The B-1 bomber and the MX missile system I have proposed must go forward without delay. The bomber we have now is out of date and leaves us with a dangerous gap in our defenses, a gap the B-1 would fill. In a similar way, the hard-silo MX missile system will provide an almost immediate improvement in our strategic defenses as other options not yet available are made ready.

Past administrations allowed our margin of safety to erode because no one could agree on what to do about that erosion. Continued arguing will mean more expensive delays, which mean longer periods of increased danger to this country. I am not willing to take that risk. History has proved again and again that weakness invites belligerence. We will build the B-1 and we will install the MX because this country will remain strong enough to remain free.

To keep America secure in freedom I ask for your continued help, support and prayers. I thank you for all you have done so far, but I call on you for more. I thank you for your sons who labor in Washington, but I'm asking for you. Speak up at work, with your friends and in your families. Talk to your neighbors and write to your Congressmen. Trust in your country and believe in yourselves.

We have waited a long time for this chance to set things right, again. We can't make a mistake now. Our opportunity may never come again.

Thank you very much.

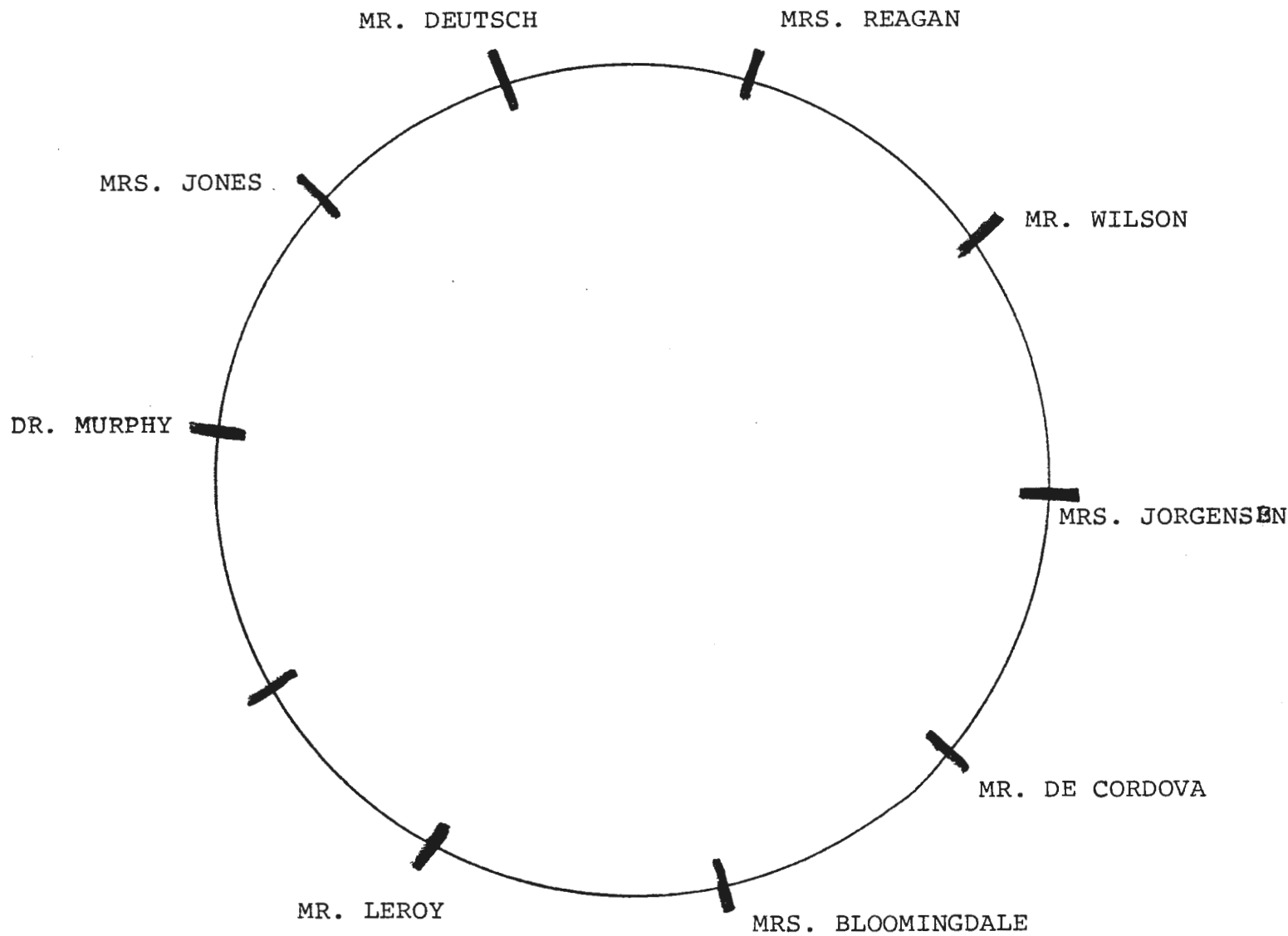
