

REMARKS: NATIONAL PRESS CLUB INAUGURAL, FEBRUARY 10, 1982

Thank you for that warm welcome, Helen and fellow members. It's a real pleasure to pay another visit to this fine, old club where so much history has been made. Tonight, we're making it again with the inauguration of the first woman president in the National Press Club's long history -- after 74 years, it's about time.

Speaking of septuagenarians, I understand that I'm eligible for reduced dues. I've got to have a little talk with your financial secretary about that.

For tonight, though, we have more pressing business. I know I speak for all of my fellow members when I say thank you to our outgoing president, Joe Slevin, for a job well done, and best wishes to Vivian Vahlberg on the office she's about to assume.

I'm only the latest of many Presidents to visit the club. One of my favorites, Calvin Coolidge, dedicated this building. They didn't call him Silent Cal for nothing. Maybe some of you remember the story of how he answered the inquisitive lady -- the one who told Coolidge she'd bet some of her friends that she could get a three-word answer out of him. Old Cal looked her up and down, paused for a moment, and then delivered a carefully-measured response: "You lose."

Well, tonight, nobody loses. The club begins a new era -that's era, not E.R.A. -- and it's also on the threshold of a promising renovation program. I can honestly say that I feel a sense of humility standing here at this moment in the same Page 2

building where Silent Cal laid the cornerstone, Harry Truman played the piano, and Richard Nixon once ate a hamburger.

I'm not going to do any of those things tonight; the cornerstone is already in place, I can't play the piano, and my food-taster took the evening off.

But I am going to administer a pledge of office to Vivian here in what has come to be an informal Oklahoma tradition. Fourteen years ago, Lyndon Johnson was here when Allan Cromley was sworn in for this same office. Al seems to have survived that glorious burden with flying colors. He's here with us tonight -- and he's still bureau chief for the <u>Daily Oklahoman</u>, where Vivian has served with such distinction for the past 11 years.

Actually, I was only second choice for this job; I'm pinch-hitting for Justice Sandra Day O'Connor who had a previous engagement. I understand the oath of office has been revised to fit the special nature of tonight's occasion, so it may sound a bit unfamiliar to some of our veteran members.

Would you please step forward, Vivian? This isn't legally binding, so you don't need to raise your right hand . . .

Dearly beloved, we are gathered together this evening under the slightly bleary eyes of the membership to join together this -- shall we say "newsperson"? -- in unholy matrimony with the office of president of the National Press Club. If anyone knows any reason why this ceremony should not take place, forget it. You've already voted and it was unanimous. The chair having heard no objections, we'll proceed. Page 3

Do you, Vivian, promise to love, honor and obey the constitution of the National Press Club, to cherish it always, in sickness and in health, through deficits and remodeling, 'til politics do you part?

Do you promise to uphold the sacred traditions of the card room, the billiard room and the taproom, and to brave the slings and arrows of outrageous board and membership meetings?

Most of all, do you promise to keep the National Press Club a warm and vital place where writers, reporters and newsmakers meet to formally and informally exchange views, ideas and plain good fellowship -- to maintain what is finest in its past and work to build its future as a major world news center?

If so, please signify by saying "I do."

[Vivian responds]

. . . Gee, I wish the answers at my press conferences were that simple. All right, then, Vivian, as a retired journalist, as a proud member of the National Press Club, and as the chief executive of another Washington concern with deficit problems of its own, I now pronounce you president of the National Press Club.

Do I get to kiss the bride, or do we just shake hands? [Shake hands]

Congratulations, Vivian.


