NACo is holding its annual Legislative Conference in Washington, D.C. on February 20- 24, 1982. NACo has been very supportive of your Federalism Initiative, calling it "a stunning victory for the counties." You met with the NACo Task Force on Federalism on February 11, 1982 in the Cabinet Room.

I. PURPOSE

To discuss with the governors their response to your Federalism Initiative. This is not meant to be a negotiating session.

II. BACKGROUND

This memorandum provides you with (1) some background information regarding the response thus far to your federalism initiative; and (2) the context in which your meetings with the governors will be held next week.

While the meetings with the governors are clearly the most important and will receive the highest media attention, there are several other meetings which will be held in the same time span.

National Association of Towns and Townships.

As you know, you met with the Board of Directors of the National Association of Towns and Townships (NATaT) on Thursday, February 18, 1982. At that meeting, you were presented with a very favorable resolution regarding the New Federalism Initiative. A copy of that resolution is attached. (See Attachment 1)

National Conference of State Legislatures.

The Executive Committee of the National Conference of State Legislatures (NCSL) will be meeting in Washington on Sunday, February 21, 1982. The state legislators have generally been quite supportive of your Federalism Initiative, although their historical position has been that income maintenance programs (including AFDC and Food Stamps) should be the full responsibility of the Federal Government. It is unclear at this time what kind of resolution will be adopted by the NCSL Executive Committee, but we are hopeful that it will contain positive generalities and avoid an outright rejection of the proposed swap.

National Association of Counties.

The Legislative Conference of the National Association of Counties (NACo) will bring approximately 1,500 county officials to Washington beginning on Sunday, February 21, 1982. You will be meeting with approximately 130 members of the Board of NACo on Monday afternoon at 3:00 p.m. Ed Meese will be speaking to them on Monday morning and the Vice President will dedicate their new building on Wednesday. We anticipate that at the meeting at 3:00 p.m. on Monday, Richard Conder, the President of the NACo, will present a resolution to you on behalf of the Board of NACo, strongly supporting your Federalism Initiative.

National Governors' Association (NGA).

NGA is holding its annual winter meeting in Washington, D.C., February 21-23, 1982.

This meeting will receive high media attention. We are working closely with key governors to develop a consensus for a resolution of support from the governors' conference for the Federalism Initiative. NGA's response is crucial. The NGA leadership is trying to avoid a partisan split on this issue.

The governors have restructured their meeting in response to your Federalism Initiative and are devoting approximately 8 hours of discussion to the issue. Rich Williamson and Dave Stockman will brief them on Sunday afternoon, February 21. The governors will hold two two-hour closed sessions to discuss their response. A State Dinner is also scheduled for Tuesday evening, February 23rd.

Most of the governors have expressed support² for the framework you announced in your State of the Union speech. Many have commended you for having taken a bold and imaginative step on the Federalism issue. The governors have expressed some reluctance about the "swap" component of the Initiative. Most are wary and some have expressed opposition. For the last four years, the governors have maintained a policy position in favor of the federalization of medicaid and welfare. They are aware that philosophically you support returning medicaid and welfare to the states. They have

been informed that our "swap" proposal represents a major step by this Administration in their direction. They have been told we expect the governors to respond with their own positive step.

The governors have also expressed concern over the funding sources for the trust fund, specifically the windfall profits tax. They see this as part of a larger issue related to the varying revenue capacities of states to assume program responsibilities.

1. Newspaper articles by Governor Alexander (R-Tennessee) and Governor Babbitt (D-Arizona). They are the lead governors for NGA on the Federalism issue. (See Attachments 2 and 3).
2. A recent New York Times article containing favorable comments from three Democrat governors (Matheson-Utah, Lamm-Colorado, Babbitt-Arizona). (See Attachment 4).
3. A chart listing the issue-by-issue response of the Public Interest Groups and key governors and senators. (See Attachment 5).
4. A letter to you from Senator Durenberger. (See Attachment 6).
5. An analysis of your Federalism Initiative by NCSL/NGA. (See Attachment 7).

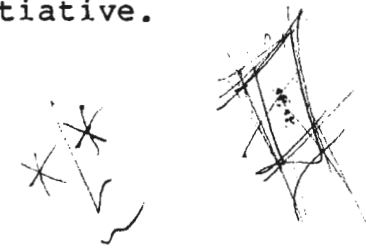

PRESIDENTIAL RADIO REMARKS TO YOUNG AMERICANS ON
GEORGE WASHINGTON'S BIRTHDAY - MOUNT VERNON, VIRGINIA

FEBRUARY 22, 1982

Thank you very much, Mrs. Guy, members of the Mt. Vernon Ladies Association, honored guests, and fellow citizens:

Today, we gather on hallowed grounds to share a special moment in our history. We come to honor George Washington, father of our country, and we are filled with pride and gratitude, knowing that because of what he did we are free and we are Americans.

Two hundred fifty years after his birth, Washington's star shines brighter than ever. "Our cause is noble," he said, "it is the cause of Mankind!" Pursuit of liberty and justice under God is still the most inspiring, the most successful, the most revolutionary idea the world has ever known.

Words alone cannot express how much we revere this giant for freedom. Yes, he is first in our hearts, and he will be first for all time. But as Lincoln said: "To add brightness to the sun, or glory to the name of Washington, is . . . impossible. Let none attempt it . . . pronounce the name, and . . . leave it shining on."

Eighty-five years later Calvin Coolidge would say, Washington's "ways were the ways of truth. He built for eternity. His influence grows In . . . action, in . . . character, he stands alone."

If one word could describe all this man was, and all he meant, it might be -- indispensable. Had he not lived perhaps some other great leader would have appeared to liberate the colonies and establish our Republic. We will never know. We know only that Washington was there, that he did fulfill this destiny, and that he did it with such skill and perfection he seemed to be carrying out a Divine plan for America.

Never a passive leader, never an armchair general, he was always in front of his troops and his Nation. He did more than live up to the standards of the time, he set them.

Washington was gifted with the vision of our future. He dreamed America could be a great, prosperous and peaceful Nation, stretching from ocean to ocean.

He hoped the deliberations at Philadelphia would end with a declaration of our independence. He even designed and presented a drawing of the new American flag to Betsy Ross -- 13 stripes and a circle of white stars on a field of blue.

When the war was going badly, his courage and leadership turned the tide of history our way. On our first Christmas as a Nation, in 1776, he led his band of ragged citizen soldiers across the Delaware River, through driving snow, to a victory that saved the cause of American independence. Their route of march was stained by bloody footprints, but their spirit did not fail. Their will could not be crushed. Washington kept them going, and, with the help of France, they finally battled their way to Yorktown and the decisive victory that ended the war.

After the revolution, he wanted to return here to Mt. Vernon -- to be with his family, to farm, to hunt, to engage in commerce. But he loved his country, and his country needed him. The 13 former colonies were impoverished, they were bickering. They needed a Constitution so they could become a union of sovereign states joined to a central government. This American political experiment was new to all human experience. The world expected us to fail. If Washington had not stepped forward again, first at the Constitutional Convention, then as our first elected President, we might well have failed.

His feats were harvested from the seeds of exceptional character. He lacked higher education but he pulled himself up with years of training and hard work.

He was a man of deep faith who believed the pillars of society were religion, morality, and bonds of brotherhood between all citizens. It has been written that the most sublime figure in American history was George Washington, on his knees in the snow at Valley Forge. He personified a people who knew it was not enough to depend on their own courage and goodness -- they must also seek help from God, their Father and Preserver.

Washington was so popular he could have been King had he wanted to be. He did not. He had no hunger for personal power. His love was liberty, and his trust was in the people. He believed they are dependable and rightminded, and he believed that a leader's responsibility is to bring out their best qualities.

Let us ask ourselves: Are we keeping faith with his trust in us? The problems we face today do not require the kind of sacrifices Washington and his men made that Christmas night on the Delaware. But they do require us to give and sustain our best efforts, to believe in each other, and to believe in the God who has blessed us and will help us rebuild our country.

George Washington and his generation of Americans met their challenge. We can, we must, and we will meet ours.

To the students across America listening in, if Washington seems much larger than life and makes you feel a little smaller, I'll let you in on a secret -- he makes us all feel that way. But you do matter -- a lot. I'm sure he would tell you the important thing is to find your goal -- and go for it. Then, if you fail -- and he himself failed many times -- pick yourselves up and try again.

Remember, our problems are also opportunities. You can take us to new frontiers in space, find medical cures for deadly disease, discover technological breakthroughs, develop better ways to grow food, provide shelter, and produce energy. The world's hope is still America's future. America's future is in your dreams. Make them come true. The only limits are your imagination, and your determination.

As Americans, let us all rededicate ourselves to the ideals George Washington set. Let us give of ourselves, so that when our time is through, history may say of us what Thomas Jefferson said of him: Their integrity was the most pure, and their justice the most inflexible we have ever known. They were, in

every sense of the word, a wise, a good and a great people. I believe we still are. And, because I believe in you, I believe we will be tomorrow.

God bless America. Thank you very much.

1. QUESTION FROM RICHARD CONDER:

The \$30.2 billion funding level for the 43 turnback programs assumes that your Administration is successful in achieving its budget cuts for FY '83. If you are unsuccessful in achieving some of those cuts and the \$30.2 billion amount is increased, will adjustments be made in the trust fund to make up for the difference?

Suggested Answer:

We are committed that there will be no winners and losers under my proposal. If the funding level for the turnback programs exceeds the \$30.2 billion which we project, we will look at ways of increasing the amount of the trust fund or changing the mix of programs to be turned back. I assure you we will not "dump" the federal programs on your backs without the revenue sources to go with them.

2. QUESTION:

There are many states which don't have the capability of picking up the oil windfall profits tax. Are you looking at other taxes which might be used in the trust fund that the states could use?

Suggested Answer:

This is another area where we are flexible and want your advice. States already have excise taxes and it is appropriate that the federal government turn this tax source over to state and local governments. Senator Dave Durenberger has suggested that a portion of the federal income tax be used to help finance the trust fund. This is an idea that I have suggested in the past, and we are carefully considering Senator Durenberger's proposal.

3. QUESTION FROM BILL MURPHY:

Which optional services under the medicaid program will the federal government pick up?

Suggested Answer:

This is another area that we are looking at, that involves many difficult and complex issues. We sincerely seek your advice on this issue.

I. PURPOSE

To discuss with the governors their response to your Federalism Initiative. This is not meant to be a negotiating session.

II. BACKGROUND

This memorandum provides you with (1) some background information regarding the response thus far to your federalism initiative; and (2) the context in which your meetings with the governors will be held next week.

While the meetings with the governors are clearly the most important and will receive the highest media attention, there are several other meetings which will be held in the same time span.

National Association of Towns and Townships.

As you know, you met with the Board of Directors of the National Association of Towns and Townships (NATaT) on Thursday, February 18, 1982. At that meeting, you were presented with a very favorable resolution regarding the New Federalism Initiative. A copy of that resolution is attached. (See Attachment 1)

National Conference of State Legislatures.

The Executive Committee of the National Conference of State Legislatures (NCSL) will be meeting in Washington on Sunday, February 21, 1982. The state legislators have generally been quite supportive of your Federalism Initiative, although their historical position has been that income maintenance programs (including AFDC and Food Stamps) should be the full responsibility of the Federal Government. It is unclear at this time what kind of resolution will be adopted by the NCSL Executive Committee, but we are hopeful that it will contain positive generalities and avoid an outright rejection of the proposed swap.

National Association of Counties.

The Legislative Conference of the National Association of Counties (NACo) will bring approximately 1,500 county officials to Washington beginning on Sunday, February 21, 1982. You will be meeting with approximately 130 members of the Board of NACo on Monday afternoon at 3:00 p.m. Ed Meese will be speaking to them on Monday morning and the Vice President will dedicate their new building on Wednesday. We anticipate that at the meeting at 3:00 p.m. on Monday, Richard Conder, the President of the NACo, will present a resolution to you on behalf of the Board of NACo, strongly supporting your Federalism Initiative.

National Governors' Association (NGA).

NGA is holding its annual winter meeting in Washington, D.C., February 21-23, 1982.

This meeting will receive high media attention. We are working closely with key governors to develop a consensus for a resolution of support from the governors' conference for the Federalism Initiative. NGA's response is crucial. The NGA leadership is trying to avoid a partisan split on this issue.

The governors have restructured their meeting in response to your Federalism Initiative and are devoting approximately 8 hours of discussion to the issue. Rich Williamson and Dave Stockman will brief them on Sunday afternoon, February 21. The governors will hold two two-hour closed sessions to discuss their response. A State Dinner is also scheduled for Tuesday evening, February 23rd.

Most of the governors have expressed support for the framework you announced in your State of the Union speech. Many have commended you for having taken a bold and imaginative step on the Federalism issue. The governors have expressed some reluctance about the "swap" component of the Initiative. Most are wary and some have expressed opposition. For the last four years, the governors have maintained a policy position in favor of the federalization of medicaid and welfare. They are aware that philosophically you support re-turning medicaid and welfare to the states. They have

been informed that our "swap" proposal represents a major step by this Administration in their direction. They have been told we expect the governors to respond with their own positive step.

The governors have also expressed concern over the funding sources for the trust fund, specifically the windfall profits tax. They see this as part of a larger issue related to the varying revenue capacities of states to assume program responsibilities.

SUGGESTED TALKING POINTS

- As you know, I have a long-held commitment to federalism. I have been calling for a restructuring of governmental responsibilities from the beginning of my first term as Governor of California.
- I know that in recent years the National Governors' Association has maintained a policy position calling for the commencement of a "sorting out" process between the state and federal governments.
- As you know, in my State of the Union Address, I announced a framework for a Federalism Initiative. I meant that announcement to represent the opening of a dialogue between state and local officials and, in particular, the nation's governors, with this Administration.
- The Federalism Initiative ranks with the highest priorities of my Administration. You have my commitment that I will focus as much of my attention this year on the Federalism Initiative as I did last year on some of our key budget proposals.
- I want to emphasize to you that the Federalism Initiative is not a budget cutting device.

- It is my intention that the Federalism proposal be a dollar for dollar exchange of programs and responsibilities. The program must be designed so that there are no winners or losers among the states. Realistically, that is the only way this program will have your support and will have a chance of being passed by Congress.
- I would hope that this issue would not become embroiled in partisan confrontation. I will work to prevent that from happening, and I will not be diverted from that goal.
- After my State of the Union speech, there were many comments made which implied that the states could not be trusted with added responsibilities. I find that suggestion unacceptable. In fact, I believe the governors of this country deserve much better treatment on this point than they are receiving.
- I know there may be some areas of the Federalism proposal where we differ. I do believe, however, that the proposal I announced is a step in your direction, a step toward many of the policy changes you have been calling for, and a step toward the added responsibilities you have been requesting. I am interested to hear your comments.

SUGGESTED TALKING POINTS
ON THE PRIVATE SECTOR INITIATIVE
AND INTRODUCTION OF BILL VERITY

- I have been concerned with the role of the private sector in our society.
- I have received reports on some of the initiatives some governors have already made in the area of voluntary action programs and private sector activities. Your progress is encouraging.
- As many of you may have already heard, I have appointed a Task Force on Private Sector Initiatives. This Task Force will be trying to focus public attention on the need for encouraging the private sector to work as a partner with public officials.
- My experience as the Governor of California taught me that there is much that can be accomplished by a governor in this area as "first citizen" of his state.
- I have asked Bill Verity, whom I have appointed Chairman of my Private Sector Task Force, to make a few remarks on this subject.
- Bill, I have to leave now, but I am sure that you will find this a useful opportunity to speak to the governors.
