TALKING POINTS FOR THE PRESIDENT FOR BETTER HEARING AND SPEECH MONTH VISITORS

- --Americans with hearing and speech problems are lucky to have Greg Hill and Nanette Fabray represent them for Better Hearing and Speech Month. Because of the outstanding contributions Nanette has and is making to the needs of the disabled, I was pleased to reappoint her to the National Council on the Handicapped. When Greg gets a little older, I'll appoint him to a government council also.
- --Over 22 million Americans have speech or hearing disabilities. There's much that can be done about these problems, and that is why the work Greg, Nanette, the Council for Better Hearing and Speech, and its 23 sponsoring national organizations is so important. Maybe one day one of these organizations will develop a solution to Greg's problem. And it just won't be Greg, but Sally, John, Mary and thousands of others with similar disabilities will be the benefactors.
- --I am pleased to help you inform the public about what your group is doing on what yet has to be done.
- -- Among the recent advances made to benefit the hearing handicapped, one most closely affects my Administration. Through close captions, or subtitled television, all of my speeches since I took office have been made instantly available to those who cannot hear. I feel proud knowing that, when I address the nation, I can reach all of its citizens.
- -- Just as we strive to give the mobility disabled equal access

to places, we must do everything in our power to bring equality of information to the hearing impaired. We look to this country's powerful television industry to support the close captioning service and we hope for the day that all programs will be acceptable to hearing impaired citizens.

I. PURPOSE

To be introduced to Professor Giovanni Pinto, President of Italcable, the communications network of Italy, and Italcable/USA.

II. BACKGROUND

In his position as President of Italcable and Italcable/USA, Professor Pinto is a prominent Italian businessman who is responsible for the entire communications network (including cable and satelite) in Italy.

Italcable/USA intends to make substantial investments in America. Mark Fowler, Chairman of the Federal Communications Commission, has had a lengthly meeting on this subject with Professor Pinto.

There is a strong possibility that Professor Pinto will be named President of the STET Group, which is the largest holding company (with assets over \$100 billion) in Italy.

Professor Pinto is a member of the Christian Democratic Party. He does not appear to be opposed or out of favor with either the Socialist or the Democratic Parties in Italy.

Italcable is the only communications network in Italy. It was started in 1921.

Professor Pinto has met Vice President Bush.
