PURPOSE I.

To indicate strong Presidential support for the House/Senate tax bill conference and to ask these Members to vote for the conference report.

II. BACKGROUND

Congressman Coughlin, who represents suburban Philadelphia and is a member of the Appropriations Committee, is serving his 7th term. If the tax bill is perceived by the public as tax reform legislation, i.e., that it corrects inequities which currently exist, Congressman Coughlin has indicated a willingness to support the tax package. The Congressman attended a White House Republican group meeting on the tax package on August 9, 1982. Coughlin was one of three Republicans who switched their votes to insure passage of the Administration-backed nuclear arms resolution, which the President personally acknowledged in a telephone call to the Congressman.

Congressman Clinger, who like his colleague, Coughlin, switched his nuclear freeze vote to support the Administration, is leaning in support of the tax package. He has expressed some specific displeasure over dividend withholding, but it is not an overriding issue. Clinger attended Tuesday's White House Republican group meeting on taxes with the President. The Congressman is serving his 2nd term and represents the 23rd District (north-central Pennsylvania). He is a member of the Government Operations and Public Works and Transportation Committees.

BACKGROUND (cont'd)

Congressman Dougherty, who represents part of Philadelphia and is serving his 2nd term, is leaning in favor of the tax package. His concerns are with the spending reductions of the bill. He met with the President on the tax bill on August 9, 1982. The Congressman is a member of the Armed Services and Merchant Marine and Fisheries Committees.

Congressman Erdahl represents the 1st District of Minnesota (southeastern) and is in his 2nd term. He currently is leaning in favor of the tax bill. He has expressed concern over the dividend withholding provision though he admits he is only superficially familiar with that and other specifics of the bill. The Congressman is a member of the Education and Labor and Foreign Affairs Committees.

Congressman Railsback is undecided on the tax bill. He has expressed no specific concerns. Railsback was defeated for re-election in the Illinois Republican primary. He represents the 19th District of Illinois (northwest) and is serving his 8th term. The Congressman is a member of the Judiciary Committee.
