PRESIDENTIAL REMARKS: BRADY TRUST LUNCHEON
THURSDAY, SEPTEMBER 23, 1982

Well good afternoon, Nancy and I are delighted you could all come and be with us for what I know we all agree is this wonderful, worthy cause -- The James S. Brady Presidential Foundation.

As you know, the foundation will honor Jim in recognition of the tremendous sacrifices he and Sarah and their family have made. It will also provide assistance to other needy individuals wounded or killed in an assassination attempt on national figures, and will provide assistance to the individual's family.

Now these good things don't just happen. They depend on the active support of fine people like yourselves, who have worked hard, and on the leadership of the Foundation's Nonpartisan Board of Directors. I won't name all the members, but I do want to pay a special tribute to three particular individuals:

Jim Lynn, President of the Foundation; and the two
who are co-chairing the fundraising effort -- Joe Rodgers and Bob
Strauss. Now since Bob and Joe are both such good numbers men,
and since this is election season, I confess I got a little
nervous. So I've made them promise me on their honor there won't
be any fundraising funny business.

I'm also delighted to tell you that Nancy will assume, with great pleasure, the position of honorary chairman of the Foundation.

You know at the first reception marking the formation of this Foundation, I said that it seemed to me that Jim Brady has connections in some very high places. He had been out at the Old Timer's Baseball game the night before, and it was raining. But when Jim was introduced, it stopped raining.

Well do you know that now he's gone back home to Chicago and pulled off another miracle? On Monday night, he went to see his favorite team and mine -- the Chicago Cubs. And after Jim threw out the first ball, the Cubs actually went out and won their game, and now they're only 19 games out of first place.

But maybe the best way to describe the effect Jim Brady has on people is to read you a letter I received from Mrs. James H. Terrell of Alexandria, Virginia, a few months ago. Her son John had heard about what we're trying to do, and although he's only nine, he wanted to help. So he decided to go out on that bike path along Mount Vernon Highway and sell lemonade for ten cents a cup to raise money.

His mother wrote: "On Sunday, April 18, 1982, young John Terrell enjoyed selling lemonade or fruit punch to the many thirsty bicyclers on the bike trail. His goal was to help Mr. Jim Brady financially. His efforts collected the enclosed \$37.00, by ten cents a cup, plus a few tips. Please accept John's love gift for Mr. Brady. John is a 4th grade student at Hollin Meadows School," in Alexandria.

You know, I just want to say that it's this kind of spirit that makes America the greatest country in the world. And Jim, if you're watching, I think John's sign says it all about the love America feels for you and how all of us are praying for your continued recovery.

Again, thank you all very much for helping to make this foundation come true and for enabling it to provide assistance to those in need.

SUGGESTED TALKING POINTS FOR MEETING WITH CEO'S/PRIVATE INDUSTRY COUNCIL CHAIRMEN

- -- Thank you all for coming today. This is quite a distinguished group of successful people.
- -- We brought you here for two reasons. The first is to personally thank each of you for your efforts last summer finding and funding private sector summer jobs for youth. The second reason is that I want you to know that this Administration is committed to giving this private sector project all the support we can next summer.
- -- I understand that you will be hearing more about this later on today. We welcome your support.
- -- I have always felt that a young person's first experience with a private sector summer job provides an excellent opportunity. I'm sure all of you agree.
- -- That's why I went to New York City last January to help David Rockefeller and Bill Spenser kick off their summer jobs program. I know you will hear a little more about their successful efforts later, but I hope I don't steal any of their thunder by saying that it was their personal leadership which made the program so successful.

- -- You have all heard us talk about private sector initiatives and partnerships. Well, we had a pretty successful partnership this summer with the National Alliance of Business. At John Filer's suggestion, I wrote the 5,000 largest corporations and asked their CEO's to work with the National Alliance of Business and their Private Industry Councils to make the hire-a-teenager program a success.
- -- I understand many new programs were started, but much more can be done.
- -- Finally, we didn't invite you here today because you don't know what needs to be done. We invited you here today to work with the National Alliance of Business and the White House to help encourage other business and private industry councils to follow your lead.
- -- You can be our ambassadors for private sector summer jobs.

 Let's do a bigger job next year.

⁻⁻ Now, before I have to go, I'd like to say a few more words about the National Alliance of Business and its Chairman John Filer. John has served as Chairman of the NAB for 3 years. His service and dedication are a tribute to this spirit of voluntarism in corporate America and to his personal commitment to the concept of corporate social responsibility which he has articulated so well for many years.

PRESIDENTIAL REMARKS: COALITION OF HISPANIC MENTAL HEALTH AND HUMAN SERVICES ORGANIZATIONS THURSDAY, SEPTEMBER 23, 1982

Good afternoon and welcome to the White House. I want to thank you for letting me be part of this program honoring five very deserving young people, and also for supporting the fine efforts of COSSMHO's (COSMO's) National Hispanic Youth Institute. Your work is a model for community projects that can make a real difference to the future of our country.

First, to these five young people and to all of you, I'd like to say: Mi casa es su casa. Of course in this case it really is su casa. It belongs to you and all Americans and we are happy to have you with us today.

Today, of course, we focus on youth, our Nation's most precious resource. The future of our Nation will be determined, more than anything else, by the character of our children. And particularly significant is the role Hispanics are playing in shaping the future of America. The make-up of your community is the most youthful of any American ethnic group -- over 50 percent are under age 25. So the guidance and inspiration you offer is even more significant.

The fine young people we honor today are wonderful examples of the values and traditions for which your community is known. Their families, their country and their President are proud of them.

--- Miss Felicia Martinez (Mar-tee'-nez) for example -- Felicia come up here. Felicia is from Tucson, Arizona, where she is a

senior at Salpointe Catholic High School. She is in the honor society as well as the speech and Red Cross clubs. Felicia is active in her church, and has served as a receptionist at St. Augustine's Cathedral. She is an accomplished speaker, having spoken before the Hispanic Youth Forum and various community programs. When writing about her future she explains:

"I plan to go into pediatrics. I am choosing this career because I love children, I am interested in medicine and I enjoy helping others."

Well, Felicia it is a pleasure to recognize you today as an outstanding young person and fine example to other Hispanic youth.

Also with us is Hemesio (ee-may'-sio) Rosado, Jr. He tells us his friends call him Junior, so if it isn't too presumptuous, I'll just include myself as one of your friends.

Born in Puerto Rico, he graduated from Charlestown High
School in the Boston area and is now on active duty in the United
States Navy. He is studying to become a fire control technician
and is learning how to work sophisticated electronic equipment.
He has always been close to his family, particularly his
grandparents, whom he credits with instilling in him a deep
respect for religion.

Writing about himself he says:

"What makes me happy is having a good time with my friends and spending holidays with my family, and getting good news because when I have a rotten day I need something to cheer me up."

I know exactly how you feel . . . as for the future, he writes:

"I want to finish my four years in the Navy, then put to use what I learned because I want to be able to support a family . . . Plus I want to be able to help my mother."

Well, Junior, it's a pleasure for me to recognize you today. You are an outstanding young person and a fine example to the Hispanic youth of this country.

Next we have with us Kennedy De La Pena from Albuquerque,
New Mexico. He told us in a letter that his full name is
actually Kennedy Richard De La Pena because his father was a
Republican and his mother a Democrat. Now I wonder if Nixon had
won the election in 1960 just what your first name would be.
Well, Kennedy, we are proud of you. This young man is currently
enrolled in New Mexico State University and is working toward a
degree in Business Administration. Over the years he's had a
number of jobs ranging from selling chili to janitorial work and
clerking. On top of all of that he has been a volunteer helping
at non-profit church bingo for the last seven years.

In high school he was a captain of the soccer and basketball teams.

Of his goals he writes:

"My current goal is to receive a degree in Business

Administration. My long term goal is to run for public office

and win!!! My prime goal is to be happy and content and to help

others be the same."

Well, you are a fine young man and we are happy to honor you today.

Then we have Sheila Renee Ortiz from Oklahoma City. She is from a military family so she moved around a lot in her younger years. Still she managed to make the honor roll in school as well as being in the student council and serving as junior and senior class president. Sheila was active in basketball and volleyball. Her favorite subject is history because she says:

"I was always interested in what happened in the past and how America became what she is today."

Today Sheila works in a grocery store and plans to take college courses in the fall. In her letter she wrote:

"I hope President Reagan thinks I'm a good example of Hispanic Youth."

Well Sheila, I certainly do and I'm proud to have you with us today.

Finally there is Rodolfo Rene Fuentes of Weslaco, Texas, currently a junior in high school and in the top 10 percent of his class. Simultaneously while going to high school this young man is enrolled as a freshman in Pan American University and plans to have completed 30 hours of college credit by the time he graduates from high school.

In high school he's been active in debate, football, drama and track. He's an officer on the Student Council and is a member of Christian Athletes, the National Honor Society and the Catholic Youth Organization.

Outside of school activities, Rodolfo is a captain of a volunteer ambulance unit.

Of the future he writes:

"My personal goal is to develop into an effective leader . . . At present my interests are not focused on one specific career, nevertheless I've rounded the field to three: medical, judicial, or political."

Well, you are certainly developing yourself into an effective leader and we are proud to honor you today.

I would like to congratulate all five of you for all you stand for. Because of your courage and hard work you are not only bettering your own lives but offering other young people examples of what they can accomplish.

I'd like to thank again the members of COSSMHO (COSMO) and all of you here today for doing your part in a very worthwhile program and I wish you the best of luck at the festivities tonight. Gracias to all of you, especially to these wonderful young people. And vaya con Dios.

NOTE FOR THE PRESIDENT:

After your remarks, Rodolfo Sanchez (director of COSSMHO), will present to you and Mrs. Reagan the gift of a painting entitled "El Cuentista" -- "The Storyteller".

Mr. Sanchez points out that the painting, which depicts an old man sharing his wisdom with young children, symbolizes the regard for family unity characteristic of the Hispanic culture, COSSMHO's desire to promote intergenerational sharing, and the importance of any program which works to bring generations together, for example, foster grandparents or drug counseling programs.

The painting is the work of Amado Pena [peen'-ya], a well-known artist whose recent works include a print in celebration of Hispanic Heritage Week, 1981, entitled "La Familia". Mr. Pena will be in attendance at the reception.

V. SEQUENCE OF EVENTS

After brief introduction and pleasantries, the interview proceeds.
