

The receiving line will come from the south door of the East Room into the Green Room; guests will each sit in a chair opposite THE PRESIDENT by the fireplace, be photographed, then depart the Green Room via the Cross Hall doors.

4:00 p.m.

THE PRESIDENT arrives the State Floor via the elevator and proceeds to the East Room where he is announced.

He continues to the podium on the east wall and makes brief remarks.

Following THE PRESIDENT'S remarks, he proceeds from the East Room to the Cross Hall and into the Green Room, where he will be seated in a chair to the left of the fireplace as one is facing the fireplace.

The receiving line will begin immediately. As guests depart the Green Room, they may exit the State Floor via the Grand Staircase or North Portico.

5:00 p.m.

At the termination of the photography session, THE PRESIDENT departs the State Floor via the elevator.

VIRGINIA - POLITICAL BRIEFING

I. SUMMARY

Republican U.S. Congressman Paul Tribble holds a narrow lead in his race against Democrat Lieutenant Governor Dick Davis in the Virginia U.S. Senate contest. A poll published by The Richmond Times-Dispatch on Sunday, September 26, 1982, showed Tribble with a 38% to 34% lead over Davis. Tribble, 35, has served three terms in Congress representing Virginia's 1st Congressional District which is made up of the Atlantic Tidewater region of the state. Tribble was one of the first members of Congress to endorse the 1980 Reagan Presidential candidacy. He has been a strong supporter of the Administration's economic program, and is a co-sponsor of the Balanced Budget Amendment. Democrat nominee Dick Davis, a 61-year-old millionaire mortgage banker and former mayor of Portsmouth, was elected Virginia's lieutenant governor in 1981. Tribble's campaign is seeking to make the race a clear-cut choice between Tribble the conservative and Davis the liberal. Davis on the other hand, is softening his once harsh denunciation of "Reaganomics," and is portraying himself as an experienced businessman from the mainstream of Virginia's Democrat Party.

Although the race is tight, it remains one of the best Republican opportunities to gain a U.S. Senate seat this year.

Nine of Virginia's ten U.S. House members are Republicans. Three Republican incumbents seeking re-election face strong Democrat opposition: Bob Daniel (4th District), Stan Parris (8th District), and Frank Wolf (10th District). In the 1st District race to succeed Republican U.S. Senate nominee Paul Trible, Republican state Senator Herb Bateman is leading. In the 6th District race to succeed retiring Republican Congressman Caldwell Butler, Republican state Delegate Kevin Miller is running neck-and-neck with Democrat James Olin. Republican Congressman Tom Bliley, whose 3rd District includes Richmond, is heavily favored to win re-election.

Republican John Warner, Virginia's junior U.S. Senator, was elected in 1978. In the Senate, he has been very articulate in his support of the Administration. Warner, who was Secretary of the Navy in the Nixon Administration, serves on the Armed Services Committee where he is a strong advocate of the Administration's defense policies.

Democrat Governor Chuck Robb, Lyndon Johnson's son-in-law, was elected Virginia's Governor in 1981 over Republican state Attorney General Marshall Coleman by a 54%-46% margin. Robb succeeded Republican Governor John Dalton, who was ineligible to seek a second consecutive term.

In 1980, the Reagan-Bush ticket carried Virginia by a 53% to 40% margin.

V. DISCUSSION

A. THE U.S. SENATE RACE - 1982

Republican U.S. Congressman Paul Trible and Democrat Lieutenant Governor Richard Davis are locked in a tight race to succeed retiring Independent U.S. Senator Harry Byrd, Jr. If Trible is successful, he will join fellow-Republican, U.S. Senator John Warner, helping to strengthen the Republican majority in the U.S. Senate.

Congressman Trible has been seeking election to the U.S. Senate for more than a year. He announced his candidacy even before Senator Byrd decided not to seek re-election last November. Byrd's decision to retire after 17 years in the Senate gave Trible's candidacy a boost, clearing the way for Trible to attract conservative Democrats and Independents who have been Byrd loyalists in past elections.

Trible represents Virginia's 1st Congressional District which takes in the Atlantic Tidewater region of the state. Trible was first elected to Congress in 1976, at the age of 29, in a district that had been considered safe Democrat territory. He was the first Republican elected to Congress from Tidewater Virginia in this century. In his first term, Trible reached beyond his conservative middle-class base to build support among blue-collar workers and blacks. His successful work in promoting this district's shipbuilding industry helped him win a second term in 1978 with 72% of the vote. By 1980, Trible's position in the 1st District was so strong that the Democrats did not even field a candidate

against him.

Trible was an active member of the "Core Group" which was made up of early Congressional Reagan supporters during the 1980 primary campaign. In Congress, Tribble has consistently supported the Administration's legislative agenda, and is a co-sponsor of the Balanced Budget Amendment.

Tribble's Democrat opponent, Lieutenant Governor Dick Davis is a millionaire mortgage banker, who has served as mayor of Portsmouth and as Virginia's Democrat State Chairman. Governor Chuck Robb's hand-picked choice for the Democrat U.S. Senate nomination had been state Delegate Owen Pickett. However, Pickett withdrew from the race in May after party liberals refused to support him. At the Democrat convention in June, only 5 months into his term as Virginia's lieutenant governor, Davis emerged as the Party's consensus candidate for the U.S. Senate.

Despite Tribble's early organizational and financial advantages, the race has remained close. At the end of June, campaign expenditure reports showed Tribble with a substantial fundraising advantage over Davis. Tribble had been building a campaign organization, headed by Judy Peachee, a former Intergovernmental Affairs Assistant at the White House, since the beginning of the year. Davis, on the other hand, had not been a candidate until the eve of the Democrat Convention in June.

Throughout the summer months, however, Davis gained widespread media attention, taking the offensive against Tribble. Instead of concentrating his efforts on national issues, Davis has concentrated on attacking Tribble's "poor attendance record in the

House." Davis claims, without dispute from Tribble, that the Republican Congressman missed 78 of 321 roll call House votes since announcing his Senate candidacy.

During August much of the campaign media coverage focused on a Tribble campaign memo which alleged that Davis staffers had solicited labor contributions at a New York meeting of the AFL-CIO's Committee on Political Education (COPE). Davis' campaign immediately denied any such connection with labor, and criticized Tribble's "dirty campaign tactics."

In late July, a Peter Hart poll conducted and leaked to the press by Davis' campaign showed Davis leading Tribble by a 38% to 33% margin. A Lance Tarrance poll conducted for Tribble's campaign in early August showed Tribble leading Davis by a 30% to 24% margin. A number of newspaper articles have recently appeared claiming that the Tribble campaign "has not caught fire."

On Sunday, September 26, 1982, a poll published in The Richmond Times-Dispatch, showed the race still extremely close. Tribble leads Davis by a 38% to 34% margin. The poll was encouraging to the Tribble campaign, as it was conducted after "Davis' hard-hitting offensive" against Tribble's campaign tactics.

Tribble and Davis met in the first of two scheduled debates on Saturday, September 25, 1982. In the debate, the two candidates stressed the issues which are likely to be the focal points of the campaign's final five weeks. Davis continued to attack Tribble's "vicious" campaign tactics; he again pointed to Tribble's "low voter participation in the House;" and he attempted to portray himself as a conservative, emphasizing his business background. Tribble went

on the offensive, warning that Davis was a liberal who would oppose Reagan Administration policies and promote "the bankrupt, tax-and-tax, spend-and-spend policies of the past."

Although the Davis campaign has picked up momentum in fundraising, Tribble is still expected to have a 2-to-1 advantage. Current estimates are that Tribble has raised about \$1 million to Davis' \$500,000. Tribble's campaign will invest heavily in television advertising during the final weeks of the campaign. Besides stressing his own conservative views, major emphasis will go to the theme "putting Virginia first." Tribble claims that his Washington experience, along with his close association with the Administration will help direct federal money to Virginia, creating new jobs.

Any feelings of overoptimism that Tribble's campaign may have had last June are gone. The reality has set in that Davis is a formidable foe who is capable of upsetting Tribble.

B. THE U.S. HOUSE RACES - 1982

The size of Virginia's 10-member U.S. House delegation was unchanged by reapportionment.

Republicans face a formidable task in retaining their 9-Republican 1-Democrat domination of the state's U.S. House delegation. Northern Virginia's two freshman Republicans, Frank Wolf and Stan Parris, face difficult re-election challenges. In the 8th District, which includes Alexandria and parts of three suburban Washington counties, Stan Parris faces his third race against liberal Democrat Herb Harris. Republican Parris was

elected to Congress in 1972, then defeated by Harris in 1974. In 1980, Parris waged a successful comeback campaign, and defeated Harris by a narrow 1,100 vote margin. The Parris-Harris, conservative-liberal re-match is expected to be extremely close. In the 10th District, which takes in Arlington and surrounding suburbs, Republican Frank Wolf faces liberal Democrat labor attorney Ira Lechner. Lechner, a twice defeated Democrat candidate for lieutenant governor and a former state legislator, is getting substantial help from high-powered Democrats. Wolf, who has supported the major objectives of the Administration in the House and has done a good job representing the concerns of his suburban Washington constituency, is considered slightly ahead in his race for a second term.

A third Republican facing a tough re-election battle is five-term incumbent Congressman Bob Daniel in the 4th District (southeast corner of the state). Daniel's Democrat opponent is state Delegate Norman Sisisky, a moderate with connections to conservatives in the district. Sisisky is well-financed and is challenging Daniel in a district which has a 40% minority population. This race will be close.

Competitive House races are taking place in Virginia's two open districts. In the 6th District, where Republican incumbent Caldwell Butler is retiring, Republican state Delegate Kevin Miller faces liberal Democrat James Olin, a former General Electric executive. Olin is from Roanoke, the district's largest city, while Miller's base is in less-populated Harrisonburg. Most observers currently rate this race dead even.

The other open race is in the 1st District, where Republican incumbent Paul Tribble, is running for the U.S. Senate. Republican state Senator Herb Bateman, helped by Tribble's popularity in this district, is expected to defeat Democrat John McGlennon.

Congressman Tom Bliley, a freshman Republican, represents Virginia's 3rd District which includes all of Richmond. Bliley is heavily favored over Democrat Richmond Supervisor John Waldrop.

Republican incumbents William Wampler (9th District) and Kenneth Robinson (7th District) are expected to win re-election without major difficulty.

Seven-term incumbent Congressman William Whitehurst, the senior Republican in Virginia's U.S. House delegation, is unopposed for re-election in the 2nd District.

The state's lone Democrat U.S. House member, conservative Dan Daniel, is unopposed for re-election to an eighth term in the 5th District.

SENATOR JOHN WARNER (R-VIRGINIA)

Senator John Warner was born on February 18, 1927. He joined the U.S. Navy at age 17, served in the Navy from 1944-1947, and then attended Washington and Lee University, graduating in 1949 with a degree in engineering. Following graduation, he began law school, but shortly thereafter volunteered for active duty in the Marine Corps. After serving in Korea, he returned to the University of Virginia Law School in 1952 and received his degree in 1953. Senator Warner was in private law practice from 1954-1956 and from 1960-1969. From 1956-1960, he served as a U.S. Attorney. Senator Warner was Under Secretary of the U.S. Navy from 1969-1972 and Secretary of the Navy from 1972-1974. Between April 1974 and October 1976, Warner served as the Administrator of the American Revolution Bicentennial Administration. He is the owner and operator of Atoka Farm (a cattle farm) in Middleburg, Virginia.

Warner was elected to the United States Senate in 1978 and will be up for re-election in 1984. He serves on the Armed Services Committee, and is Chairman of the Subcommittee on Strategic and Theater Nuclear Forces. In addition, he is a member of the Energy and Natural Resources Committee and the Rules and Administration Committee. He also serves on the Joint Committee on Printing.

Senator Warner has three children: Mary, Virginia, and John.

PAUL S. TRIBLE, JR.
(Republican - Virginia)

Representative Paul Tribble represents the First District in Virginia (east central Virginia) and is serving in his third term. He is a member of the House Armed Services Committee and the House Budget Committee.

One of the President's House "Core Group" members, Paul has been an active supporter of the economic recovery program and a staunch advocate of the Administration's national defense initiatives. He is running for the U.S. Senate seat becoming vacant as a result of the retirement of Harry F. Byrd (Independent - Virginia). Paul's Democratic campaign opponent -- Virginia Lt.
