He serves as Ranking Republican Member of the Interior Subcommittee on Oversight and Investigations and the Agriculture Subcommittee on Forests, Family Farms and Energy. Ron is a farmer and rancher by profession. He is in a very tight race against his Democratic opponent.

On August 11, Ron and his wife Cindy accompanied you on your trip to Billings, Montana. On Thursday, October 28, Ron and Cindy will fly with you from Casper, Wyoming to Great Falls, Montana.

Mrs. Dick (Lynne) Cheney

Lynne Cheney, wife of Congressman Dick Cheney (Republican-Wyoming), will fly with you on Thursday, October 28, from Andrews Air Force Base to Casper, Wyoming. Mrs. Cheney has written two novels and is the mother of two young children.

Congressman Dick Cheney is the Chairman of the Republican Policy Committee and sits on the Interior and Insular Affairs Committee. He does not have a tough race and should win re-election handily. On March 2, 1982, Lynne and Dick accompanied you on your trip to Cheyenne, Wyoming.

MEMORANDUM FOR THE PRESIDENT

FROM: ED ROLLINS  
SUBJECT: WYOMING - POLITICAL BRIEFING

I. SUMMARY

Republican incumbent U.S. Senator Malcolm Wallop appears to be regaining momentum in his re-election campaign for a second term against Democrat former state Senator Rodger McDaniel. However, polling data during October has shown Wallop's lead to be extremely fluid. In early October a Lance Tarrance poll showed Wallop with a 25-point lead; by mid-October Wallop's lead slipped to only 2 points; and now, the most recent tracking polls indicate that Wallop holds a 19-point lead. The timing of intensive media blitzes by both campaigns may have contributed to the fluctuation in Wallop's lead. Although Wallop appears comfortably ahead, his campaign is reluctant to consider his lead safe.

Republican former state House Speaker Warren Morton is running a strong campaign to unseat Democrat incumbent Governor Ed Herschler, who is seeking an unprecedented third term. Morton has hit hard on the failures of Herschler's administration, especially in the areas of state government growth, prison reform, and water issues.

Current tracking polls show Morton within 10 points of the Democrat incumbent and gaining ground. Morton faced a brutal media assault by his Democrat opponent in mid-October, and his campaign went into a slump. However, Republican Morton has broadened his attack on Herschler, and has begun an upward trend in the polls. One underlying issue enhancing Morton's chances is the fact that no other governor of Wyoming has broken the tradition of serving more than two terms.

Two-term Republican incumbent U.S. Congressman Dick Cheney, Wyoming's only U.S. House member, was re-elected in 1980 with 69% of the vote and is expected to easily defeat Democrat challenger Ted Hommel.

Wyoming Republicans are currently conducting a five day, ten county campaign blitz across the state to boost the campaign efforts of incumbent Republican U.S. Senator Malcolm Wallop, Republican gubernatorial nominee Warren Morton, and incumbent Republican U.S. Congressman Dick Cheney. The series of campaign rallies is being emceed by popular Republican incumbent U.S. Senator Alan Simpson, whose seat is not up for election this year. This joint campaign drive, which began last Saturday, will climax on Thursday morning with the President's visit to Casper. Wyoming Republican state chairman Fred Schroeder feels strongly that all three campaigns will be greatly enhanced by the President's visit.

In 1980, the Reagan-Bush ticket carried Wyoming by an overwhelming 63% to 28% margin.

The President attended a fundraising reception and rally on behalf of Senator Wallop in Cheyenne on March 2, 1982.

V. DISCUSSION

A. THE U.S. SENATE RACE - 1982

Republican incumbent U.S. Senator Malcolm Wallop is being challenged by Democrat former state Senator Rodger McDaniel, in his bid to win re-election to a second term. Wallop now appears to have regained momentum after a mid-October tailspin during which Wallop's own campaign polls showed the Republican Senator fall from a 25-point lead to only a 2-point lead over McDaniel. The polls have continued to fluctuate, and the latest tracking polls indicate that Wallop now has a 19-point lead.

Wallop's opponent, Rodger McDaniel is a liberal Democrat, who served as Teddy Kennedy's Wyoming state Chairman during the 1980 Presidential primaries. In early October, largely funded by

contributions from labor organizations, McDaniel began a ten-day media assault on Wallop. McDaniel's advertising campaign exploited the social security issue, charging that Wallop had voted six times to reduce social security benefits. He charged that Wallop's support for the President's tax program showed that Wallop "favors the rich over the poor." McDaniel also claimed that Wallop had avoided paying \$18,000 in taxes by taking the \$75-a-day Congressional tax deduction. Wallop initially ignored McDaniel's barrage of charges, stating that he was determined to take the high road and avoid negative campaigning. However, when tracking polls showed Wallop's lead drop 23 points during a two week period, Wallop's campaign changed tactics. Wallop proved that he had not taken the \$75-a-day deduction, by releasing relevant tax returns. Wallop began responding to McDaniel's charges with a massive media campaign. Wallop has attacked McDaniel's views as totally out of place in Wyoming, just like his liberal mentor, Teddy Kennedy. Wallop has also seized upon the Democrat's assertion that we should cut our defenses, and "trust the Russians."

The campaign is now gaining new confidence, believing that their continuing media effort, combined with the President's visit, will ensure Wallop of re-election to a second term.

#### B. THE GUBERNATORIAL RACE - 1982

Republican gubernatorial nominee Warren Morton is waging a tough, well-funded campaign against Democrat incumbent Governor Ed Herschler, who is seeking an unprecedented third term. Morton, a former Wyoming House Speaker, has a knowledgeable grasp of

statewide issues, and is giving Herschler a far more difficult race than had been earlier predicted.

Morton has attacked Herschler's administration on three major issues; water, prison mismanagement, and state government growth. Morton claims that Herschler's failure to take advantage of potential water sale agreements lost the state millions of dollars. He also attacks the governor's inability to deal with the overcrowding of the state's prisons, which has forced Herschler to parole convicted criminals. Morton claims that during Herschler's eight years in office, state spending in Wyoming has increased at a rate seven times faster than federal spending.

In early October, a Tarrance poll showed Morton trailing Democrat Herschler by only 8 points, Herschler led by a 50% to 42% margin. However, Herschler began a media assault on Morton, charging the Republican candidate, a millionaire who owns a number of oil wells in the state, is a "puppet of the oil interests." The immediate reaction to Herschler's personal attack against his Republican challenger caused a sharp drop for Morton in the polls. Mid-October Tarrance polls showed Herschler increasing his lead to 20 points over Republican Morton. However, Morton reacted by stepping up his own media campaign, emphasizing the Democrat governor's failed policies.

Morton has also seized upon the "three-term" issue, stating that re-electing the Governor to a third term would go against Wyoming tradition. Morton expresses the theme that it is time to replace Herschler's "worn-out" ideas with a new approach.



Tracking polls show that during the past week Morton has been regaining momentum, and he now trails the Democrat by 10 points.

C. THE U.S. HOUSE RACE - 1982

Republican incumbent U.S. Congressman Dick Cheney, former Chief of Staff to President Ford, was elected to Congress in 1978. He won re-election in 1980, by a 69% to 31% margin. Cheney is heavily favored to win his third term over his Democrat challenger, Ted Hommel, a teacher from Cheyenne.

SUBJECT: MONTANA - POLITICAL BRIEFING

I. SUMMARY

Republican U.S. Senate nominee Larry Williams is waging a strong challenge against Democrat incumbent U.S. Senator John Melcher. During the past several months, polling data by Dick Wirthlin has shown that the lead in this race has been shifting back and forth. Williams' campaign now considers the race a dead heat. Last June Melcher led Williams by an 11-point margin, but by early October, after a visit by the President, Williams gained a 4-point lead over Melcher. However, in early October, Melcher began a searing attack on Williams, charging that the Republican candidate is a "con man." The Melcher campaign lifted several quotes out of context from Williams' most recent book, How to Prosper in the Coming Good Years, in an effort to show that Williams has "bad economic sense." By mid-October, Williams had fallen 10 points behind Melcher. In recent days, however, Wirthlin polls show that Williams' campaign has regained its momentum, and Williams now trails Melcher by only a 4-point margin. Williams remains one of our best chances to unseat an incumbent Democrat U.S. Senator this year.

Three-term Republican incumbent Congressman Ron Marlenee is facing a strong Democrat challenger in Montana's 2nd District (East-Billings, Great Falls). Democrat Howard Lyman, a rancher from Great Falls, is attempting to misrepresent Marlenee's position on agricultural and environmental issues. Recent tracking polls done for the Marlenee campaign show the incumbent Republican currently leading his Democrat challenger by approximately 15 points.

In the 1st District (West-Missoula, Butte), Democrat incumbent Congressman Pat Williams is heavily favored to defeat his Republican challenger, Bob Davies, an electrical engineer.

In 1980, the Reagan-Bush ticket carried Montana by a 57% to 32% margin.

V. DISCUSSION

A. THE U.S. SENATE RACE - 1982

Republican U.S. Senate nominee Larry Williams is waging a highly effective challenge against freshman Democrat incumbent U.S. Senator John Melcher. This is one of our best chances to defeat an incumbent Democrat U.S. Senator this year. If Williams is successful, he will become Montana's first Republican U.S. Senator in 30 years.

Williams, a third generation Montanan, is an investment advisor and publisher. He writes a monthly newsletter dealing with the stock market, and has just recently finished his fourth successful book relating to business: How to Prosper in the Coming Good Years. In 1978, Williams was the Republican nominee in the U.S. Senate race to succeed Democrat incumbent Lee Metcalf. Although defeated by Democrat U.S. Congressman Max Baucus, Williams won 44% of the statewide vote.

Democrat Melcher won his first U.S. Senate term in 1976, defeating Republican Stanley Burger by a 64% to 36% margin. He succeeded four-term Democrat U.S. Senate veteran and former Majority Leader Mike Mansfield who now serves as Ambassador to Japan.

Williams has based his challenge to Melcher on two major themes: support for the President's economic program and his commitment to the people of Montana. Williams is stressing the positive results that have already come from the President's economic program, and the Republican refrain that we should "Stay the Course." Williams seeks to associate himself with the



President, who is personally popular in Montana. The President's August visit to Billings, Montana was an invaluable boost to Williams' campaign. Williams claims that as a Republican Senator working with a Republican President, he can accomplish much more for Montana than a Democrat who is a member of the Senate Minority. Williams disclaims Melcher's charge, however, that he would be a "rubber stamp" for the President.

In order to emphasize his commitment to representing Montana's interests, Williams has refused to accept any out-of-state contributions, except from the Republican Senatorial Committee. The Williams campaign has publicized the fact that the majority of Senator Melcher's campaign contributions have come from political action committees outside Montana. Melcher is expected to outspend Williams by a 2-to-1 margin. To date, Williams has raised approximately \$300,000 compared to Melcher's \$600,000. The National Political Action Committee (NCPAC) has spent approximately \$120,000 over the past two years, filling Montana's airwaves with blistering attacks on Melcher's Senate record. Melcher has made a campaign issue of NCPAC, charging that an "outside" organization is trying to "manipulate" Montana's voters. Williams has dissociated himself from the NCPAC campaign.

In recent weeks, Melcher, feeling the heat from a close race, has mounted a strident assault on Williams. Melcher has called Williams a "con man" who has no real concern for people. Several passages from Williams' book, How to Prosper in the Coming Good Years, have been lifted out of context in an attempt to prove that Williams is "cold-hearted." Melcher has even tried to make an

issue of a \$9000 ring which Williams bought his wife, claiming that Williams "has no economic common sense." The initial impact of these attacks had an adverse effect on Williams' campaign. Wirthlin polling data showed Williams falling from a 4-point lead over Melcher to 10 points behind the Democrat incumbent.

Williams has countered the Melcher assault by pointing to his proven record of helping people in Montana. He highlights his 1979 drive for the adoption of a balanced budget amendment to the Montana constitution, and he is reminding voters that he was the prime mover behind the adoption of "Initiative 86," which made Montana the first state to index its income tax, a move that has saved the state's taxpayers millions of dollars.

The most recent Wirthlin polling data shows Williams regaining momentum, and he now trails Melcher by only a 4-point margin. The Williams campaign believes that the President's visit to Great Falls will give Williams the boost he needs to unseat Melcher next Tuesday.

B. THE U.S. HOUSE RACES - 1982

Three-term Republican incumbent U.S. Congressman Ron Marlenee is facing a tough re-election challenge against Democrat Howard Lyman in Montana's 2nd District (East-Billings, Great Falls). Lyman is a rancher from Great Falls, the second largest city in the district. (Billings is the largest city).

Defense-related issues have become a major focal point in the campaign. There is an initiative on the November ballot in Montana to prohibit deployment of the MX missile in the state, and one calling for a nuclear freeze. Marlenee opposes both initiatives,

while Lyman supports them. Lyman also charges that Marlenee favors the sale of all of Montana's wilderness areas, a charge which Marlenee calls "nonsense."

Lyman has called for large-scale cutbacks in defense spending, while Marlenee upholds the Administration's position. Marlenee has made an issue of a plank almost adopted by the state's Democrat convention, calling for the shutdown of Malmstrom Air Force Base, which is located just outside of Great Falls.

Marlenee is stressing the fact that he is an effective representative of Montana's interests in his service on the House Agriculture and House Interior and Insular Affairs Committees.

Current tracking polls conducted by Marlenee's campaign show him leading Lyman in Yellowstone County (Billings) by 20 points, and ahead of Lyman in Cascade County (Great Falls) by 10 points. Together, these two counties comprise over two-thirds of the district's vote.

The 1st District (West-Missoula, Butte) is represented by two-term Democrat Congressman Pat Williams. Williams was re-elected in 1980 by a 61% to 39% margin, and is expected to win re-election over his Republican challenger, Bob Davies, an electrical engineer from Bozeman.
