





I. **PURPOSE**

To accommodate the request of Congressman Don Fuqua (D-Florida) and Congressman Larry Winn (R-Kansas) to have the President present the Harmon Trophy to the 1982 winners of the award.

II. BACKGROUND

Congressman Don Fuqua (D-Florida) is Chairman of the House Science and Technology Committee. In the past, he has supported the President on several key economic votes.

Congressman Larry Winn (R-Kansas) is the Ranking Minority Member of the House Science and Technology Committee. He has generally been a strong supporter of the President's economic program.

The Harmon International Aviation Trophies were founded in 1926 by the late Colonel Clifford B. Harmon, pioneer American balloonist and aviator. The award is the Nobel Prize of American aviation and is given in the categories of Astronaut, Aviator, Aviatrix and Aeronaut (lighter-than-air). There was no 1982 aeronaut award. Such distinguished aviators as Jimmy Dolittle and Charles Lindburgh have received the trophy in the past.

The 1982 Astronaut winners are the four astronauts who carried out successfully Space Transportation System (STS) missions one and two in the Columbia Space Shuttle. They are John W. Young, civilian commander of STS-1; Captain Robert L. Crippen, pilot of STS-1; Colonel Joe H. Engle, Commander of STS-2; and Captain Richard Truly, pilot of STS-2.

The 1982 Aviator winner is Jerry Foster, the commercial helicopter pilot for KPNX Broadcasting Company of Phoenix, Arizona. As a volunteer, he has located lost persons, spotted flood victims and made mountain rescues, all involving a saving of lives.

II. BACKGROUND Continued:

The 1982 Aviatrix winner is Janice Brown, an 89-pound teacher who piloted the world's first successful purely solar-powered aircraft over the Arizona desert for one hour and 32 minutes, attaining an altitude of 3,200 feet.

- 7:10 p.m. The regular dinner guests are escorted by Social Aides to the East Room where they are announced. (A Social Aide will also announce each guest to the Press Pool in the Lower Cross Hall.)

The Vice President and Mrs. Bush and Acting Secretary of State and Mrs. Dam will arrive the North Portico. They should be escorted into the Red Room to await the arrival of Ambassador Roosevelt and the Official Party.

(Harpist is in the Diplomatic Reception Room.)

The second motorcade of the Official Party departs the Madison Hotel.

7:15 p.m. At the arrival of the first motorcade at the North Portico, a Social Aide will escort the Vice President and Mrs. Bush and Acting Secretary of State and Mrs. Dam from the Red Room to join the arriving party at the foot of the Grand Staircase.

The Chief of Protocol escorts the following to the Yellow Oval Room via the Grand Staircase:

7:20 p.m. Second motorcade of the Official Party arrives White House at North Portico.

A Social Aide will escort them to the Red Room.

A senior Government official will serve as host in the Red Room to the remainder of the Official Party. A Social Aide, with the help of a Protocol Officer, will give out seating cards to the guests.

Four additional Social Aides will then escort the Party, one by one, into the East Room at 7:35.

- 7:25 p.m. His Excellency the President of the Islamic Republic of Pakistan and Begum Zia-ul-Haq depart the Madison Hotel accompanied by Mr. Roosevelt. (Military Cordon will line the driveway.)
- 7:29 p.m. THE PRESIDENT AND MRS. REAGAN depart the living quarters by elevator and proceed to the State Floor.

(U.S.M.C. Orchestra in Main Foyer)

The Chief of Protocol will serve as hostess protem for THE PRESIDENT AND MRS. REAGAN as they greet the President of the Islamic Republic of Pakistan and Begum Zia-ul-Hag.

- 7:30 p.m. The President of the Islamic Republic of Pakistan and Begum Zia-ul-Haq are greeted by the Military Aide and escorted into the Grand Foyer where they are greeted by THE PRESIDENT AND MRS. REAGAN at the foot of the Grand Staircase. THE PRINCIPALS will then proceed to the Residence via the elevator.
- 7:35 p.m. The remainder of the Official Party in the Red Room is escorted to the East Room and announced.

Color Guard proceeds up Grand Staircase to hallway outside Yellow Oval Room.

7:40 p.m. Guests (save PRINCIPALS) depart Yellow Oval Room via elevator for East Room and are announced. The Acting Secretary of State and Mrs. Dam are announced first followed by The Vice President and Mrs. Bush.

7:40 p.m. Cont'd.

OIC requests permission to secure the Colors. THE PRESIDENT responds, "Permission granted." Color Guard proceeds to secure the Colors and proceeds out of Yellow Oval Room down the Grand Staircase, led by OIC.

At foot of Staircase, Color Guard divides.

7:45 p.m.

The PRINCIPALS arrive on the State Floor via the Grand Staircase, pause at the foot of the Stairs for press photo session, and proceed directly to the East Room to full Honors.

After the announcement of the PRINCIPALS, the PRINCIPALS enter the East Room and form a receiving line which will be in the center of the Cross Hall doors, just inside the East Room. The order of the line from north to south is as follows: THE PRESIDENT, PRESIDENT ZIA-UL-HAQ, MRS. REAGAN, BEGUM ZIA-UL-HAQ.

Note: The Color Guard will precede the PRINCIPALS into the East Room and take their places on either side of the PRINCIPALS for the receiving line.

The Chief of Protocol stands to THE PRESIDENT'S left with a Social Aide on her left to make introductions to THE PRESIDENT.

Guests going through the receiving line will move as follows: they will go passed the PRINCIPALS, continue into the north door into the Green Room, out the Green Room into the Cross Hall and into the State Dining Room for dinner.

Having come through the receiving line, the Official Party will go directly into the State Dining Room.

After all the guests have gone through the receiving line, the PRINCIPALS should hold in the East Room until all guests are in the State Dining Room, then proceed down the Cross Hall to the State Dining Room.

(Appropriate music should be played.)

Guests in the Map Room and Lower Cross Hall should go into the West Garden Room for dinner.

The after-dinner guests arrive at the Diplomatic Reception Room and are led up the Grand Staircase with the guests from the West Garden Room to the Color Rooms for coffee and liqueurs.

All guests will be encouraged to mix and mingle in all Color Rooms.

- 9:40 p.m. Cross Hall doors to the East Room are opened to allow guests to be seated if they wish.
- 10:00 p.m. All guests but PRINCIPALS will proceed to the East Room for seating. The south doors from the Green Room to the East Room may be used as well as the Cross Hall doors.
- 10:10 p.m. PRINCIPALS enter the East Room via the Cross Hall doors and are seated on specially allocated chairs in the first row.
- 10:15 p.m. The entertainment begins.

10:45 p.m. The entertainment concludes.

PRESIDENT AND MRS. REAGAN mount the stage to be photographed with the entertainers, and THE PRESIDENT makes thank-you remarks.

10:50 p.m. The President of the Islamic Republic of Pakistan and Begum Zia-ul-Haq are escorted to the Grand Foyer by THE PRESIDENT AND MRS. REAGAN where they are bid goodnight at the foot of the Grand Staircase.

The Military Aide will then escort the President of the Islamic Republic of Pakistan and Begum Zia-ul-Haq to the North Portico for departure.

11:00 p.m. THE PRESIDENT AND MRS. REAGAN then begin the dancing in the Grand Foyer.

Guests are served champagne and join in dancing.

11:30 p.m. All guests depart.
