With these leaders, you should stress your commitment to seek a bipartisan solution to our budget problems, and reiterate your desire to work closely with these members during the months ahead to ensure a sound budget which will benefit the American people. At some point in the meeting, you will sign copies of the budget for the leaders.

SUGGESTED TALKING POINTS FOR MEETING WITH HOUSE AND SENATE BIPARTISAN LEADERSHIP

- -- As you know, later today I will submit my Fiscal Year 1984 budget to the Congress. As I have done in previous years, I want to take this opportunity to meet with you before Congress begins formal consideration of the budget.
- -- We will be having a detailed briefing on the budget very shortly here in the State Dining Room, and I hope all of you will be able to join us for that discussion. I do want to point out that our budget proposal this year will result in \$558 billion in deficit reductions between 1984 and 1988. I am convinced that unless we take these actions, the resulting deficits in the outyears could stifle the economic recovery which is just now beginning. As I mentioned in my State of the Union message, we have a four-part plan which will include a federal spending freeze, measures to control the growth of "uncontrollable" spending programs, defense savings, and a standby tax.
- -- Now I know that there will be some who will have difficulties with one aspect or another of our plan. However, I am hopeful that we can work together in a bipartisan fashion to achieve our goal of sustained economic recovery.

- -- I believe that our budget provides a sound framework for Congressional action, and as I mentioned before, we have a plan here that is fair, prudent, and realistic.
- -- I look forward to working closely with all of you. I appreciate very much the guidance you have already given me in this area, and I hope you will continue to do this. Needless to say, all Americans will benefit from our cooperation.

TALKING POINTS FOR MEETING WITH BI PARTISAN SENATE HOUSE AND COMMITTEE LEADERSHIP

to know that I very much appreciated the warm reception
I received when I came up to the Hill last Tuesday night.

- -- As you know, we will be sending our FY 84 budget proposal to the Hill later today, and I am glad to have this opportunity to meet with those of you who will play a critical role in Congressional action on the budget. We know, and the American people know, that in these difficult economic times, effective leadership is critical. I think each of you here has a special responsibility in this regard, and I want to thank you for coming down here today to discuss one of the most important issues we will face this year.
- -- As we proceed here today, we will be hearing from Marty
 Feldstein, Dave Stockman and Don Regan on the details of
 our budget proposal, but I would like to give you a
 brief outline of the major components of our FY 84 budget.
- -- As I mentioned in my State of the Union address, I am submitting a four-point proposal to increase economic growth and reduce deficits. As a matter of fact, my budget plan will result in \$558 billion in deficit reductions between 1984 and 1988. Without these reductions, baseline deficits between \$200 and \$300 billion would threaten our economic recovery.

- -- First among my four-point plan is a fiscal spending freeze which means that a fiscal spending than the rate of inflation.
- -- Second, I have included measures to control the growth of so-called "uncontrollable" spending programs.
- -- Third, I am proposing \$55 billion in defense savings over the last five years. I believe this represents a reasonable savings in this important area, without diminishing our ability to negotiate arms reduction or endangering our security.
- -- Finally, I will ask for a stand-by tax limit to no more than one percent of the Gross National Product to start in fiscal 1986. It would last no more than three years and would start only if the Congress has first approved our spending freeze and budget control program. In essence, this is an insurance policy for the future, and is intended to encourage reduction of our deficits.
- -- I believe the thrust of our program is fair, it is realistic, and it is prudent. I am convinced that we must make every effort to bring fiscal spending under control and bring the deficit down. Without this kind of economic recovery, unemployment will continue to run at unacceptable levels, and I know that this is something that none of us wants.

-- Now I am going to turn this meeting over to Marty, Dave and Don and I know they will be happy to give you the details of our plan and respond to any questions you may have.

PRESIDENTIAL REMARKS: ANNUAL CONVENTION OF NATIONAL RELIGIOUS BROADCASTERS MONDAY, JANUARY 31, 1983

Thank you Brandt Gustavson, ladies and gentlemen, distinguished guests, thank you all very much. My word, what a wonderful sight you are. You know, I just realized why it's so easy to tell you're the National Religious Broadcasters. You're the real miracle-workers. In a few days, I'll be celebrating another birthday which should put me within reach of Moses. But that doesn't bother me. Because every year when I come here, when I look out at your warm, caring faces, I get a very special feeling -- I feel like I've just been born again.

There's something else I've been noticing. In a time when recession has gripped our land, your industry has enjoyed phenomenal growth. Now there may be some who feel frightened or threatened by your success. I'm not one of them. As far as I'm concerned, the growth of religious broadcasting is one of the most heartening signs in America today.

When we realize that every penny of that growth is being funded, voluntarily, by citizens of every stripe, we see an important truth -- the American people are hungry for your message because they are hungry for a spiritual revival. When Americans reach out for values of faith, family and caring for the needy, they are saying we want the Word of God. We want to face the future with the Bible.

Facing the future with the Bible -- it's a perfect theme for your convention. You might be happy to hear that I have some

"good news" of my own. Thursday morning, at the National Prayer Breakfast, I will sign a proclamation making 1983 the National Year of the Bible.

We are blessed to have its words of strength, comfort and truth. The grass withereth, the flower fadeth, but the Word of our God shall stand forever. I hope Americans will read and study the Bible in 1983; it is my firm belief that the enduring values presented in its pages have great meaning for each of us and our Nation. The Bible can touch our hearts, order our minds and refresh our souls.

Now I realize it is fashionable, in some circles, to believe that no one in Government should encourage others to read the Bible. That, we're told, will violate the constitutional separation of church and State established by the Founding Fathers in the First Amendment.

Well, it might interest those critics to know that, none other than the Father of our Country, George Washington, kissed the Bible at his innauguration.

John Adams called it "the best book in the world." Ben Franklin said: "... the longer I live, the more convincing proofs I see of this truth -- that God governs in the affairs of men ... Without His concurring aid, we shall succeed in this political building no better than the builders of Babel; we shall be divided by our little, partial, local interests, our projects will be confounded, and we ourselves shall become a reproach and a by-word down to future ages. .."

So, pardon me, but when I hear the First Amendment used today as a reason to keep traditional moral values away from

policymaking, I am shocked. The First Amendment was not written to protect the people and their laws from religious values; it was written to protect those values from Government tyranny. I've always believed that this blessed land was set apart in a special way -- that some divine plan placed this great continent here between the oceans to be found by people from every corner of the Earth who had a special love for freedom and the courage to uproot themselves, leave homeland and friends to come to a strange land and when coming here they created something new in all the history of mankind: a country where man is not beholden to government, government is beholden to man.

Now as you know, one way to promote those traditional values we share is by permitting our children to begin their days the same way the Members of the United States Congress do -- with prayer. The public expression of our faith in God through prayer is a fundamental part of our American heritage and a privilege which should not be excluded from our schools.

No one must be forced or pressured to take part in any religious exercise. But neither should the freest country on Earth ever have permitted God to be expelled from its classrooms. When the Supreme Court ruled school prayer unconstitutional 21 years ago -- it ruled wrong. And when a lower court recently stopped Lubbock, Texas, high school students from even holding voluntary prayer meetings on campus after school -- it ruled wrong too.

Our only hope for tomorrow is in the faces of our children.

Jesus said: "Suffer the little children to come unto me, and forbid them not: for such is the Kingdom of God." Last year, we

tried to pass an amendment that would allow communities to determine for themselves whether voluntary prayer should be permitted in their public schools. Well, we failed, but I want you to know something: I am determined to bring back that amendment again, and again, and again, until we succeed in restoring religious freedom in the United States.

We were frustrated on two other fronts last year. There are 5 million American children attending private schools today because of the emphasis on religious values and educational standards. Their families, most of whom earn less than \$25,000 a year, pay private tuition; they also pay their full share of taxes to fund the public schools. We think they're entitled to relief. This year, we will work hard again to secure passage of tuition tax credits for deserving families.

There is another struggle we must wage, a struggle to redress a great, national wrong. We must go forward with unity of purpose and will. Let us come together, Christians and Jews, let us pray together, march, lobby and mobilize every force we have, so we can end the tragic taking of unborn children's lives. Who among us can imagine the excruciating pain the unborn must feel as their lives are snuffed away?

I am glad that a Respect Human Life Bill has already been introduced in this Congress by Representative Henry Hyde. Not only does this bill strengthen and expand restrictions on abortions financed by tax dollars, it also addresses the problem of infanticide. It makes clear the right of <u>all</u> children, including those who are born handicapped, to food and appropriate

medical treatment after birth -- and it has the full support of my Administration.

I read in the <u>Washington Post</u> about a young woman named Victoria. She was with child, and she said: "In this society we save whales, we save timber wolves, and bald eagles and Coke bottles. Yet everyone wanted me to throw away my baby." But Victoria's story has a happy ending. Her baby was born and lives.

Victoria has received assistance from a Christian couple, and Sav-A-Life, a new Dallas group run by James McKee, a seminary student who helps find alternatives to abortion. There <u>is</u> hope for America; she remains a powerful force for good; and it's thanks to the conviction and commitment of people like those helping Victoria. They are living the meaning of two great commandments: "Thou shalt love the Lord thy God with all thine heart, and with all thy soul, and with all thy might;" and "Thou shalt love thy neighbor as thyself."

Each year, Government bureaucracies spend billions for problems related to drugs, divorce, alcoholism and disease. Has anyone stopped to consider that the best way to balance the Federal budget is not by taxing people into the poorhouse; and it's not by cutting spending to the bone; but rather it's by all of us simply trying to live up to the Ten Commandments and the Golden Rule.

That's what's happening with the 700 Club's "Operation Blessing." They have given \$2 million to 8,500 churches on the condition that each gift is matched dollar for dollar or two for one. The result has been fantastic: More than 100,000 needy

families helped, either through direct contributions or in-kind gifts, ranging from food, clothing to education, dental care and housework.

The PTL television network is carrying out "A Master Plan For People That Love," opening centers all across the country to provide food, clothing, furniture and job bank centers at no cost. Don't listen to those Washington cynics who run our country down. America's heart is strong; and her heart is good.

You know, I mentioned drugs a moment ago. I hope you'll forgive me if I digress just long enough -- because I don't often get this chance -- to say publicly how proud I am of Nancy, and the job she's doing helping to fight drug addiction.

I know each of you is contributing, in your own way, to rebuilding America, and I thank you. As broadcasters, you have unique opportunities. And all of us, as Protestants, Catholics and Jews, have a special responsibility to remember our fellow believers who are being persecuted in other lands. We are all children of Abraham, we are children of the same God.

You might be interested to know about a few of the changes we're making at the Voice of America. Our transmissions of Christian and Jewish broadcasts are being expanded and improved. This year, for the first time in history, the Voice of America broadcast a religious service worldwide: Christmas Eve at the National Presbyterian Church in Washington, D.C.

Now these broadcasts are not popular with the governments of totalitarian countries. But make no mistake, we have a duty to broadcast. Alexander Herzen, the Russian philosopher wrote: "To shrink from saying a word in defense of the oppressed is as bad

as any crime." I pledge to you that America will stand up, speak out and defend the values we share. To those who would crush religious freedom, our message is plain: you may jail your believers, you may close their churches, confiscate their Bibles, and harrass their rabbis and priests; but you will never destroy the love of God and freedom that burns in their hearts -- they will triumph over you.

Malcolm Muggeridge, the brilliant English commentator, has written: "The most important happening in the world today is the resurgence of Christianity in the Soviet Union, demonstrating that the whole effort sustained over 60 years to brainwash the Russian people into accepting materialism has been a fiasco."

Think of it: the most awesome, military machine in history, but it is no match for that one, frail man -- hero, strong yet tender, Prince of Peace. His name alone -- Jesus -- can lift our hearts, soothe our sorrows, heal our wounds, and drive away our fears. He gave us love and forgiveness, He taught us truth, He left us hope. The Book of John tells us: "For God so loved the world, that He gave His only begotten Son, that whosoever believeth in Him should not perish, but have everlasting life."

With his message, with your conviction and commitment, we can still move mountains. We can work to reach our dreams and make America a shining city on the hill. Before I say goodbye, I wanted to leave you with these words from an old Netherlands folk song, because they made me think of our meeting here today:

We gather together to ask the Lord's blessing.
We all do extol thee, Thou leader triumphant
And pray that Thou still our Defender wilt be.

Let Thy congregation escape tribulation.

Thy name be ever praised! O Lord, make us free!

To which I would only add: America, America, God shed His grace on thee.

We look forward to continuing our close relationship with you in your new status, but you will always be family to us.

Over the years, perhaps the most lasting and valuable things we've built together are not the roads, the airports, the schools and hospitals, but rather an understanding of the meaning of democracy and freedom and the dignity of self-determination.

With this knowledge you've adopted your own constitution.
