SUGGESTED TALKING POINTS FOR BRIEFING WITH STATE AND LOCAL OFFICIALS

March 14, 1983

- -- Welcome to the White House. I am delighted that you are able to be here for this briefing on many of the initiatives which are being undertaken by my Administration.
- -- I know you have had a chance to be briefed on social security, energy, transportation and budget issues. I'd like to focus my remarks on the economy and on the Federalism Initiative which I recently transmitted to the Congress.
- -- With respect to the economy, we know that last year was a period of painful economic readjustment for all levels of government. State and local governments were particularly hard hit.
- -- I realize that your job has not been made any easier by the recession and the unemployment that came with it. But these problems have been a long time in the making and we knew they would take some time to correct. We also knew that we would not serve you well if we turned to the same quick fixes that have been used in the past -- artificial answers that masked economic problems for a while, and then, after a couple of years, made them far worse.

- -- The policies of the 1970's, though often well-intentioned, had a very damaging cumulative effect. While GNP increased only 70% between Fiscal 1976 and Fiscal 1981, Federal taxes more than doubled and federal spending jumped 80%.
- -- In order to change the situation, I chose an economic program with one overriding objective: to restore long-term, non-inflationary, economic growth.
- -- During the past two decades we've had but two periods of sustained economic growth, and in both cases inflation shot up. Each burst of inflation was followed almost immediately by a new recession. As a consequence, much of the gains from growth were wiped out.
- -- The only way to prevent this from happening in the 1980's is to make sure that economic growth is non-inflationary. Fortunately, inflation has been whipped -- for now. Last year it was 3.9%, the lowest in a decade. And in the past six months, it's been below 2%.
- -- The economic recovery that will create new jobs is now taking shape. Almost all economists are now agreed on that. And they have good reason.

- -- The index of leading economic indicators climbed 3.6% in January, the largest increase since July 1950. Construction spending soared 8.4% in January to a record annual rate -- a rise in activity that was the largest since March 1946. The U.S. auto production in January and February was more than 50% higher than the levels a year ago.
- -- To maintain this progress, we have to continue to slow the growth of federal spending. We must also do nothing that will impede the recovery, or worse, stop it in its tracks.
- -- With respect to the Federalism Initiative that I recently sent to the Congress, this remains a very high priority for me.
- -- The Federalism package, which incorporates four major megablock grants to state and local governments, is not a vehicle for budgetary savings. We will take whatever funding levels Congress enacts for FY '84 and lock in those numbers through FY '88.
- -- The legislation provides for stability and certainty of funding which you have long called for.
- -- It requires mandatory pass-throughs to local governments and consultation by the States on any major program or policy changes.

- -- The proposal also includes the preservation of General Revenue Sharing. General Revenue Sharing is consistent with the basic philosophy of this Administration that we should provide maximum flexibility to state and local officials.
- -- But I came here not for a monologue, but a dialogue and now I'd like to hear your comments and questions.

I. PURPOSE

To express strong Presidential support for the enactment of the Comprehensive Crime Control Act of 1983.

II. BACKGROUND

Enactment of legislation to reform several elements of the federal criminal statutes has been a priority of this Administration. Legislation was transmitted to the 97th Congress to change sentencing and bail laws, the exclusionary rule, the insanity defense, narcotics enforcement and several other substantive reforms in criminal law. Senate approved a major crime bill, S. 2572, the Violent Crime and Drug Enforcement Improvements Act, last September by a vote of 95 to 1. That legislation addressed several of the areas of concern to the Administration including bail and sentencing reform and improved forfeiture provisions. The House of Representatives failed to approve this measure. It adopted, instead, H.R. 3963, a miscellaneous assortment of criminal justice proposals. The Senate acceded to most of these proposals. This legislation was vetoed for, among other reasons, its creation of a federal "drug Czar". In vetoing H.R. 3963, the President reaffirmed his strong personal commitment to the fight against crime and stated that he looked forward to working with the 98th Congress to secure passage of substantive criminal law reform.

A new crime package, the Comprehensive Crime Control Act of 1983, is ready to be transmitted to the Congress. Many of the proposals were considered by the previous Congress but others are new. Each provision is important in ensuring that crime in America is dealt with effectively.

SUGGESTED TALKING POINTS FOR MEETING WITH CONGRESSMEN AND SENATORS ON THE COMPREHENSIVE CRIME CONTROL ACT OF 1983

I. PURPOSE

To participate in a memorial service for 13 federal law enforcement officers who have recently lost their lives in the line of duty.

II. BACKGROUND

This memorial service is being held to eulogize the supreme sacrifice made by 13 federal law enforcement officers in recent months and to recognize the dangers faced daily by all law enforcement officers. You have spoken by telephone to most of the widows of these agents, but this public event will let other federal, state and local law enforcement officials know that they are appreciated. Those being memorialized are as follows:

- -- Three Secret Service Agents (George Patrick La Barge, Donald W. Robinson, and Donald Bejeck) died while providing protection for Queen Elizabeth at Yosemite National Park on March 5, 1983.
- -- U. S. Marshal Kenneth Muir, 53, and Deputy U. S. Marshal Robert Cheshire, 33, were shot to death while attempting to apprehend a fugitive on February 13, 1983.
- -- Prison guard Gary L. Rowe, 31, was beaten to death at the San Diego Metropolitan Correctional Center on February 7, 1983.
- -- Prison guard Gregory J. Gunter, 30, lost his life during an inmate disturbance which occurred at the Federal Correctional Institution, Petersburg, Virginia, on December 25, 1982.
- -- Four FBI agents (Robert W. Connors, Charles L. Ellington, Terry B. Hereford, Michael J. Lynch) were killed while on duty in a plane crash on December 16, 1982.
- -- Ariel Rios of the Alcohol, Tobacco and Firearms Bureau, while serving as an undercover agent on detail to the South Florida Task Force, was shot and killed in Miami on December 2, 1982.

-- Thomas J. Devine of the Drug Enforcement Administration was shot in the leg and the base of the neck on October 12, 1972, by a suspect in an undercover narcotics investigation. He died from the wounds on September 25.

The President, the Attorney General, the Secretary of the Treasury, top federal law enforcement officials, representatives of state and local law enforcement organizations, and close family of the 13 officers.
