MEETING WITH REPUBLICAN CONGRESSIONAL LEADERSHIP

I. PURPOSE

To encourage Republican unanimity as the key to congressional passage of your MX/Midgetman missile recommendations, to review legislative actions called for in your Central American speech last week and to reemphasize your commitment to fiscal restraint in the FY84 budget resolution.

II. BACKGROUND

Several major legislative issues will be voted upon by the Congress in the next few weeks. The 45 day clock has begun to run on MX/Midgetman and both the House and Senate must act on resolutions of approval by June 3. Brent Scowcroft, Cap Weinberger and other Administration officials will continue testimony this week before various congressional committees and floor action could take place as early as the week of May 16th.

On Central America, there are a number of crucial congressional actions this week. The House Foreign Affairs Committee is marking up our FY 1984 security assistance request today and the Senate Foreign Relations Committee will mark it up on Thursday. Votes are also likely today in the House Intelligence Committee on the so-called Boland Amendment (on covert activities in Nicaragua) and perhaps on similarly restrictive language in the Senate Intelligence Committee. In addition, the House Appropriations Subcommittee may markup the FY 1983 supplemental request for \$50 million for El Salvador today or tomorrow.

Finally, the Senate has begun debate on its version of the FY84 budget resolution. The Senate Budget Committee reported 3 year resolution, as you know, includes 5% a year on defense spending, little by way of domestic cuts and \$30 billion in revenue increases in FY84 alone. It is clearly unacceptable. Senator Baker and others members of the leadership have been meeting in an effort to unite all Republicans in the Senate behind a 2 year resolution more to our liking but still far from satisfactory. (Detailed information will be provided you prior to the leadership meeting.)

SUGGESTED TALKING POINTS

MX

- The legislative clock has begun to run on MX.
- I have, as you know, endorsed the bipartisan commission's recommendations, including deploying 100 MX missiles in existing silos and commencing work on a small missile.
- I am counting on Republican support in pushing these recommendations through Congress and would welcome any suggestions you have on how best to achieve this important objective, which has profound foreign and defense policy implications.
- We simply must win this vote and I will be doing all I can to ensure passage.

CENTRAL AMERICA

- Because the challenge to our security that is emerging in Central America requires both a national consensus and a steady, bipartisan course, I took the unusual step of addressing you in joint session.
- The Democrats' response has not been entirely as we hoped, but there have been clear indications that many are beginning to understand the complexities of the situation. We will continue to pursue bipartisan support, but especially need a strong Republican backing in our efforts toward preventing a full-fledged crisis in Central America.

- There are, I understand, a number of crucial congressional actions coming up today and later this week. The House Foreign Affairs Committee is marking up my FY 84 security assistance request today and their Senate counterparts will mark it up on Thursday, May 5. The House Appropriations Subcommittee may markup my FY83 supplemental request for \$50 million as early as this afternoon. And the House Intelligence Committee is scheduled to vote today on the so-called Boland Amendment---the Senate Intelligence Committee may consider similarly restrictive language as well.
- I need Republican support during these crucial markups. This means more than just voting with us. It also means propping up some of your colleagues.
- Again, I would welcome any suggestions on how we can provide the economic and military assistance our neighbors so vitally need if they are to shield themselves from subversion and allow democracy to grow.

Drug Abuse Prevention/CM176 - Carlton Turner, Director of the Drug Abuse Policy Office, will review Administration efforts to deter drug abuse among America's youth.

EXECUTIVE SUMMARY

On September 15, 1981 President Reagan issued Executive Order 12320 which mandated a Federal program "... designed to achieve significant increases in the participation of historically Black colleges and universities in Federally-sponsored programs." This program has three components: 1) a special review of Federal agency funding for Historically Black Colleges and Universities (HBCUs) and development of an annual plan of assistance; 2) identification, reduction, and elimination of barriers "which may have unfairly resulted in reduced participation in, and reduced benefits from, Federally-sponsored programs"; and 3) involvement of the private sector in strengthening HBCUs.

In response to the Executive Order, Secretary of Education Terrel H. Bell conducted a special review of Federal agencies, and identified the 27 Federal agencies which provide a major share of Federal funding for higher education. It was determined that these 27 agencies provided 98% of the Federal funds that went to HBCUs. As a result, the first Annual Federal Plan to Assist HBCUs (Annual Plan) was developed whereby the 27 designated agencies set projections for financial support of HBCUs for fiscal year 1982.

The final Performance Report for fiscal year 1982 shows the actual dollar amounts of agency funding to HBCUs during that fiscal year. It is President Reagan's intent that this document serve as a "report card" on Federal agencies' performance in complying with the Executive Order. The Report compares the actual obligations to the projections set forth in the FY 1982 Annual Plan as a means of measuring the performance of the designated agencies in their support of Executive Order 12320. In addition, some of the agencies' strategies for reducing barriers to HBCU participation in Federally-sponsored programs are

highlighted. Statistical highlights of the FY 1982 Performance Report are provided below:

- o FY '82 Agency obligations to HBCUs were \$564,458,319, an increase of \$19,640,319 or 3.6% over the FY '81 actual funding to HBCUs.
- o The 27 designated agencies exceeded 100% of their aggregate funding goal for HBCU funding in FY '82. The projected goal was \$546,913,000; the actual funding was \$564,458,319, or 103.2% of the goal.
- o The amount of funding available to all higher education institutions (HEIs) was down in FY '82 from FY '81, but the amount of funding and percentage of available money going to HBCUs were increased.

- o Twelve of the agencies met or exceeded their funding goals for FY '82:

- o Of the fifteen agencies which did not meet their goals, efforts ranged from one agency with less than 12 percent of its projected goal to four agencies which attained over 90% of their goals. These agencies are:

- o The Department led all agencies in funds awarded to HBCUs with a total obligation of \$430,887,802. The agency with the highest percentage of its HEI obligations going to HBCUs was the Department of Housing and Urban Development with 39 percent of \$3,211,254 or \$1,254,600.

- o Fourteen agencies equalled or exceeded their FY '81 obligations. Special mention should be made of the Department of Commerce, the Department of Defense, and the Veterans Administration, which increased their obligations by more than 300 percent over FY 1981. In addition, the Department of Housing and Urban Development exceeded their FY 1981 obligations to HBCUs by 230 percent.
- o Agencies employed a variety of strategies to increase the participation of HBCUs in Federally-sponsored programs.

The strategies included:

- institutional site visits, workshops, professional seminars;
- informational mailings concerning contract and grant programs;
- set-aside provisions in grant programs;
- development of R&D programs for HBCUs;
- identification and cataloging of individual HBCU R&D capabilities; and
- use of agency discretionary authority to target awards to HBCUs.

Overall, the Federal government agency support of the Executive Order was significant. Higher obligations were made to HBCUs and HBCUs received a greater percentage of the total HEI funding in FY '82 than in FY '81.

To film the President presenting the "Invest-In-America" Eagle Award to Marvin Stone, Editor of U.S. News and World Report. 5:50 p.m. Guests begin to arrive the Southwest Gate, Diplomatic Reception Room, and are announced to the Press Pool in the Lower Cross Hall by a Protocol Officer.

Foreign guests are then led up the Grand Staircase to the State Dining Room for refreshments.

American guests are led directly to the East Room for refreshments.

6:10 p.m. Guests are lined up by the Office of Protocol in the State Dining Room for the receiving line.

6:30 p.m. THE PRESIDENT AND MRS. REAGAN arrive the State Floor via the elevator. They proceed to the Blue Room via the Cross Hall and take their places in front of the window for the receiving line.

The receiving line begins, and will feed from the south door of the State Dining Room into the Red Room, from the Red Room into the Blue Room, past THE PRESIDENT AND MRS. REAGAN in front of the window, through the south door of the Blue Room into the Green Room, into the Cross Hall and into the East Room for refreshments.

American guests will not go through the receiving line, but will be in the East Room to greet the foreign guests as they come off of the receiving line.

7:10 p.m. Strolling Strings enter the East Room via the Cross Hall and and play briefly. Guests coming off of the Receiving Line in the Green Room will be held briefly in the Green Room until the Strolling Strings have entered the East Room.

7:30 p.m.
(approximately) At the conclusion of the receiving line, THE PRESIDENT AND MRS. REAGAN proceed from the south door of the Blue Room into the Green Room, from the south door of the Green Room into the East Room where they walk through, greeting the guests.

THE PRESIDENT AND MRS. REAGAN then depart the East Room via the Cross Hall doors and proceed to the elevator.
