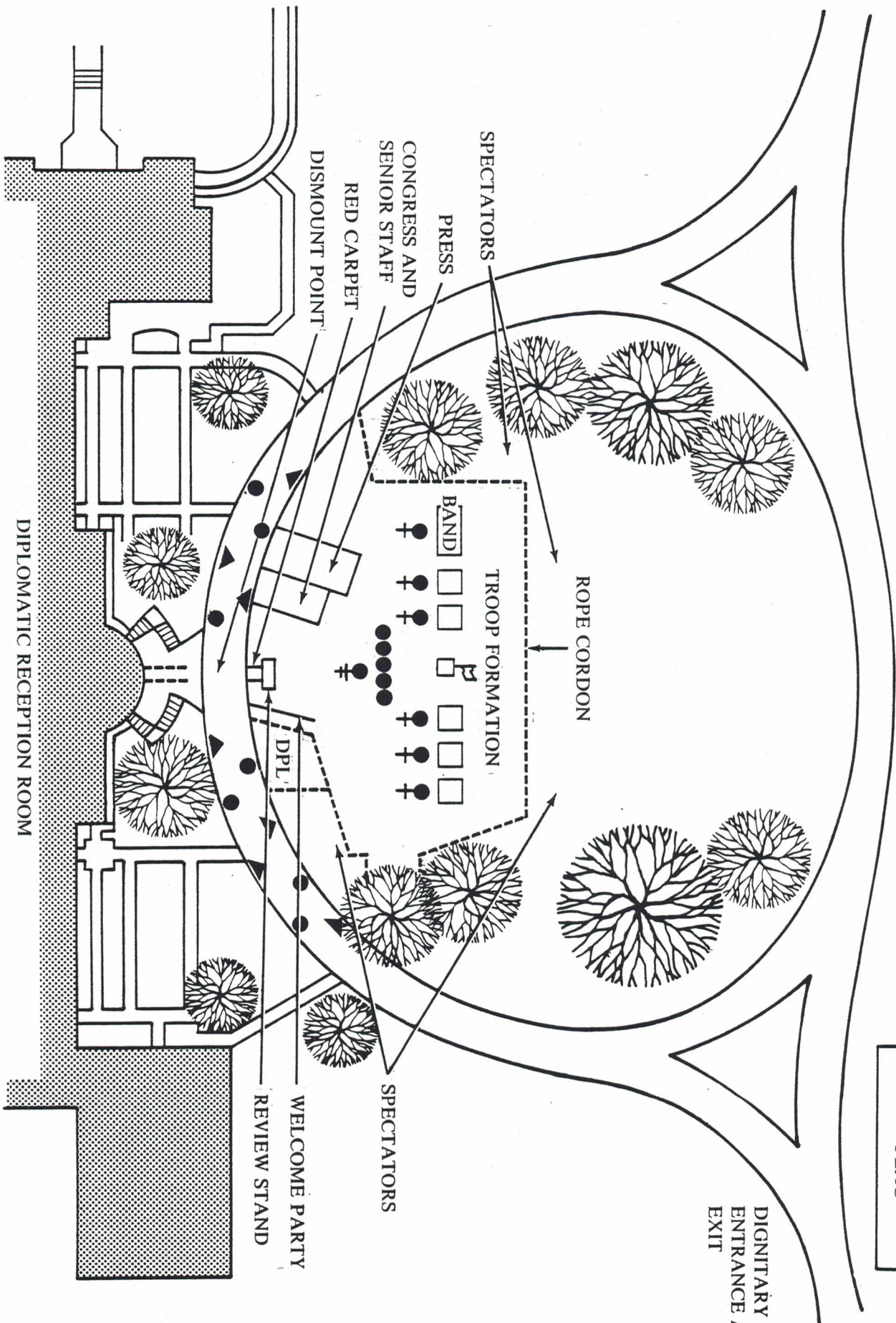

PRESIDENTIAL REMARKS: PRESIDENT EANES OF PORTUGAL
STATE DINNER TOAST
THURSDAY, SEPTEMBER 12, 1983

Mr. President, this morning I mentioned the gratitude all Americans feel for the part Portuguese immigrants and their descendants have played in building our country. Tonight I must tell you that I owe a personal debt of gratitude to Portugal for another reason. It was in 1542 that a Portuguese explorer, Joao Cabrillo, discovered California, the State closest to my heart.

Mr. President, this morning, we had a chance to explore issues that concern us both. Our discussion about relations between our two countries, our common support for the NATO Alliance, and our close consultations on southern Africa demonstrate how much our nations share a firm commitment to freedom and peace.

Mr. President, Americans esteem those who rise from humble beginnings to positions of national service. You and Mrs. Eanes have probably seen the Lincoln Memorial, the monument to a President who began life in a simple log cabin. In many ways, your own life parallels that of Lincoln, for you too began life in modest surroundings, then rose in the service of democracy to your nation's highest office. Mr. President, we honor you for that achievement.

You once stated your determination that "the Portuguese people will have their democracy." Today, the Portuguese people do, indeed, have their democracy, and Portugal, fully committed to political and economic freedom, has taken its rightful place
