Attached is biographical information on the Members of Congress who will be joining the President for his trip to Columbia, South Carolina.

Accompanying the President round trip on Air Force I will be Senator Strom Thurmond, Congressman Floyd Spence, Congressman and Mrs. Carroll Campbell and Congressman Tommy Hartnett.

Senator Howard Baker and Mrs. Nancy Thurmond will not be traveling on Air Force 1 but will join the Presidential party for all of the activities in South Carolina.

SENATOR HOWARD BAKER (R-TENNESSEE)

Casual and pragmatic in style, Senator Howard Baker has proved to be one of the most effective and well respected Majority Leaders in the history of the Senate. He has been a strong and effective supporter of your Administration's programs. Senator Baker's skill at personal persuasion has often made the difference on close votes in the Senate, and he is always available and sensitive to his colleagues' needs. Although most of Baker's time is consumed in leadership responsibilities, he is also an effective member of the Environment and Public Works Committee, the Foreign Relations Committee, and the Senate Rules Committee.

Senator Baker comes from a political family; his father served seven terms as a member of the House from Tennessee, and he is married to the former Joy Dirksen. In 1982, his daughter, Cissy, ran an unsuccessful campaign for the House. Baker was first elected to the Senate in 1966, and has announced that he will not seek re-election when his current term expies in 1984. He has indicated a likelihood that he will consider running for President at some future time.

Baker is a lawyer by profession, and served three years in the Navy. In addition to his daughter, Baker and his wife, Joy, also have a son, Derek, and one grandchild. Baker is an avid photographer and is rarely seen without a camera of some size.

In his dual role as Majority Leader and number two on the Foreign Relations Committee, Senator Baker is currently deeply involved in two areas of great interest to the Administration -- the War Powers Act and Lebanon and the nuclear freeze/builddown. Both face crucial tests this week. He will also face major leadership challenges over the next two weeks as many issues come up as part of the Continuing Resolution.

SENATOR STROM THURMOND (R-SOUTH CAROLINA)

Senator Thurmond was born December 5, 1902, in Edgefield, South Carolina. Thurmond graduated from Clemson College in 1923. He studied law at night and was admitted to practice in all Federal Courts including the U.S. Supreme Court. He volunteered for military service in World War II and was subsequently awarded 18 decorations, including the Bronze Star and the Purple Heart.

Thurmond is a former State Senator, Circuit Judge, and Governor of South Carolina, 1947-1951. He was the States Rights Democratic Candidate for President of the United States in 1948. He has been elected in South Carolina as an Independent, as a Democrat, and as a Republican. He became a Republican in 1964 during the Presidential campaign of Senator Barry Goldwater. Senator Thurmond was first elected to the U.S. Senate on November 2, 1954, and has been reelected each succeeding term. Thurmond is President pro-tempore of the Senate and Chairman of the Senate Judiciary Committee. He also serves on the Senate Armed Services Committee and the Senate Veterans Affairs Committee.

He has been an excellent friend of this Administration, particularly in his capacity as Senate Judiciary Committee Chairman. For example, Senator Thurmond worked effectively to have both your school prayer amendment and Senator Hatch's silent prayer amendment reported from the Judiciary Committee. Without his assistance, only the Hatch amendment would have been reported. You have thanked Senator Thurmond personally for his assistance in this matter.

The Senate is expected this fall to debate your Crime package, which Senator Thurmond was instrumental in guiding through the Judiciary Committee. The Judiciary Committee may take action on the Administration's Fair Housing legislation before the end of this session so that the Senate floor debate on this important issue can be scheduled for early next year.

Senator Thurmond is married to the former Nancy Moore and has four children; Nancy Moore, Strom Jr., Juliana Gertrude, and Paul Reynolds.

CONGRESSMAN FLOYD SPENCE

(R - South Carolina)

Floyd Spence was first elected to the House of Representatives in 1970. The second district, which the Congressman represents, is in the center of the State and includes the capital, Columbia, Mr. Spence's home.

The third ranking Republican on the House Armed Services Committee, Mr. Spence has been a solid and consistent supporter of the President's defense policies and initiatives. He has voted with the Administration on all key votes in the 98th Congress except on the IMF extension. He also serves as Ranking Member of the Committee on Standards of Official Conduct (the "Ethics Committee" so much lately in the news).

Mr. Spence has earned the confidence and respect of his colleagues. He serves on the executive committee of the Republican Committee on Committees, which makes all House Republican Committee assignments. He is also on the House Republican Policy Committee.

A practicing attorney in South Carolina, Mr. Spence served in the Navy in Korea and for ten years in the South Carolina legislature, including a term as State Senate Minority Leader before his election to the Congress.

Mr. Spence is a widower and the father of five sons.

CONGRESSMAN CARROLL CAMPBELL, JR.

(R - South Carolina)

Carroll Campbell was first elected to Congress in 1978. After an initial period of service on the Appropriations Committee, he transferred to the prestigious Ways and Means Committee in 1983 where he serves on the Oversight Subcommittee and as Ranking Member of the Subcommittee on Public Assistance and Unemployment Compensation. He represents the fourth district which serves the towns of Greenville and Spartanburg in South Carolina's northwest mountain country.

An ardent supporter of the Administration and the President, especially opposing big government and high taxes, Mr. Campbell has voted with the Administration on all issues in the 98th Congress except the consideration of the IMF extension, though he did join us on final passage.

As the Ranking Member of the Ways and Means Subcommittee on Public Assistance, he is in a unique position to advocate the Administration policies on welfare issues in a strongly liberal committee. He has become a champion of new Child Support Enforcement legislation and has endorsed the Administration bill as well as his own.

Carroll Campbell's background is in real estate and farming. He was Executive Assistant to Governor Jim Edwards in 1975-76 and in the South Carolina Senate in 1976-78. His district is considered safe.

Mr. Campbell is married and the father of two sons. His wife, Iris, will be accompanying him on Air Force I.

CONGRESSMAN THOMAS F. HARTNETT

(R - South Carolina)

Congressman Hartnett is in his second term having defeated Charles (Pug) Ravenel in 1980 following the retirement of Mendel Davis. The Congressman represents the first district of South Carolina which is in the southern tip of the State and includes Charleston, Mr. Hartnett's home, and accounts for his special interest in shipbuilding.

A member of the Armed Services Committee, Tom Hartnett has been an active and vocal supporter of the President's policies and the Administration's legislative initiatives. He has consistently voted with the Administration on all issues except the IMF extension.

Mr. Hartnett is an up-and-coming young Republican Member and is highly respected by his colleagues who elected him Freshman Class President for the 2nd session of the 97th Congress.

Mr. Hartnett is a realtor, used to be a Democrat and served eight years in the South Carolina House of Representatives and eight years in the State Senate. He is married and the father of two children.

SOUTH CAROLINA -- POLITICAL BRIEFING

STATE POLITICAL BACKGROUND

- The growth of the Republican party has led to GOP victories in 4 of 5 presidential elections since 1964.
- Three of South Carolina's six members of Congress are Republicans.
- South Carolina has only elected one Republican as Governor and U.S. Senator since Reconstruction Strom Thurmond and James West (Governor 1974-78).
- For years now, South Carolina has been more progressive then most of its neighboring states in the growth of its economy.
- The economic strength of South Carolina has moved inland from the ports. Textiles have become the largest industry with the biggest concentration of mills in the Piedmont, along Interstate 85 passing through Greenville and Spartanburg.
- South Carolina's new image is one of a prosperous Sun Belt industrial mecca.
- The influx of "Yankee" corporations, industrial growth and lessening of racial tensions have given the state something most Deep South states lack -- a functioning two-party system.
- State politics is divided equally among three groups:
 - -- blacks, who remain heavily Democratic and are attracted to liberal candidates like Charles Ravenel.
 - -- country club whites, who are solidly Republican in national and most state contests.
 - -- textile-mill whites, who dislike the national Democratic party for its liberal stands on cultural issues, endorsing values antithetical to theirs, and smirking at their traditional values (religion, patriotism, family) as backwards; but on many economic issues they remain New Dealers. They strongly dislike labor unions, talk of redistributing income, tax breaks for the rich, social security cuts, and cuts in school lunch and education programs. They have voted mainly with the Democrats since 1970.

- During the colonial period, South Carolina was the only colony where blacks massively outnumbered whites, and most settlers were large landholders who could only grow their crops (sugar, rice, indigo) with the labor of vast numbers of slaves.
- The Civil War began in early 1861 when rebels opened fire on Fort Sumter in Charleston harbor. These rebels consisted of young aristocrats who were hotheaded opponents of any action that in any way restricted or reflected negatively on slavery.
- For a time during the 1870s, blacks controlled the South Carolina legislature and the state's congressional delegation. But such "outrages" of Reconstruction were soon ended, and the blacks and most poor whites lost the vote and all political rights.
- South Carolina no longer has a black majority 30% of its residents were black in 1980; nor does it practice white supremacy 28% of its voters were black in 1982. However, since these blacks are younger than whites and tend to have more children, the long-term prospect is for the black percentage to increase.
- South Carolina has an estimated population of 3,203,000 of which 2,179,854 were of voting age, but only 1,229,319 were registered.
- For most of the 20th century, South Carolina has been among the lowest in per capita income, level of education, and public health statistics.
- South Carolina has one of the lowest levels of political participation; as late as 1948, only 142,000 South Carolinians voted in the presidential election the population was over two million people.

1984 PRESIDENTIAL ELECTION

- South Carolina will send 35 delegates to the Republican National Convention.
- It will cast 8 electoral votes in 1984.
- President Reagan carried the state in 1980 with 49.4% of the vote and carried Richland County (Columbia) by a 51%-46.5% vote margin.
- The Republican primary will be held on March 10, 1984.

DEMOCRATIC PRESIDENTIAL CAMPAIGN

• Several South Carolina Democratic leaders are getting involved with the Mondale and Glenn campaigns. These Democrats support favorite son Fritz Hollings, but do not see him as a viable candidate. The goal is to create a second choice - probably Glenn.

- Mondale's top supporters include: James Quackenbush, Carter's 1980 state manager; and Sam Tanenbaum, a well-known fundraiser for Governor Riley.
- Some Democrats feel that Hollings has not raised enough money and have doubts about the ability of his staff.
- Two veteran South Carolina Democrats have joined Senator Ernest F. Hollings presidential campaign -- Democratic National Committeeman Donald Fowler, and South Carolina State Ports Authority Chairman Henry Tecklenburg, Jr.

-- Fowler is the political coordinator;

- -- Tecklenburg is the campaign coordinator and will be based out of Washington, D.C.
- The Columbia State (9/4) newspaper reports that Senator Fritz Hollings is throwing all his resources into a make-or-break showing in Maine's October 1 straw poll and he is expected to spend half of September stumping there.
- Hollings press spokesman, Al Kamhi, believes that Hollings has a good opportunity to win the straw poll, but that they'll settle for a clear, strong third place finish.

STATE POLITICAL SUMMARY

U.S. SENATE:

- 29-year incumbent Republican Strom Thurmond is expected to seek re-election and is the solid favorite. Although mid-July polls gave Governor Riley a 47%-40% advantage over Thurmond, Riley has announced that he will complete his gubernatorial term.
- Other prominent Democrats which have declined the nomination include:
 - -- former U.S. Rep. Ken Holland, who will be organizing and heading "Democrats for Thurmond";
 - -- U.S. Rep. Butler Derrick;
 - -- State Comptroller General Earle E. Morris, Jr., who has endorsed Thurmond;
 - -- Adjutant General T. Eston Marchant, who has endorsed Thurmond;
 - -- Secretary of State John Campbell, who has endorsed Thurmond;
 - -- Charleston Mayor Joe Riley, who has endorsed Thurmond.

- Possible Democrat candidates have included:
 - -- former Lt. Governor Nancy Stevenson, who has been slowed somewhat by two major operations in the last 6 months and is preoccupied by Hollings' presidential race;
 - -- Democrat State Chairman and former 13-year Rep. W.J. Bryan Dorn; however an August 13 auto accident has put him in the hospital and a race is unlikely for him now.
- Thurmond has raised about \$400,000, much of it with the assistance of Columbia banker W.W. "Hootie" Johnson and former Governor Robert McNair.
- Anti-tax advocate and Libertarian <u>Dean Allen</u>, 32, has announced he will challenge Thurmond in November. Allen has called Thurmond "a conservative who has become a liberal;" his platform calls for an end to income taxes, a return to the gold and silver monetary standard and a balanced federal budget.

- -- When he is not working on major issues, Thurmond is looking out for South Carolina interests; constituent service is one reason he has survived so long in a rapidly changing state.

 He always makes sure his state receives a steady flow of funds.
- -- In 1971, Thurmond became the first Southern senator to hire a black professional staff member.
- -- Thurmond remains an avid physical fitness enthusiast.

Democrat Richard Riley won a second term in defeating Republican William Workman, Jr. by a huge 70%-30% margin.

Republican Thomas Hartnett won a second term over Democrat Mullins McLeod by a 54%-45% margin.

6th C.D. East - Florence

First term Republican John Napier was narrowly defeated by Democrat state Representative Robin Tallon by a 52%-48% margin. Napier was originally elected to fill the seat formerly held by John Jenrette. The 6th District Republicans consider Tallon vulnerable and are already searching for a candidate to challenge him in 1984. They hope the candidate will be Napier, but he has yet to announce his intentions.

- In 1982, the GOP gained two seats in the state House (there were no state Senate elections.)
- All state Senate and House seats will be up for election in 1984.
- The legislature has completed congressional and state house redistricting plans. However, the state senate redistricting is still incomplete, and political observers in the state expect it will go to the courts.

STATE PARTY UPDATE

- State Chairman George G. Graham, has announced he will not seek re-election to another term.
- The state party convention, April 13-14, 1983, will therefore be selecting a new state chairman as well as at-large delegates to the Republican National Convention.

- Potential candidates for the position include:
 - -- GOP National Committeeman John E. Courson;
 - -- former Agriculture Commissioner Bryan Patrick;
 - -- Greenville County Councilman Mike Spivey.
- Courson is presently working on the Thurmond effort coordinating a voter identification and fundraising drive in South Carolina.
- The state party is at present actively involved in two special legislative elections one each in the state House and Senate. Both are considered toss-ups.
- The party is also organizing a massive voter registration program to be conducted in the GOP-leading precincts statewide.

STATE ISSUES

- The legislature approved a multi-state pact with other southern states regarding the disposal of low-level nuclear wastes. The agreement stipulates that South Carolina will continue to accept low-level nuclear wastes from other states at the Savannah River Plant until 1992. However, each state will be responsible for developing their own disposal sites after 1992.
- Bob Jones University lost its tax exempt status after the Supreme Court voted 8-1 that their discriminatory practices did not allow them to use a religious exemption. The Administration had briefly supported the tax exempt status, but later reversed the decision. Bob Jones University is located in Greenville.
- The parents of U.S. Navy Lieutenant Commander Albert A. Schaufelberger, III, who was the first American casualty in El Salvador, lived on Fripp Island.
- Jesse Jackson has mounted a very aggressive voter registration program in South Carolina through Operation PUSH.
