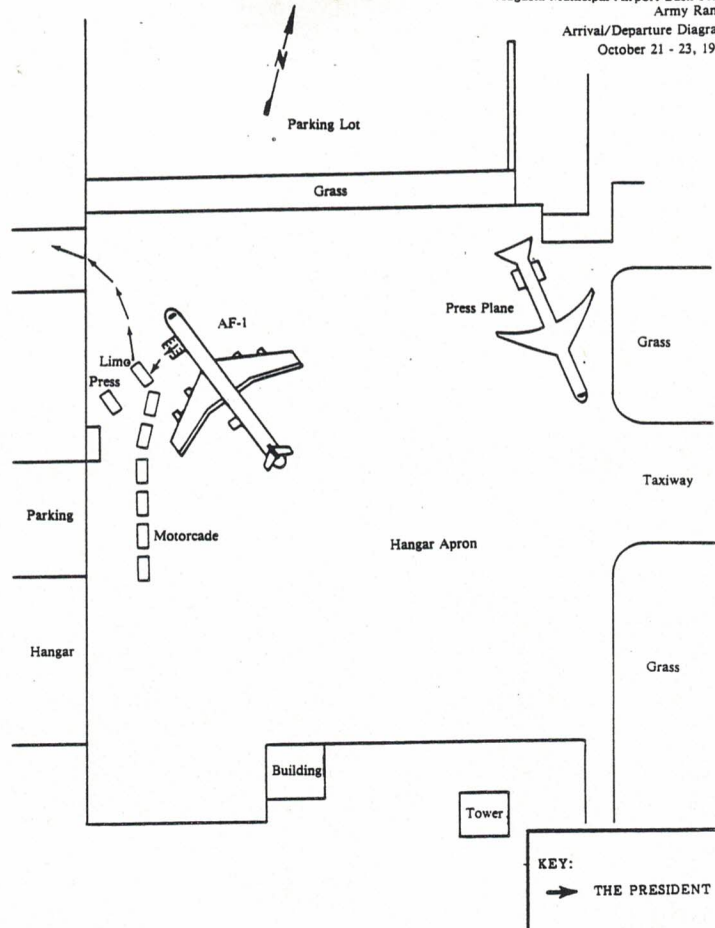

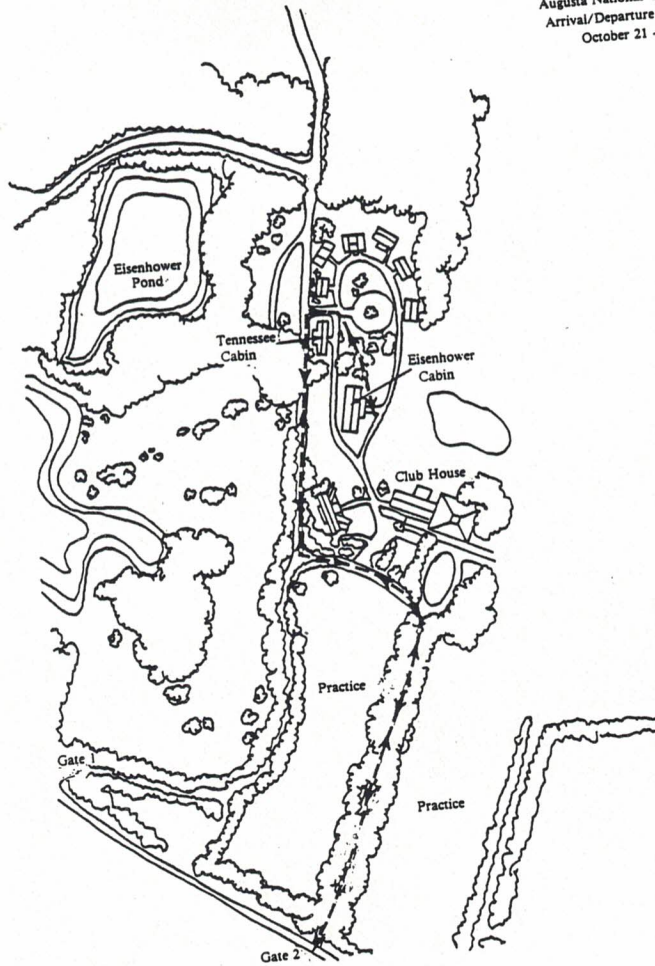

SUBJECT: GEORGIA — POLITICAL BRIEFING

STATE POLITICAL BACKGROUND

- Since 1948, Georgia has voted Republican in 2 of 9 presidential elections (1964 for Barry Goldwater; 1972 for Richard Nixon).
- Georgia has elected only one Republican U.S. Senator in its history - incumbent Mack Mattingly.
- The state has not elected a Republican governor since Reconstruction.
- Georgia has the greatest land area of any state east of the Mississippi.
- Georgia has been known as the Empire State of the South.
- Georgia's per capita income, which was only 50% of the national average back in 1929 and 68% in 1950, had climbed to 97% in 1980.
- Atlanta's Hartsfield International Airport, opened in 1980, is the world's busiest airport in the number of planes taking off and second only to Chicago's O'Hare in the volume of passengers.
- The city of Atlanta proper lost 70,000 people in the 1970's, dropping to a total population of 425,022 while the suburbs gained.
- About two million people live in the Atlanta area.
- White flight is a serious problem facing Atlanta. By 1980, the population was 66.5% black; in suburban areas only 13% was black.
- Georgia is a major manufacturing state in textiles, apparel, wood products - (69% of Georgia's land is covered by forests)--transportation equipment, chemicals, food processing, airplanes and mobile homes.
- State agricultural products include cotton, peaches, peanuts, livestock and Georgia leads the nation in poultry production.
- Federal military establishments pump billions of dollars into Georgia's economy each year -- they include Ft. Benning, Warner Robins Air Force Base, Ft. Stewart, Ft. Gordon, and Kings Bay Naval Submarine Base.

- Tourism is down since the defeat of Jimmy Carter in 1980.
- The state has made enormous strides in race relations - each year it attracts thousands of talented blacks.
- 18 Georgia counties have majority black populations, yet only 6 have majority black voter registration.
- Atlanta has become one of America's most vibrant cities as it has become a major corporate and business center. 431 of the Fortune 500 industrial firms have offices in Atlanta.

1984 PRESIDENTIAL CAMPAIGN

- Georgia Republicans will send 37 delegates to the 1984 Republican National Convention.
- Georgia will have 12 electoral votes in 1984.
- Georgia was among the 6 states plus the District of Columbia carried by Jimmy Carter in 1980.
- President Reagan finished second with 41% of the statewide popular vote in 1980 and received only 44% of the Richmond County (Augusta) vote.
- The state Democratic and Republican presidential primaries are scheduled to be held on March 13, 1984.
 - This date has become known as "Super Tuesday" because of the number of Democratic convention delegates up for grabs.
 - Georgia is one of nine states holding Democratic primaries or caucuses on that date.

DEMOCRATIC PRESIDENTIAL CANDIDATES

Debate

- A debate among Democratic presidential candidates will be held March 11, in Atlanta, two days before the Georgia presidential primary. The debate which will be sponsored by the League of Women Voters is the second debate to be scheduled for the 1984 campaign season. The first League - sponsored debate will be in Manchester, New Hampshire in late February 1984.

Mondale

- Members of the host committee for a June Mondale reception in Atlanta included Jack Watson, former Carter White House chief of staff; Dorothy Padgett, former Carter political protocol chief; Robert Lipshutz, former council to Carter; and former ambassadors Philip Alston and William B. Schwartz, Jr., all of the Atlanta area.

- Members of the Carter White House who have yet to endorse a candidate include former White House Chief of Staff Hamilton Jordan; former Office of Management and Budget Director Bert Lance, the current Democratic State Party Chairman; and former U.N. Ambassador Andrew Young.
- Atlanta Mayor Andrew Young was elected in 1972 as Georgia's first black congressman since Reconstruction. He was all set to endorse Mondale months ago, but has since become silent.
- Former President Jimmy Carter has formally endorsed Walter Mondale for the Democratic presidential nomination. Carter, however, does not intend to campaign actively in 1984.
- Chip Carter and Dot Padgett will open Mondale's Georgia office later this fall.
- Young believes that Jackson's presidential effort is futile, but publicly encourages him to run to help black registration.

Glenn

- Sen. John Glenn has hired Alan McLeod to coordinate his Georgia efforts and is the first candidate to open a campaign office in Georgia.
- McLeod is working with Chris Valley, a social services administrator for a private, non-profit agency and former chairman of the Georgia Young Democrats, to contact members of religious and welfare organizations and political groups for financial and/or volunteer help.
- U.S. Rep. Robert Lindsay Thomas has endorsed Glenn and will head Glenn's state committee.
- Besides Thomas, others named to Glenn's Georgia election committee are state Rep. Larry Walker, Jr. of Perry, state Senator Roy Barnes of Marbleton, Bob James, president of Carver State Bank, and Pauline Woods, head of the 1st Congressional District Democratic Committee.
- Over 200 Georgians have volunteered to work on the Glenn campaign.

Others

- House Speaker Tom Murphy and Lt. Gov. Zell Miller have both endorsed former Governor Reubin Askew.
- Sen. Ernest Hollings has appointed a full-time coordinator in Georgia.

- Sen. Gary Hart has named Atlanta attorney David Garrett III as his coordinator in Georgia. Garrett is working on a volunteer basis from his office.
- Fulton County Commission Chairman Michael Lomax will support Hart's bid for the Democratic nomination.

STATE POLITICAL SUMMARY

U.S. SENATE:

In 1984, incumbent Democrat Sam Nunn will be running for election for a third term. The entire Georgia Congressional delegation has endorsed Nunn, including Republican Rep. Newt Gingrich and Senator Mack Mattingly. Nunn was reported to have \$580,000 in campaign funds available according to the June 30 FEC reports. That made his campaign chest the sixth largest in the Senate. No Republican opposition is expected.

GOVERNOR:

State Representative Joe Frank Harris, a conservative Democrat, defeated Republican state Senator Bob Bell by a 63%-37% margin. Bell is now the State Chairman of Georgia's Republican party.

SPECIAL ELECTION:

7th Congressional District Primary: October 18
Run-off: November 8

- Kathryn McDonald, widow of the late Congressman Larry McDonald, who was killed when the Soviets shot down a Korean airliner, finished first of the 19 candidates on the non-partisan ballot for her dead husband's seat. McDonald defeated second-place finisher Democrat state legislator George W. "Buddy" Darden by a 31%-26% margin. Republican attorney David Sellers, who lost to Larry McDonald in 1982, finished third in the special election with 23%.
- Conservative Democrat McDonald will face liberal Democrat Darden in a November 8 run-off.

Key 1982 Congressional Elections

1st C.D. Southeast -- Savannah

Democrat Lindsay Thomas defeated Republican state Representative Herb Jones by a 64%-36% margin. This seat was vacated by U.S. Rep. Bo Ginn who retired to run for governor.

4th C.D. Atlanta (suburbs)

Democrat Elliott Levitas easily defeated Republican Dick Winder by a 65%-35% margin in an election held in late November due to redistricting delays.

STATE LEGISLATURE:

Republicans are in the minority in both houses of the state legislature. In 1982, however, the GOP did post a gain of 2 seats in the Senate, while recording no losses in the state House. The current party make-up is:

MUNICIPAL ELECTIONS:

- Macon, Georgia

General election: November 8

- First-term Republican Mayor George Israel of Macon is considered a favorite for re-election.
- Israel easily won the October 4 Republican primary.
- The Democrat candidate is Floyd Busbee, is a former member of the Georgia Pardon and Parole Commission.
- Israel is currently chairman of the National Conference of Republican Mayors.

STATE PARTY UPDATE

- On May 21, the Georgia Republican Party elected new officers.
 - Former state Senator Bob Bell retained his chairmanship of the party. Bell lost in his bid for the governorship in 1982.
 - Tom Hocaday, a professional political operative from Texas, has been hired as the new executive director in a total overhaul of the party's entire professional staff.
- Programs being developed by the party include:
 - new long term party plan for the '84 elections to cover 1 or 2 targeted Congressional races, legislative elections, and the presidential election. (Democrat Gov. Harris has admitted that wresting the southern region of the country away from Reagan will be extremely difficult.)
 - new long term financial plan.
 - targeted polling program.
 - organizing a strong voter identification program, especially in the suburban areas.
 - designing outreach into the rural/farm communities - especially difficult areas for Republicans in 1982.
