In May, 1983, the Office of Public Liaison of the White House asked me to develop a group of physicians who were concerned about the medical aspects of nuclear war, who would be interested in learning more specific information about that issue in order to counteract the emotional, sometimes hysterical, tirades of the "Physicians for Social Responsibility". With the excellent cooperation and assistance of members of the Office of Public Liaison such as Ms. Whittlesley, Ms. Buckalew, Mr. Rousselot, and Mr. Blackwell we have been able to accomplish this objective. We have established a timetable for an informational briefing to be followed by various personal appearances throughout the nation that would provide solid methods for disaster preparedness, handling nuclear casualties, and therefore thwart the thrust for nuclear disarmament that had emanated from the demagogues.

Now, I find myself at a loss to conscientiously continue with this project. The failure of substantive response to the Korean Airline massacre has left me almost speechless. In the two weeks since this tragedy, your administration has failed to demonstrate its will and resolve to respond to an unconscionable act on the part of the Soviet Union. There is no way I can ask a group of physicians to demonstrate their will and resolve until you and your Administration take appropriate steps to defuse the Soviet Union. This failure to act is the crowning blow in a series of activities to support Communism and its allies with technologic and economic assistance that is controlled by the Executive branch of government.

It is with a heavy heart that I must respectfully withdraw my support and energy from what appeared to be a major trend in the direction of re-establishing the greatness of the United States of America.
