



The primary purpose of ASLO is to help elected officials return to the form of government originally established by our founding fathers. To implement these precepts by assisting local governments through sharing research information and staff facilities, establishing a clearinghouse for local ordinances, providing for an ordinance exchange program, preparing and disseminating model legislation, conducting and sponsoring forums, lectures, debates and similar programs, and through improving communications between local officials and officials at other levels of government.

Attached hereto is a draft of the articles of incorporation for your new city and county officials organization. I don't know if you have a name in mind. I have tentatively entitled the organization The American Society of Local Officials.

The articles of incorporation will be complete with the addition of the names and addresses of at least three directors in Article TWELFTH. Please look the articles over, determine whether they meet your requirements, and add the names of the three initial directors. I will make sure that they are filed.

The next step after filing the articles of incorporation would be to prepare bylaws along the lines of the American Legislative Exchange bylaws, or, if you prefer, along the lines of the Free Congress Foundation bylaws. Basically, all we need to do is to set forth the basis for membership in the organization and the provisions for corporate governance. We would then prepare an application for tax-exempt status. The articles of incorporation and bylaws need to be put in final form before preparation of the application for exemption, since some of the questions on that form relate to these documents.

ARTICLES OF INCORPORATION

OF

AMERICAN SOCIETY OF LOCAL OFFICIALS

To: The Recorder of Deeds of the District of Columbia, Washington, D.C.

We, the undersigned, being natural persons of the age of 21 years or more, acting as incorporators of a corporation, do hereby adopt the following Articles of Incorporation for each corporation pursuant to the District of Columbia Nonprofit Corporation Act.

FIRST: The name of the corporation is:

AMERICAN SOCIETY OF LOCAL OFFICIALS.

SECOND: The period of duration is perpetual.

 $\underline{\text{THIRD}}$: The specific and primary purposes for which this corporation is formed and for which it shall be exclusively administered and operated are to receive, administer and expend funds for charitable and educational purposes in connection with the following:

- 1. To assist local governments by sharing research information and staff facilities;
- 2. To establish a clearinghouse for local ordinances and provide for an ordinance exchange program;
 - 3. To prepare and disseminate model legislation;
- 4. To engage in nonpartisan research, study and analysis, for the benefit of the general public, regarding the role of local government in American life; and to publish the results of such study and research;
- 5. To improve communications between local officials and officials at other levels of government;
- 6. To create educational materials and conduct educational activities in support of the general purposes of the Corporation;

- 7. To conduct and sponsor forums, lectures, debates and similar programs;
- 8. To assist other charitable, educational and social welfare organizations in the conduct of similar activities;
- 9. To establish in the main office or elsewhere all departments and activities necessary to carry out the purposes of the corporation; and
- 10. To engage in any and all lawful activities incidental to the foregoing purposes except as restricted herein.

In order to accomplish the foregoing charitable and educational purposes, and for no other purpose or purposes, this corporation shall also have the power to:

- (a) sue and be sued;
- (b) make contracts;
- (c) receive property to devise or bequest, subject to the laws regulating the transfer of property by will, and otherwise acquire and hold all property, real or personal, including shares of stock, bonds and securities of other corporations;
- (d) act as trustee under any trust whose objects are related to the principal objects of the corporation, and to receive, hold, administer and expend funds and property subject to such trust;
- (e) convey, exchange, lease, mortgage, encumber, transfer upon trust or otherwise dispose of all property, real or personal;
- (f) borrow money, contract debts and issue bonds, notes, and debentures, and secure the payment of any performance of its obligations; and
- (g) do all other acts necessary or expedient for the administration of the affairs and attainment of the purposes of the corporation;

provided, however, that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this corporation.

<u>FOURTH</u>: The corporation shall have such members as determined by the Board of Directors as set forth in the Bylaws

FIFTH: No part of the net income of the corporation shall inure to the benefit of or be distributable to its trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of the purposes and objects set forth in Article THIRD hereof.

SIXTH: The business of the corporation shall be carried on through its Board of Directors; the manner of their election or appointment, other than the initial Board of Directors provided for herein, shall be as provided in the Bylaws. The Bylaws and other documents of the corporation may refer to the Board of Directors as the Board of Trustees.

SEVENTH: The private property of the incorporators, directors, and officers, shall not be subject to the payment of corporate debts to any extent whatever; in furtherance and not in limitation of the powers conferred by statute, the corporation is expressly authorized to carry on its business and to hold annual or special meetings of its Board of Directors in any of the states, territories or possessions of the United States, or the District of Columbia.

EIGHTH: Notwithstanding any other provision of these Articles, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

NINTH: Upon the dissolution of the corporation or the winding up of its affairs, the assets of the corporation shall be distributed exclusively for charitable, religious, scientific, testing for public safety, literary or educational purposes to organizations which are then exempt from Féderal Tax under Section 501(c)(3) of the Internal Revenue Code of 1954, and to which contributions are then deductible under Section 170(c)(2) of such Code or corresponding provisions of any subsequent federal tax laws.

TENTH: The address, including the street and number of its initial registered office is: 1747 Pennsylvania Avenue, N.W., Washington, D.C., and the name of its initial registered agent is Alan P. Dye.

ELEVENTH: The corporation reserves the right to amend, change or repeal any provision contained in these Articles of Incorporation or to merge or consolidate this corporation

with any other nonprofit corporation in themanner now or hereafter prescribed by statute, provided, however, that any such action shall be calculated exclusively to carry out the objects and purposes for which the corporation is formed, and all rights herein conferred or granted shall be subject to this reservation.

TWELFTH: The number of trustees constituting the initial Board of Trustees is five, but the number of trustees may be increased or decreased in the manner set forth in the Bylaws, provided that the number shall not be less than three.
