Dear Mr. Blackwell,

Dr. Jim Fowler, our Lions International President, has expressed his real pleasure in having the chance to meet with you yesterday. We are including with this letter a packet of information regarding the 50th anniversary celebration which we are planning, including speeches by Dr. Fowler and President Reagan and guest appearances by Governor Thompson of Illinois and Senator Percy and others.

This event is expected to produce approximately a quarter of a million dollars in charitable funds from the private sector, in keeping with the President's own philosophies as expressed on several occasions, including just the other evening on television. Besides enhancing the President's goals of private sector support for health care, the arts and the handicapped, it will also provide a stage for him to generate political support in a critical year in one of the most important election states in the union.

Would you please take the time to discuss this program with Governor Jim Thompson of Illinois, the President's Illinois campaign manager? He is joining us for the event and believes the President should be here, also. We appreciate your time and consideration and await your early response.

WHO ARE THE LOSS



They are volunteer members of clubs grouped under an International organization, where they enjoy fellowship, develop their leadership capacities, and dedicate part of their free time to help those in need all over the world, while making their individual communities a better place to live in.

The Origin

Lionism began in the United States in 1917 when a group of independent clubs responded to an ideal presented to them by a young Chicago insurance agent, Melvin Jones.

The ideal was one of service as a group to their fellow men without regard to politics, religion, race, or in any way the personal interests of the members. This was heralded as a departure from the trend current at that time of forming clubs basically with a commercial motive. A conference was called of some 25 independent clubs on June 7, 1917 and from this meeting the organization was born.

The Name

The official name of "Lions" is: "The International Association of Lions Clubs" or simply "Lions Clubs International."

The Emblem

It consists of a gold letter "L" on a circular purple field. Bordering this is a circular gold area with two conventionalized lion profiles at either side facing away from the center. The words "Lions" appear at the top and "International" at the bottom. Symbolically, the lions face both past and future—proud of the past and confident of the future.

It is the unwritten obligation of every Lion to wear and display his emblem with pride.

The Slogan

"Liberty, Intelligence Our Nation's Safety."

The Colors

Purple and Gold

To Lions, **purple** stands for loyalty to country, loyalty to friends, loyalty to one's self and to the integrity of mind and heart. It is the traditional color of strength, courage and tireless dedication to a cause. **Gold** symbolizes sincerity of purpose, liberality in judgement, purity in life and generosity in mind, heart and purse toward his fellow man.



World-wide Growth

Although the youngest, The International Association of Lions Clubs has grown to be the largest service club organization in the world, represented by over 33,600 clubs with a membership exceeding 1,285,000 in over 150 countries and geographic areas.

World-wide Organization

The Association's headquarters is located in Oak Brook, Illinois, U.S.A. The Association is governed by an elected Board of 33 members from all parts of the world. This Board includes 28 Directors, 3 Vice-Presidents, the Immediate Past President and is headed by the International President.

Club Organization

A Lion joining a club for the first time pays an entrance fee to the Association. His annual dues to the International Association, the District and his home club constitute his financial commitment other than his meeting costs and participation in functions.

A Lion member may transfer to any club in the world, subject to the new club's acceptance. It is a requirement that a Lion complete his transfer within six months following the date of termination of membership in his former club.

Club meetings are held at least twice monthly. Normally one meeting is devoted to business and the planning of projects and the other to a dinner meeting often with a guest speaker, sometimes with ladies present.

The required attendance of members (either at club meetings or at activities), participation of ladies, type of program, formation of committees, etc., are all decisions finally taken by the local club based on the broad recommendations of the Association.

Lions Clubs elect their officers annually and work through club committees.

All monies for a Lions Club activity are raised by the efforts of the members through whatever legal fund-raising projects they may devise.

The Basis of Membership

Any male person of legal majority, good moral character and good reputation in his community may be granted membership in a duly authorized Lions Club. Membership is by invitation only.

Service to the Community

From the start, the emphasis has been on service in all forms to less fortunate members of the community. The club constitution, as recommended by the Association, may be adapted by the local club to suit its own particular requirements while keeping within the principles of the Association and its International constitution. This autonomy allowed to the individual clubs and the concentration on practical service have perhaps been the two principal factors which maintain the momentum of the Association's growth and progress.

International Cooperation

At the same time the completely international nature of the organization, with the possibility of frequent and everincreasing contact between the members of the clubs around the world based on their common interest in community service, has always been a feature to catch the imagination and the enthusiasm of the broadest of minds.

Condell Memorial Hospital is a nonprofit, 183-bed acute care complex dedicated to providing the residents of central Lake County with comprehensive and individualized medical services. Its staff and physicians, representing all specialties in medicine, annually care for over 9,000 inpatients (including 850 newborns) and almost 67,000 outpatient visits, including 18,000 emergency visits.



A HISTORY OF COMMUNITY SUPPORT: The history of Condell's growth is a story of the generosity of Lake County's residents. The hospital on the prairie was founded in 1928 through a bequest of Elizabeth Condell. Its land was donated by the industrialist Samuel Insull, and many members of the community donated the remaining capital. In 1952 the Noble Wing was added

through a gift from Lillian Noble Keene, and in 1954 the Hannah Hough Memorial Maternity Wing was created through a gift of Frank G. Hough. Thousands of individual donations helped build the West Wing, completed in 1973. In 1981 a major expansion and renovation almost doubled the Hospital's area, modernizing all major facilities with the support of more than 1,500 individuals, foundations, and businesses.

Innovative Programs: Condell Memorial's services include the Ambicenter, in which outpatients can receive surgery and return home the same day. The new obstetric expansion provides such optional services as prenatal classes in natural childbirth, a birthing room, rooming-in, and sibling visitation. The 24-hour Emergency Department receives twelve paramedic units serving eighteen communities in Lake County. The Intensive and Cardiac Care Center's eight private critical care rooms have computerized monitoring systems with 24-hour recall. Other services, such as the Children and Teenage Center, are equally up-to-date and patient centered.

MEDICAL EDUCATION: Condell helps train medical professionals in affiliation with: College of Lake County Associate Degree Nursing Program and Licensed Practical Nurse Program; University of Health Sciences/The Chicago Medical School Department of Physical Therapy; Northwestern University—The Medical School Programs in Physical Therapy and Northern Illinois School of Allied Health Professionals' Program in Physical Therapy. Condell's own medical staff has a vigorous continuing education program. For the community's residents, Health-line provides, over the telephone, medical information on hundreds of topics.

THE AUXILIARY: Over 300 members of the hospital's Auxiliary volunteer to work with patients and students, to raise funds, to operate the Blue Smock resale shop in Libertyville and the hospital gift shop, and to engage in other activities vital to Condell's welfare. They have pledged \$300,000 to Condell's expansion program.

Donor Information: The Condell Health Care Foundation was incorporated in 1980 "to foster, promote, develop, encourage, maintain, receive, and accept" contributions to Condell Memorial Hospital. Gifts to the Foundation are tax deductible.

Donor Recognition and Memorial Opportunities: The Center Club of the Hospital provides membership to donors on many levels, from "Centurion" to "Directors' Circle." All memorial and commemorative gifts are inscribed in the Hospital Register, on view in the hospital's main lobby. The 1981 expansion provided many naming opportunities for donors, some of which are still available, including a wide variety of facilities and equipment in every department. The Hospital is also seeking contributions to help fund a new surgical suite, for which there is a serious need. For detailed information, contact Henry E. Krippner, Director of Development.

In the time of the "great house", David Adler was one of its most distinguished architects. From 1911 to 1947, he designed and built some of the most beautiful dwellings in the United States. Most of his homes were built in Chicago and along its North Shore, occasionally ranging as far as Honolulu, Sarasota, Pebble Beach, and Ipswich, Massachusetts. Most are still standing, cherished by their owners, magnificent testimonials to Adler and to a past era.

With offices in Orchestra Hall and a long and distinguished record of service as a Trustee of The Art Institute of Chicago, David Adler, in his gracious way, left a heritage of affection for the city and its reputation as a world center of architecture. That his home for more than thirty years should become a lively art center is a most appropriate memorial to the man and his works.

To accomplish this immediate goal and to assure the future of his home and its use as an art center, friends of the Adler tradition and other distinguished business and cultural leaders have already established The David Adler Cultural Center, an Illinois not-for-profit corporation.

Today, hundreds of local and nearby residents participate each year in a wide variety of events and classes. Civic organizations as well as private businesses have become involved through special events. The scope of the programming extends far beyond any single artistic discipline, covering the visual arts, music, theater, film, dance, and writing. Spearheading the activities and community involvement are the two principal organizations of the Center; the founding Arts Club, now known as The Libertyville Arts Center (founded in 1949) and The Libertyville School of Folk and Old Time Music, founded in 1975.

Programs encompass a wide range of art and music classes for both adults and children, with exhibits, discussion groups, live model sketch nights, open studios, Art Forum (a lecture, film, and demonstration series), art and music workshops, jam sessions, Open Stage, concerts, folk dance gatherings, and an annual Festival of the Arts.


The extensive activities, coupled with the warmth and inspiration of the Adler House atmosphere, have created an "oasis" where serious artists and interested laypeople can gather to share ideas, experiences, and companionship. Serving as a base from which to reach out into the community, The David Adler Cultural Center is becoming a vital force enriching countless lives.

FINANCIAL RESPONSIBILITY

Self-help has characterized the growth of the Center. From its beginning, more than a dozen local service clubs have contributed money and labor to the rehabilitation efforts. As programs and services have expanded, most of the operating income is now derived from tuition fees, membership dues, and rentals. Both the Village and the Township have assisted with limited funds for community recreation. But all of these good efforts must now be substantially augmented by generous gift support from individuals, corporations, and foundations.

The Board of Directors of the Center will have as its goals:

- ... To complete the David Adler memorial room and exhibit
- ... To provide adequate professional staff
- ... To complete restoration and rehabilitation of the building and grounds
- ... To provide annual operating funds
- ... To provide a multipurpose facility for lectures, theater, concerts, and dance. Visible recognition will be conferred upon a major donor through the naming of this facility for the donor or for a person designated by the donor.
- ... To establish and develop endowment funds to assure the excellence of The David Adler Cultural Center of perpetuity.

Dear Mr. President:

First, please accept our heartiest congratulations on your decision to run again for election in 1984. We support you and wish you well.

This letter is written to repeat an earlier invitation to you to join the Libertyville Lions Club on January 9, 1984, on the occasion of its 50th anniversary of service to humanity. Your presence at our event would serve a tremendous public good and could greatly enhance your campaign in this pivotal State of Illinois. Libertyville's major experiences in the political arena have only been with democratic candidates like Adlai Stevenson and John F. We have been asked by the Tempel Smith family of Wadsworth, here in Lake County, to invite you and Mrs. Reagan to be their house guests at the Tempel Farms and to join them in a morning ride on their beautiful Lipizzan horses, the finest in the world. A large picture of you and King Hussein, riding Lipizzans, adorns one of the walls in their beautiful facility.

Also, during your visit here, Mr. and Mrs. Walgreen have asked that you join them at their "Hazelwood" estate in Dixon, Illinois, where you have some very fond memories. All of the important details regarding security, scheduling, etc., have yet to be coordinated with your staff, but are already in the planning.

Mr. President, we need your help to extend the work of the Lions Club. We respectfully ask that you consider all of the above and give us your positive answer at as early a date as possible. Our most sincere thanks to you.


The David Adler Cultural Center has announced that they plan to use money from this event for 3 purposes: the building of an endowment, special programs and the building fund. Details accompany this release.

The Endowment Fund had its beginning with monies from William McCormick Blair. He became our founding inspiration with regard to both the Center and these monies, and this Endowment was originally set up to perpetuate the Center and secure its future. Currently with \$62,160 in cash and bequests, our goal of \$500,000 in the Endowment Fund will insure that the Center has a basic foundation from which to grow. Since the fund is still in its very early stages, it would be a major benefactor from the Lions resources.

The Programs, the second area, is divided into the art school and the school of music. Enrollments in these schools have increased 100% since 1981, with close to 1,000 students taking part in classes and workshops annually. Current classes include: Suzuki violin and piano, guitar, banjo mandolin, jazz improvisation, instrument building, painting, watercolor, sculpture, ceramics, drama and many other disciplines too numerous to mention. Other programs such as our concert series preserving traditional American music and dance, exhibits of local and national artists and our annual Festival of the Arts would also benefit. The monies that would be applied here would

be of major benefit directly to the students and to the community because all monies go directly to the grass roots; to the individual students and into the classrooms to be used for the proliferation of additional programs as well as the enhancement of existing programs to benefit the student and the entire learning environment for both art and music.

The Building Fund, our third area, will enable us to create additional space to expand and diversify our cultural programming. Current space at the Center has restricted growth of some programs and prohibited expansion of new programs. The first phase of the proposed 2000 square foot addition is estimated to cost approximately \$150,000 and would serve as a multi-purpose room and make the Cultural Center more accessable to the handicapped.

The David Adler Cultural Center Board of Directors would like to reserve the right to apply the monies in the above areas according to the most critical needs, using the computation of percentage amounts to assertain the applications that would most significantly benefit the community as a whole.

Thompson, Percy say they'll come to Lions bash

Gov. James R. Thompson is telling the Libertyville Lions Club he plans to attend its 50th anniversary bash next. month and that he will do his best to make sure President Reagan will be there as well.

Lions Club President Henry E. Krippner and 50th anniversary chairman George M. Winters Jr. met with Thompson last week, and Winters says Thompson was excited about what the Lions are doing.

"HIE WAS VERY exact in his comment that he himself will definitely be there," says Winters, who admitted he was excited to be meeting with the governor.

After meeting with Thompson, Winters and Krippner, who were accompanied by Robert Neal, chairman of the Lake County Republican Central Committee, met with aides to U.S. Sen. Charles H. Percy, R-Ill. Percy aides at that time confirmed the senator will attend the bash as well.

With that momentum, Winters hopes Percy and Thompson will try to con-

vince the president that Libertyille will be good place to stop Jan. 9. The president is expected to announce his plans to run for re-election sometime in January or February.

Winters stresses that although the 50th anniversary banquet may have to be at Marriott's Lincolnshire Resort because of its size, the president would stop in Libertyville if he decides to attend the celebration.

Libertyville Village President Paul M. Neal said he would like to see the president travel through town, with stops at the David Adler Cultural Center, village hall and the Cook House in Cook Park.

"WE WANT Libertyville to be No. 1." Winters said. "We want to thank the citizenry of this community for their support of the last 50 years."

Also coming to the celebration is Lions International President James Fowler, and those invited include Chrysler Corp. Chairman lee Iacocca: U.S. Sen. Howard Baker, R-Tenn.; U.S. Sen. Alan J. Dixon, D-Ill.; U.S. Rep. John Porter, R-10th; and U.S. Rep. Philip M. Crane, R-12th.

Both Crane and Porter are writing the president and urging him to come to Libertyville, Winters said, but notther representative has yet said whether they will be able to attend.

The Lions are envisioning a possible fund-raising activity in which they'd grant 20 couples a private reception with the president at \$10,000 a crack. A contribution of \$1,250 a couple would entitle private receptions with Thompson, Percy and other guests who decide to attend.

Proceeds from the fund-raiser would

be donated to the Adler Center, Condell Memorial Hospital, with the remaining funds to be used by the Liens to belo handicapped people.

FOWLER IS scheduled to meet with Reagan later this month and will ask him whether he alans to come to Libertyville Jan. 9, Winters said.

The Lions already have completed a schedule of events for Reagan if he decides to visit but are not making those plans public until the Secret Service and other agencies have louked it over. The plans would be coordinated with the Libertyville Police Department.

Is Libertyville Reagan's kind of town?

The Libertyville Lions Club is hoping to land President Reagan for its 50th anniversary banquet in January, and while that might seem a tall order, the Lions think they have a chance.

"We feel we have a very strong case for the president of the United States to visit Libertyville at this time and this year," said George M. Winters Jr., chairman of the club's 50th anniversary committee.

IN FACT, the Lions are so excited about the chances that Reagan might accept the invitation, they're envisioning a fund-raising possibility in which they'd grant private audiences with the president at \$10,000 a crack.

Some even think the appearance would be an opportune time for Reagan to announce his candidacy for re-election.

"What better place than in Libertyville to do it?" Village President Paul M. Neal said.

As far as the White House's response to all of this, all anybody will say is that when the Lions sent an initial invitation in June, the president's appointment secretary replied that the Reagan's schedule is not drawn up that far in advance and the Lions should reinvite him later in the year.

"That was a very encouraging sign for us,"
Winters said. "It was not the typical refusal you
get from the White House."

EARLIER THIS month, the club, which also is inviting Gov. James R. Thompson, sept its second invitation to Reagan, who grew up in Illinois early in the century.

Club President Henry E. Krippner and Winters are scheduled to meet with Thomson Friday morning to ask him to come to the prebration as well as to intercede as Reagan's Winois campaign chairman to bring the president to Liberty-ville.

"There are various sources of people in Lake County who are helping us," Winters said.

Among the others invited are Dr. James M. Fowler, Lions International president, who has said he will attend; Chrysler Corp. Chairman Lee Iacocca; U.S. Sen. Howard Baker, R-Tenn., the Senate Majority Leader, U.S. Sen. Alan J. Dixon, D-Ill.; Sen. Charles H. Percy, R-Ill.; Transportation Secretary Elizabeth Dole; U.S. Rep. Philip M. Crane, R-12th; U.S. Rep. John Porter, R-10th; Donald H. Rumsfeld, president of G.D. Searle and special envoy to the Middle East; and Robert Schoellhorn, chairman of Abbott Laboratories.

The Lions will attempt to raise between \$150,000 and \$200,000 at the Jan. 9 event. The money would be split between Condell Memorial Hospital, the David Adler Cultural Center and the Lions Club, to be used to help handicapped people.

THE BANQUET is scheduled for the Cabriolet restaurant, but may be moved to Marriott's Lincolnshire Resort.

The funds would be raised by charging \$100 a person for the banquet, as well as setting up private receptions with the guests for an undetermined cost. If Reagan comes, as many as 50 couples would be allowed a private audience for \$10,000 a couple.

Winters said the trip would provide Reagan the opportunity to announce his candidacy for president, as well as travel through Illinois for a quick campaign tour.

In their letter, the Lions invited Reagan to stay at the Tempel Smith farm near Wadsworth, as well as stay at the Charles R. Walgreen III estate near Dixon, where Reagan grew up. Reagan has visited the Walgreen property several times.

Hopes remain high for Reagan visit

Governor and Sen. Percy accept invitations to attend Lions' fundraiser

"We're quite sure President Reagan and Mrs. Reagan are coming," George M. Winters, 50th ampiversary chairman of Libertyville's Lions International Club, said Monday in the Libertyville Village Hall.

Winters referred to an invitation to the Reagans to come to Libertyville on Jan. 9 to participate in the Lions' anniversary celebration — a fundraiser which Winters hopes will raise \$150,000 to \$200,000 for the Medical Center of Lake County at Condell Memorial Hospital, the Adler Cultural Center and for Lions' programs for the handicapped (blind).

Winters said he is aware that a number of national or international events could intervene, but plans are pretty firm as of now.

Winters revealed at a press conference Monday that Gov, James Thompson and U.S. Sen, Charles Percy (R-III.) have accepted invitations. Winters and Henry E. Krippner, president of Condell Memorial Hospital and of the Libertyville Lions, visited Thompson in his office Friday to issue the invitation personally.

"THOMPSON WAS REALLY interested, I'd say he was even excited, about the possibility. And when Sen. Percy, who was in his Springfield office at the time, heard about our plan, he asked us to come to his office, and he accepted an invitation," Krippper said Monday.

"We've had no turndowns yet. And we expect to hear from all the other invitees next week." Winters said.

Also invited to the affair are:

U.S. Sen. Howard Baker (R-Tenn.) the Senate majority leader; U.S. Sen. Alan J. Dixon (D-HL.); Lee lacocca, president of Chrysler Motors Corp.; Elizabeth Dole, U.S. Secretary of Transportation; U.S. Rep. Philip Crane (R-12th) of Arlington Heights; and U.S. Rep. John Porter (R-10th) of Winnetka.

Also invited are Donald Rumsfeld, U.S. special envoy to the Middle East and chief executive officer of G.D. Searle Co., Skokie, and Robert Schoellhorn, chilirman of the board of Abbott Laboratories, North-Chicago.

WINTERS AND KRIPPNER are planning the visit with Mr. and Mrs. Gaylord Donneley who represent the Adler Cultural Center, and Mr. and Mrs. Charles R. Walgreen, III, representing the Medical Center of Lake County, Condell Memorial Hospital.

The planned three-tiered affair coinciding with the Jan. 9 event includes:

 A private audience with the Reagans for 10-20 couples at \$10,000 per couple;

 A private reception for other invited guests at \$1,250 per couple of \$625 per unaccompanied person;

 A dinner banquet with the Reagans and James M. Fowler, president of Lions International at \$100.

Spokesersons for the Libertyville Lions said Monday that "this is a Libertyville affair, and all events will be held in the village except for the banquet which would have to be held in the Marriott Lincolnshire Resort for security reasons."

Otherwise, all events will be held in the village, including Adler House, Village Hall and the Cook Mansion.

WINTERS NOTED THAT "this is

pianned to give something to the people of Libertyville" and stated that attempts will be made so that the public will have an opportunity to participate in the program.

'If we can get him to be driven through the middle of town, we'll do it," he said.

He said he has prepared "flow charts," with the help of village officials and the police department, which will be sent to state security people and the president's staff for their approval.

Winters said that this affair has been in the planning stage since April. Invitations were sent out at that time, but most answered that it was too early to commit to the time and date, and asked to be contacted later.

Both are aware that in the President's job, a number of events, national and international, could intervene.

He added that, if the President and Mrs. Reagan can come, there is no way of knowing how long they might stay or whether other residents of the area might have a chance to see or hear the President.

Thompson, Percy to attend Lions' fete in Libertyville

Gov. James Thompson and Sen. Charles Percy, R-Ill., have both promised to attend the Libertyville Lions Club's 50th anniversary celebration Jan. 9 in Libertyville.

Club spokesmen met with Thompson in Springfield on Friday and took the opportunity to ask the governor's aid in getting President Ronald Reagan to attend.

A formal invitation was sent to Reagan in early November and the club's anniversary event chairman, George Winters,

said he is 85 percent sure the president will accept.

Winters said Monday the visit with Thompson was very encouraging. "It was the most successful meeting we could have had with the governor," said Winters. The meeting, which was scheduled to last 15 minutes went on for nearly an hour, he added. "He (the governor) was very excited by what we had to say."

The club has also invited such corporate and federal government leaders as Lee Iacocca, president of Chrysler Corp.; Sen. Howard Baker, R-Tenn.; Transportation Secretary Elizabeth Dole, and Donald Rumsfeld, the U.S. special envoy to the Middle East and president of G.D. Searle & Co. While none of the VIPs has accepted, none has sent his regrets - another reason for optimism, Winters said.

Lions International President Dr. James Fowler, who has also agreed to attend the celebration, met with club officials Sunday. He is slated to meet with Reagan Dec. 15 and promised to lobby

for a presidential appearance Jan. 9.

If Reagan attends, the club will host a banquet at \$100 per person for dinner with the president and other VIPs. A \$625 ticket will get the ticket-holder an invitation to a private reception with the governor, Percy and other special guests.

The club hopes to earn \$150,000 to \$200,000 through the banquet. The money from will go to Condell Memorial Hospital and the Adler Cultural Center for the Arts, both in Libertyville.

There are also plans for a private audience with the president for 20 to 50 couples at \$10,000 a couple — \$5,000 per individual.

The banquet will probably be held at the Marriott's Lincolnshire Resort, though Winters was adamant in saying the event was being held in honor of Libertyville's support of the Lions Club. He also promised that if Reagan accepts the invitation, the president will visit the village.

Reagan visit to Libertyville in January '85% sure'

A very special party invitation went out in the mail last month and may now be tucked away in an appointment calendar on the president's desk at the White House. The Libertyville Lions Club announced Monday it has invited President Reagan to attend the club's 50th anniversary celebration Jan. 9 in Libertyville.

George Winters Jr., anniversary event chairman, said the club is "85 percent sure" the president will accept the invitation. Winters and fellow Lions will meet with Gov. James Thompson Friday morning to extend an invitation to him and ask his help in getting the president to attend. Thompson was recently named the state chairman of Reagan's re-election campaign.

This is the second letter sent to the president, A formal invitation was made in June, but a White House spokesman told the Libertyville club it was too early in the year to make commitments for 1984. However, the Lions were encouraged to send a second invitation later in the year. The second letter was sent Nov. 11.

Personal invitations to attend the January celebration have also been sent to the president by three influential Illinois families, including the event's co-chairpersons, Mr. and Mrs. Gaylord Donnelley of Libertyville and Mr. and Mrs. Charles Walgreen III, who live near Dixon, III., Reagan's hometown. The

third invitation came from the Tempel Smith Farms, breeders of the famous white Lippizan horses. The Smith family has « offered the president and his wife the use of their Wadsworth estate as a place to stay during the visit.

According to Winters, the Donnelleys, who were close friends with Nancy Reagan's parents, sent a "very personal letter" to Mrs. Reagan, And the Walgreens, whose family once employed the young Ronald Reagan as a lifeguard at their private estate. have made their home open to the president on several occasions in the past.

In the invitation, the Llons also used as lure the state's strong Republican leaning, saying: "... Illinois is the most important election state in 1984," and "Lake County is one of the most Republican counties in the entire state." The letter went on to say Reagan would attend a private reception with major corporate figures in Lake and Cook counties, offering the president "Important potential for campaign funds."

The Lions have also invited Lee Iacocca, Chrysler Corp. president, Sen. Howard Baker (R-Tenn.), Sen. Alan Dixon (D-Ill,), Sen. Charles Percy (R-Ill.), Transportation Secretary Elizabeth Dole, Rep. Philip Crane (R-Mt. Prospect), Rep. John Porter (R-Winnetka), Donald Rumsfeld, the U.S. special envoy in the Middle East and president of G.D. Searle & Co., Robert Schoellhorn, Abbott Laboratories chairman, and Dr. James Fowler, Lions International president

Only Fowler has accepted, though as of Monday, there have been no rejections. Winters said other guests will also be added to the list.

The club hopes to raise \$150,000 to \$200,000 through its anniversary celebration, which, if Reagan attends, would include a \$10,000-a-couple banquet for 20 to 50 couples. The "private audience" would probably be held at Marriott's Lincolnshire Resort, though the club has already reserved the Cabriolet Restaurant in Libertyville in case the affair turns out to be smaller than planned. If Reagan does not attend, ticket prices will be lowered, though Winters said the Lions are already committed to hosting a banquet honoring Fowler and tickets for it will run \$100 per couple.

The money will go to the Lions Club, which will donate it to Condell Memorial Hospital and the Adler Cultural Center for the Arts, both in Libertyville.

So far there have been no plans to allow the public access to Reagan if he should attend, though one spokesman said he doubted the community would be excluded. "I can't believe if this thing happens there won't be something for the full community," he said.

Winters said the club has been told by the White House if may have to wait until just two weeks before the anniversary celebration before it is notified of the president's visit.



Editor's Viewpoint Potential History: President Reagan's Visit To County

by BILL SCHROEDER

If President Ronald Reagan is able to accept an invitation for a Lions Club program, he'll make Lake County history by being the first U.S. President to set foot in the county while in the White House.

Presidential candidates have visited Lake County, but never the Commander in Chief.

Libertyville Lions Club members are going all out to make the observance of their 50th anniversary as memorable as possible. The traditional invitation to the President has resulted in more than a glimmer of hope that Reagan can attend festivities. Presidential protocol and security being what it is, anniversary planners won't know for sure for some weeks.

Abraham Lincoln visited Waukegan before he became a national political figure. A bronze plaque commemorates the white clap board house in which Lincoln slept. President Franklin D. Roosevelt passed through Waukegan on a north bound North Western train in the early days of his Presidential tenure, but the train didn't stop


so that doesn't qualify as a visit.

Two prominent Republicans recalled the Roosevelt train. M.R. Schroeder, retired publisher of Lakeland Newspapers, related that throngs converged on the Waukegan depot and lined the tracks to get a glimpse of FDR. "You could see him from a window with his famous cigaret holder and nose glasses. He waved and was gone. A lot of people were disappointed that the train didn't even slow down," Schroeder recalled. Former State Sen. Robert Coulson, who also is a former mayor of Waukegan, confirmed FDR's high speed pass through. "I was about 10 years old," remembered Coulson who is retired and resides in Waukegan. "Only I was on the wrong side of the tracks so I didn't see him."

President John Kennedy appeared in a rally in Cook Park, Libertyville, a few months before he was elected President in 1960. That's the closest a U.S. President ever has come to setting foot in these parts.
