Today, as you well know, we must nurture and develop unity, sound perspective and support for sufficient initiative to continue that successful preservation. In the past, you have helped me in relation to global matters, and I recently thanked you for your invaluable support for my response to the Soviets regarding the Korean Airline incident. I would also like to reiterate my appreciation for the approach to welfare reform you suggested at our recent meeting on legislation to raise the debt ceiling.

I now wish to express my gratitude for your support concerning another special, more comprehensive issue. Your leadership of the National Forum Foundation has played a major role in improving public perception on Latin American affairs. Most notably, in April, 1983, the Foundation took part in establishing what has become known as the Outreach Working Group on Central America, which consists of Administration representatives, Congressional staff members and independent organizations with wide public support.
