RED FLAGS:

KUDOS: Chris Noel, who was recommended to us by Phyllis Schlafly and Bobby Mueller of the Vietnam Veterans of America (an unlikely combination of endorsements!), was extraordinarily helpful in resolving the hunger-strike at Wadsworth VA Hospital of the original five strikers. She worked at it full time, postponed a planned trip to Florida to visit her parents, and handled extremely delicate matters with great skill. William Anderson, Director of Wadsworth VA Hospital, was very successful in gaining the respect of the original hunger-strikers as well. We are fortunate that Anderson is there to continue the dealings with the more radical, politicized protesters who

were attracted by the initial publicity and who still remain at the hospital. Although we decided not to follow Nick Longworth's advice that we deal with the hunger strikers through sit-down organizer, Ron Bitzer, Longworth was very cooperative in maintaining our communications with Mr. Nimmo and Dr. Custis and with Wadsworth VA Hospital Director Anderson.

Penn James' office saw the urgency of the matter and dramatically accelerated the processing of the Presidential appointment of Dr. Custis as acting VA Administrator. Without Custis in place to sign the letters to the protestors, the situation would surely have worsened and professional agitator Ron Bitzer would almost certainly have "captured" the hunger strikers for use in furtherance of his own political agenda.

Karna Small fielded an avalanche of press inquiries in a highly professional way and avoided any signals coming from the White House which would have disrupted our plans to convince the hunger strikers, through the VA, that the President is actively working in their best interests.

CHANGES IN ISSUE FORECAST:

The protests at the Wadsworth VA Hospital continue, although the original hunger strikers have broken their fast and express appreciation for what the President is doing in their behalf. It is too early to tell whether or not Ron Bitzer can maintain his group of sit-in protestors or organize a group subordinate to him for a hunger strike.

Chris Noel suggest there is a good chance the remaining protestors will drift away. The potential however does remain for serious confrontations and drastic acts by people now led by Ron Bitzer. We must closely monitor Bitzer's response to the letter to him from Dr. Custis outlining the President's policy with respect to issues important to Vietnam Veterans.

RED FLAGS: 1. There is increasing unrest among conservative leaders due to the conception that the Administration is not fighting hard for the bloc grant proposal. As we discussed in the weekly report last week, there are perceptions that the Administration has not developed a strategy. The trend in the Congress to pass phoney bloc grant proposals which include strings on the states and set asides for particular programs, particularly Legal Services Corporation and Community Services Administration, are of major concern to conservative organization leadership.
