THE MIRACLES— a choir made up of mentally retarded adults. The immediate thoughts that come to most people's minds are elementary songs, simple percussion instruments, and, for the most part, anything but a musical sound. Not so with The Miracles from Baddour Memorial Center, a private residential facility for mildly and moderately retarded adults in Senatobia, Mississippi! Their wide range of talents, combined with a professionalism in stage presence to match any contemporary musical group, has resulted in more requests for appearances than the group can handle.

During 1980, their first full year of formation, The Miracles traveled 26,000 miles and sang before 43,000 people. Their travels during 1981 will take them to 6 Southeastern states on an 11-day singing tour, to Purdue University for the United Methodist Men's Convocation, to Oral Roberts University for a student body chapel program, to the Superdome in New Orleans for the Kiwanis International Convention, and to Marble Collegiate Church in New York City. This is in addition to a packed schedule of appearances in churches, schools, colleges, and civic organizations.

THE MIRACLES

Miracles can happen in different ways. Some miracles happen instantly without any human participation but just through the power of God. The miracle of salvation was brought about through great suffering and the divine Resurrection of Christ. Other miracles occur after much work and time by dedicated people. But whether miracles happen instantly, after suffering and hardship, or over a period of time, one factor is constant. MIRACLES DO HAPPEN AND THEY HAPPEN BECAUSE OF THE LOVE AND POWER OF GOD!

At Baddour Memorial Center, the mildly retarded men and women who live there are at long last being recognized for the miracles that they have always been. Perhaps because of their handicap, society has believed that their birth was not nearly so miraculous as that of a "normal" person. The residents are defying this belief in a way so remarkable and so beautiful that it could have only happened because of God's divine intervention into the lives of the people who have brought Baddour Center from "yesterday's impossibility" to "today's miracle." This is why the Center's traveling choir is named "The Miracles." This talented group of mentally retarded men and women are not only witnesses of the "miracles" within themselves; but God's Holy Spirit, working through them, is causing most wondrous and miraculous things to happen in the hearts and lives of those who hear them.

The group has been formed for less than two years, beginning in June of 1979. During 1980, The Miracles traveled 28,000 miles and sang before over 43,000 people. One person who heard them wrote a glowing editorial about his experience. Here is an excerpt:

"Let me share an experience with you as best that I can through this paper.

I cannot put into words the looks on their faces. Exuberance does not come close. Smiles--happy, cheerful, loving smiles.

Sparkling, twinkling eyes. They were so honest and so open. They did not appear to even know the words hate, prejudice, malice, or jealousy. They all worked together lifting their voices up and making a joyful sound. Being there, seeing them listening to them sing was an experience comparable to an Easter Sunrise service or a Midnight Christmas Mass. It was great. It was meaningful. It made me realize that I am such a small part of something so much larger and greater."

On another occasion, The Miracles went to a hospital and provided an afternoon Chapel service. The service was videotaped and aired several times during the week throughout the hospital. A secretary related a story about how the doctor she worked for was touched by the service. She said that this doctor was an agnostic but that during that week he had walked into the office with tears streaming down his face. He told her he had just watched The Miracles' program and that he had never seen or heard anything that made him more assured of the existence of God.

During a visit to a nursing home, The Miracles sang "How Great Thou Art."

Each time the chorus was sung, a feeble, old black man would join in with the choir. Later, a nurse related that these were the first sounds that man had uttered in many months.

There was the time when after a service, the minister wept openly for several minutes and said, "For 50 years, I have prayed 'thy Kingdom come,' and today, I have finally understood and experienced the coming of the Kingdom."

The stories could go on and on. These dedicated men and women give so freely of their time and talents. Each one has a regular job, and yet they spend 15-18 hours each Sunday traveling to two or three churches and nursing homes. All of them are volunteers giving of their time and talents not only to tell the story of Baddour Center but to share the wondrous love of Christ. Being with them is

audiences with an overwhelming love.

The members of this choir know what the word "committment" means; they are careful stewards of what God has given them. One man worked in a dairy for 33 years before coming to the Center. He had to be at work by 3:30 each morning. In 33 years, he missed only two days of work; he was committed to doing the best job he could with what he had. He not only sings with the choir, he also sees that the bus is kept clean and that the equipment and supplies are in good order.

On one weekend, the choir traveled and performed 34 hours. Upon arriving at the Center at 1:30 in the morning, one young lady cheerfully asked, "What time is practice today? I can't wait!" After a 13-hour bus trip during which the air conditioner broke, the following day The Miracles gave 5 performances. That evening as they gathered for a devotional service, one choir member prayed for forgiveness for not doing more for God's Kingdom.

"The Miracles" will be touring seven Southeastern states in June of this year. They have also been invited to Purdue University in July to sing before over 5,000 United Methodist Men from all over the world. They will sing before over 1,000 persons from all over the United States at an annual Christian retreat where Dr. Howard Hendricks will be the featured speaker. They will be singing in the Superdome this summer before over 30,000 people at the Kiwanis International Convention. The Miracles will also be singing in Marble Collegiate Church in New York in December of this year.

The Lord continues to bless all of the residents of Baddour Center in a most special and magnificent way. This blessing goes with The Miracles everywhere they go and is transmitted to all who hear them. It is truly a "unique ministry to mankind," for which we way "TO GOD BE THE GLORY FOR THE THINGS HE HAS DONE."

I hope that you personally will read this letter, but I realize how unlikely that may be in light of the "mountains" of correspondence you must receive. Neverthelesse I send this request to you accompanied by three months daily prayers.

I am the Director of "The Miracles," a choir made up of mentally retarded adults who are residents of Baddour Memorial Center. In Senatobia, Mississippi. Baddour Center is a residential village of mildly and moderately retarded adults. According to the National Association of Private Residential Facilities for the Retarded, Baddour Center is one of only three residential facilities in the United States that operates totally without government funding. In fact, our Center is valued today in excess of \$5 million, and the entire project was sponsored by individuals, businesses, and churbhes, enabling this unique ministry to develop without accepting any funds from our government. It has been a project of intense planning, hard work, and faith——and it has succeeded in becoming a model residential facility for this Nation.

Now, to my request! The Miracles have been invited to sing in Dr. Norman Vincent Peale's church in New York City on Sunday, December 14. Since we will be in the Washington area, I have hoped and dreamed that it might be possible for them to sing for you and Mrs. Reagan in the White House. Mr. President, there are 6,000,000 mentally retarded persons in this country. Each of these persons has families who are desperately seeking fulfillment for these "special" pepple. These mentally retarded persons and their families need HOPE! I believe by your recognition and by the honor that would be given The Miracles by appearing before you, a message of hope would be sent to these 6,000,000 mentally retarded persons and their families.

Very few pepple have believed that the mentally retarded can make a positive contribution to our society. At Baddour Center, we have proved these few to be correct, not just with our choir that has sung before 80,000 people in 13 states during only 18 months, but with all our residents who participate in a Vocational Program that is second to none. Every resident at Baddour Center works and is paid based on the work they are able to do. One example of their productivity—in a heat transfer operation

(putting decals on T-shirts), 20 mentally retarded persons can place decals on 48,000 T-shirts per week, working only 5 hours per day. In addition, their error rate was compared to that of "normal" people, and our residents were 2 percentage points below in errors!

Mr. President, there are many more seecess stories. We have a Community Government made up of residents elected by their peers. They sponsored a voter registration drive so that last year, 97% of our residents voted in the Presidential election.

I beg of you to honor these "special" people by allowing The Miracles to sing for you. As I was writing this letter, one of the choir members came in my office. I told him what I was doing, and his reply touched my heart. He said, "If this is God's will, it will happens And if it happens, it will be one time when I don't think you will have to remind anyone to smile." I pray that you will bring smiles to these truly extraordinary people and to all the others in our country who need this glimmer of hope.

It would give many of us great pleasure if they were given the opportunity to bring their music to the White House in a manner which would meet with your approval.

Baddour Memorial Center 4s a pilot project aims, among other things, to show what the retarded can do given the right environment. It also hopes to break down the barriers of prejudice so that these innocent victims of fato may be treated with love and respect and not feared. Anything which you cando to further this cause will be most appreciated by all families involved. Since this is the "Year Of The Handicapped" it would seem appropriate. It is my understanding that Mrs. Reagan is supportive of the Foster Grandparents plan which brings love to the children as well as to the older person. She is to be commended. We all need to be loved.
