DEAR MR. PRESIDENT:

I AM DELIGHTED TO REPORT THAT MAJOR EFFORTS ARE NOW WELL UNDERWAY TO GENERATE A MASSIVE GRASSROOTS LETTER-WRITING CAMPAIGN TO THE UNITED STATES SENATE IN SUPPORT OF YOUR PRAYER AMENDMENT, SJR73. EACH SENATOR SHOULD START RECEIVING A FLOOD OF LETTERS IN SUPPORT OF YOUR AMENDMENT IN LATE SEPTEMBER. THE MAXIMUM EFFORT SHOULD ARRIVE AT THEIR DESKS DURING THE FIRST WEEK OF OCTOBER AND SHOULD REMAIN STRONG UNTIL THE MIDDLE OF THE MONTH.

IF THE SENATE WERE TO SCHEDULE SJR73 FOR PLOOR ACTIONS IN THE MIDDLE OF OCTOBER IT WOULD GREATLY ENHANCE CONSTITUANCY INFLUENCE ON THE SENATORS' VOTING, THEREBY MAXIMIZING THE OPPORTUNITY FOR PASSAGE OF THIS HIGHLY DESIRABLE AMENDMENT. Battle Lines Drawn:
School Prayer Wersus 'Right of Silence'

School prayer proponents will have their choice of two constitutional amendments in early September as the Senate begins floor consideration of President Reagan's measure and an alternative proposal offered by Sen. Orrin Hatch (R-UT).

Both versions were sent to the Senate Floor last month "without recommendations", meaning the Senate Judiciary Committee had not endorsed either bill.

This dual consideration approach has lead many Americans to seriously examine the contents of both amendments. The examination is not merely one of analytical research, but a hard hitting campaign spelling out major differences between the two proposals.

The Reagan Amendment reads as follows:

"Nothing in this constitution shall be construed to prohibit individual or group prayer in public school or other public institutions. No person shall be required by the United States or any state to participate in prayer. Nor shall the United States or any state compose the words of any prayer to be said in public schools."

This amendment would restore organized prayers to public schools. Teachers would be permitted to offer prayer, read scriptures, or ask students to give prayer recitations. However, students would not be required to participate and governments would not be permitted to draft the prayers.

Recent public opinion polls have indicated that nearly threequarters of the American people support the Reagan method for restoring voluntary school prayer. Yet, despite this groundswell of public support, Sen. hatch has proposed a watered down prayer alternative, which reads:

"Nothing in this constitution shall be construed to prohibit group silent prayer or meditation in public schools. Neither the United States or any state shall require any person to participate in such prayer or meditation, nor encourage any particular form of prayer or meditation.

"Nothing in this constituion shall be construed to prohibit

equal access to the use of public school facilities by all voluntary student groups."

The Hatch version would only permit students to observe a moment of silence during school hours for meditation. It is feared that if silent prayer is adopted as the only constitutionally approved practice, other forms of expression which have been historically permitted will be automatically excluded. This would include such things as invocations and benedictions at various functions; student groups voluntarily saying a blessing before their meals; the carrying of Bibles on school premises; the singing of songs related to religious holidays, ect.

Opponents of the Hatch Amendment also contend that the second phrase of the last sentence of section 1 runs a serious risk of being misinterpreted as embracing more than just schools. If so, there could be efforts to ban all forms of religious expression in all areas of government, such as: the functions of all chaplains in federal, state and local government institutions; the motto on U. S. currency; the taking of oaths; the convening of the Supreme Court, and the list goes on and on. Such a far reaching impact is hard to imagine but the judicial mischief which could lead to such an impact is not hard to imagine.

Supporters of both amendments have endorsed the concept of equal access to the use of school facilities. Yet, it is feared that by including it in the Hatch Amendment as a right which is not already guaranteed by the constitution, serious legal repercussions will occur on relevant legal cases currently in litigation. Legal experts also speculate that the enclusion of "Equal Access" in the Hatch constitutional amendment will open the door to lawsuits designed to shut down existing voluntary religious programs on all campuses.

Pro school prayer forces are favoring the Reagan Amendment over Hatch's version because the measure seeks to return "real prayer, rather than silence" to America's public schools.

A coalition of religious and political leaders have voiced support for the Reagan solution to the school prayer problem. It is believed that their endorsement of the President's amendment will provide enough pressure on key Senators to get the necessary two-thirds approval for passage.

Among those publicly endorsing the Reagan Amendment was Moral Majority President Jerry Falwell: "I don't believe we've been fighting this prayer battle for the right to remain silent. And that is why I am supporting his (President Reagan's) amendment."

Paul M. Weyrich, executive director of the Committee for the Survival of a Free Congress, said, "Silent prayer gives weak sisters an opportunity to squish out on school prayer."

Pat Robertson said he would use his Christian Broadcasting Network to oppose the Hatch silent prayer amendment.

Television evangelist Jimmy Swaggart said, "The American people want the Reagan Amendment to pass. If it's not brought to bear, there's a possibility that some congressmen and senators will be looking for a job. It's that simple."

Gary Jarmin of Christian Voice may have best represented the conservative movement's concern when he said, "There is very little support for Hatch's version. Because of Sen. Hatch we're going to have our own forces badly divided and spilling each other's blood on the Senate floor."



Long prayer petition coming to Assembly

GALLUP — Cecil Todd's "America For Jesus" Crusade is coming to the First Assembly of God Church, 716 E. Hill St., Sunday, Sept. 4, reports Pastor Terry Bell.

Todd is a 10-year member of the National Religious Broadcasters, Chairman of the first National Clean Up TV Crusade and has a Doctor's Degree in Divinity.

Attending the program also will be famous Elvis Presley impersonator, Aaron Patrick, who has traveled extensively using his talents to portray the vocal talents of the late Presley.

The nationwide crusade was recently launched by the Revival Fires Minstry from Joplin, Mo. and is designed to unite people under the Christian banner of love, faith and power.

Purpose is to put prayer back into the public school, give a Bible to every school age young person without one, stop the godless killing of unborn babies and bring more of the powerful influence of Jesus Christ to America, reports Bell.

Minister holds sign-up for prayer petition

Students in America's public schools should have the privilege of starting their days with prayer, just as America's lawmakers do, an advocate of voluntary school prayer said Sunday night.

The Rev. Cecil Todd, the founder and director of Revival Fires Ministry of Joplin. told members of the Oak Grove Assembly of God Church in Springfield that Americans are demanding that their children have the right to pray in public schools.

"Gallup polls show that 85 percent of Americans favor returning prayer to schools," Todd told the 125 church members. "They just want the same privilege as members of the House and Senate."

In June 1963, the U.S. Supreme Court ruled voluntary school-sponsored prayer to be a violation of the constitutional principle of separation of church and state.

Todd, speaking during Sunday night services at the church at 1320 S. Oak Grove, illustrated his plea for a return of school prayer by presenting members with a petition calling for Congress to rescind the 1963 decision.

The petition, Todd said, contains 85,000 signatures and is recognized by the Guinness Book of Records as the largest petition ever started.

The petition is more than 1,000 feet long, and before it's presented to Congress in mid-July it will have more than 100,000 names, he said.

The purpose of the petition is to convince lawmakers that they must reinstate school prayer to properly represent their constituents, Todd said.

"We're not talking about a mandatory prayer," he said. "It would be just for those who want to."

Todd said he has taken the petition to rallies in 28 states and has signatures from people in all 50 states. At the top of the than the rights of the majority."

petition there is a place reserved for President Reagan, Todd said.

Reagan has supported returning voluntary prayer to public schools.

During his message Todd said young people, especially high-school students, have been victims of the court's prayer

In the 20 years since it was imposed, he said, crime has gone up 300 percent, more than I million babies have been aborted and thousands of high-school students have committed suicide.

"We also haven't had a president that has lasted two terms in office," he said. "One has been assassinated, another shot at and another run from office. The last one to serve two terms, Dwight Eisenhower, was the one who put 'under God' in the Pledge of Allegiance."

Many public school students are asking for the right of voluntary prayer, Todd

"Girls are asking why they are allowed to have birth-control pills, alcohol, cigarettes and pot, but they aren't allowed to pray," Todd said. "They are now starting to cry out about it.


"We have rules allowing kids to have places to smoke (in school), but we have no place where they can go to pray," he said.

Todd said he supports separation of church and state. However, he said prayer does not constitute a church-sanctioned

"I believe in separation of church and state but not separation of God from country," Todd said. "God is not church, God is not a religion. He is a relationship."

Those who wish to pray are being denied their rights to do so, he said.

"What we have is a case of the tail wagging the dog," he said. "The rights of the minority have become more important

Peace pilgrims spread word in Springfield

Peace.

It is a word that comes often from "peace pilgrims" on a journey to Amarillo, Texas. The group, on its way from Washington, D.C., to Amarillo, brought its message of nuclear disarmament to Springfield this weekend.

Members of the group, who have walked about 600 miles since leaving Washington on Pentecost Sunday, spoke to about 35 people during a program Sunday afternoon at St. Agnes Cathedral. They talked of the doom and disaster nuclear weapons bring.

But they talked even more of the faith in God they believe is needed to remove humanity from the brink of nuclear holocaust. And they mixed the message with the freedoms prescribed in a document signed 207 years ago today - the Declaration of Independ-

The founding fathers had a deep belief in the right to life, said Andrew Comas of Yonkers, N.Y. That freedom is being trounced on by a huge defense budget, he said.

"The arms race is destructive of life," he said. "It is killing the poor. It is taking away our freedom, I strongly recommend re-reading the Declaration of Independence."

The group said much of the money being spent on defense could be spent on food and social programs

Although the odds and history - a string of wars - are against them, the group members say they stick to their idealism because it is rooted in a belief

"We have to put our trust in God," said Karan Loats from Maryland, "And that's where our security is, not in nuclear weapons. God teaches us other ways to interact with people.

"I think that all we can do is use our minds and bodies to work for peace."

One of the walkers is a mother of two children. Lyn Shaw, of Connecticut, said she was tired of the despair and hopelessness she felt. So she joined the 1.600-mile journey to Amarillo.

She also said July Fourth is a special day for recognizing that the arms race must be stopped.

"I love my country very much," she said, "but I love it in the way a parent loves his or her child."

Parents don't allow their children to walk into busy streets, she said, and "in the same way I can't stand by and watch my country take this course that

Dear CBN Friend,

In just a few days, a vote will be taken in the United States Senate which I believe will affect the entire future of our nation. What I'm talking about is the vote on the President's proposed School Prayer Amendment.

Less than two months ago this same amendment came up before the Senate Judiciary Committee. Even White House staffers predicted defeat.

Meanwhile, my associate Ted Pantaleo of The Freedom Council worked behind the scenes to rally the support of Christian leaders. And I made an emergency appeal on "The 700 Club" encouraging our viewers to contact the members of the committee.

The result was dramatic. The senators unexpectedly voted 14-3 in favor of reporting the President's Amendment to the full Senate.

Neither the United States nor any state shall compose the words of any prayer to be said in the public schools.

Working together with The Freedom Council, we are doing all that we can to secure the passage of this amendment.

But it won't be easy. It hasn't been easy yet and it's not going to

be now. While we rejoice in the Judiciary Committee's action, we can't afford to relax our efforts in the least. We need to work harder than ever before.

You see, this is our greatest chance in two decades to regain this most vital of our freedoms.

Right now, I'm urging you to write the two U.S. senators from your state. Tell them how strongly you support the President's Prayer Amendment. And tell them how important it is to you that they support this amendment as well. Then ask them to let you know how they intend to vote.

It is vital that you refer to SJR 73 when you contact your senators. Senator Orrin Hatch has introduced an alternative prayer amendment which would permit only silent prayer. But I agree with what President Reagan says about that amendment: "I don't believe we've been fighting this prayer battle for the right to remain silent!"

So make sure your senators know you support the President's Amendment, SJR 73, but are opposed to the Silent Prayer and Meditation Amendment.

There's no time to waste. This measure could come before the Senate any day. Let us begin right now -- this very minute -- to create the groundswell that will leave no doubt in the minds of any U.S. senator that the American people want them to LET OUR CHILDREN PRAY AGAIN!

Please write, telephone, or visit your senators today. And talk to your pastor, your relatives, your friends -- even casual acquaintances -- and urge them to join us in this effort.

With your help and the help of others, we can make an impact on the future of this nation. After 20 years America's children can once again be free to pray.

- 6. State clearly how you want him to vote and ask him to write you and let you know how he intends to vote.
- Write a follow-up letter if he doesn't answer your question directly. Politely insist that he respond to your question.
- Send a follow-up thank-you letter when the senator votes the way you asked him to.
- Be sure and sign your name.
- 10. Don't be belligerent or threatening. Senators know your vote in the next election for them might be in question if they do not vote as you have instructed them. Trying to persuade the senator with your vote introduces a negative element into your communication that will likely destroy any positive results from your attempt to influence him.

WHY A PRAYER AMENDMENT?

- **FACT:** Several years ago, in Whitestone, New York, a young child was forced to stop saying grace at lunchtime by his principal.

These are just a few shocking examples of what has taken place since the Supreme Court ruled against allowing prayer in our public schools in 1963. As a result of that decision, our government has moved from being neutral toward religion to an attitude of open hostility toward it.

Why should prayer be permitted in our schools?

Because of bistorical and constitutional precedent: Our nation was founded on the principle of religious freedom which was written into our original Constitution. From 1607, when the first permanent English settlers landed on this continent, until 1962, prayer was an integral part of this nation's public life.

Because a majority of Americans favor a prayer amendment: Gallup and Harris polls have shown that 73 percent of all Americans favor a constitutional amendment to restore prayer in public schools. Why should a small minority force their views on the majority of Americans who clearly favor this amendment?

Because it's fair and morally right: The children of agnostics and humanists enjoy perfect freedom to express their beliefs. In all fairness, our children should not be denied the right to freely express their faith in God.

For these reasons it is imperative that we let our elected officials know where we stand. Within a few days, the Senate will vote on President Reagan's Prayer Amendment. You can make your voice count in this vital decision by contacting your senators today.
