2 of 4 nominees multimillionaires

CPB Board Chairman Sharon Rockefeller and three newcomers glided through a brief and amiable confirmation hearing Feb. 4. with all but one nominee sure to be appointed directors of CPB. The shoeins are Rockefeller; Richard Brookhiser, senior editor of the National Review; and consultant and former Columbia Pictures Communications President Karl Eller.

Helen Marie Taylor, a former actress active in Virginia Republican politics, is the one candidate whose seat on the board is still uncertain. Sen. Ernest Hollings (D-S.C.), ranking minority member of the Senate commerce committee that must confirm the presidential appointees, has queried Taylor on her view of public broadcasting's programming and her future role as CPB director. In addition, sources say, elements of her FBI file are still being examined.

Bouquets: But there was no hint of a controversy in the hearing room last Friday, as senators testified on behalf of their native sons and daughters. West Virginia Senators Jennings Randolph and Robert Byrd flanked Sharon Rockefeller while her husband, West Virginia Gov. John D. Rockefeller sat in the back, holding their youngest son.

Later, Sen. John Warner (R-Va.) warmly presented Taylor, while Charles Percy (R-III.) spoke up for Eller, as did Sen. Barry Goldwater (R-Ariz.), who was conducting the hearing.

Only Richard Brookhiser was compelled to go it alone. His New York senators were out of town.

hearing room veteran, did most of the talking. In response to a question by Goldwater, she spoke against commercials on PTV, "Advertising would inescapably alter the public service... nature of public broadcasting..."

Taylor said that she also would "be reluctant to support" product advertising, and believes more could be accomplished in annual fundraising. For instance, Louis Rukeyser, Alistair Cooke and William Buckley could join fundraising drives, she suggests.

Rockefeller told Goldwater that all the studies CPB has devoted to public broadcasting's funding have led to the same conclusion: federal aid must be kept up.

But she objected to the congressionally imposed formula that tells CRB how its budget must be spent. "It allows absolutely no discretion in this time of tight finances," she said. "I respectfully submit that the allocation scheme be lifted."

She added that "peace" now reigns among former pubcast antagonists—but her call to lift the formula may have set the stage for another struggle, Pubcasting sources tell Current that neither TV nor radio would be happy if CPB were to regain entire control over its budget.

Well-heeled nominees: Reagan's nominees are not short for cash. Brookhiser, with an annual income of just over \$40,000, is the poorest of the lot. A distant second is Taylor, whose joint income tax return with retired husband Jacquelin reported \$788,415 in 1981, almost entirely from stock dividends. The Taylor's stocks include General Tire and Rubber, Taft Broadcasting, Schering-Plough Corp. and a variety of oil and tobacco companies.

Karl Éller holds about \$37 milion in stocks and bonds and other interests, including 500,000 shares of Gannett, Inc., and 1,000 shares of Turner Broadcasting.

CPB Chairman Sharon Rockefeller's personal "net worth" is reported at \$2.4 million. Her husband's assets, however, total \$94.5 million. The Rockefellers' top investments include IBM, Apple Computers, Exxon, Chase Manhattan and AT&T.

Political perspectives: Rockefeller is well known as a devoted supporter of the Equal Rights Amendment, both as active advocate and financial backer. Her political contributed contributions went to

mostly Democratic causes and campaigns, including \$5,000 to the Democratic National Committee, \$2,000 to Sen. Randolph (D-W.Va.). \$1,000 to Senate Minority Leader Byrd (D-W.Va.). \$750 to the campaign of House telecommunications subcommittee chairman Tim Wirth (D-Colo.), \$500 to Sen. Howard Cannon (D-Nev., defeated) and \$500 to the ranking minority member of the House subcommittee that appropriates for CPB, Silvio Conte (R-Mass.).

On the other end of the political spectrum, Helen Marie Taylor has been a staunch contributor to conservative causes and candidates. She has been a supporter of Reagan for the presidency since 1968, and has backed such groups as NCPAC, the American Conservative Union, the American Security Counsel, the National Conservative Foundation, Conservatives for Immigration Reform, the National Right to Work Legal Defense Fund. She has contributed to the campaigns of Sen. Jesse Helms (R-N.C.), Sen. John East (R-N.C.), Rep. Phil Crane (R-III.) and testified before the Virginia State Assembly in opposition to the Equal Rights Amendment, for a freeze on sex education until the state board of education personally reviewed all related study materials, and in favor of "Free Enterprise and Capitialistic and Economic Studies" for high school students.

Eller has been a member of myriad civic organizations, from the Rotary Club to the Salvation Army, and was named / Phoenix "Man-of the Year" in 1977, Al-

though his political affiliations are not apparent in reported contributions, he does have strong views about decision-making with potential applications to CPB, judging from a speech he gave to the Tucson Leadership Graduating Class of 1981:

"It makes no sense at all to have our society insisting on a "democracy of judgment"—a group decision; because a group decision is nothing more than a compromise of mostly mediocre minds...The democracy of judgement seems to worship mediocrity because it is acceptable to the masses.

"The phrase 'elitist' is usually invoked by those who have uncritically embraced the average or ordinary pieties of the new populist morality in today's America."

Richard Brookhiser has been been writing on many political issues for the conservative National Review since 1977. He is a member of the Council on Foreign Relations, and was employed by the Republican National Committee for several months last year as a speech writer for George Bush.

He'ld like the CPB post, he explained on his application filed with the Senate Commerce Committee, because he "is interested in the same things CPB is interested in fostering...I tune in, and I pay for what I get—twice: as a taxpayer, and as a member of WNET in New York. At the same time, I can bring to the job a broad perspective, uncramped by intramural struggles and loyalties."



Dangers seen in appeal on editorializing

Pacifica radio's top staffer Sharon Maeda says public broadcasters' right to editorialize is overshadowed by broader implications of the Justice Department's appeal recently accepted for review by the Supreme Court.

In its appeal, the Reagan Administration contends that it can impose restrictions on free speech of organizations that receive federal money, Maeda told Current. Specifically, the Justice Department is arguing that the high court should uphold a 15-year-old law banning editorials by public broadcasters. A District Court judge in California ruled last August that the law is unconstitutional.

Maeda says the wider dangers of the case will attract amicus curiae briefs from concerned organizations outside public broadcasting. Plaintiffs in the case, besides the Pacifica Foundation are the League of Women Voters of California and Rep. Henry Waxman (D-Cal.).

...while "Princess" appeal goes nowhere

The Supreme Court has declined to review the "Death of a Princess" cases, leaving standing a Circuit Court ruling last fall. That decision affirmed the right of state-owned public broadcasters to cancel previously scheduled broadcasts of the controversial 1980 documentary. Viewers, who pressed the appeals for nearly three years in separate cases in Houston and Birmingham, Ala., "had no constitutional right to compel the broadcast of the programs," the Circuit Court majority ruled last fall.

Taylor out: O'Conner in as CPB nominee

Though her name has not yet been officially withdrawn, Helen Marie Taylor will not be confirmed by the Senate Commerce Committee as a director of CPB, predicts a committee aide. She was supposed to have succeeded Gillian Sorensen on the CPB Board.

Meanwhile, Harry O'Conner, who distributed President Reagan's "fireside chats" on radio, has been nominated to the CPB Board. If confirmed, he will succeed Charles Roll.

First Lady consorts with Chemical People

Nancy Reagan will host two one-hour PTV specials to air Nov. 2 and 9. The two-parter from WQED, Pittsburgh, The Chemical People, tackles school-age drug and alcohol abuse. "We are in danger of losing an entire generation unless we act now to educate our selves and our children," the First Lady said in a press conference March 21. "The Chemical People is a powerful tool and I am pleased to be part of the project."

Communities have been urged to hold town meetings concurrently with the first program, which combines documentary and drama to illustrate the extent of chemical and drug abuse by the young. The second hour advises communities on how to form permanent task forces to prevent and combat "substance abuse." To date, 26 national organizations have pledged active involvement in organizing town meetings and task forces.

When the program first was broadcast locally by WQED in the spring of 1982, more than 12,000 residents in western Pennsylvania met in groups to watch. As a direct result of the program, 112 allied task forces in 15 counties were established to confront chemical abuse by youths.

Goldwater still against Mrs. Taylor

WASHINGTON — After talking to Virginia's two U.S. senators, U.S. Sen Barry Goldwater remains unswayed in his concerns about a Virginia woman nominated to an administration board.

The nomination of Helen Marie Taylor of Richmond to the Corporation for Public Broadcasting board of directors appeared in serious trouble yesterday, Senate sources said.

Goldwater, a Republican from Arizona, is chairman of a Senate Commerce Committee panel that oversees the board.

Sens. Paul S. Trible Jr. and John W. Warner, Virginia Republicans, talked with Goldwater Wednesday and yesterday, respectively, aides said.

"The situation hasn't changed that I know of," Earl Eisenhower, Goldwater's press secretary, said yester-

"I have not seen or heard anything that has alleviated (Goldwater's) concerns." Asked whether Goldwater would ask the White House to withdraw the nomination, Eisenhower said, "I think that would be the wisest course for everybody at this point." He said he did not know whether Goldwater would follow that course.

"The concerns came out of the FBI background report," Eisenhower said. He could not elaborate because only senators are allowed to examine the reports.

In addition, sentiment in the Commerce Committee is running about 80 percent to 20 percent against confirmation of Mrs. Taylor, he said.

The committee last week delayed confirmation of Mrs. Taylor but voted unanimously to recommend confirmation of three other nominees. In addition to Goldwater, Sen. Ernest Hollings. D-S.C., had questions then about her appointment.

Bill would permit govt. access to records only through subpoena or exparte court order and would require govt. to notify individual if subpoena is sought to gain access to his records. Person then could go to court and challenge govt. request for records. If govt. agent believed notifying individual would harm investigation, Weiss plan would permit agent to seek court order similar to that required to tap phone if "reasonable cause" were shown. Bill also would set limits on later use and "redisclosure" by govt. agency of such records.

Videotex America, Times Mirror Co.'s joint venture with Infomart, signed up Chronicle Publishing Co., owner of San Francisco Chronicle, as local marketing affiliate for its videotex service. Publisher will share in research from Times Mirror field trial in southern Cal. and decide later whether to form partnership to operate videotex service in San Francisco Bay area. Phoenix Newspapers Inc. and Fla. Publishing Co. already have signed agreements to explore feasibility of offering such services in their areas. Videotex America officials are analyzing results of trial before they decide whether to do more testing in 1983 or 1984.

NCTA-CRT court battle update: Copyright owners have filed motion to strike from court record part of brief filed by United Video in support of NCTA appeal of CRT-imposed 3.75% distant signal rate. United Video, common carrier for WGN-TV Chicago, included appendix to brief (Daily, Jan. 25) consisting of letters from client cable operators giving notice they planned to drop WGN as of Dec. 31 because of higher copyright rates. United Video intended to show by letters widespread industry movement to drop distant signals because of higher copyright rates. Copyright owners (MPAA, sports interests, NAB, BMI, et al.) argue appendix should be stricken for several reasons, mainly that some letters are from non-Form 3 systems (those with semi-annual revenues of at least \$214,000) or are systems outside all TV markets, meaning higher copyright rates wouldn't apply to them.

Nominations of current CPB Chmn. Sharon Rockefeller, media consultant Karl Eller & National Review editor Richard Brookhiser to CPB board are expected to sail through Senate Commerce Committee next Tues. However, nomination of Helen Taylor of Richmond may be held up because of concerns raised by her background file. Taylor belongs to several racially-exclusive clubs and has contributed money to organizations such as Accuracy in Media and Moral Majority which have criticized public broadcasters. In addition, she reportedly gave money to Prince Edward School Foundation set up to get around school desegregation order in 1950s. Once okayed by committee, nominations will be sent to Senate for approval.

National Council of Churches has asked CBS for time to answer charges on Jan. 23 segment of 60 Minutes that Council has become politicized and aids Marxist-Leninist revolutionaries. Segment, hosted by Morely Safer, said funds from church members are being used to buy guns for revolutionaries. CBS had no comment. Council said it was considering complaint to National News Council.

Sen. Nunn (D-Ga.) introduced 3-bill package "designed to halt the flow of American high technology and defense secrets to the Soviet Union." He said hearings last year by Senate Permanent Subcommittee on Investigations "indicated that the Soviets are increasingly adept at obtaining American technical knowhow, while all too often the U.S. response has been inadequate to the challenge." He said bill would improve export controls by focusing on key high-technology items. Under present system, he said, govt. "tries to control too many commodities and thus fails to keep track of those products the Soviets desire most."

Problems and promise of expanding cable industry are discussed in 3 new books (Communications Press, about 200 pp. each, \$21.95 each). Dear John:

There is a matter of some importance that I would like to bring to your attention concerning a mutual friend and fellow Virginian, Helen Marie Taylor.

As you know, President Reagan has nominated Mrs. Taylor for the Board of the Corporation for Public Broadcasting.

Reportedly Senator Barry Goldwater has placed a hold on her nomination. Incredibly one reason being given is the fact that she gave a contribution to our organization, The Christian Broadcasting Network, to help establish our Washington News Bureau, where you and other senators have been interviewed by me on national television.

I consider this restriction on Mrs. Taylor's First Amendment freedoms to be an absolute outrage!

I have just gotten off the phone with Dr. Mildred 'Jefferson of Boston who called on Mrs. Taylor's behalf. Dr. Jefferson is a professor of surgery at Boston University Hospital and holds twenty-five honorary degrees. She is black. Dr. Jefferson tells me that another innuendo about Mrs. Taylor is one of racism.

To set the record clear, Dr. Jefferson tells me that Helen Marie Taylor was an early contributor to the NAACP, and was a major supporter of the Sydenham Hospital, which Dr. Jefferson says was the only hospital in the entire United States where blacks could be trained as surgical interns. She also told me that Mrs. Taylor was chairman of the New York Audition Committee of the Royal Academy of Arts. In that capacity she sent the first American Negro man and woman to London for training in dramatic art.

Dr. Jefferson feels that Sharon Percy Rockefeller does not like Helen Marie Taylor and is trying to frustrate the President's wishes in this appointment.

John, I think it is an absolute crime what happens to conservative nominees to various public positions. First there is a hold; then the Washington Post and its associates begin a smear campaign; then the candidate is labeled "controversial"; then the pressure increases as further liberal editorial voices are raised against them; and finally The White House is forced to withdraw the nomination in favor of someone acceptable to the Eastern establishment.

I hope that you will use your influence on the Communications Sub-Committee to rectify what seems to be a grave injustice to a woman, who although extremely outspoken as we know, has tried to use her wealth and position to foster traditional values in the United States.
