In recent correspondence to you, California Tribal Chairmen's Association (CTCA), a statewide organization representing thirty-eight (38) federally recognized tribal governments in California, expressed the need for tribal governments to have a mechanism for access to the Executive Branch.

In December, 1980, tribal governments in California joined, in the spirit of tribal solidarity, with tribal leadership throughout the nation to establish a meaningful and harmonious relationship with the Executive Branch of Government.

Continuous efforts of tribal leadership throughout the nation, to create a forum by which the government-to-government relationship with the Federal Government can be maintained, have resulted in establishment of an American Indian Leadership Council. The Council, comprised of eight regional leaders from federally recognized tribes, is led by Chairman Peter MacDonald of the Navajo Nation.

CTCA has formally petitioned the American Indian Leadership Council for the addition of a California seat, to be represented by a member of CTCA. We have been recently advised that the Council is considering expanding to include three additional seats. The expansion will insure tribal representation from all geographic areas in the nation.

CTCA member tribes wish to join with the American Indian Leadership Council to meet with the President on tribal affairs. We believe the American Indian Leadership Council can be used as the mechanism through which access to the Administration can be obtained.

Although CTCA and members of the American Indian Leadership Council recently met with Mr. Morton Blackwell, Assistant to the President for Public Liaison, and other Senior Staff from the Administration, no formal commitment has been made by the Administration to continue to meet with the American Indian Leadership Council.

CTCA recognizes that the unique problems of Indian people cannot be addressed adequately without consultation with Tribal Governments.

CTCA and tribal leadership throughout the nation continue to await the opportunity to meet with the President and members of the Executive Branch to implement a formal mechanism through which access can be achieved.

Your letter of December 23, 1981, to President Reagan regarding your request that tribal governments be provided the opportunity to participate in the budget-making process has been forwarded to this office for a response.

As you know the Department of the Interior and the Bureau of Indian Affairs FY 1982 appropriation has been passed by Congress. Funding was provided at the conference level less 4 percent across the board and allowed no shifts in priorities. Tribal governments have been provided opportunities to participate in the Bureau's budget-making process. In fact, this Administration is committed to more local control of Federal expenditures as part of the President's Economic Recovery Program.

Consistent with the President's program, the Bureau is initiating the Consolidated Tribal Governmental Program as a pilot or (prototype) project this fiscal year. The CTGP will allow tribal governments to cluster a number of similar programs or service areas under a single contract. The Tribes will determine their own needs and priorities and plan and implement programs to meet their particular needs and priorities under CTGP. The Tribal governments may for example, concentrate funds in high need or priority areas and reduce expenditures in areas of less need under CTGP.

Your suggested language will be studied and considered for inclusion in future budget submissions.



On May 6-7, 1981, the National Tribal Chairmen's Association is sponsoring a National Tribal Government's Conference in Washington, D. C., for the purpose of presenting to the Reagan Administration positions on a variety of issues that affect federally recongnized tribal governments throughout the nation.

The primary focus of the meeting will be to stress the need for formal access to the Executive Branch, as well as work towards a commitment from the President on an American Indian Policy. Additionally, certain specific issues such as the federal trust responsibility, our government-to-government relationship with the federal government, block grants and tribal programs will be discussed.

California Tribal Chairmen's Association, a statewide organization representing thirty-four (34) federally recognized tribal governments, is working with NTCA to coordinate efforts for a meeting with you and other Administration officials. We wish to stress that, because of our legally recognized relationship with the federal government, tribal governments are seeking to establish and increase their relations with other units of state and local government. We also have contacted Mr. Edwin Meese, Ms. Elizabeth Dole and Mr. Morton Blackwell to meet with over 100 tribal leaders on this and similar topics.

We cannot understate the need of tribal governments for access to the Executive Branch to discuss this significant issue regarding our government-to-government relationship. Over 176 tribes met in December, 1980, at a National Issues Forum and reiterated this need. Resolutions were forwarded to the Transition Team in December in anticipation of initiating a working relationship with the Reagan Administration.



Therefore, in behalf of NTCA and CTCA's membership, we request an appointment with you on May 6 or 7, 1981 to meet with delegates at the conference, held at the National Education Association Auditorium, 1201 16th Street, N. W. We would appreciate an address on the topic of your office's role in interfacing with units of state and local government, so that tribal representatives may have an opportunity to voice their concerns with regard to their working relationship with federal and state governments.



Dear Mr. Meese:

California Tribal Chairmen's Association is a statewide organization representing thirty-eight (38) federally recognized tribes in California.

Tribal governments throughout the State believe that a mechanism for access to The Executive Branch must be established. The elected leadership of tribes throughout California and the nation have been working with Administration staff to create a forum by which they can maintain their government to government relationship with the Federal Government. An American Indian Leadership Council of regional leaders from federally recognized tribes has formed, which we believe to be an excellent vehicle for tribal access to the President.

President Reagan keenly recognized the need for access between tribal governments and the Federal Government, as expressed in statements in his 20-Point Indian Issues Response published during the Reagan-Bush Campaign. We look towards the President for his support of the American Indian Leadership Council, as the mechanism through which access can be achieved.

Over 176 tribes through the nation called for access to the Executive Branch through a twelve member council, composed of regional tribal representatives to advise the President, at the National Issues Forum, in December, 1980. Their recommendations were forwarded to Mr. Richard Richards on the Transition Team; we enclose another copy for your review. Although no response was forthcoming, an American Indian Leadership Council, led by Chairman Peter McDonald, the Navajo Nation, formed to advise the President on tribal affairs.

Tribal leaders again called on administration officials for access in May, 1981, and recommended that an American Indian policy statement be adopted by the President. We enclose that statement for your review and endorsement by President Reagan.

CTCA member tribes, along with other intertribal organizations, wish to join with the American Indian Leadership Council to meet with the President on tribal affairs. We are looking toward the American Indian Leadership Council to expand its representation to include three additional chairmen, so that every geographic area and the needs of all tribal governments - small and large - will be served.

Tribal governments in California have made every effort to work with the Administration in this endeavor. In the spirit of tribal solidarity, we have joined with the elected leadership throughout the nation to establish a meaningful and harmonious relationship with the council and the Executive Branch of Government.

We anxiously await the opportunity for tribal leadership of all the United States to meet with you and thereby maintain the honor and integrity of the Federal Government's relationship with Indian people.

We will look forward to the new Administration's response and work with the national organizations to relay it to you.



# In Support of the American Indian's Right to Religious Freedom

| WHEREAS: | One hundred seventy-six (176) Federally recognized tribes |

|          | Chairmen's Association and All Indian Pueblo Council; and |

- WHEREAS: The purpose of this National Issues Forum was to make recommendations to the Reagan Administration for orderly transition of tribal affairs; and
- WHEREAS: A major concern of those tribes present at the National Issues Forum involves their religious freedom and the right to pursue religious practices; and
- WHEREAS: The right to one's religious freedom for all Americans is guaranteed by the First Amendment to the United States Constitution; and
- WHEREAS: The Native American Church of North America requires the use of peyote as a sacrament and uses it in its ceremonies as practiced by members under the authority of the church; and
- WHEREAS: Federal laws have upheld the rights of members of the Nativ American Church to use peyote in religious practices; and
- WHEREAS: Certain state laws are nonetheless in conflict with federal laws and their enforcement has resulted in prosecution of Indian people;
- WHEREAS: Such prosecutions strongly interfere with the Indians' right and in particular, the Prarie Band of Potawtomi's rights, to religious practices and guarantee of religious freedom under the First Amendment to the United States Constitution
- WHEREAS: The American Indian Religious Freedom Act exists to further ensure the rights of all Indian people to pursue religion practices as guaranteed by the First Amendment of the Unit States Constitution.
- NOW, THEREFORE, BE IT RESOLVED that Federally recognized tribes present at the National Issues Forum join with the Prarie Band of Potawatomi tribes in support of the American Indian Religi Freedom Act and support the rights of all Indian people to

pursue their religious freedom as guaranteed by the First Amendment of the United States Constitution.

TO URGE SUPPORT BY THE REAGAN ADMINISTRATION OF THE INDIAN CHILD WELFARE ACT (PL 95-608)

WHEREAS:
One hundred seventy-six (176) Federally recognized tribes met at a National Issues Forum in San Diego, California, December 15-17, 1980, sponsored by the California Tribal Chairmen's Association and the All Indian Pueblo Council; and

WHEREAS: The purpose of this National Issues Forum was to make recommendations to the Reagan Administration for or- derly transition of tribal affairs; and

WHEREAS: Congress, through statutes, treaties, and the general course of dealing with Indian tribes has assumed the responsibility for the protection and preservation of Indian tribes and their resources; and

WHEREAS: There is no resource more vital to the continued existence and integrity of Indian tribes than their children; and

WHEREAS: The United States has a direct interest, as trustee, in protecting Indian children who are members of or are eligible for membership in an Indian tribe; and

WHEREAS: Congress, in passing the "Indian Child Welfare Act of 1978" has declared that it is the policy of this nation to protect the best interests of Indian children and to promote the stability and security of Indian tribes and families; and

WHEREAS: Adequate funding is needed to meet the goals of the "Indian Child Welfare Act of 1978" and

NOW, THEREFORE, BE IT RESOLVED, that those tribes present request that the administration of President-Elect Reagan adopt and actively support the goals and intent stated within the "Indian Child Welfare Act of 1978"; and

BE IT FURTHER RESOLVED, that those tribes present request the Reagan Administration to approve Congressional appropriations to fund the "Indian Child Welfare Act of 1978" for Fiscal Year 1982.

WHEREAS: The National Issues Forum coordinated by the California Tribal
Chairmen's Association and all Indian Pueblo Council, met in
San Diego, California on December 15-17, 1980, to discuss issues
of mutual concern to Federally recognized tribes;

WHEREAS: The purpose of the forum is to advise and make recommendations to the Reagan Administration for the orderly transition of tribal affairs;

WHEREAS: The Elected tribal leaders attending the forum, recognize the need for legislation amending all block grant programs to include provisions for direct funding to tribes;

WHEREAS: There exists a need for a uniform formula for all federal agencies to abide by to fully fund indirect cost rates of tribes as established by any one authorized agency.

WHEREAS: Legislation to improve the inconsistencies in the formulas presently used for indirect cost rates would improve the situation and not jeopardize other tribal funds to meet indirect costs.

WHEREAS: Such legislation should identify "set aside" funds for the purpose of establishing a uniform indirect cost rate;

NOW THEREFORE, be it resolved:

That the elected tribal leaders at the National Issues Forum sanction and support legislation to provide direct access by tribes to block grants by direct funding for this purpose;

#### LET IT BE FURTHER RESOLVED:

That such legislation provide for a formula for an indirect cost rate to be applied uniformly by all federal agencies serving Federally recognized Indian tribes.
