Congratulations on your successful efforts in leading the passage of the Tax Equity and Fiscal Responsibility Act of 1982, the Conference Committee Report on H.R. 4961.

Section 251 of this Act contains several provisions from S. 1910 that are of significant importance to the churches of this country. Indeed, leaders of over twenty-seven religious denominations have been working for several years to clarify the tax law related to the retirement benefits of ministers and other denominational workers. We are pleased that Section 251 is a part of the Tax Equity and Fiscal Responsibility Act.
