Dear Morton:

On behalf of the delegation from the Washington Interreligious Staff Council (WISC) I want to express my thanks for the visit with you on October 27. We were, of course, sorry that Diane Luzzano could not join us, but we enjoyed the conversation with you while we waited. We felt that we were able to clarify the process we should follow to get a fully developed proposal to you regarding the idea of a meeting between the President and the Presidents and Executive heads of the denominations and faith groups which work together in WISC. I have enclosed a listing of these groups along with the names of the Washington based staff for your files.

I will be in touch with the executive offices of these groups to work together with them to develop the proposal and will forward it to you as soon as it is ready. As we said to you during our conversation there is important precedence for these religious leaders to meet occasionally with the President for off-the-record conversations and exchanges which sometimes touch on the issues of current political attention but often on matters of the spirit and of theological concern. I look forward to working with you on this.
